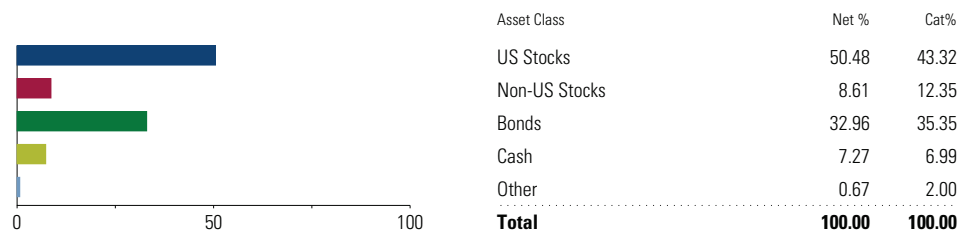

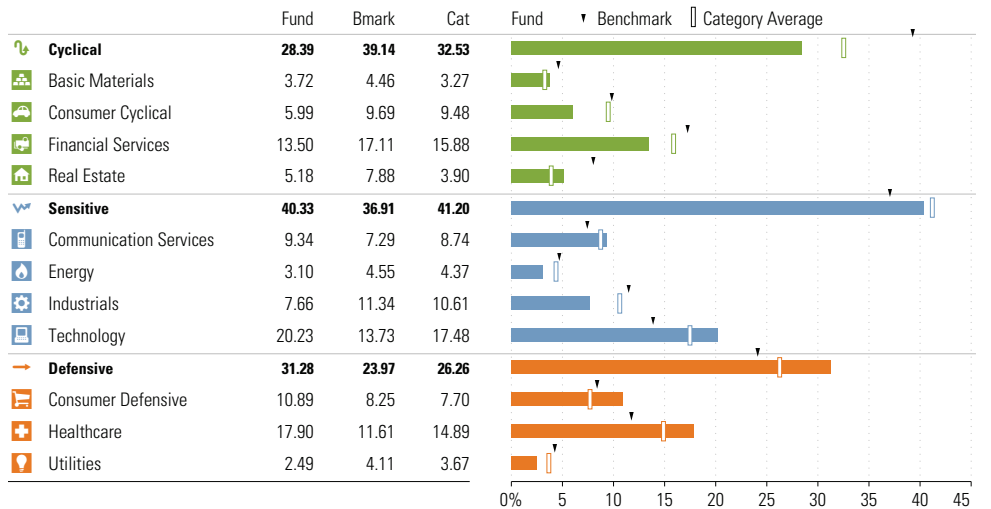

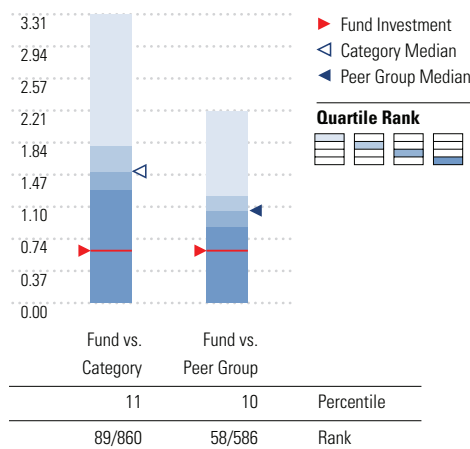

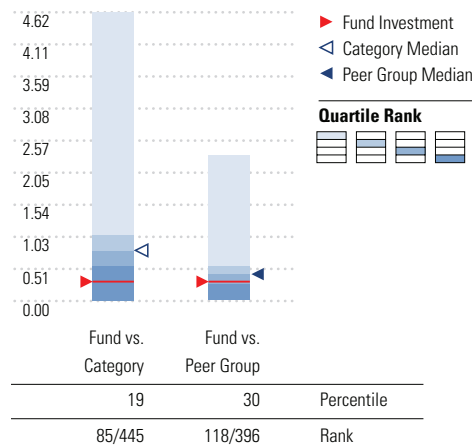

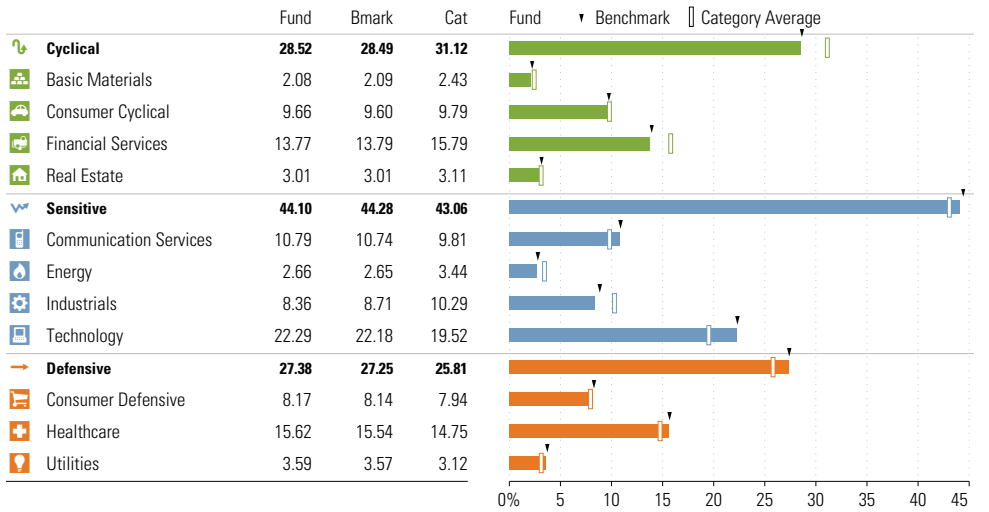

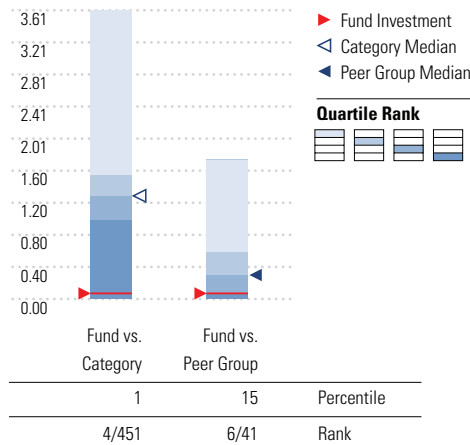

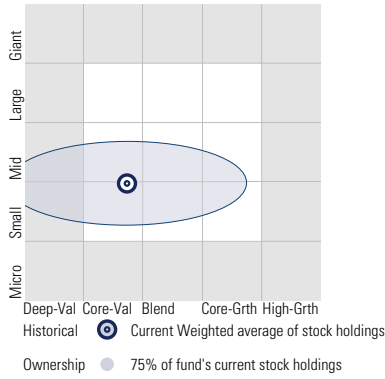

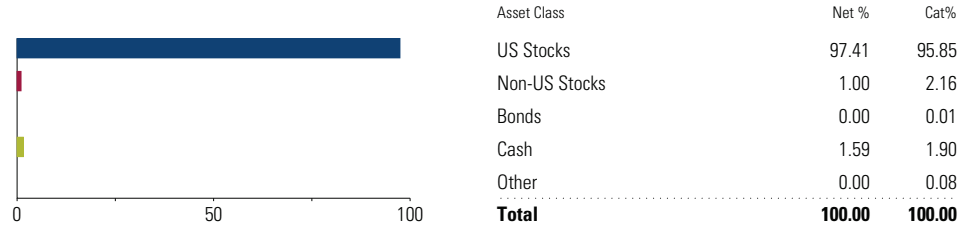

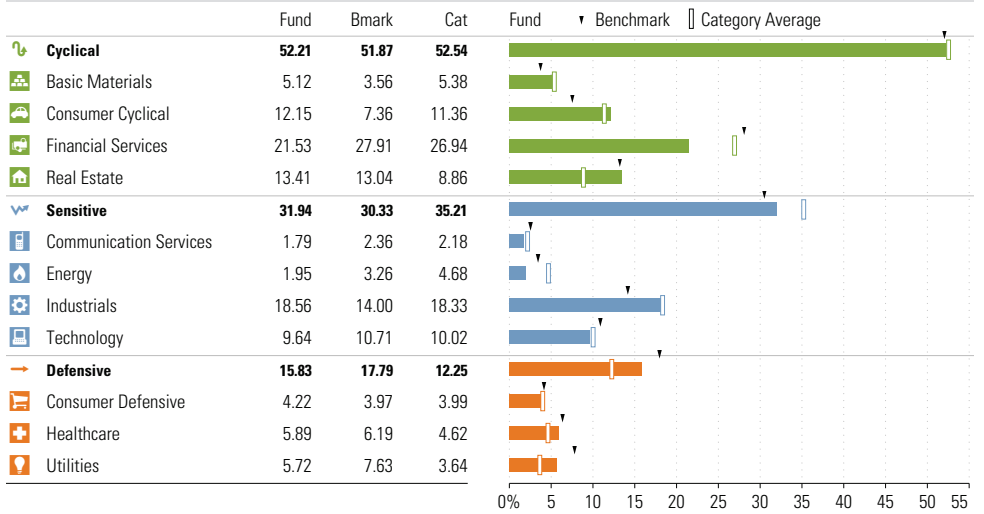
Style Breakdown

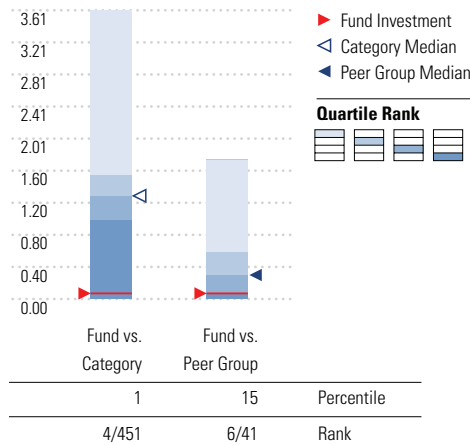

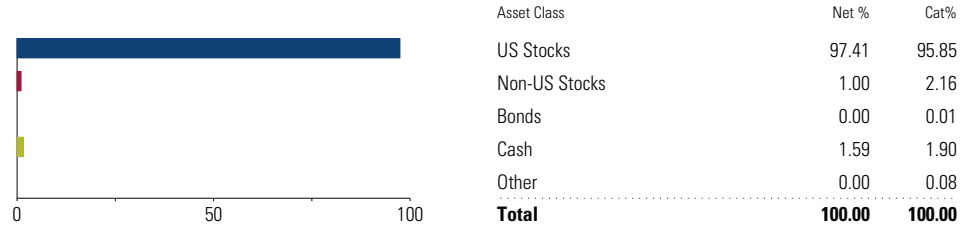

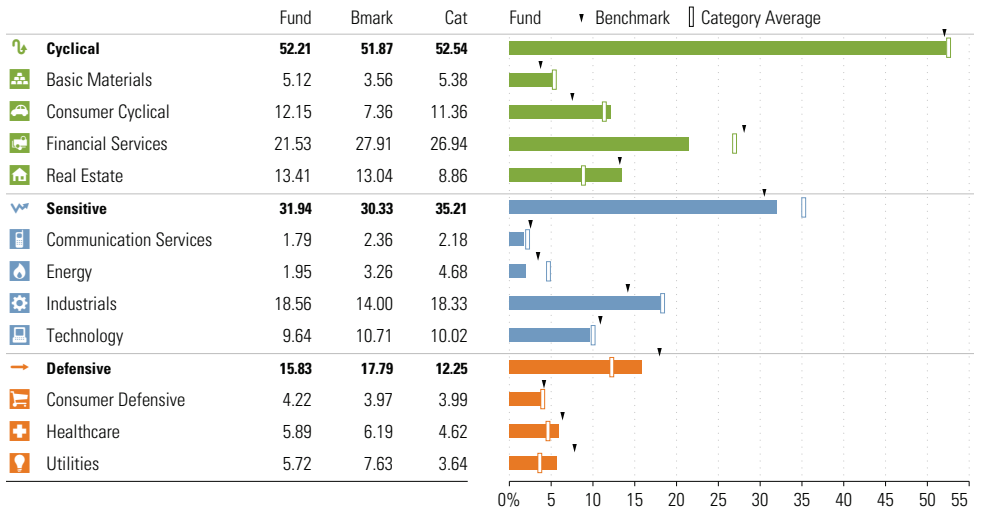
