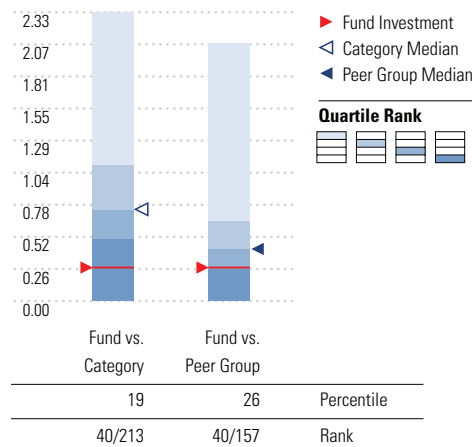

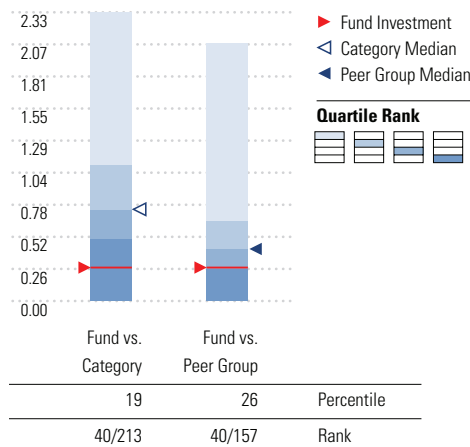

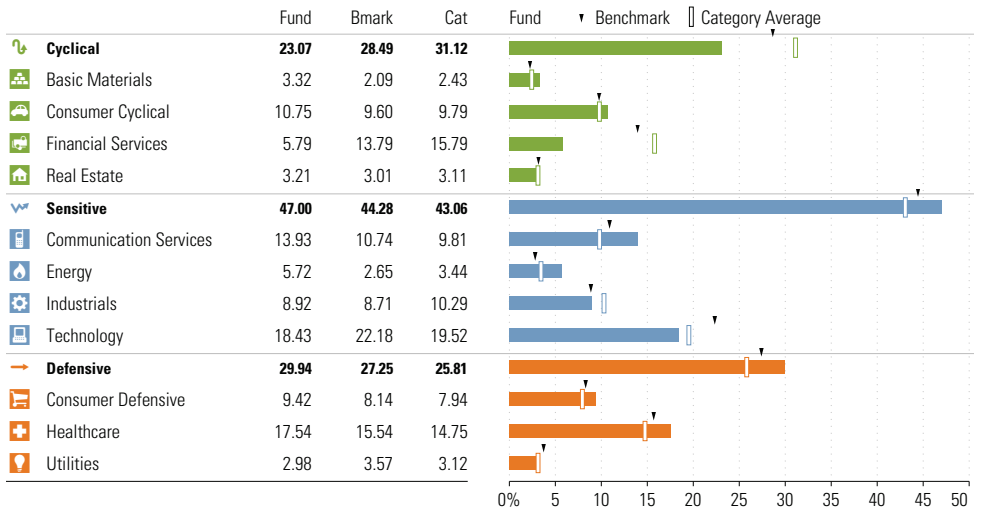

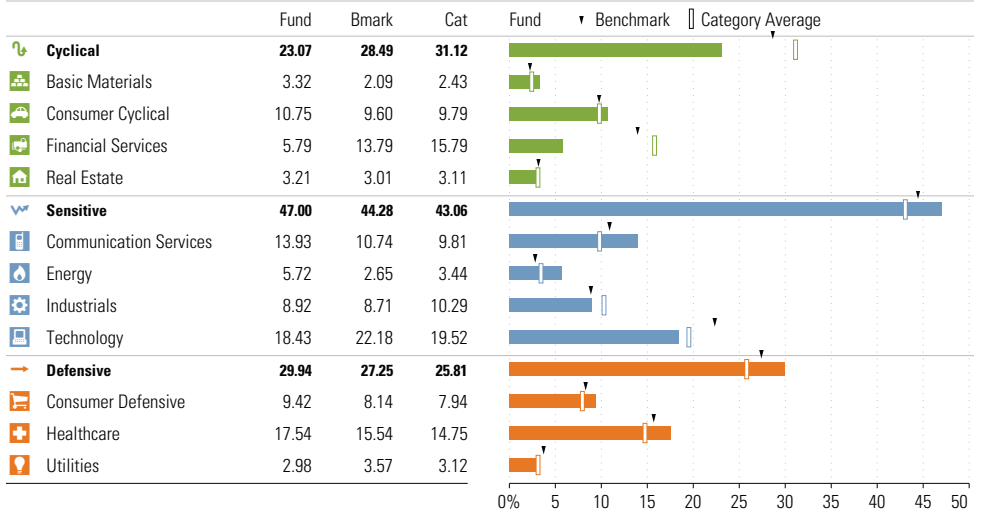

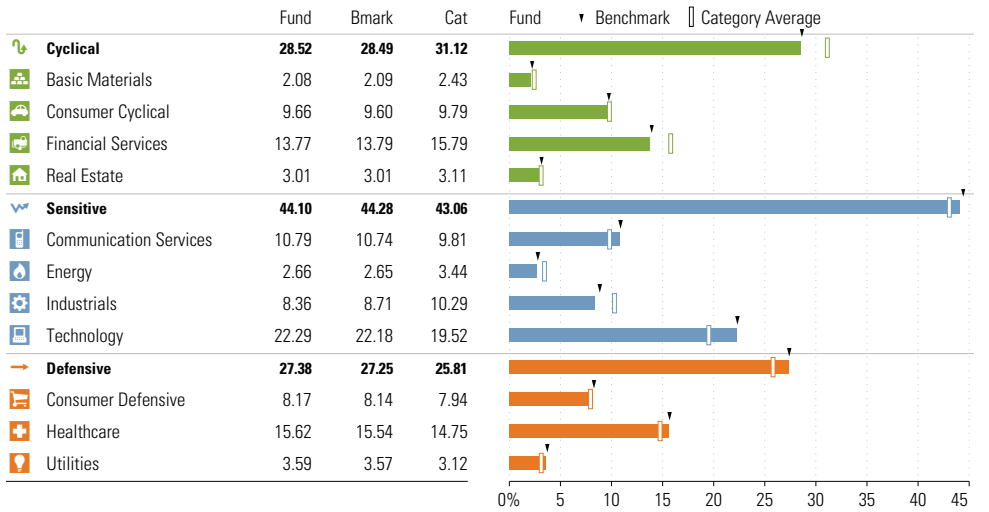

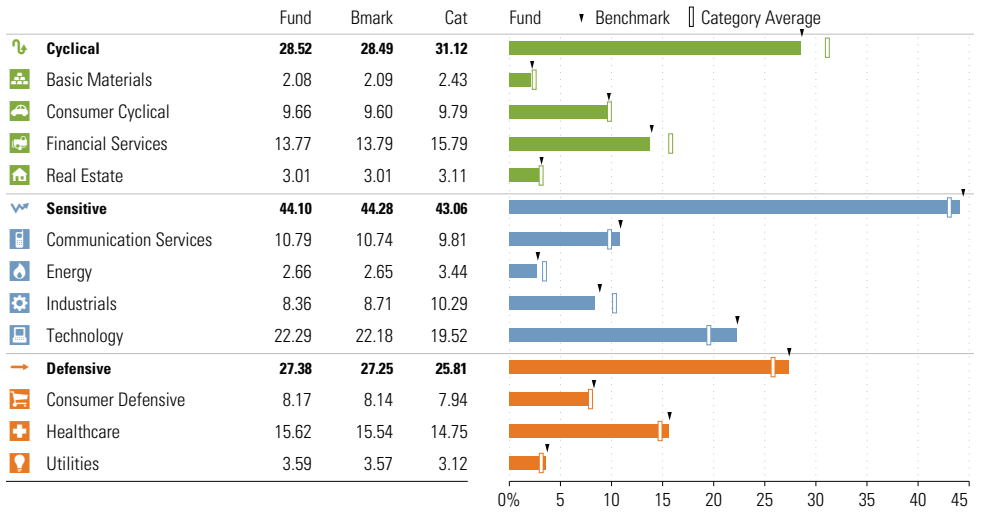

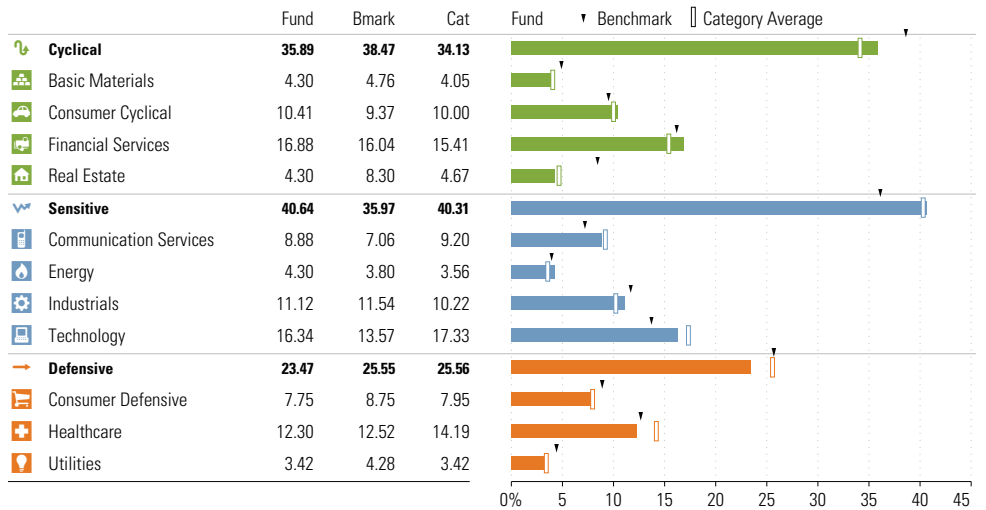

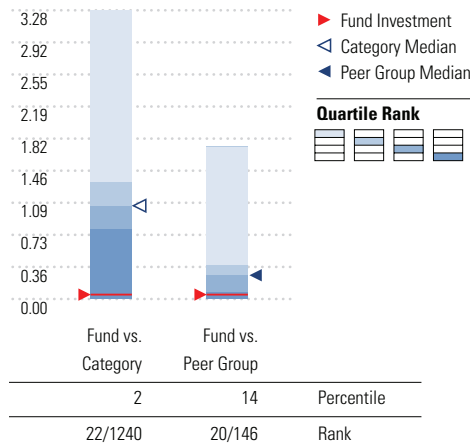
Growth of \$10,000

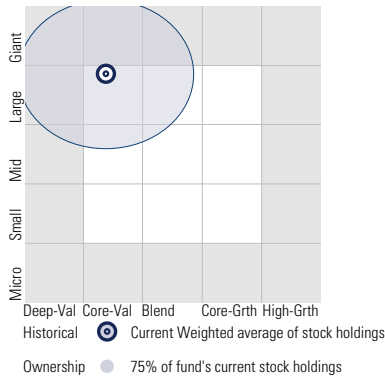

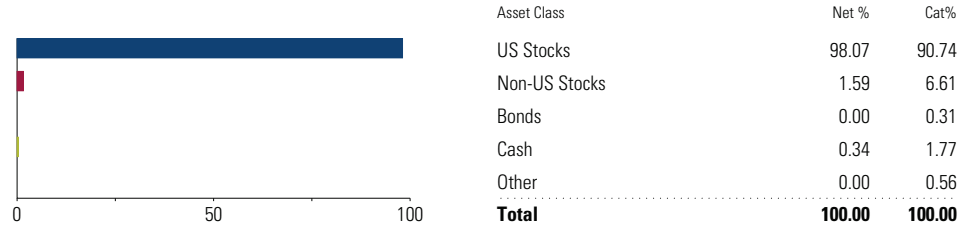

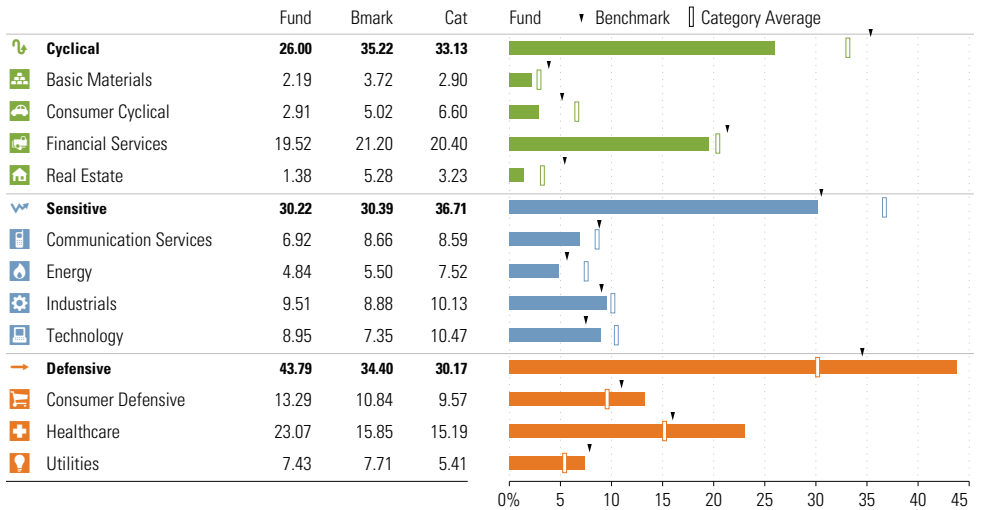
Style Breakdown

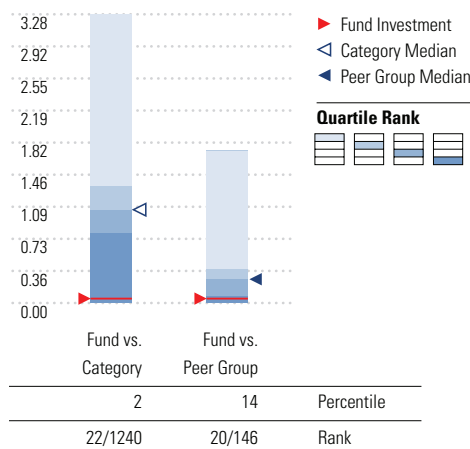

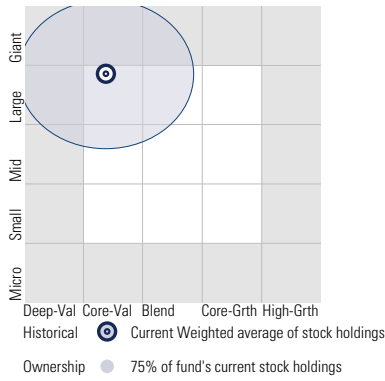

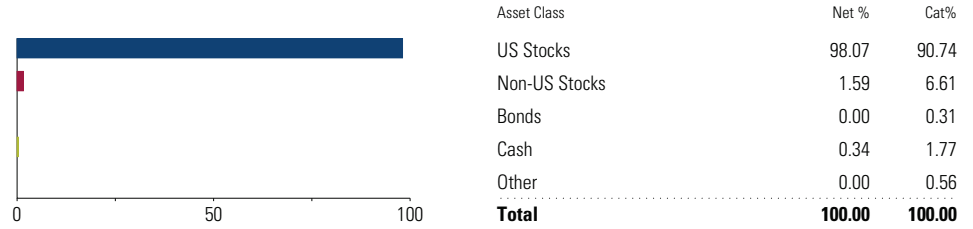

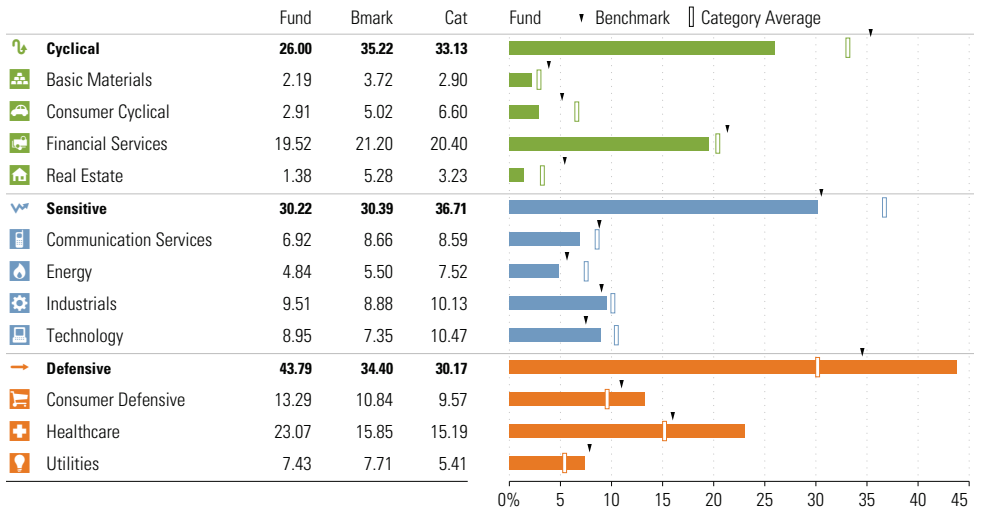
Style Breakdown
