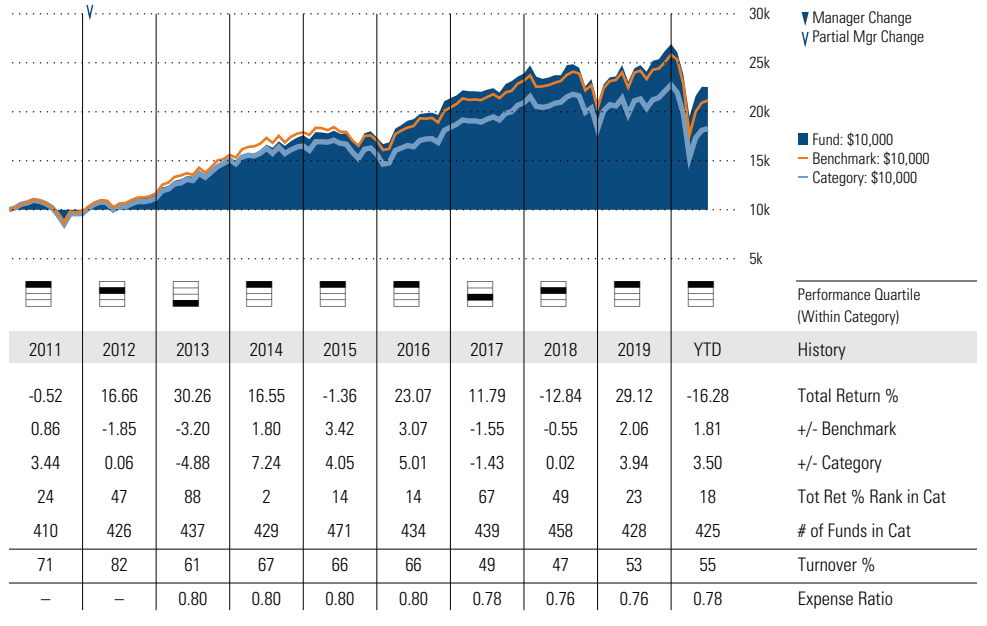

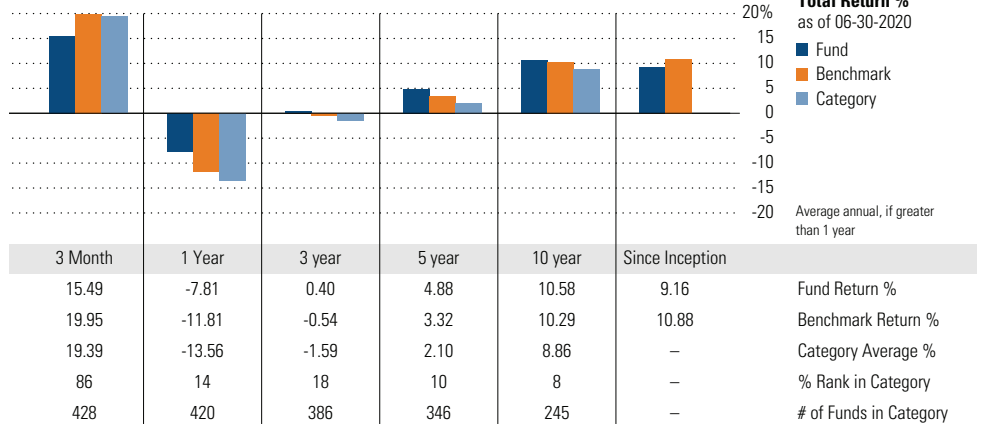

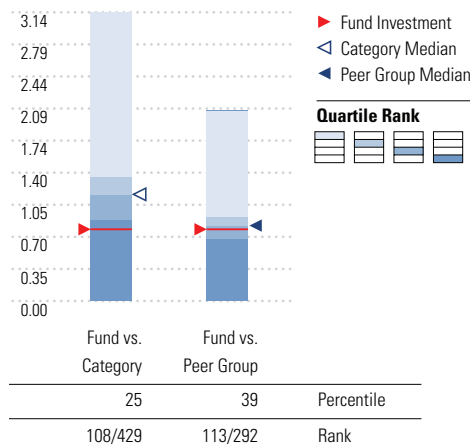
Growth of \$10,000

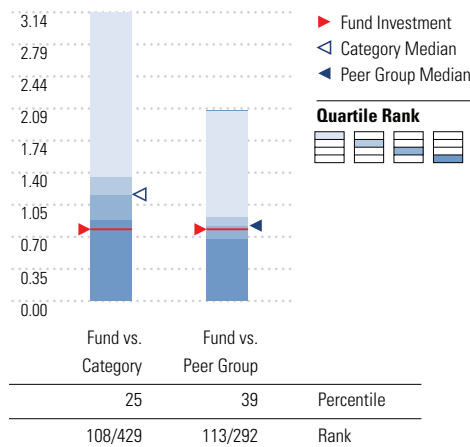

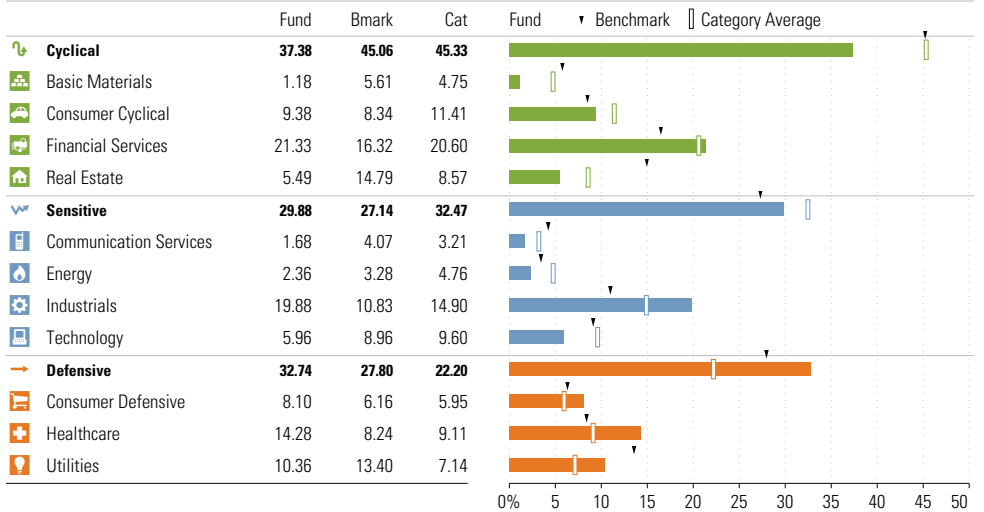

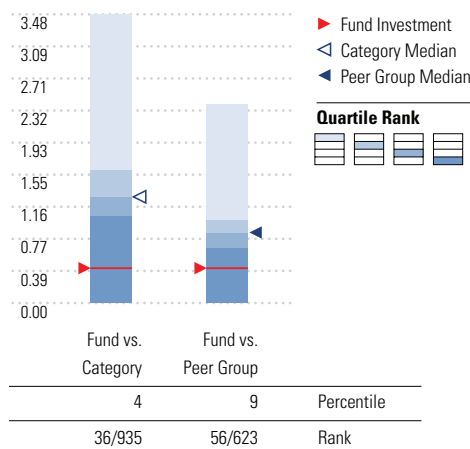

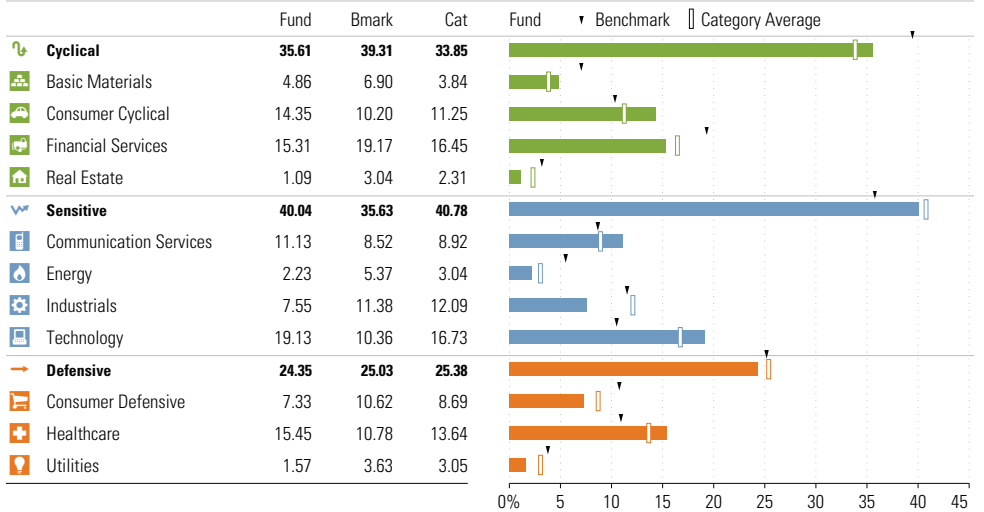

Growth of \$10,000



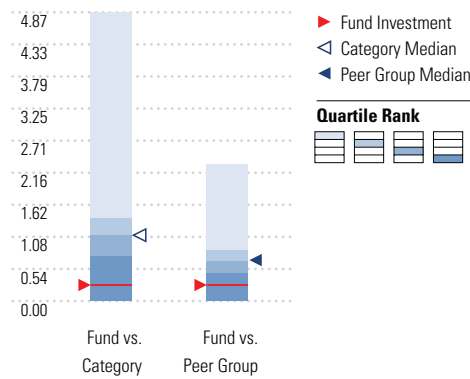

Growth of \$10,000



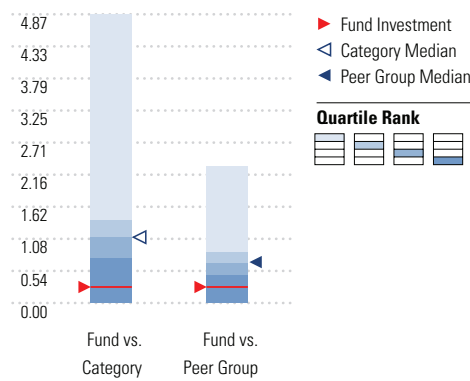

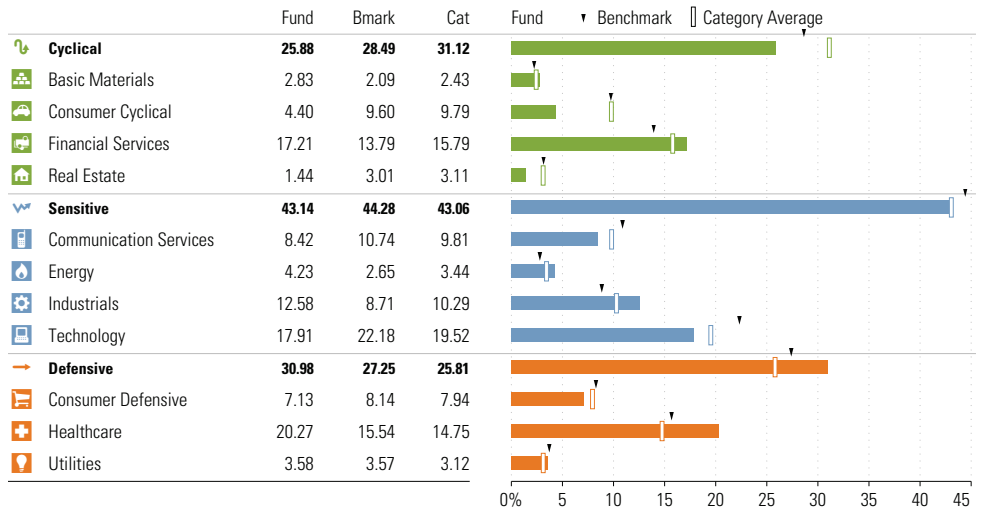

Growth of \$10,000



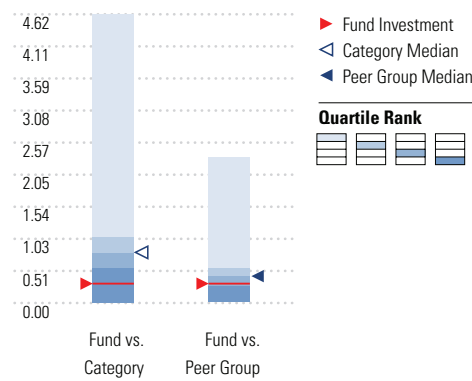

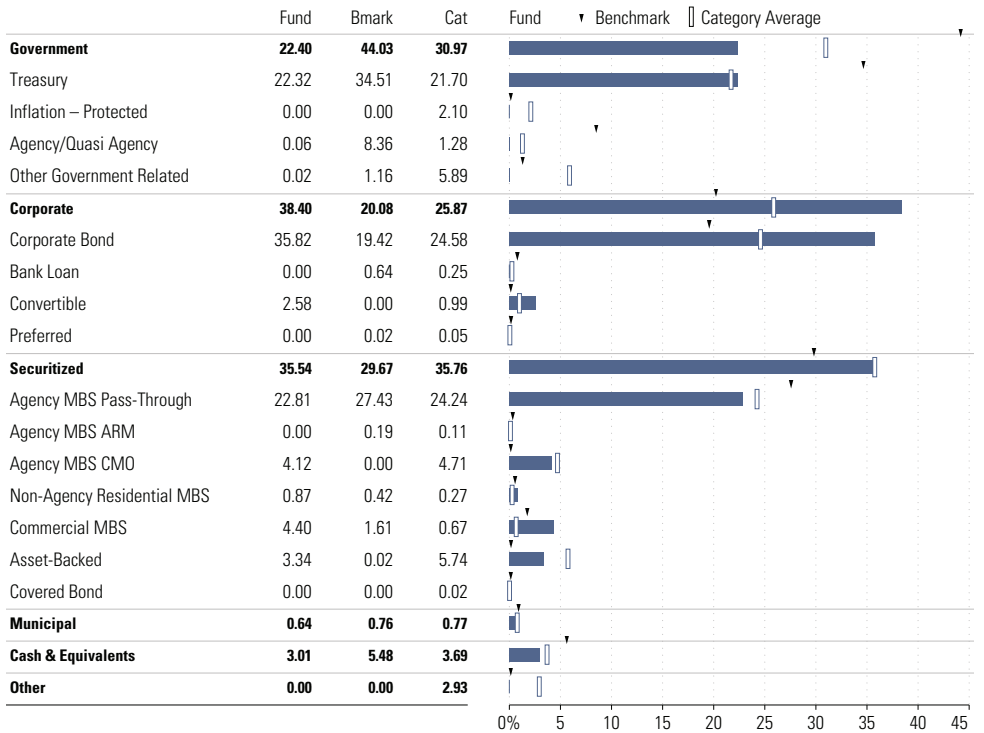

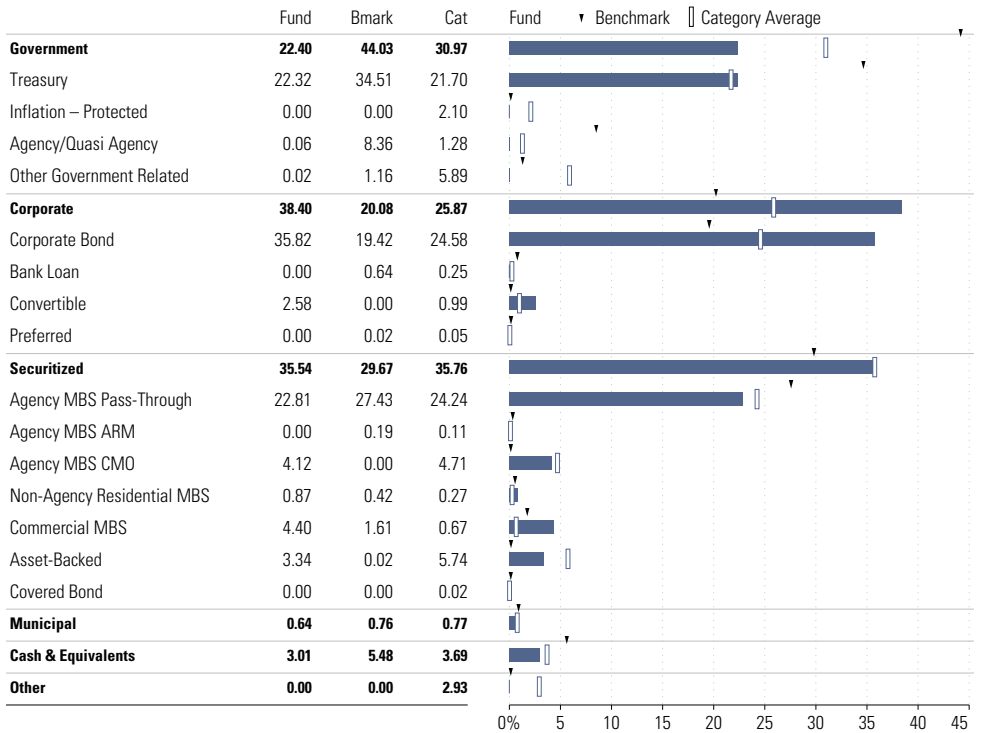

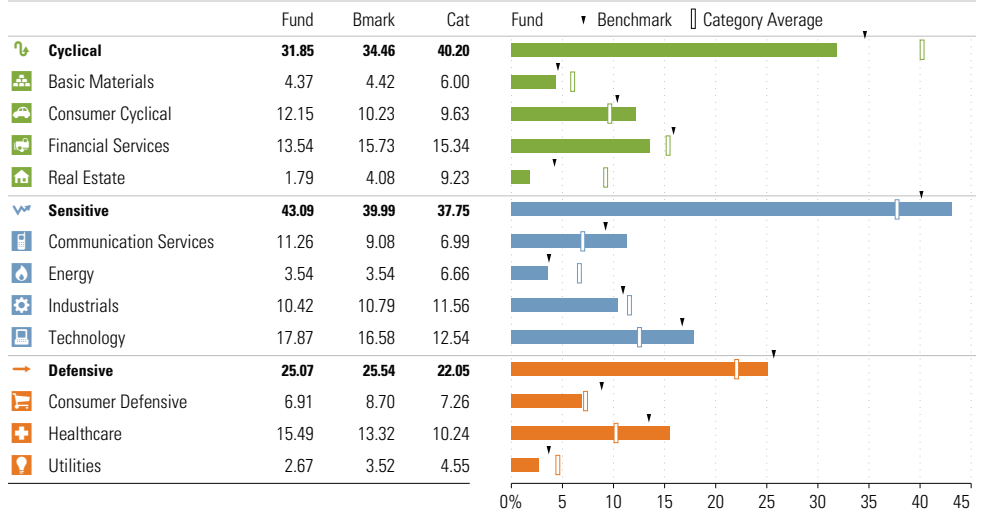

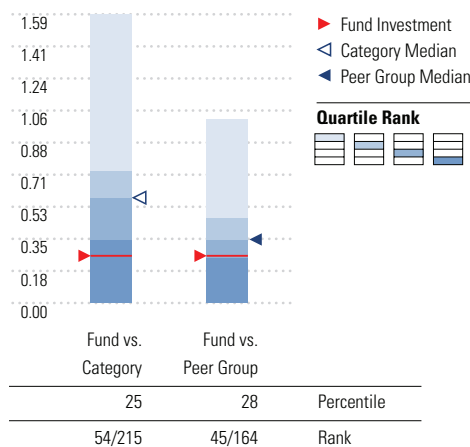

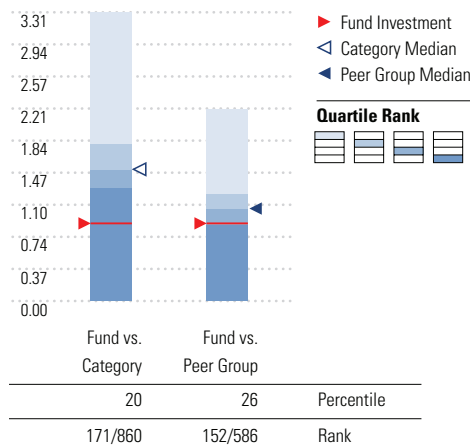

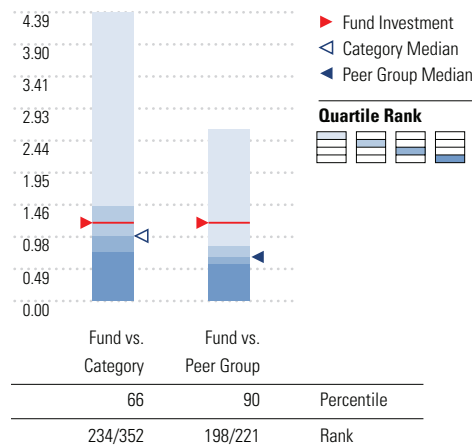

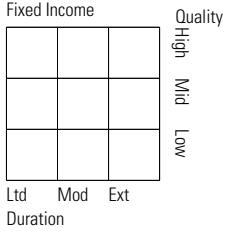

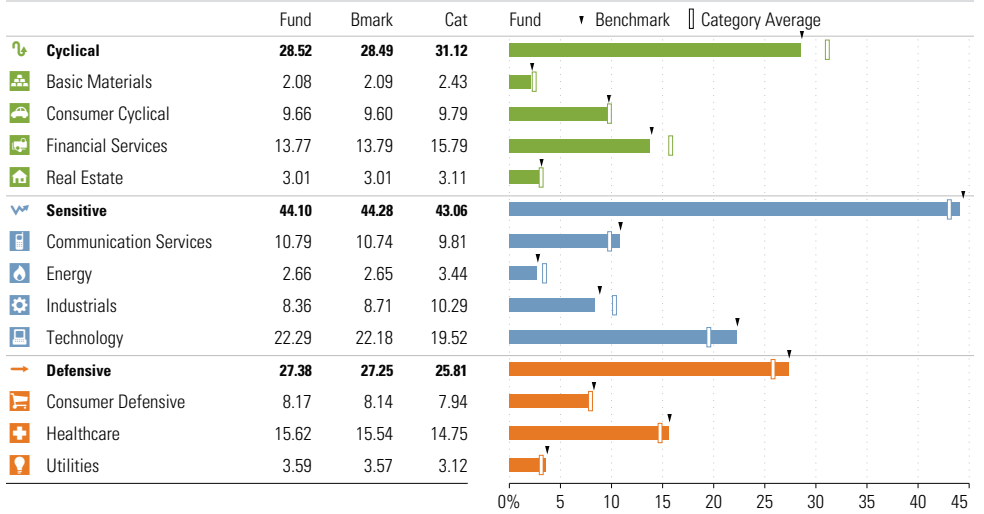

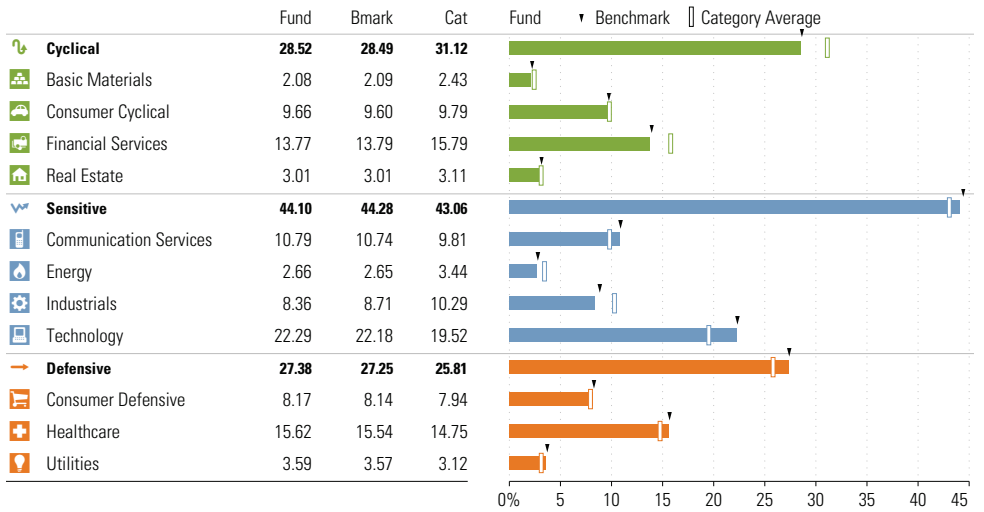

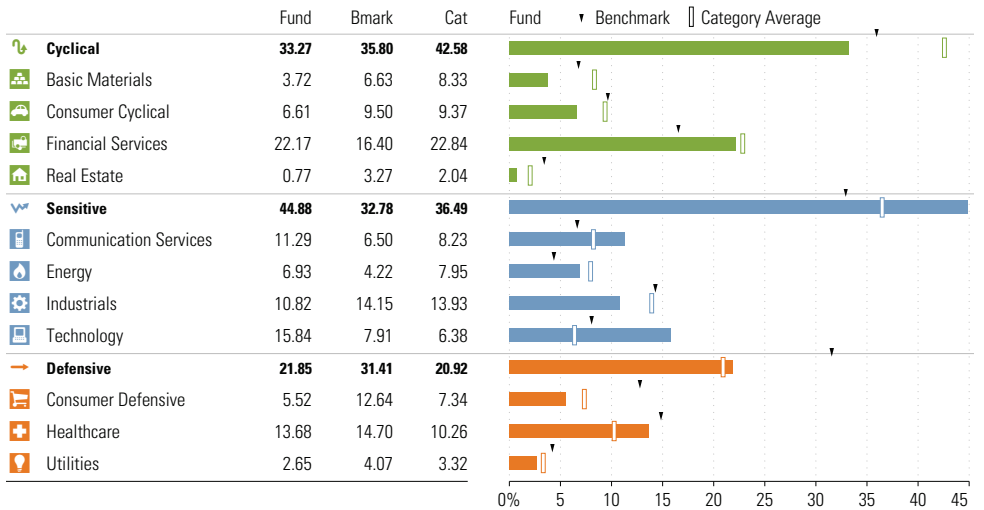

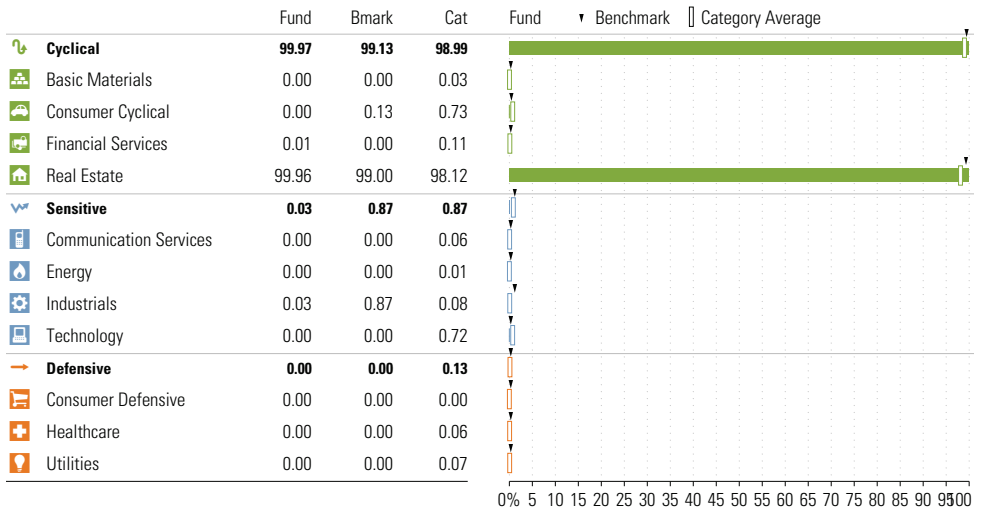

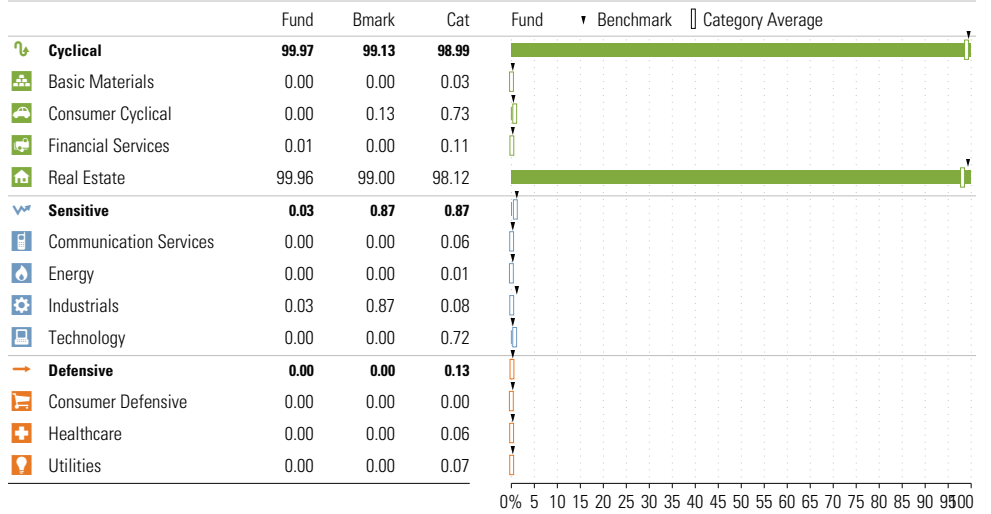

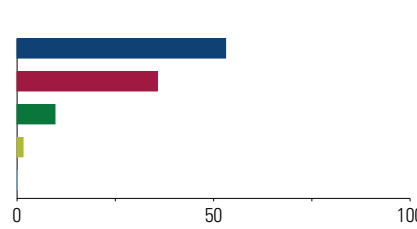

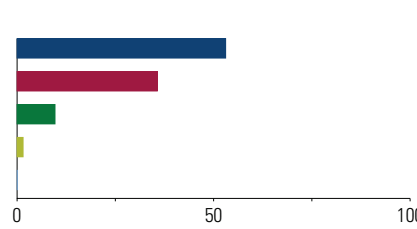

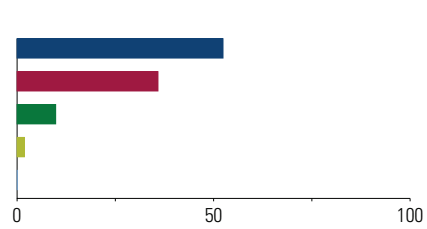

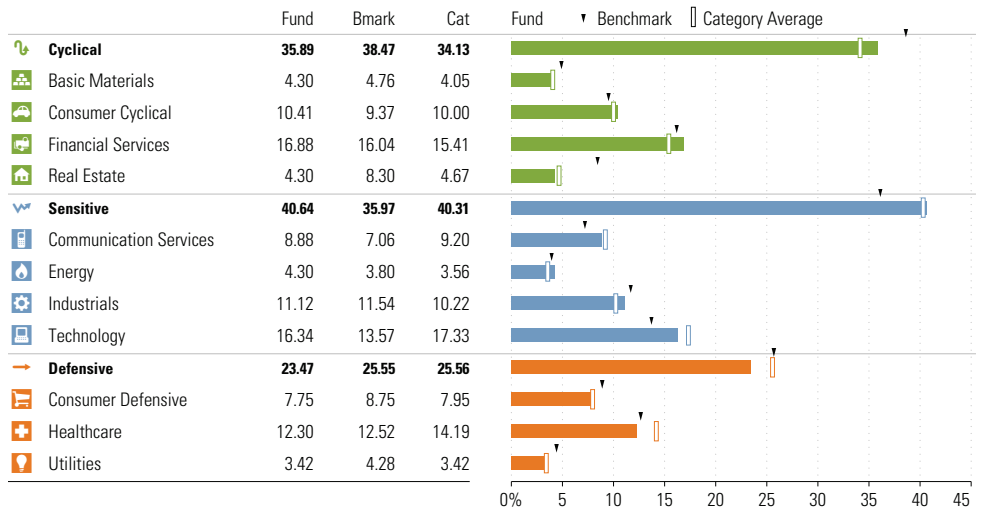

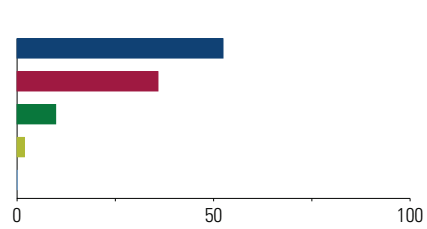
