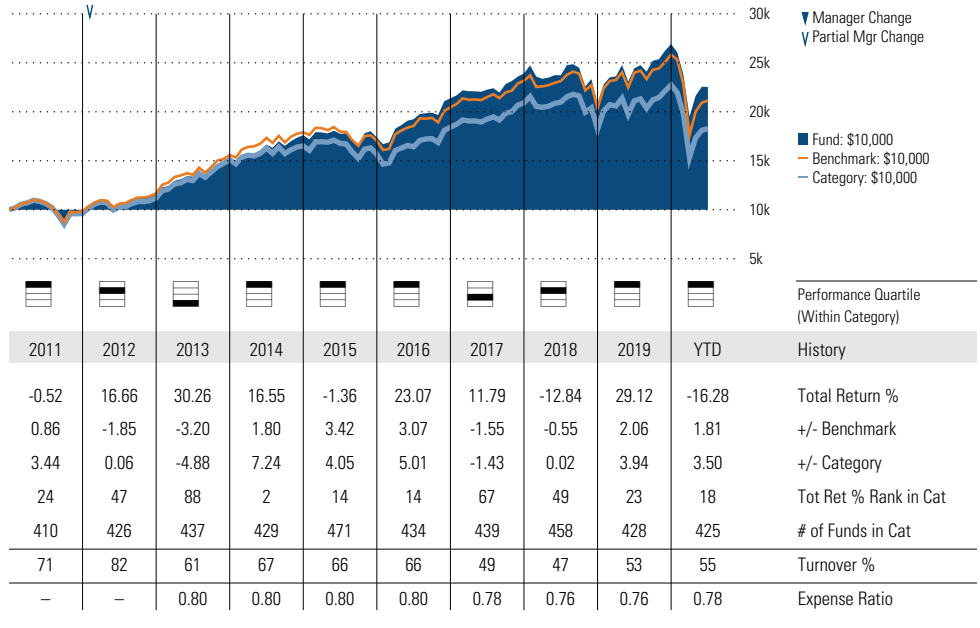

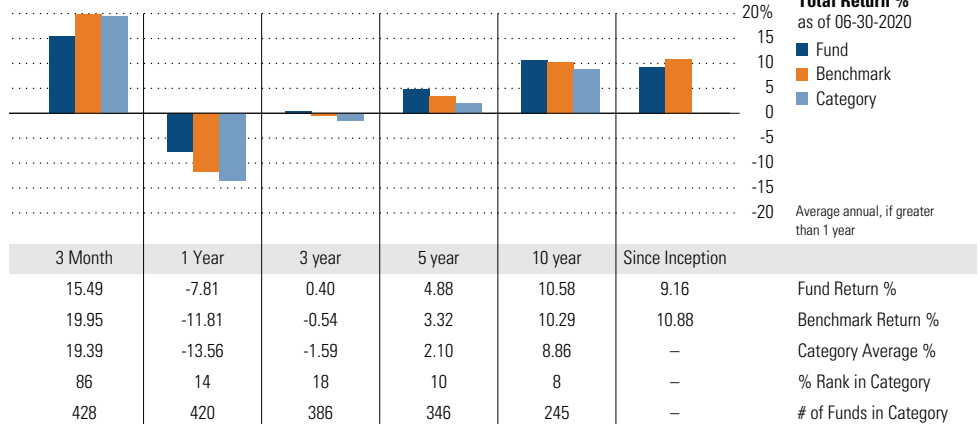
Growth of \$10,000



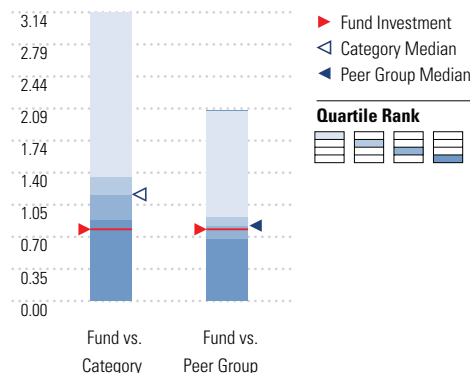

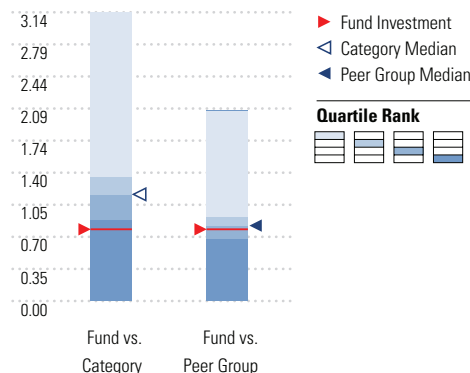

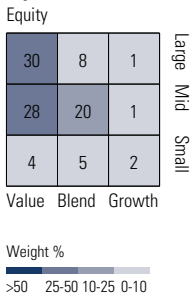

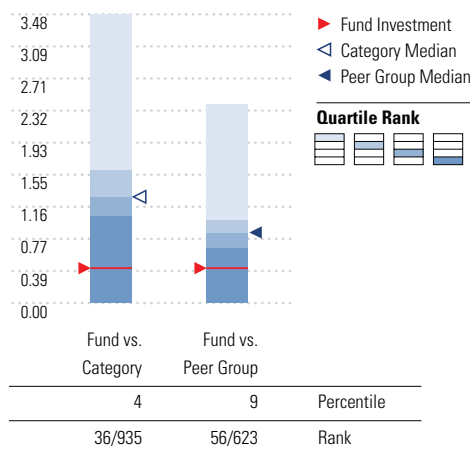

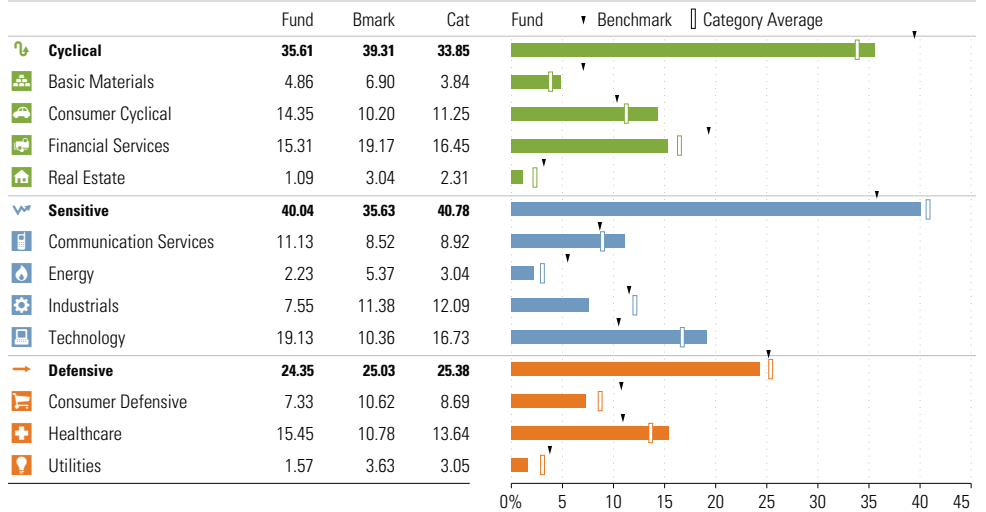

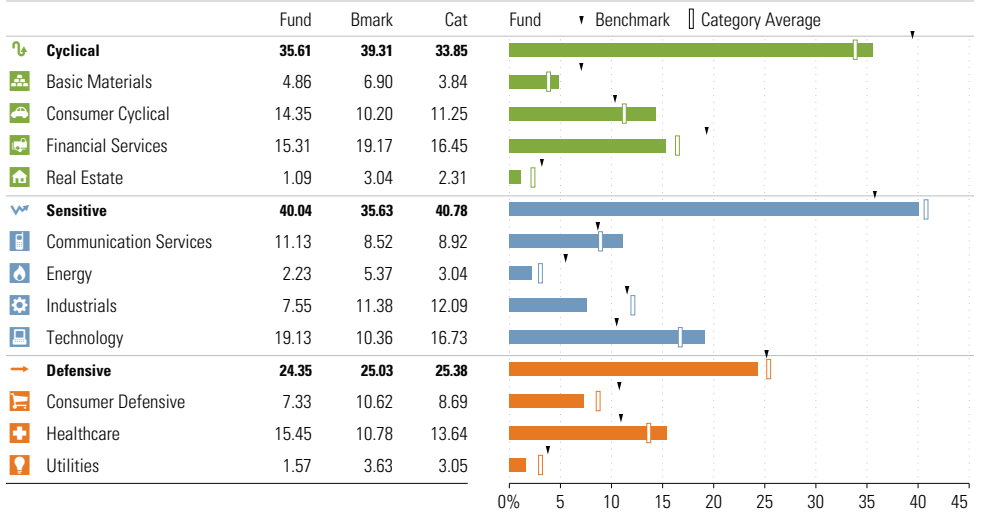

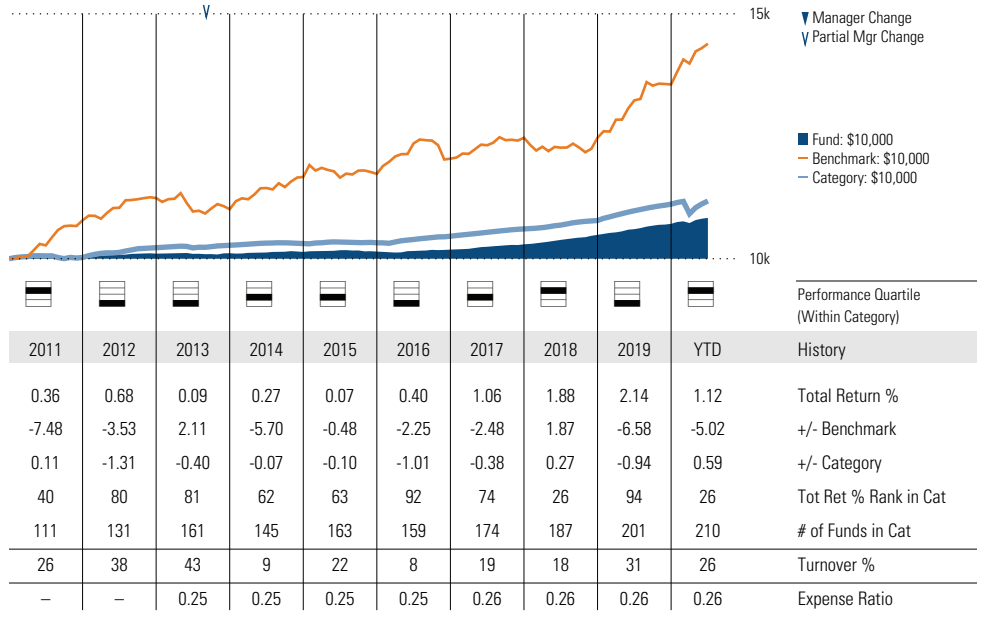

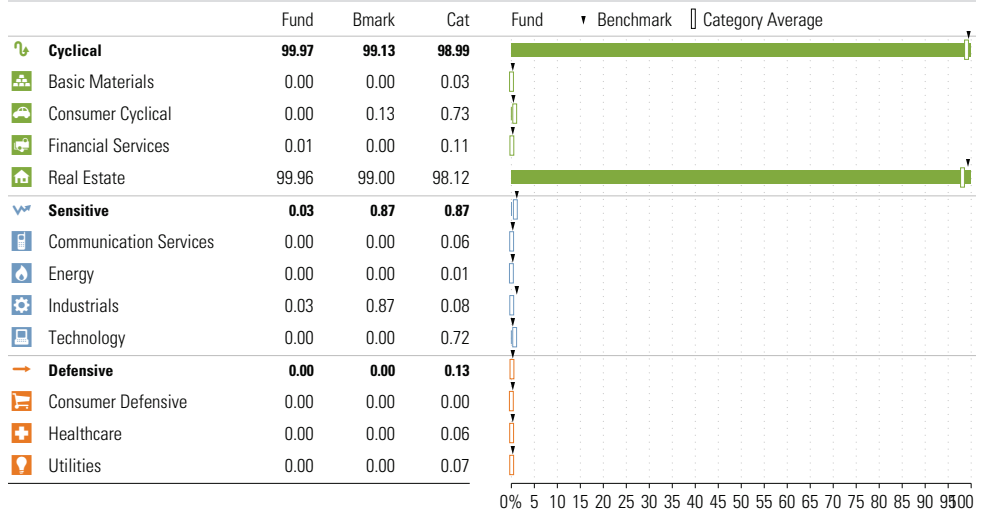

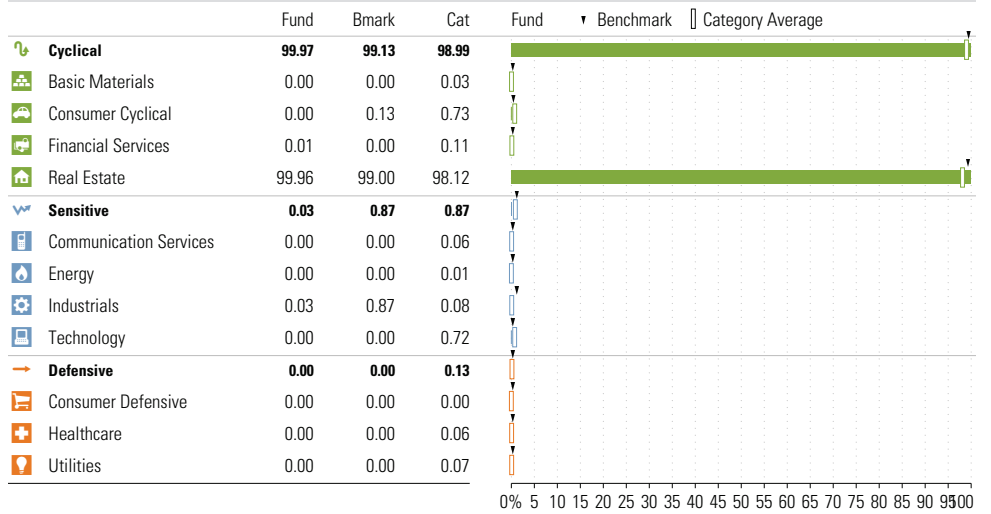

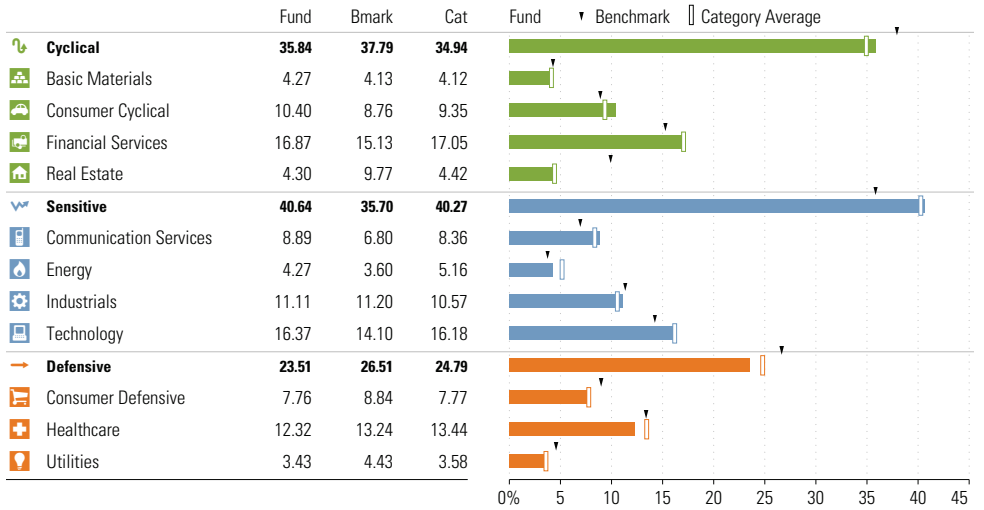

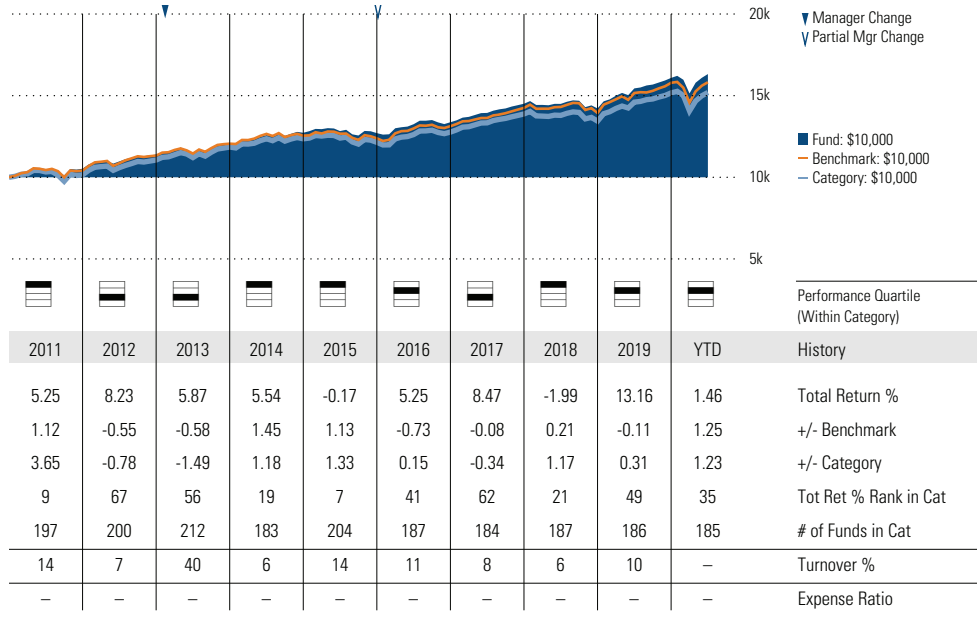

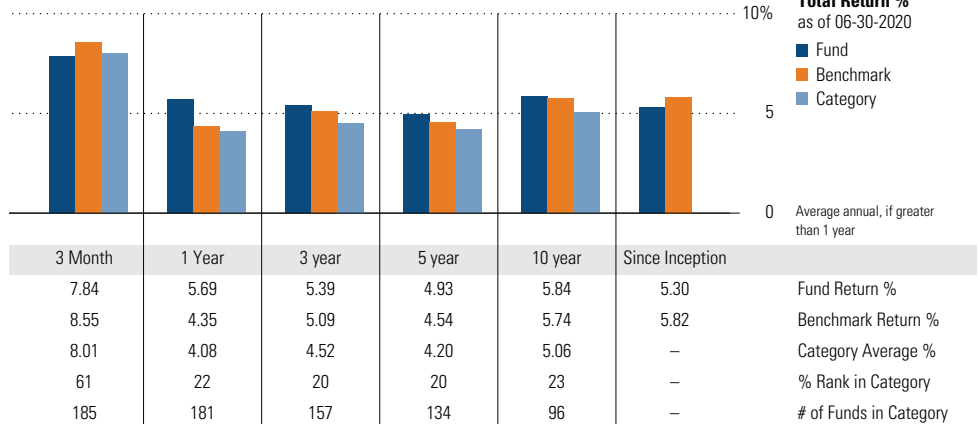

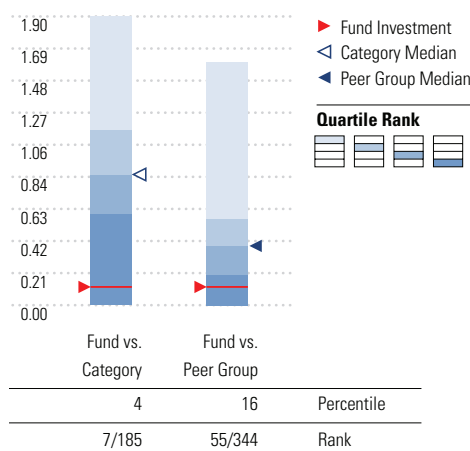
Growth of \$10,000

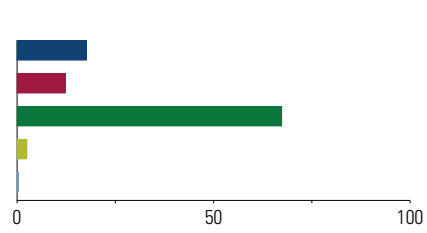

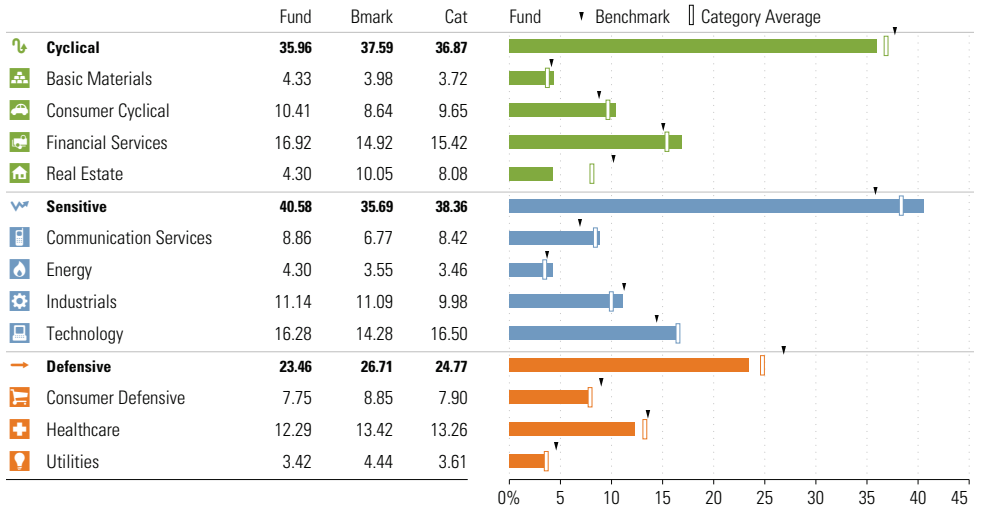


Asset Allocation as of 06-30-2020
