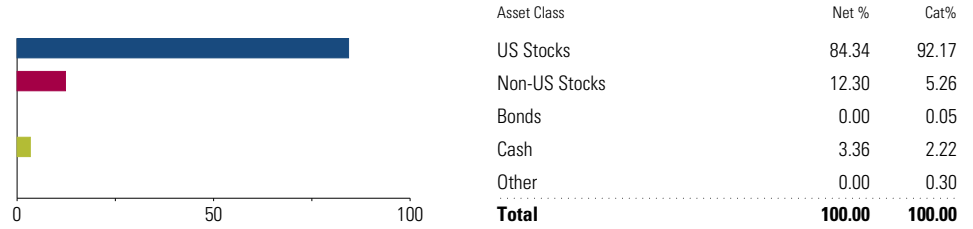

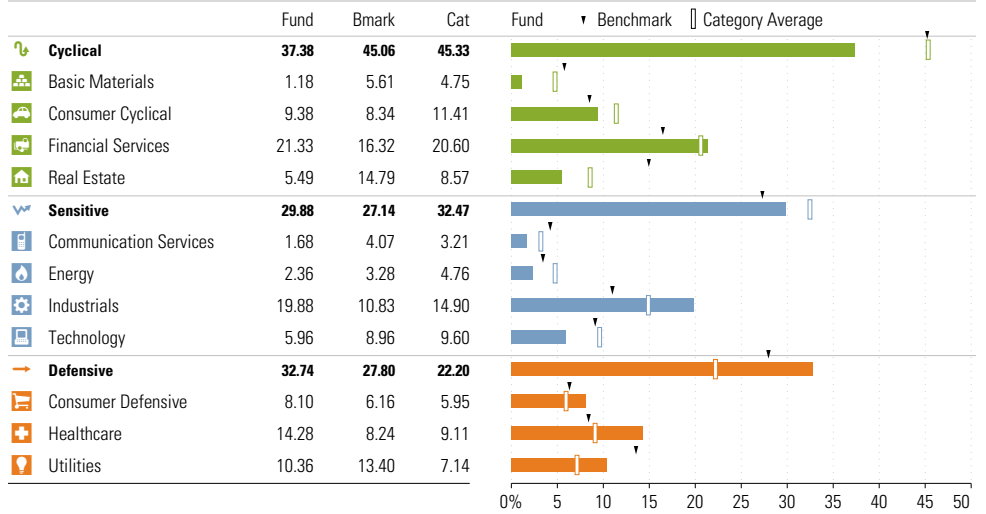

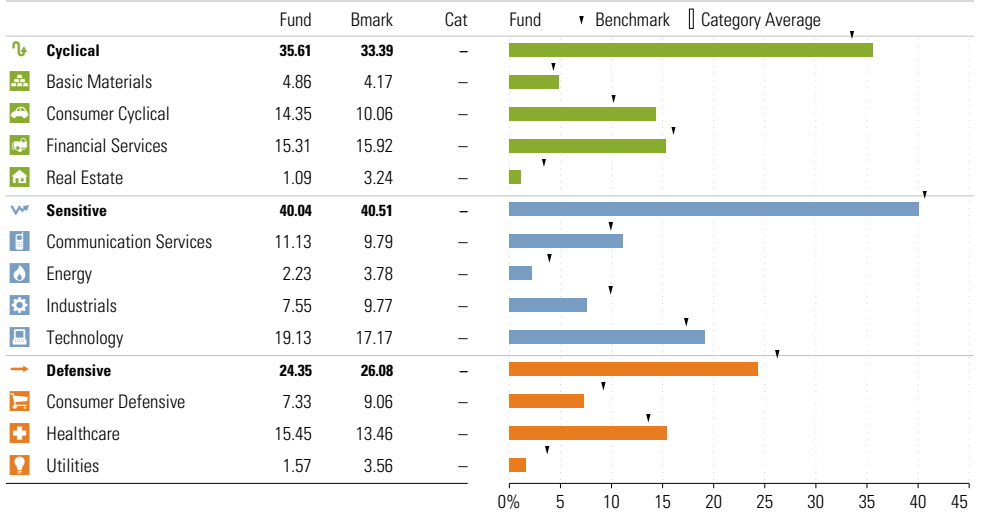

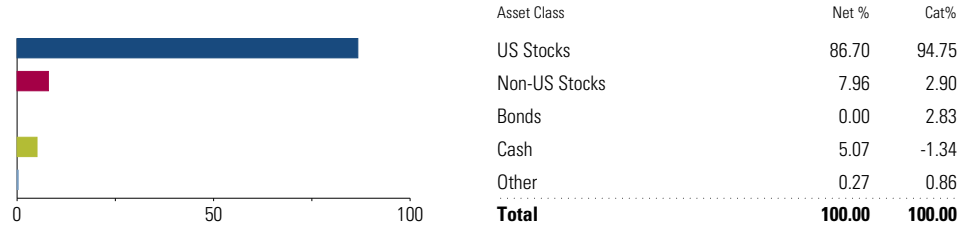

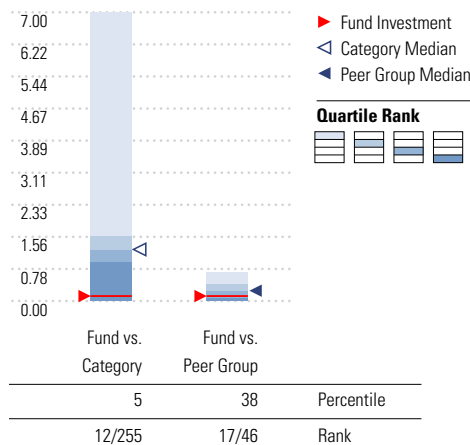

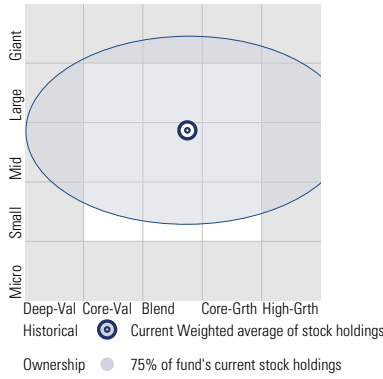

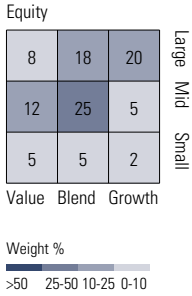

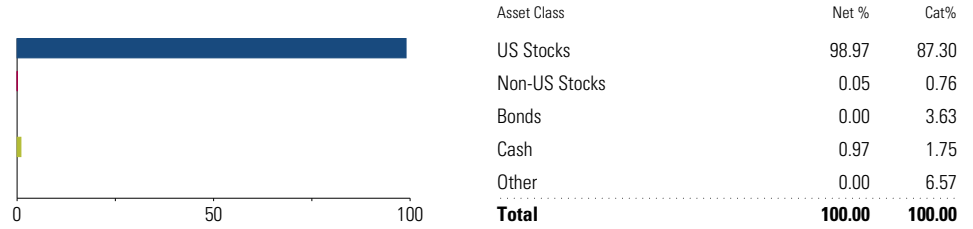

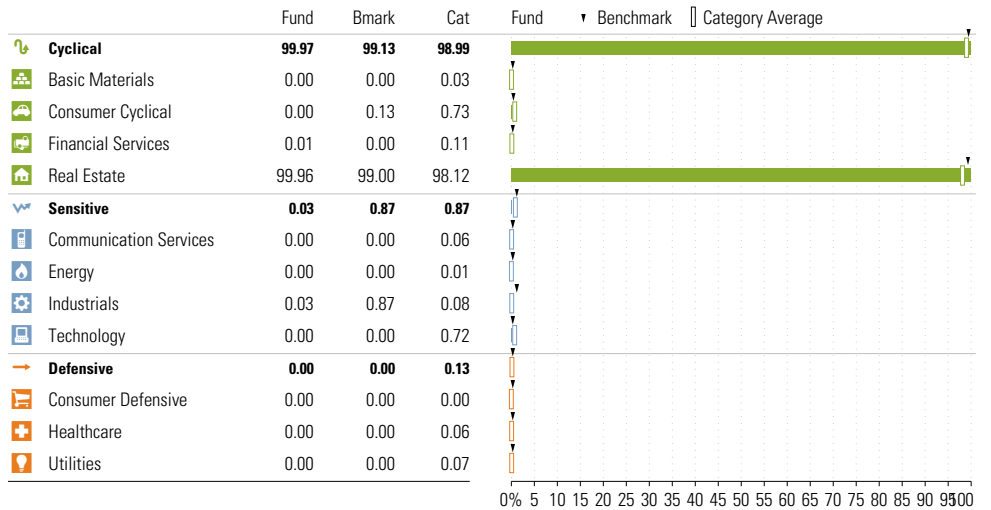
Style Breakdown
