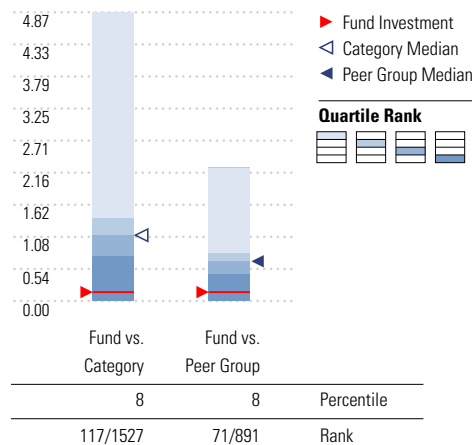

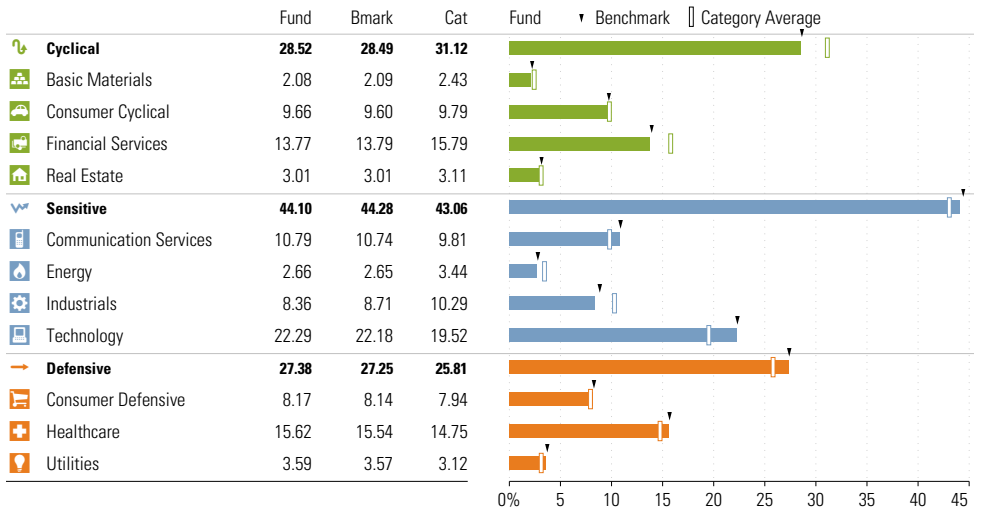

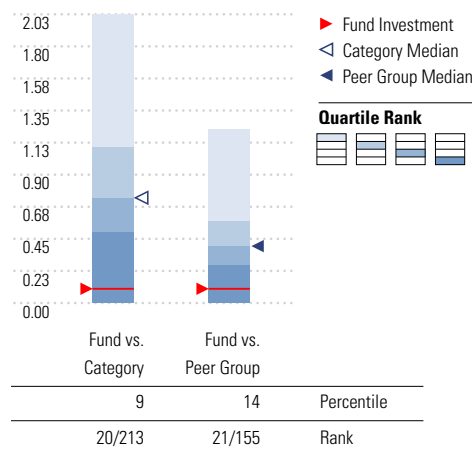

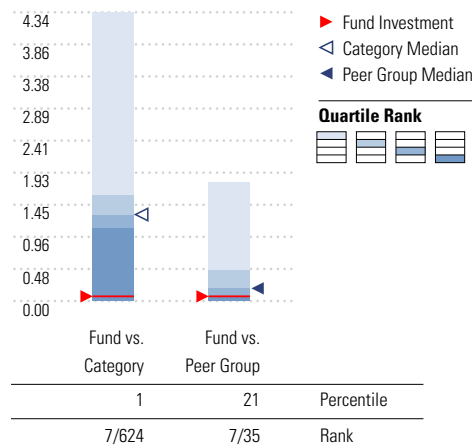

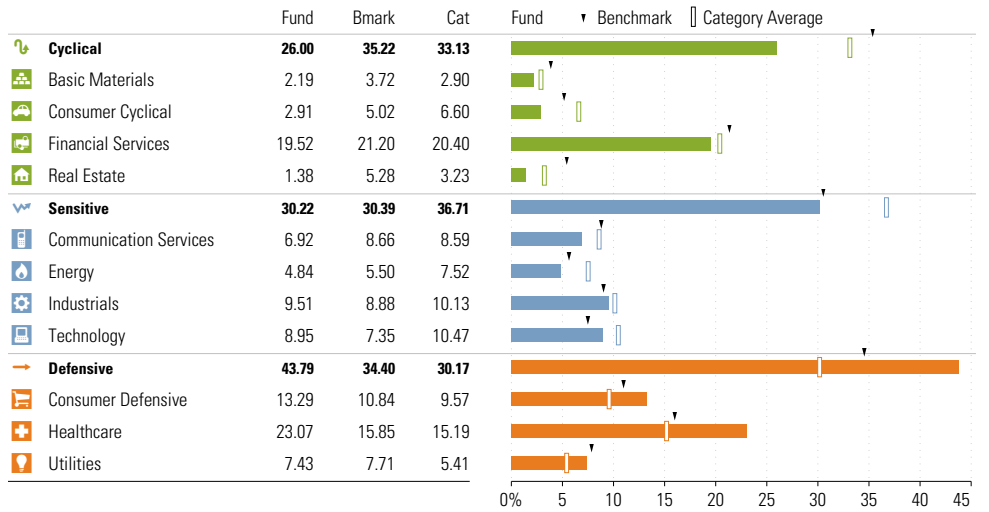
Style Breakdown
