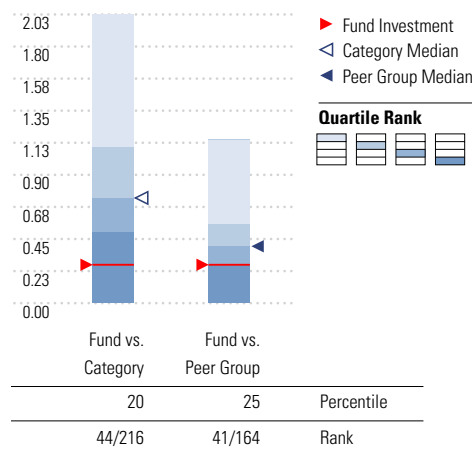

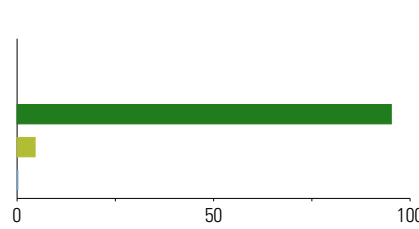

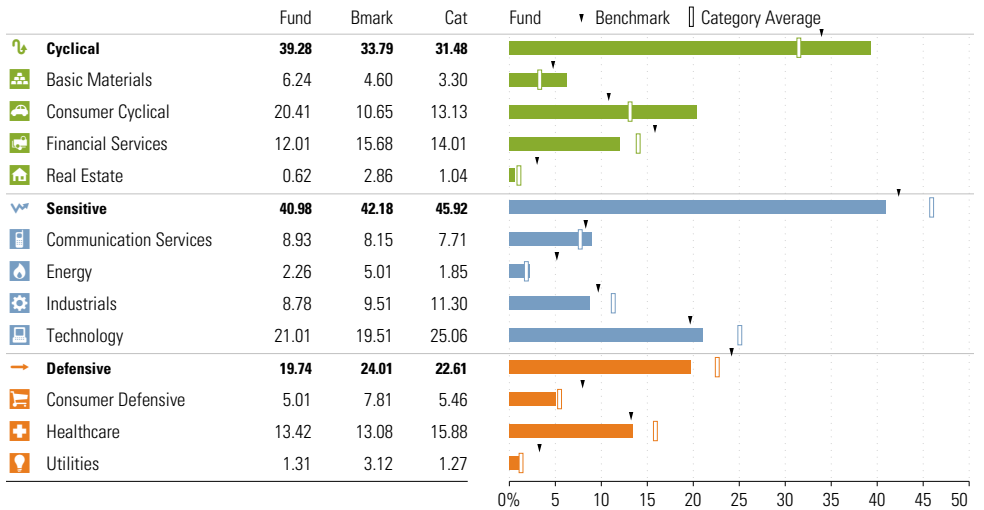

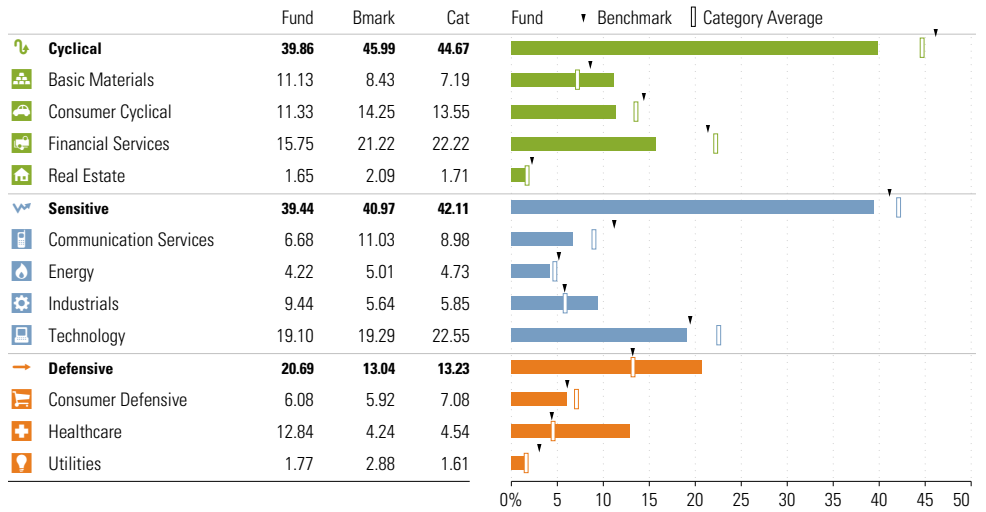

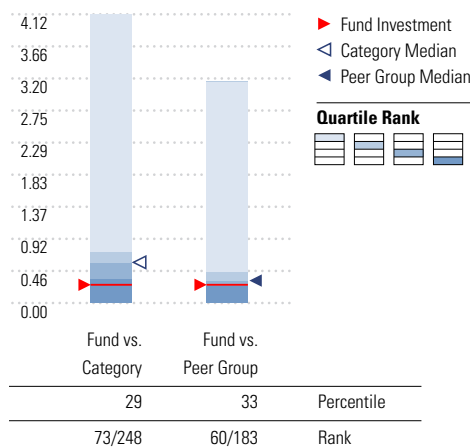

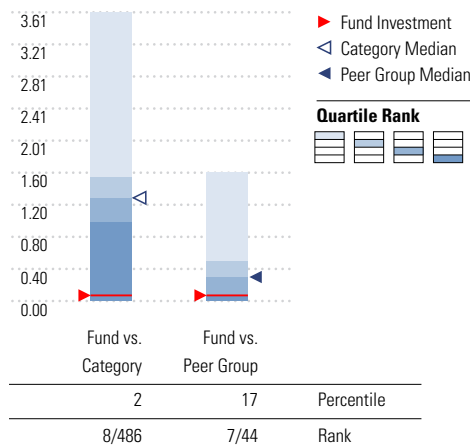

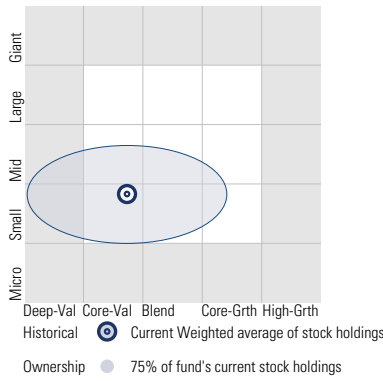

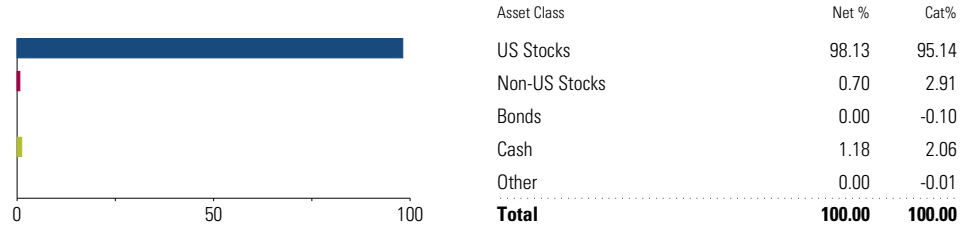

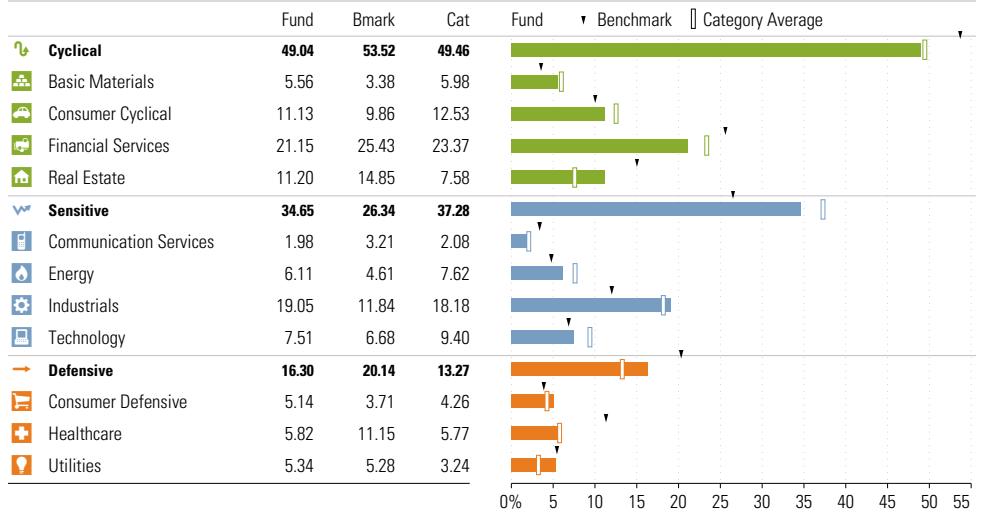
Style Breakdown

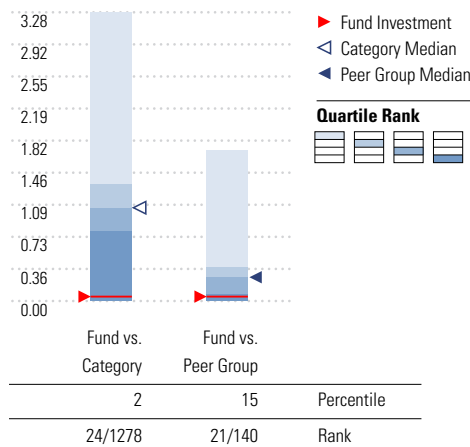

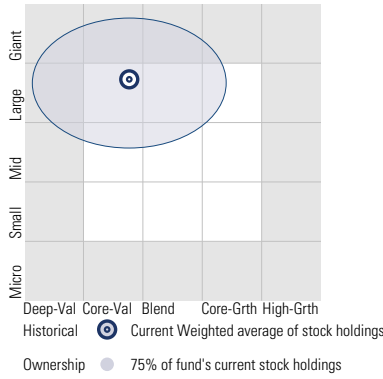

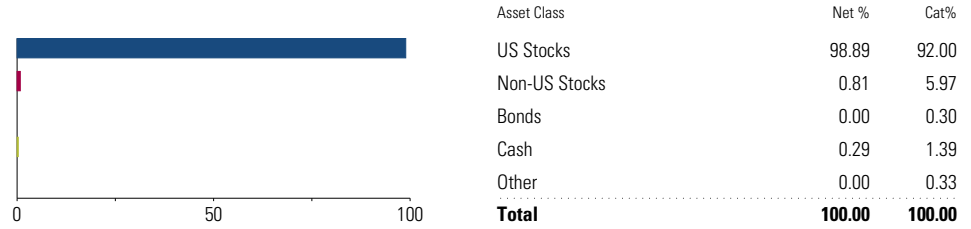

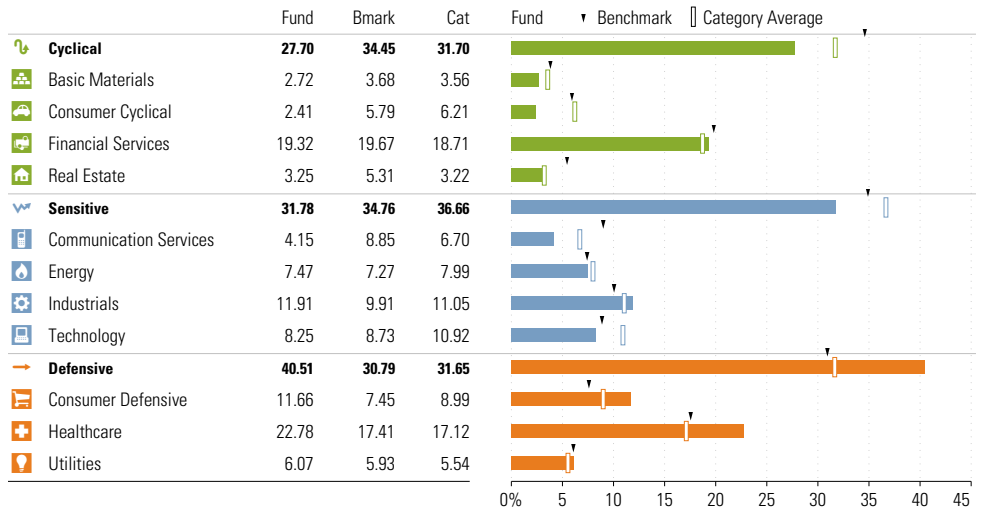
