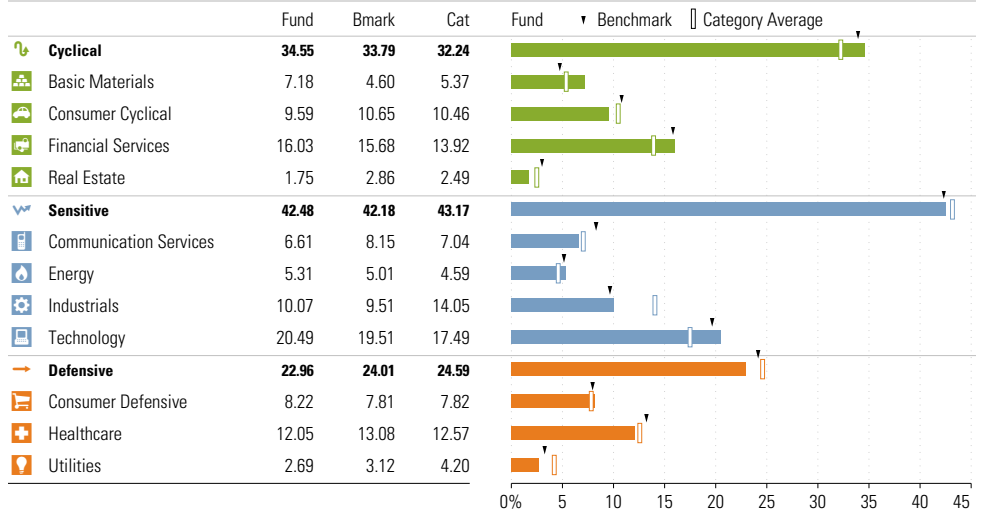

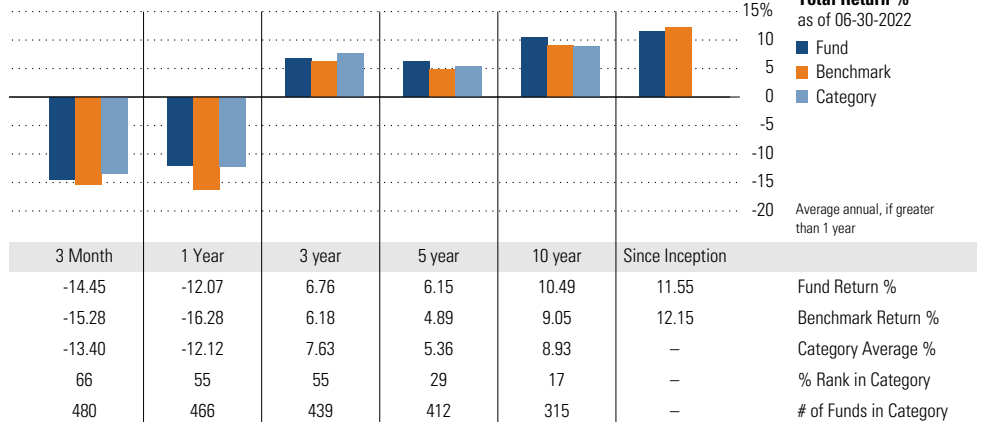

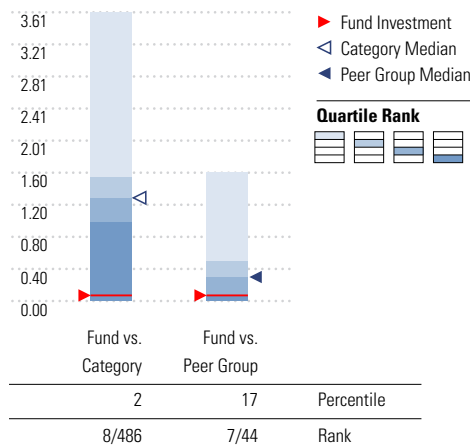

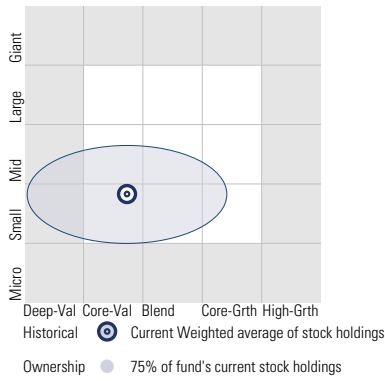

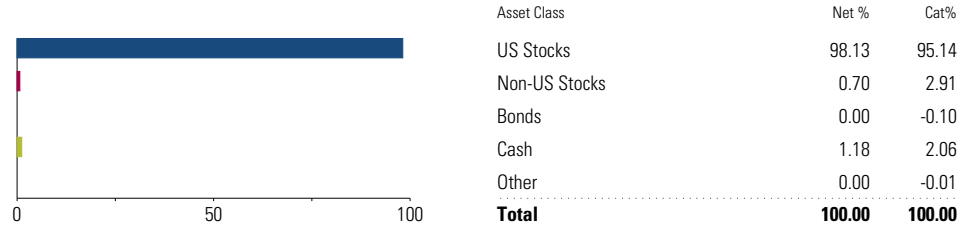

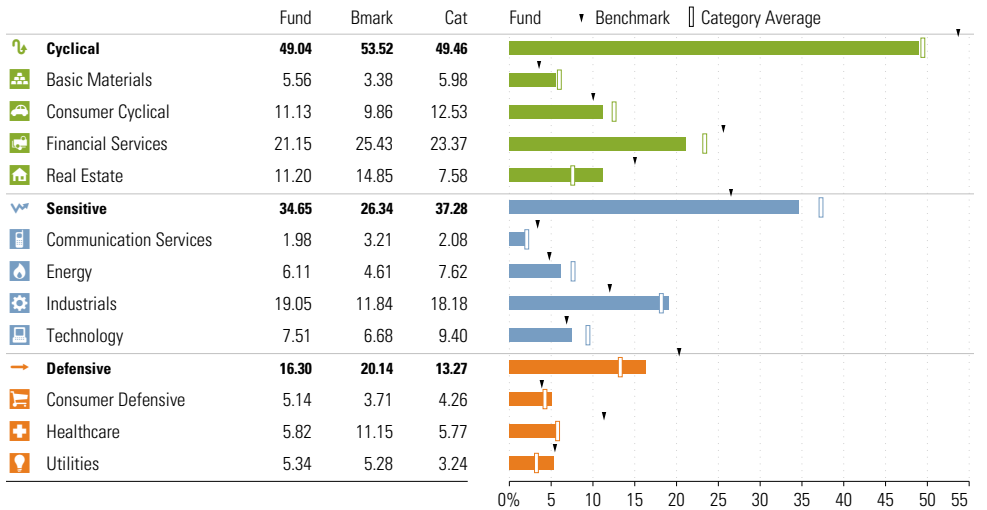
Style Breakdown
