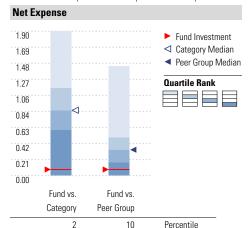

Trailing Performance



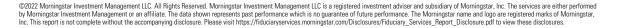


