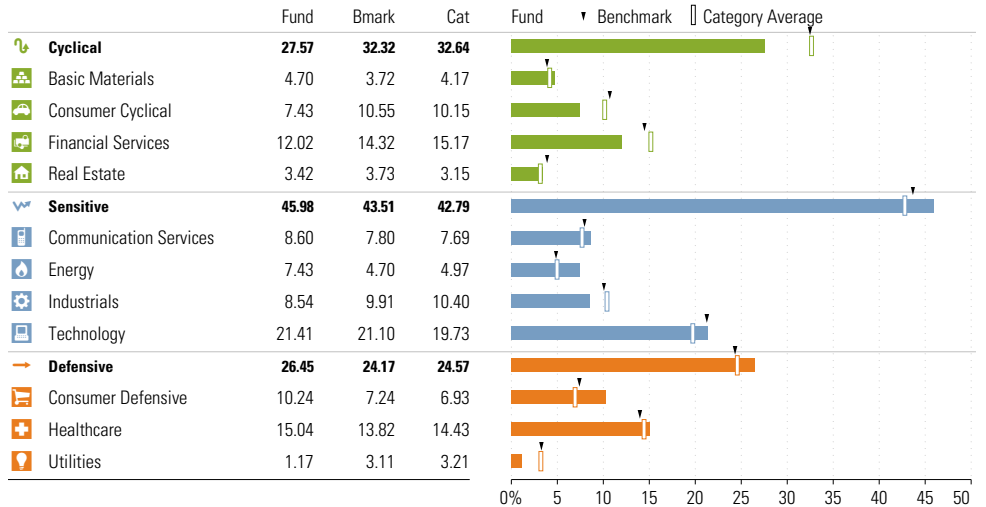

Growth of \$10,000



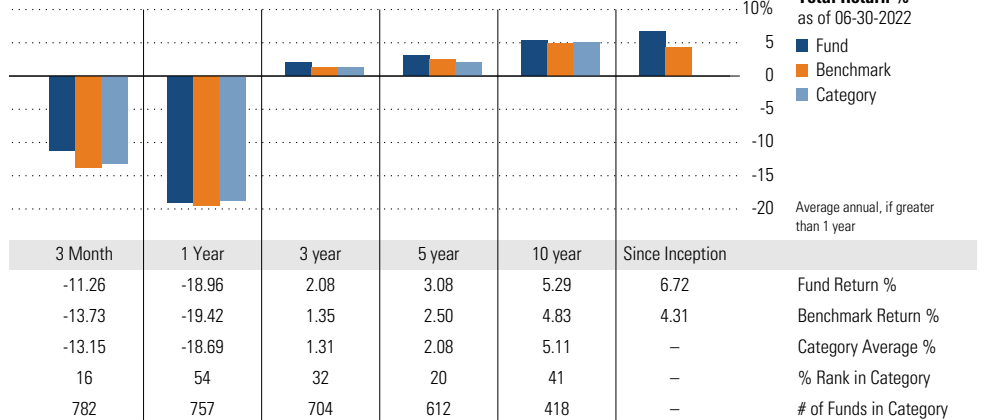

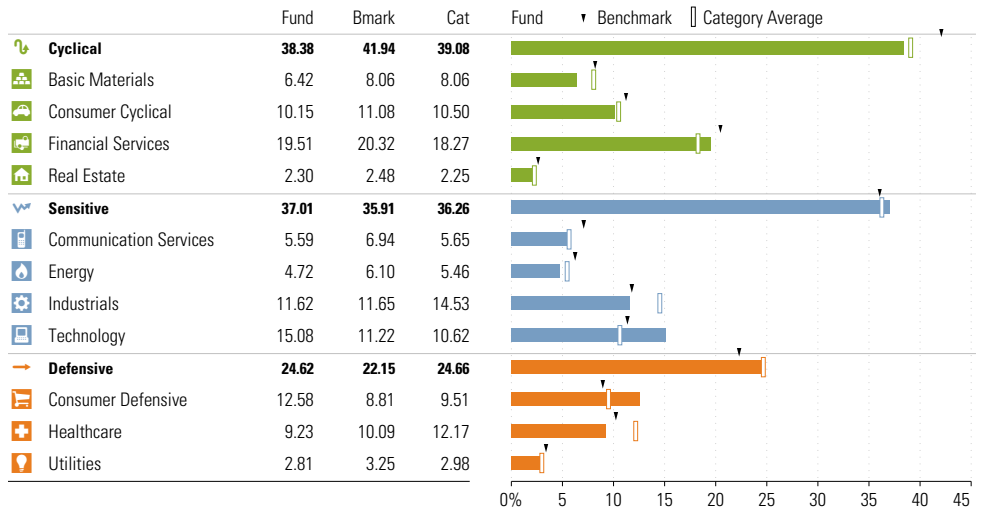

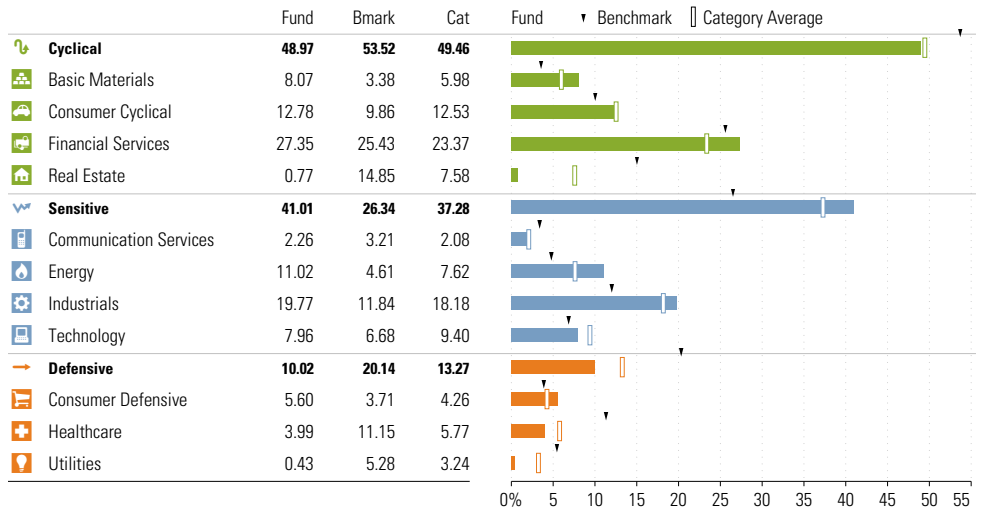

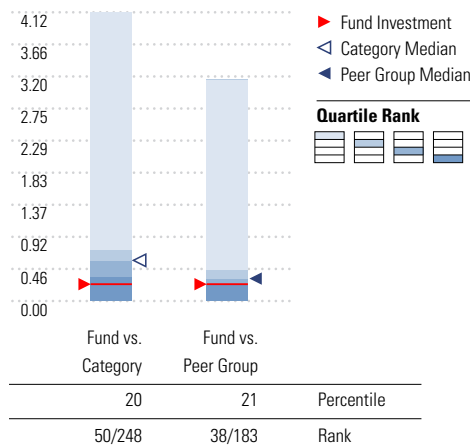

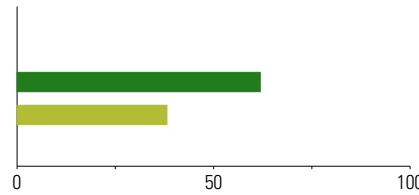

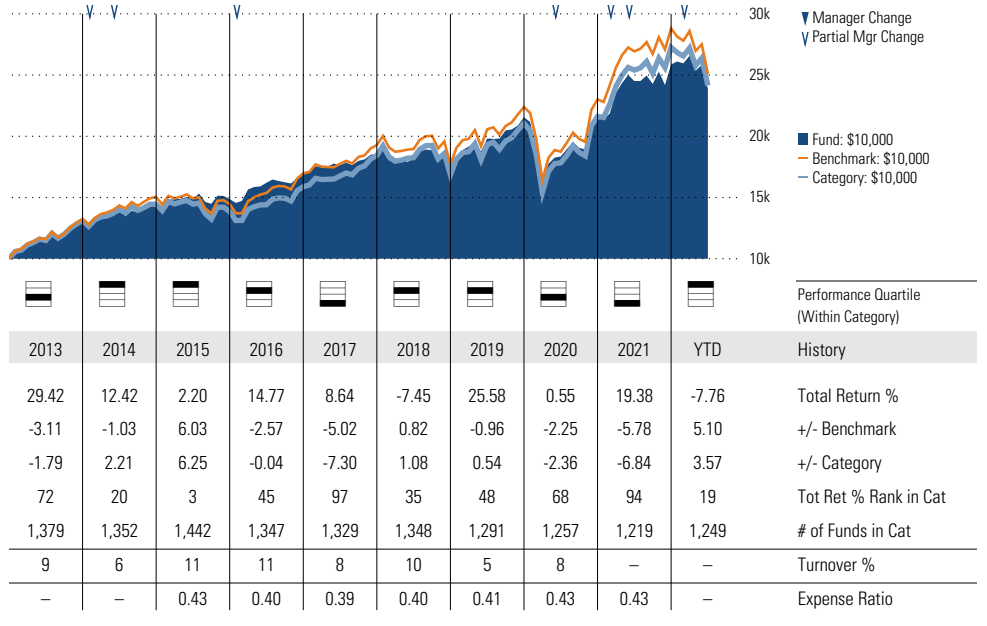
Morningstar Investment Management LLC Analysis

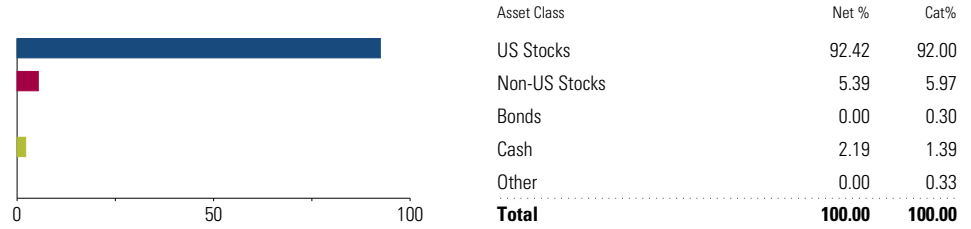

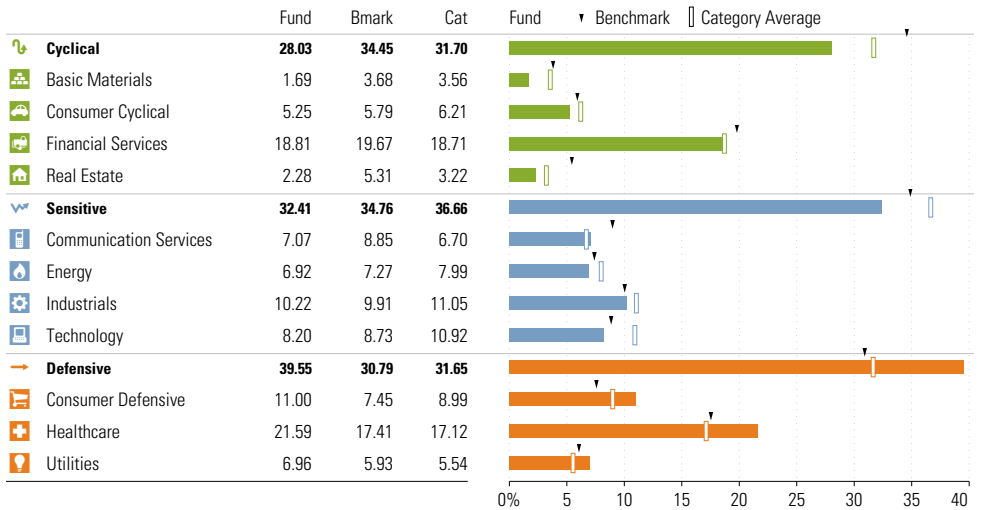

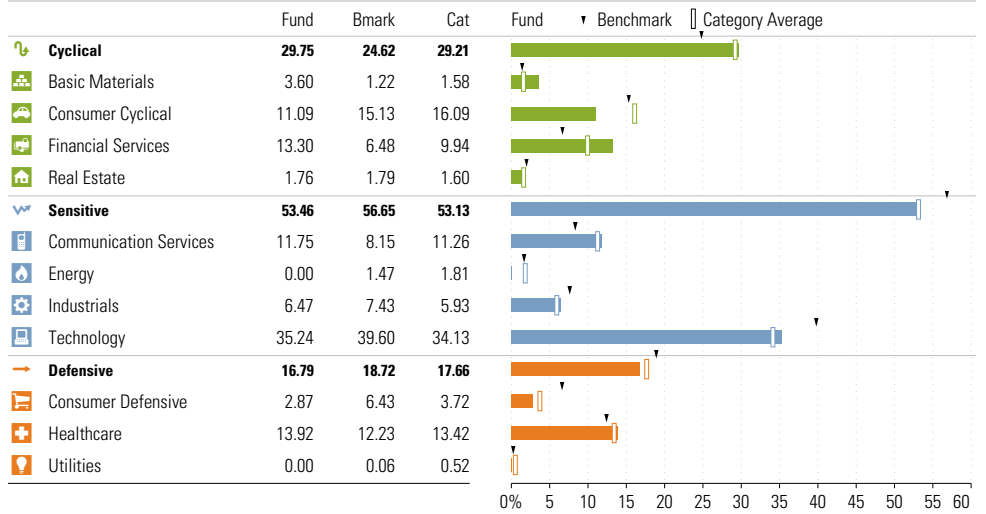

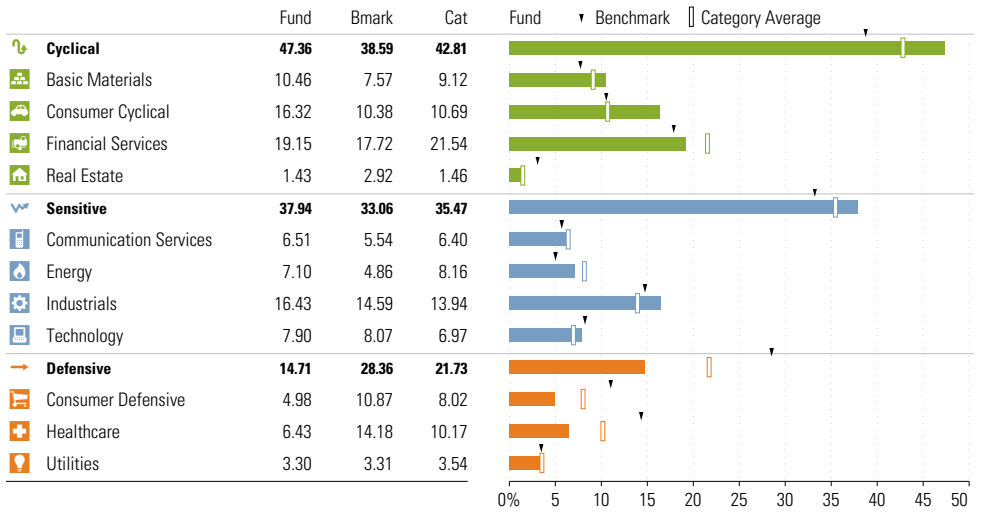

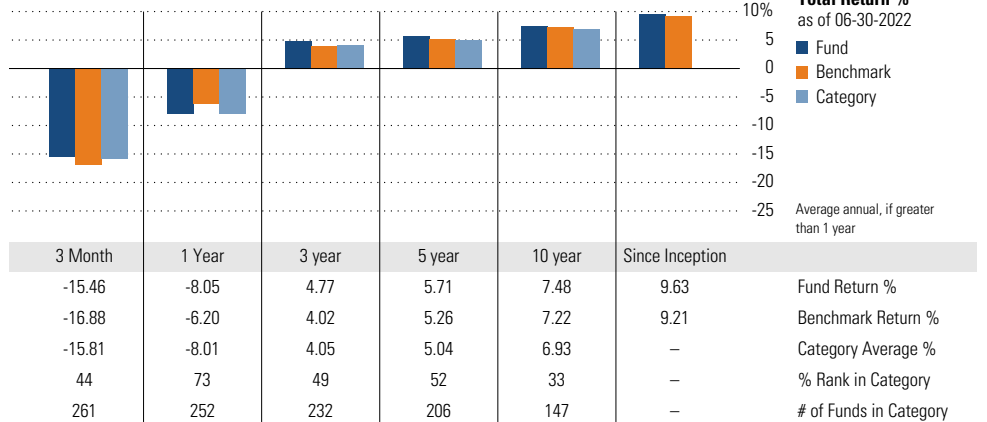

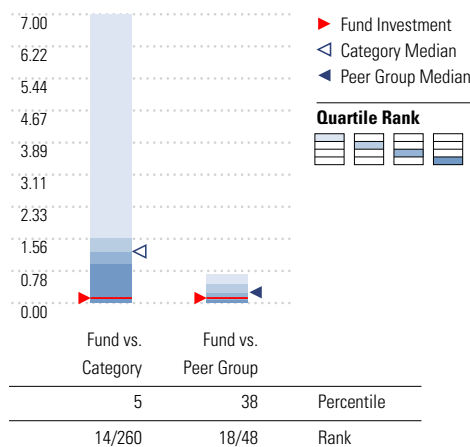

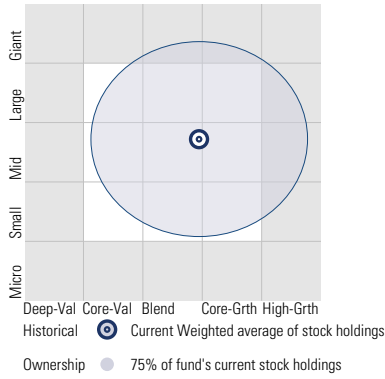

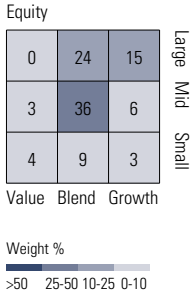
Asset Allocation as of 06-30-2022
