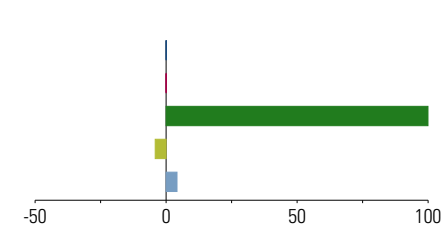

Growth of \$10,000



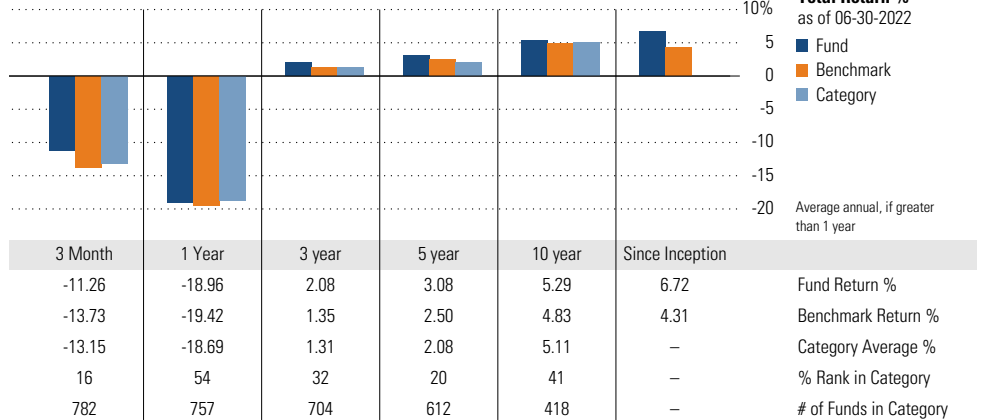

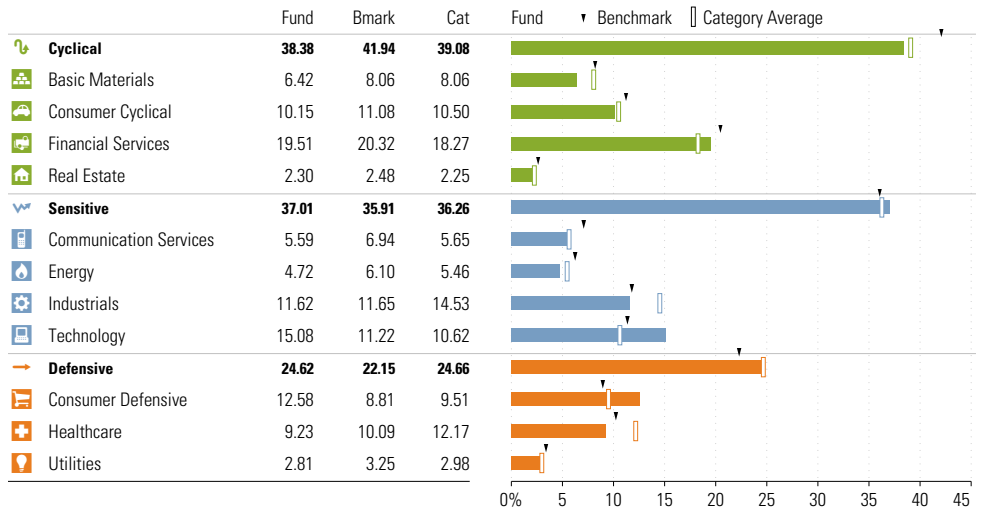

The fund's longtime co-portfolio managers, Ingrid Dyott and Sajjad Ladiwala, will both retire in 2022, and a new portfolio manager, Dan Hanson, will take over this fund as of April 1, 2022. While Hanson has significant industry experience across multiple firms, he is new to Neuberger Berman, and has no public track record managing an ESG strategy, though he has managed ESG strategies for institutional clients since 2006. We will monitor the fund for any strategy changes and look for performance improvements under the new PM.

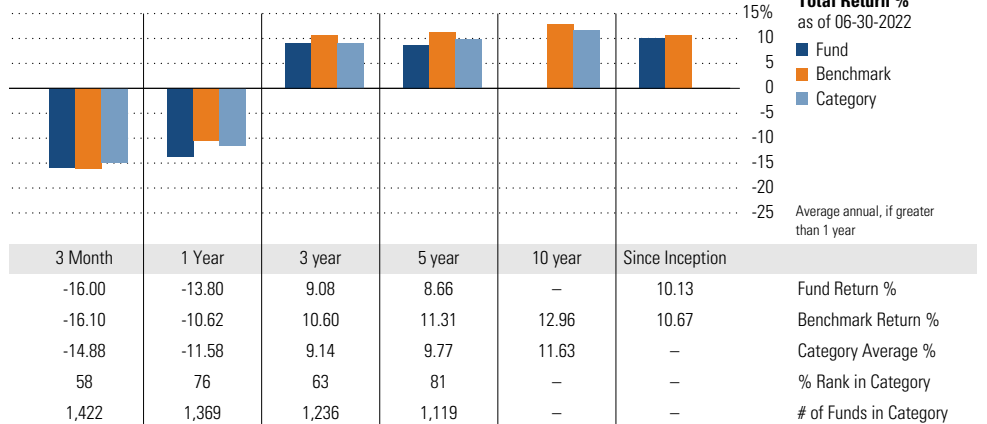

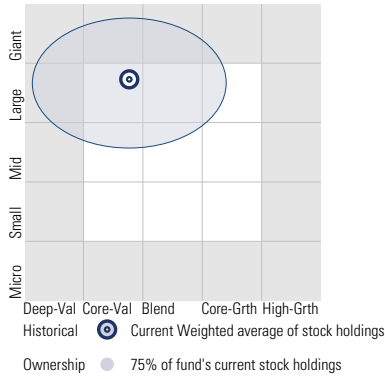

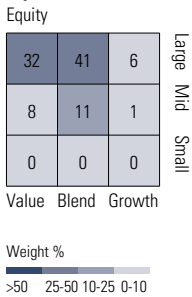

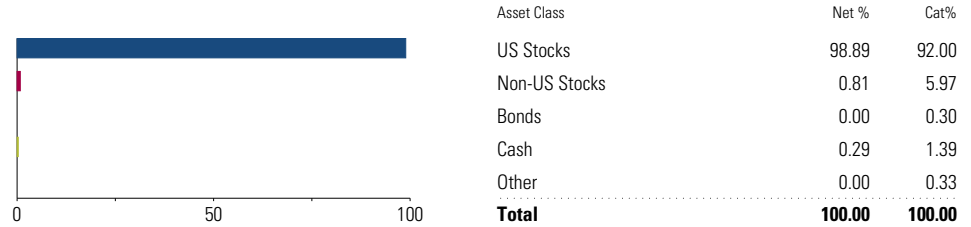

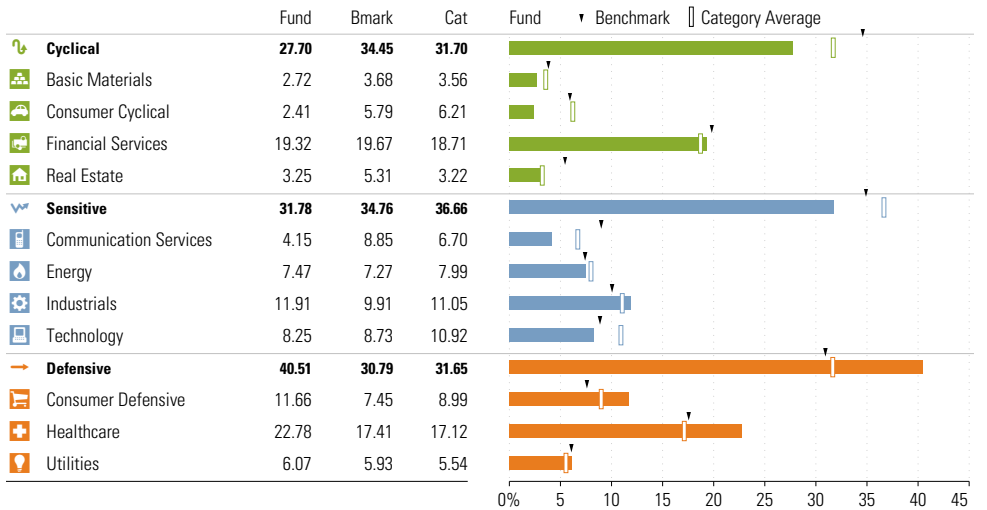
Style Breakdown
