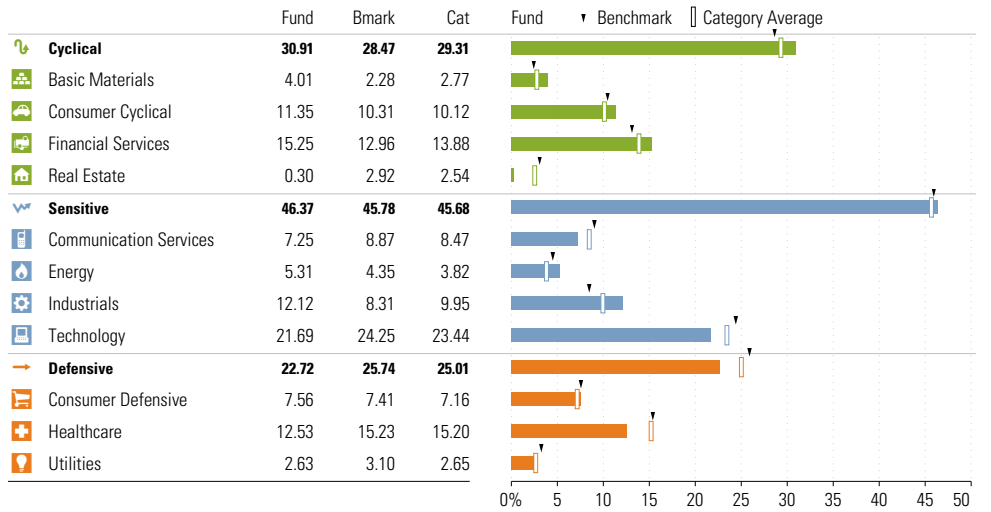

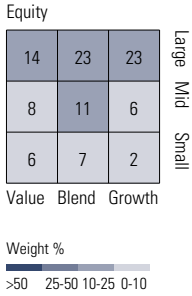
Asset Allocation as of 06-30-2022

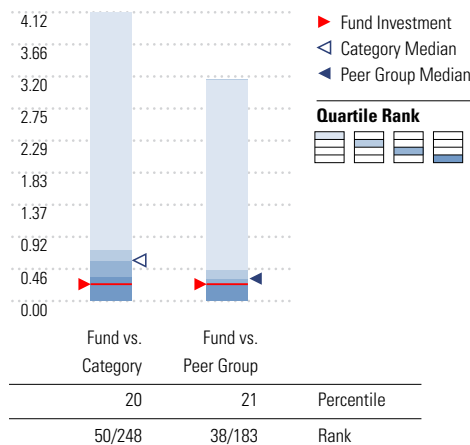

Growth of \$10,000



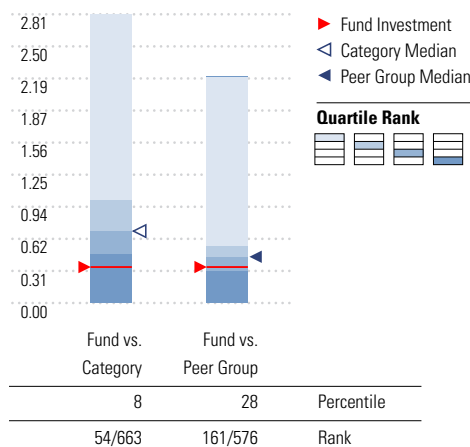

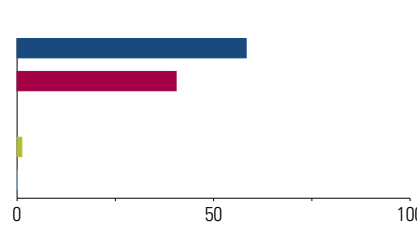

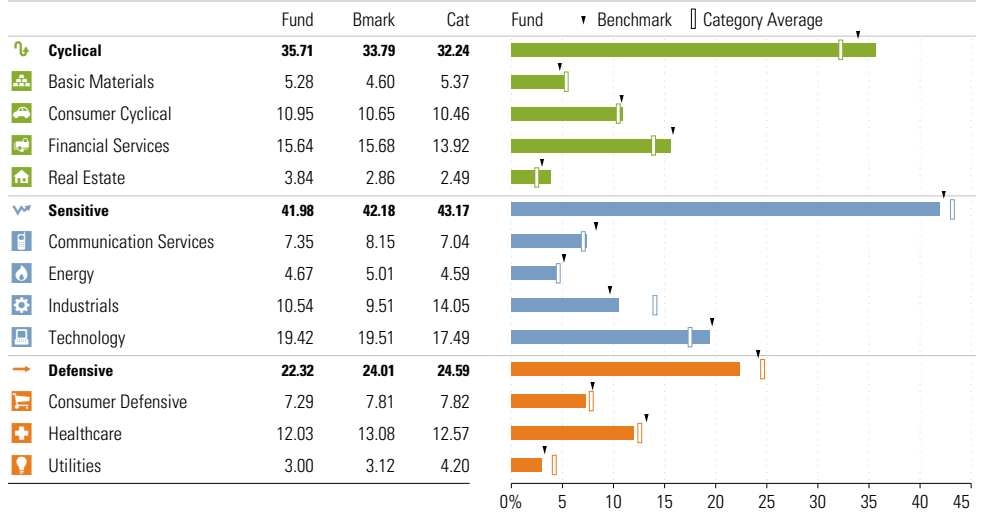

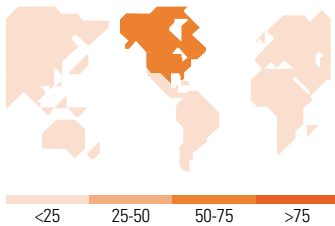
