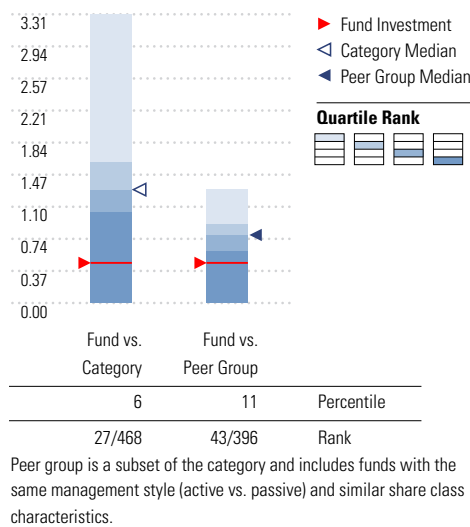

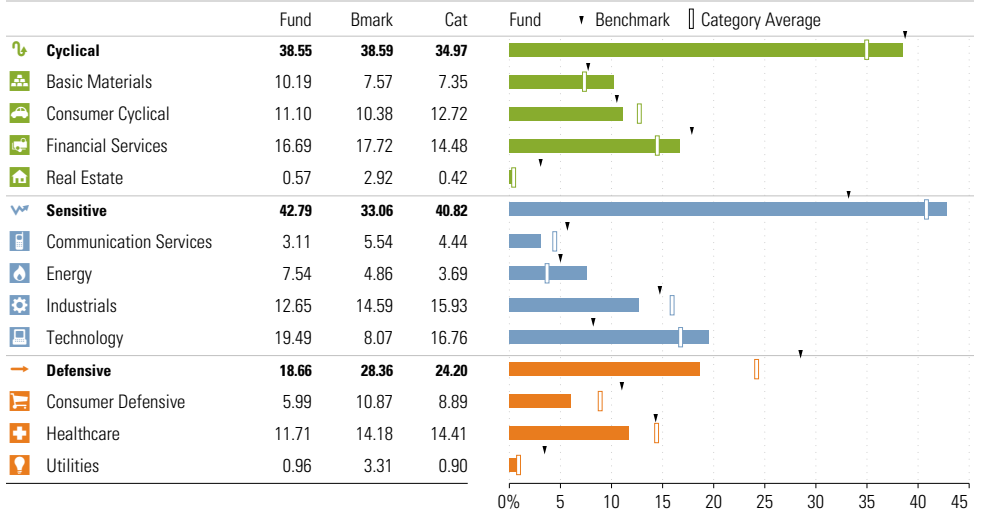

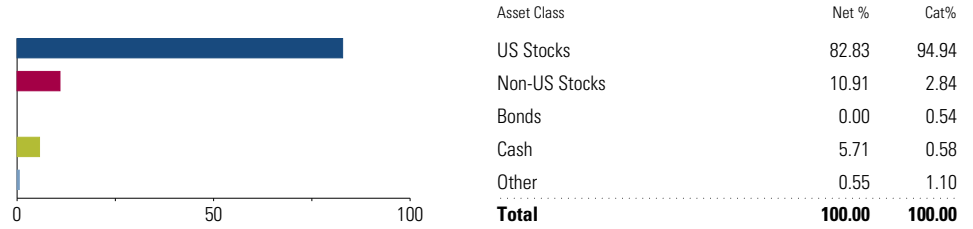

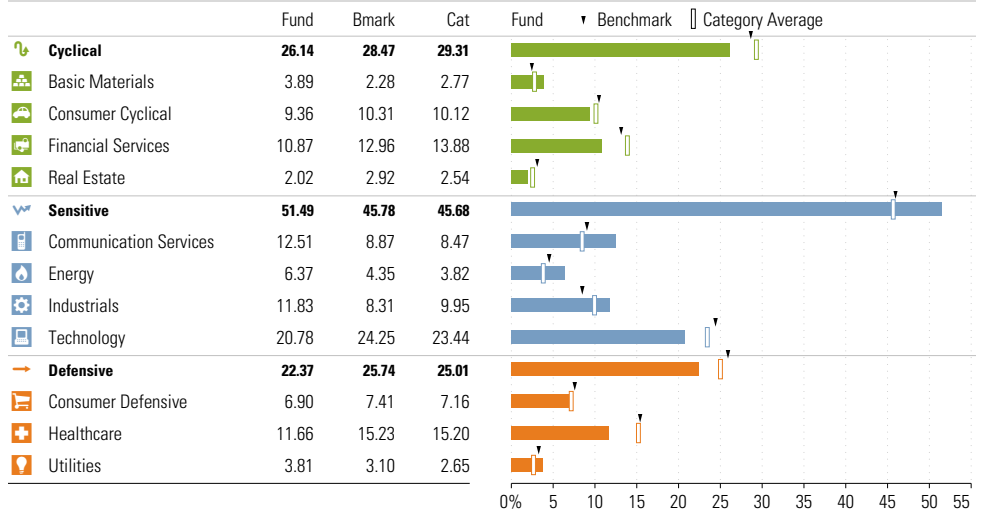

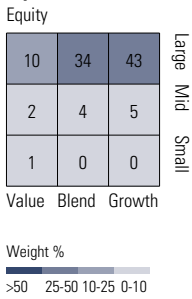

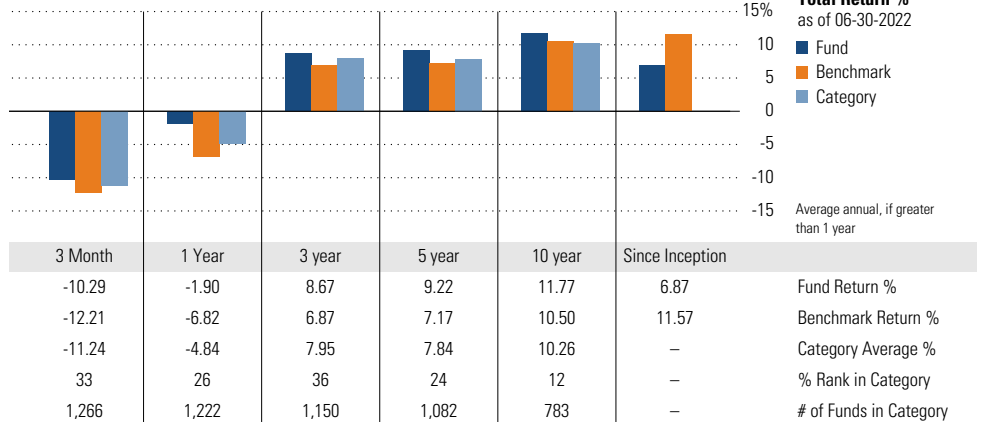

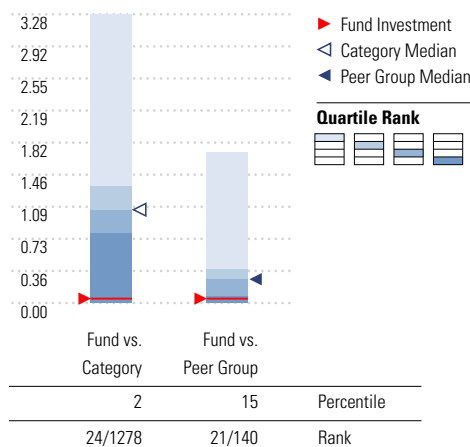

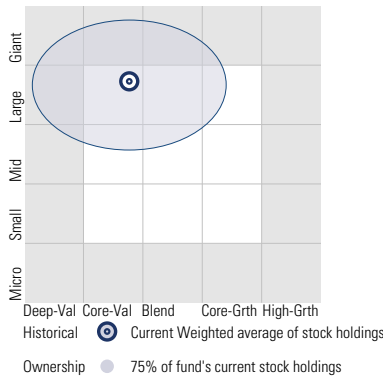

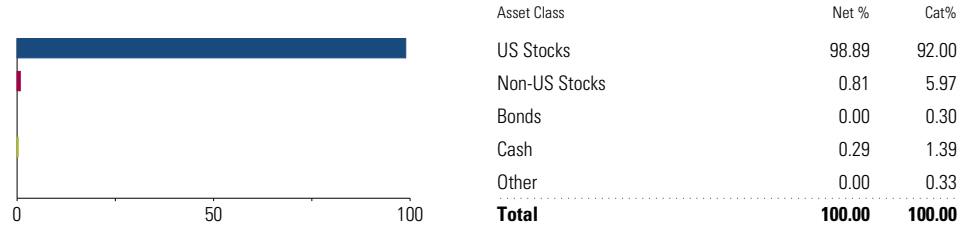

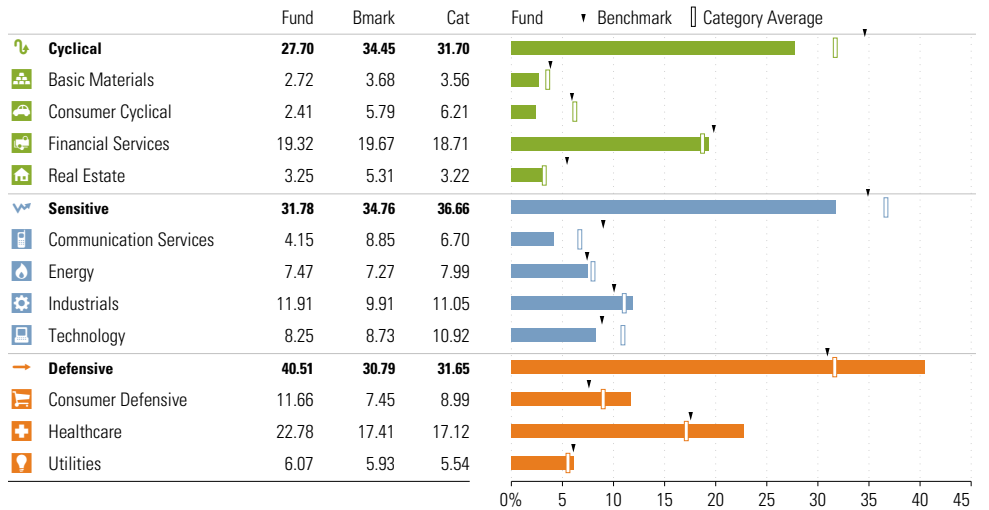
Style Breakdown
