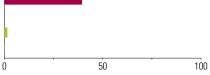

# World Regions % Equity 06-30-2023





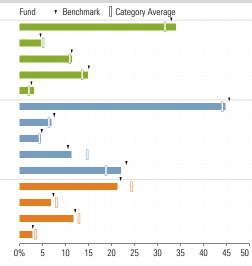
