We are taking ClearBridge Mid Cap off watch. We placed the fund on watch in Q2 2020 due to a leadership change in June 2020 when Matthew Lilling joined Brian Angerame as co-portfolio manager and prior co-manager Derek Deutsch moved into a different role at the firm. Subsequently, the strategy exhibited a material style shift, with a greater emphasis on lower-quality securities, and performance became more volatile than it had been in the past. Over the first half of 2023, performance has stabilized and portfolio quality metrics have improved. At this time, the investment process appears to be achieving its objectives, with returns that are commensurate with risk. The fund's prospects appear solid, so we are taking it off watch. This particular share class fails our expense screen with fees that are higher than the broad category average. Plan costs are sometimes wrapped into fund fees, but because costs are predictive of a fund's future relative performance, we would still like to see lower overall expenses here.
