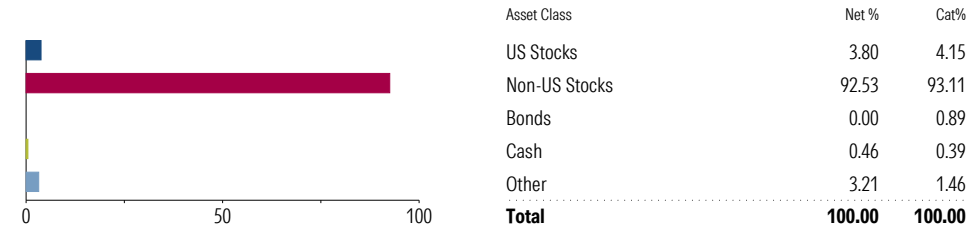

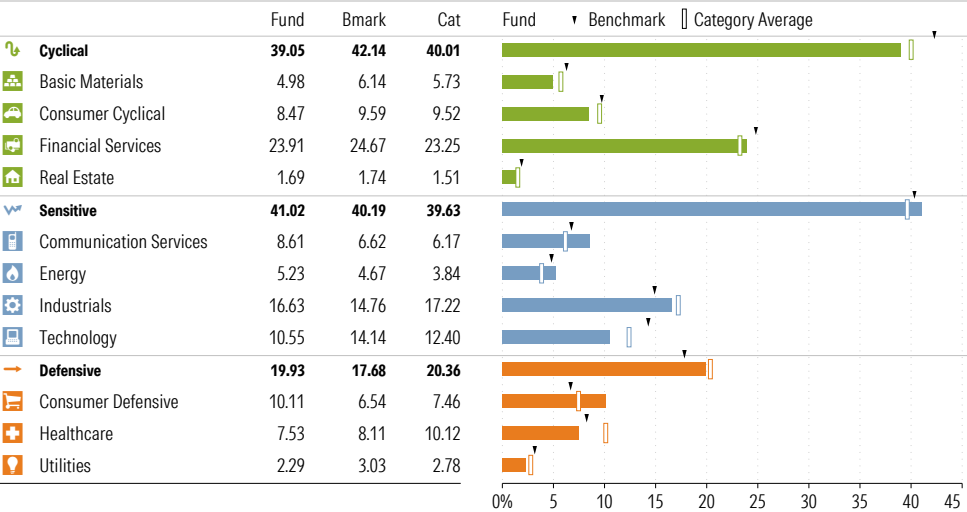

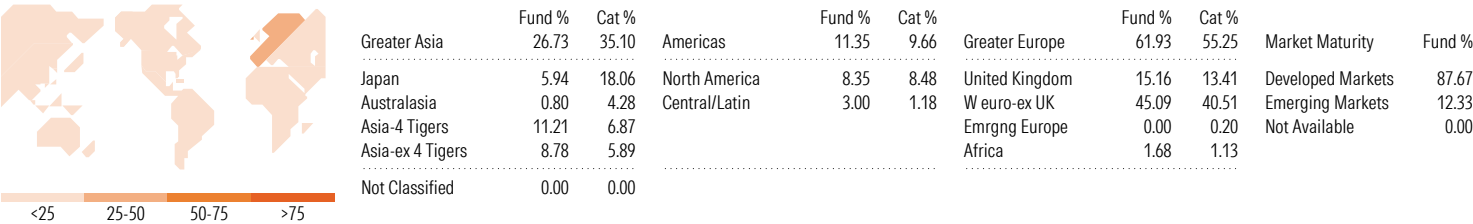
Asset Allocation as of 06-30-2025

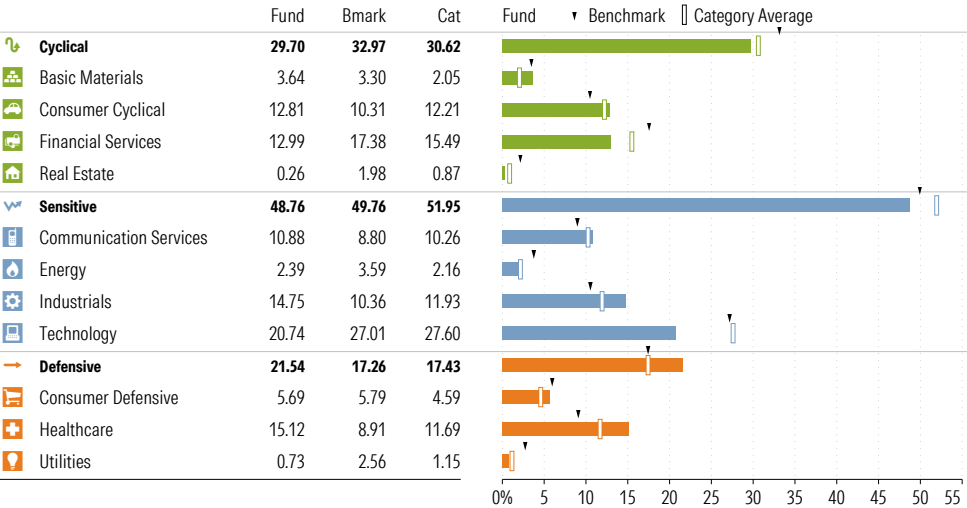

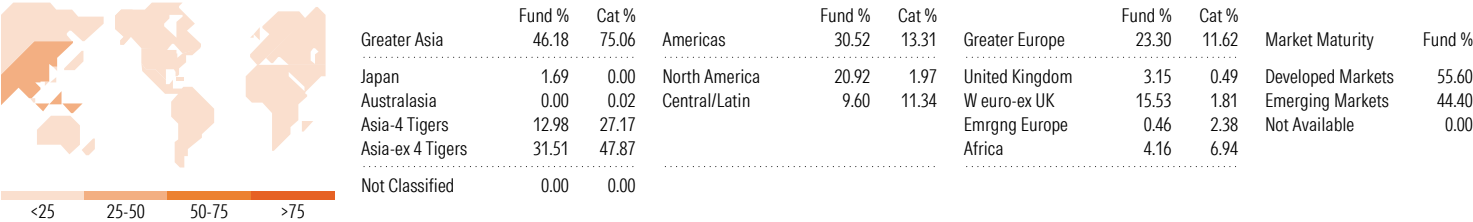

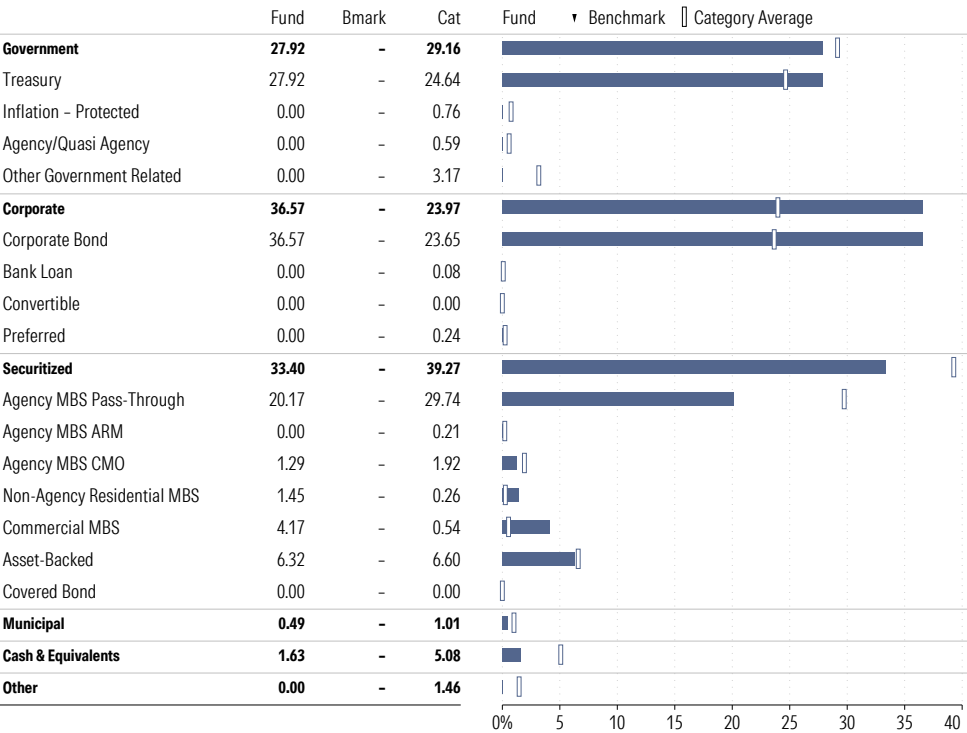

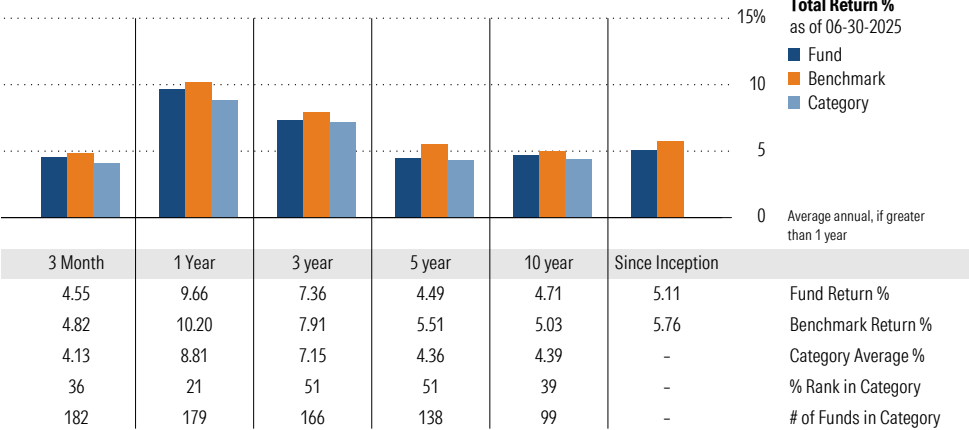

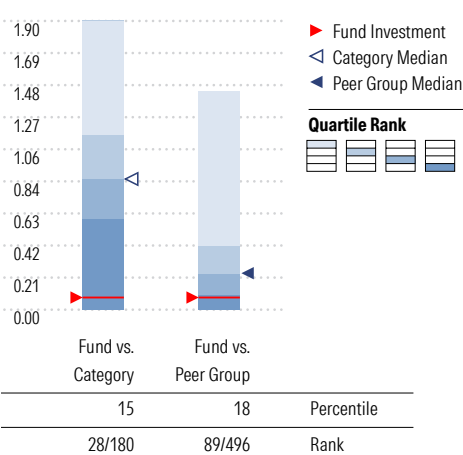
Growth of \$10,000

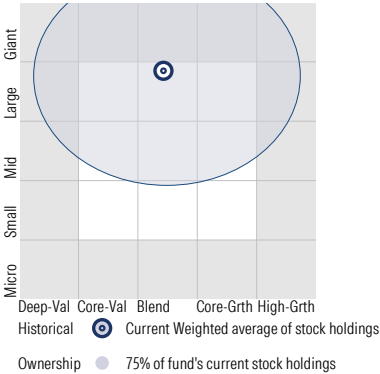

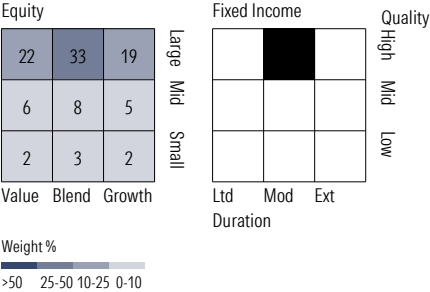

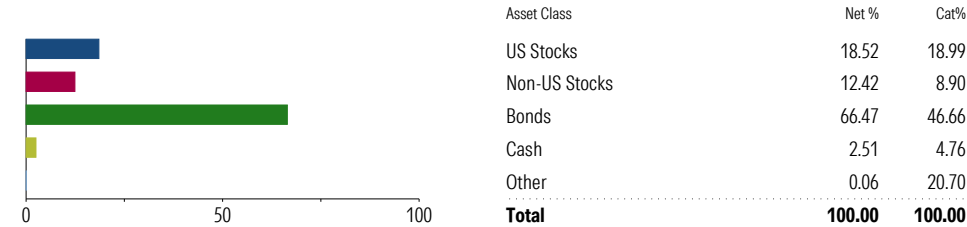

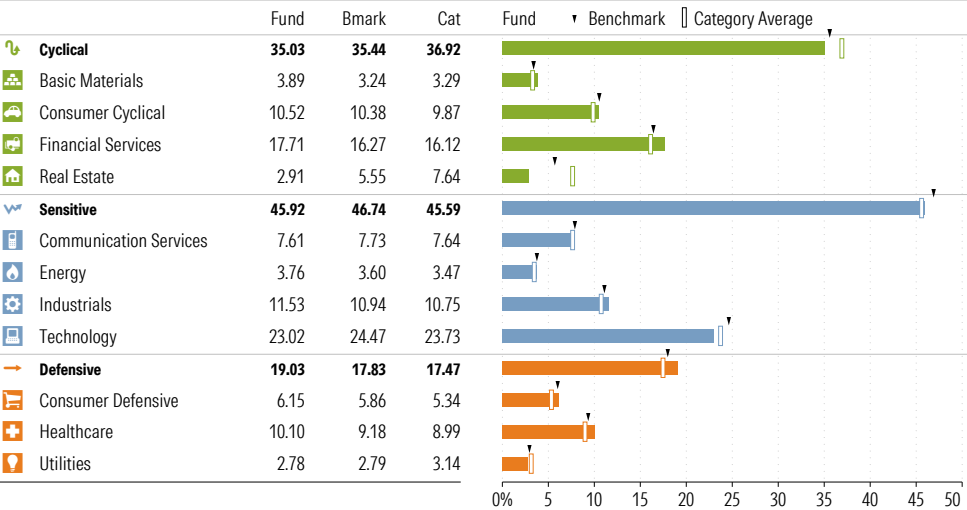
Style Breakdown
