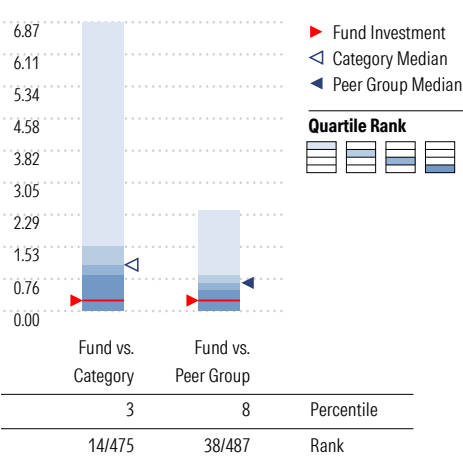

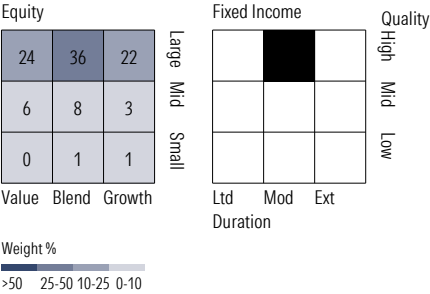

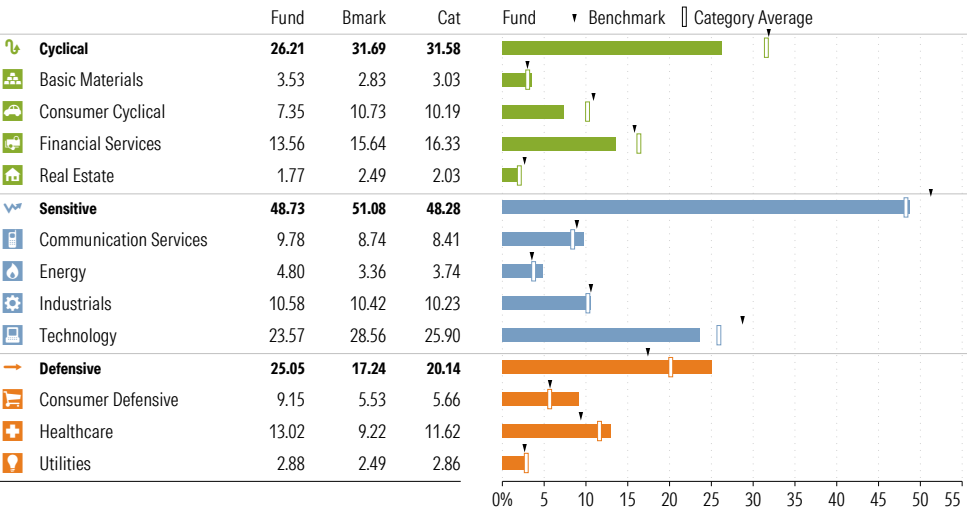

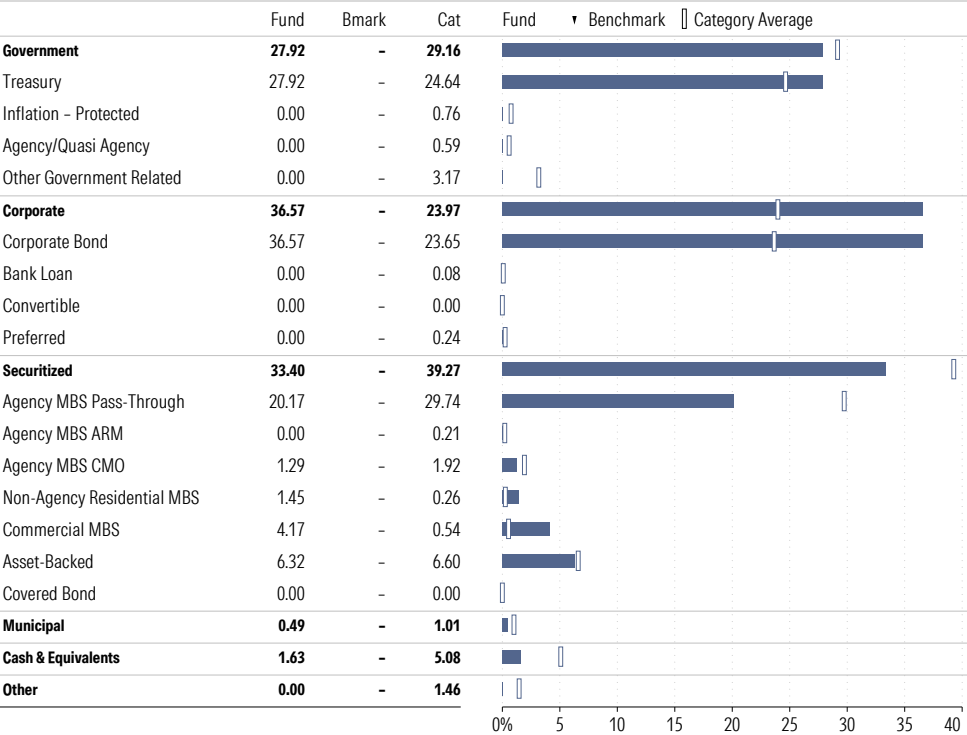

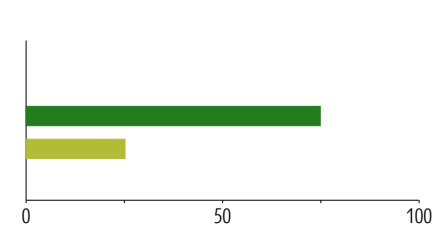

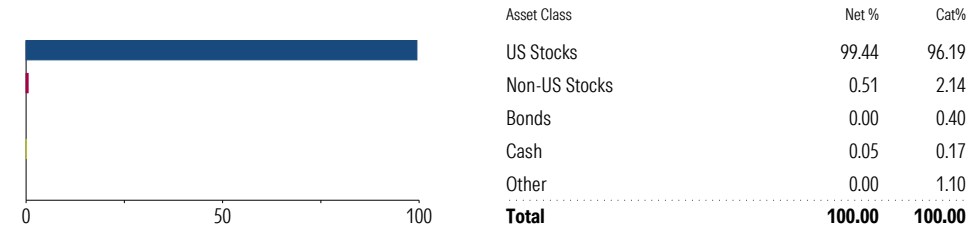

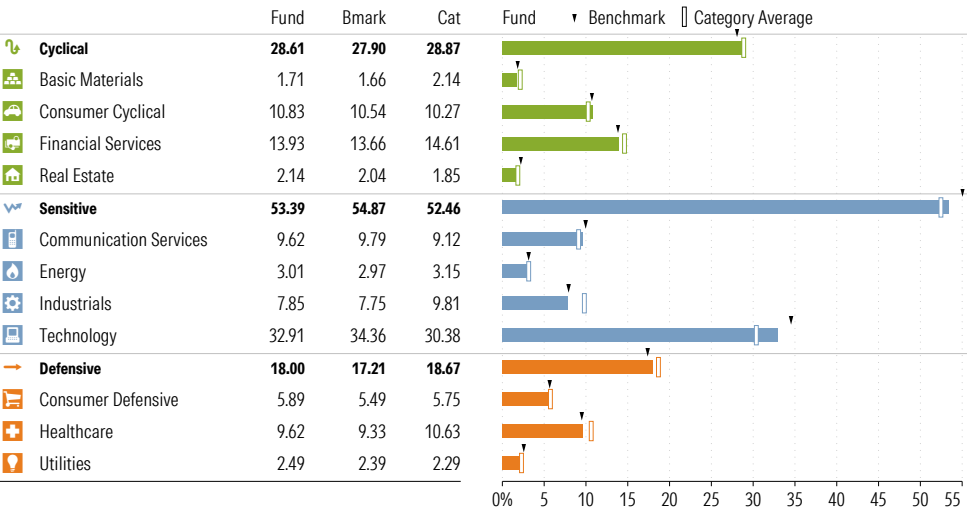

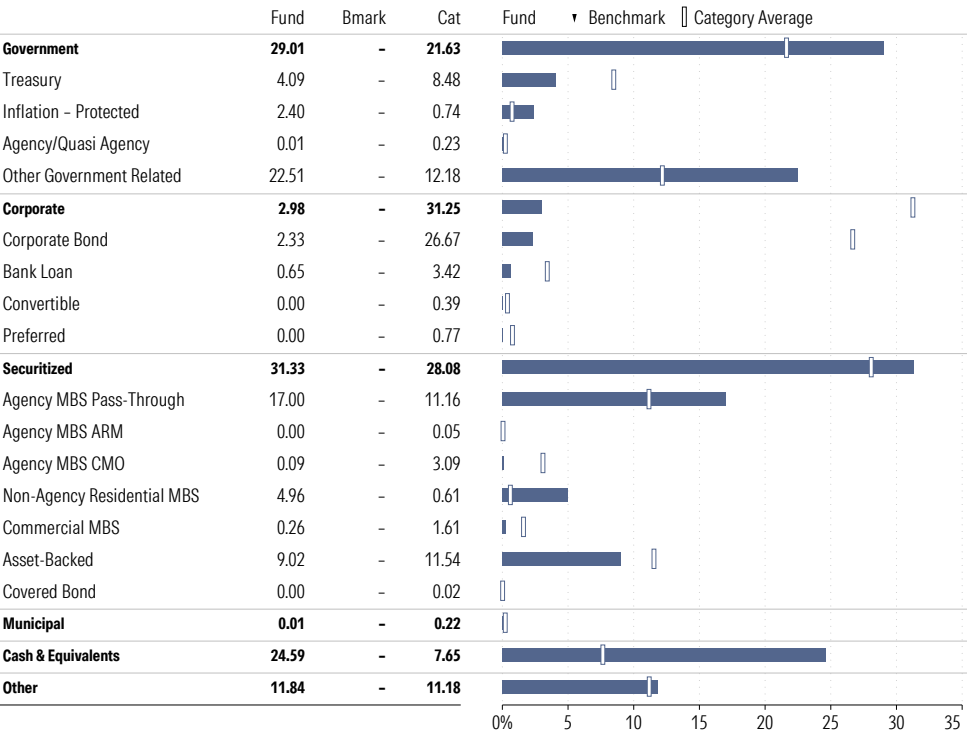

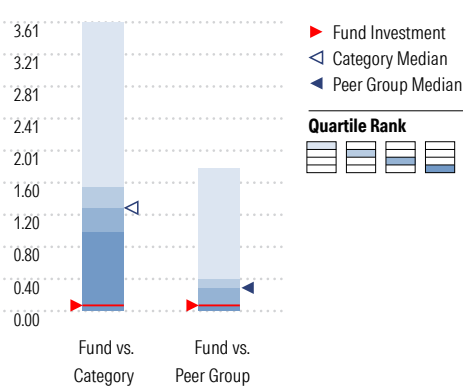

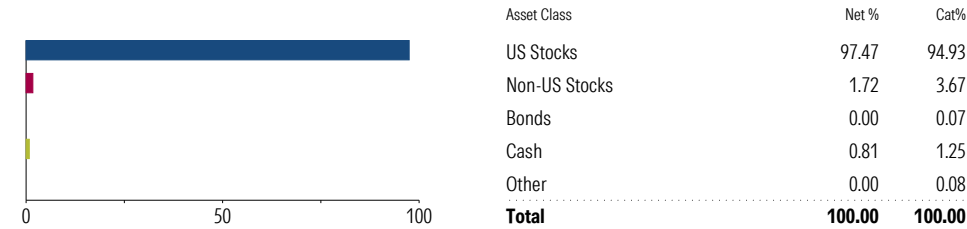

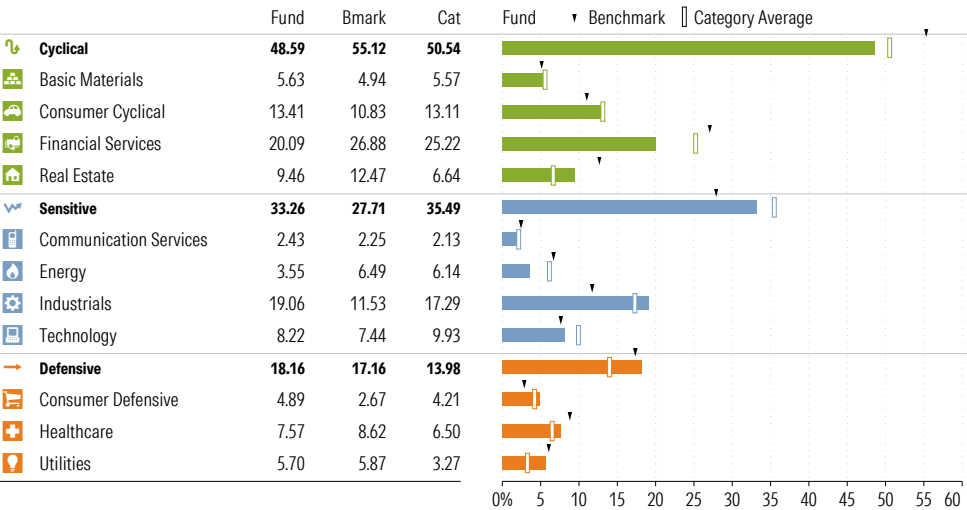
Style Breakdown

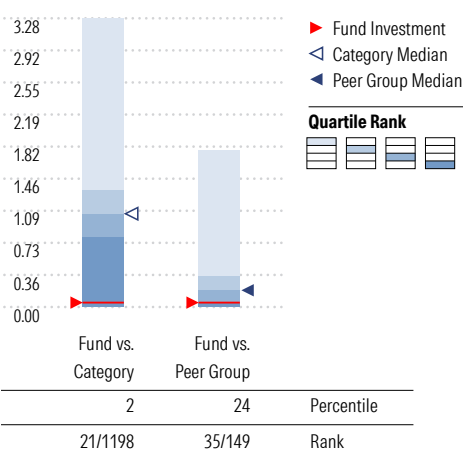

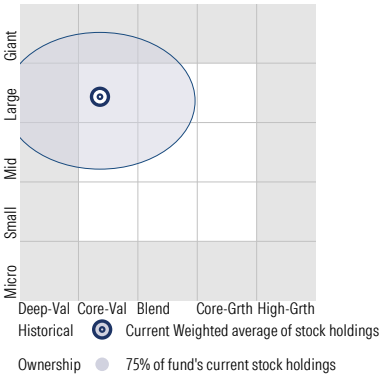

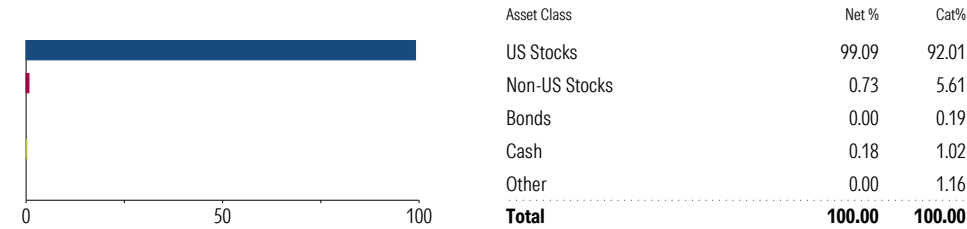

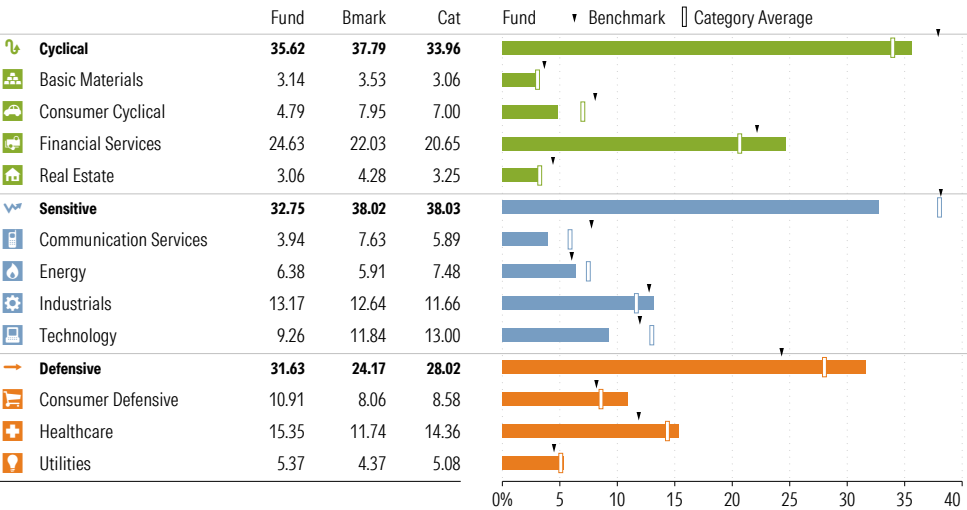
Style Breakdown
