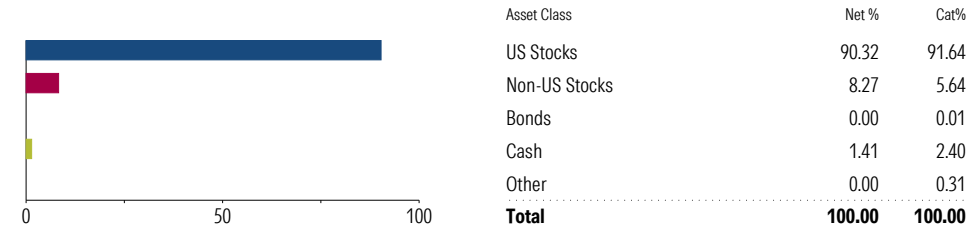

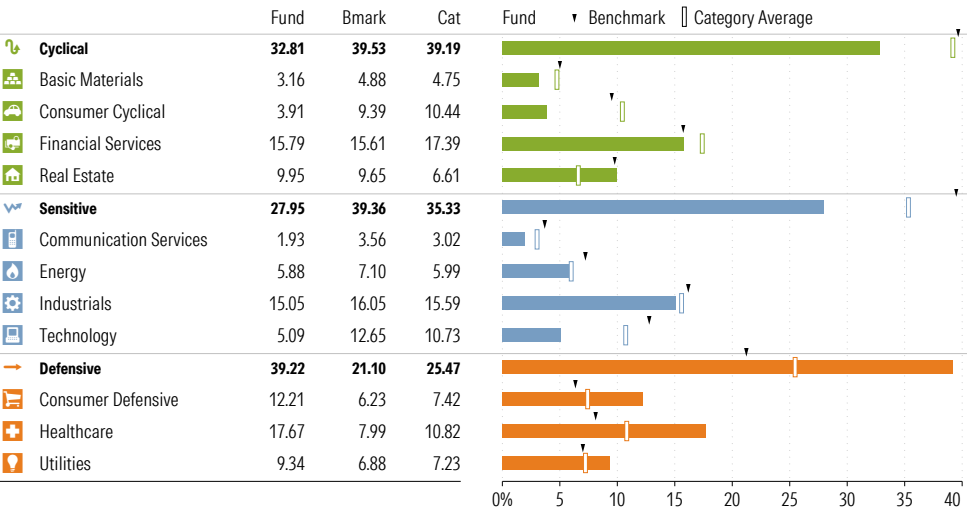

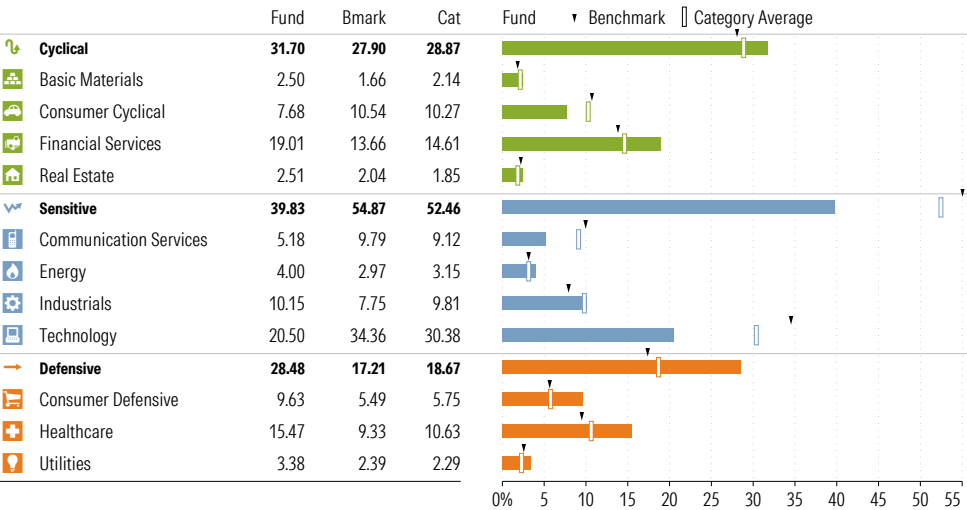

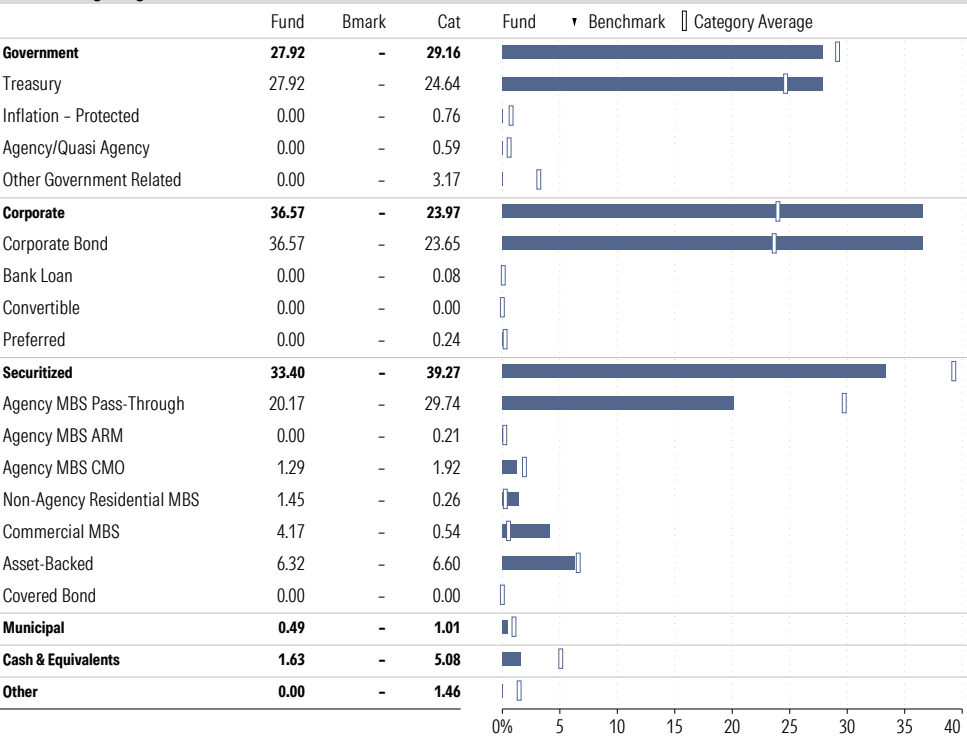

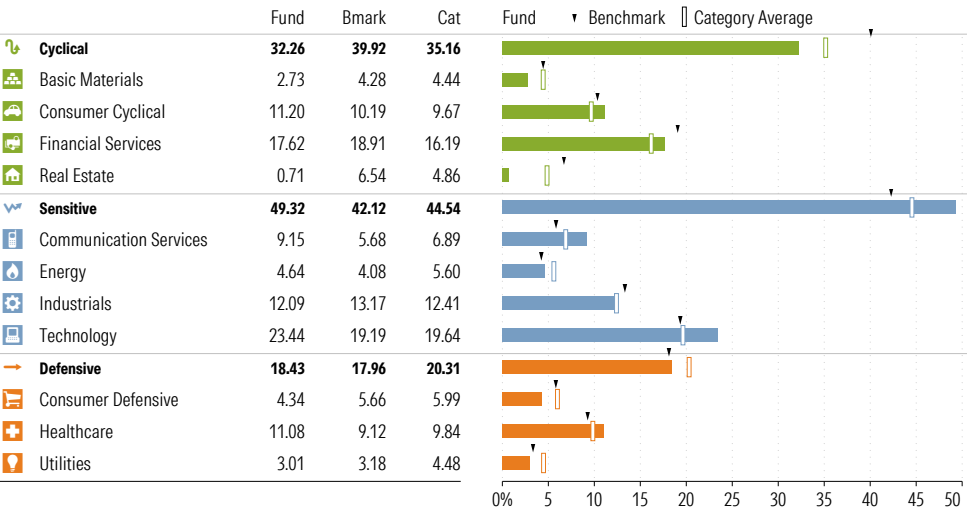

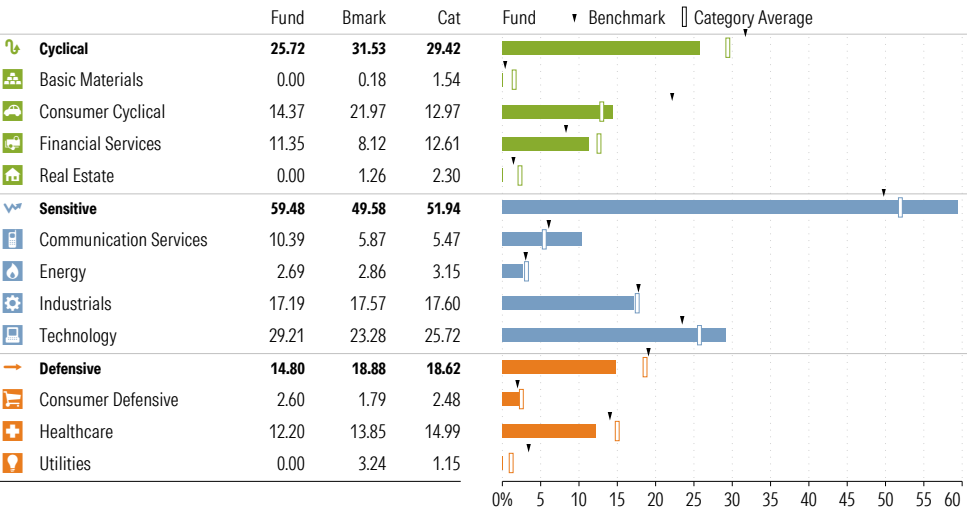

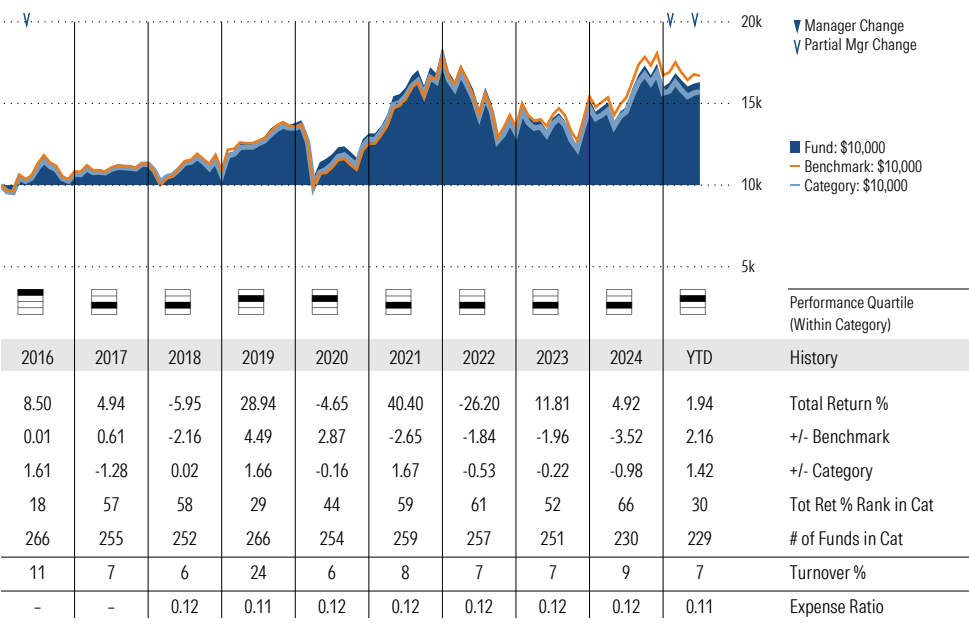

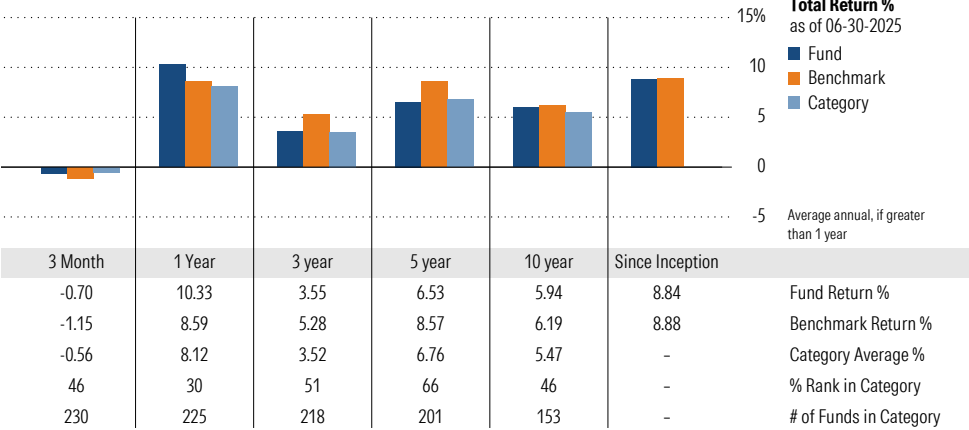

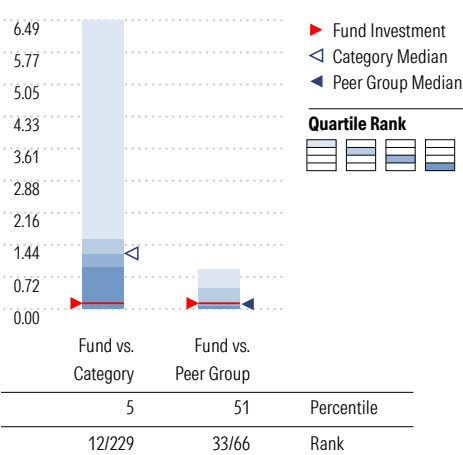

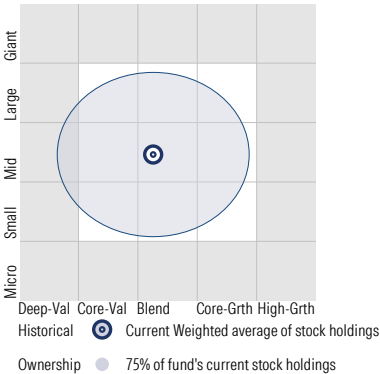

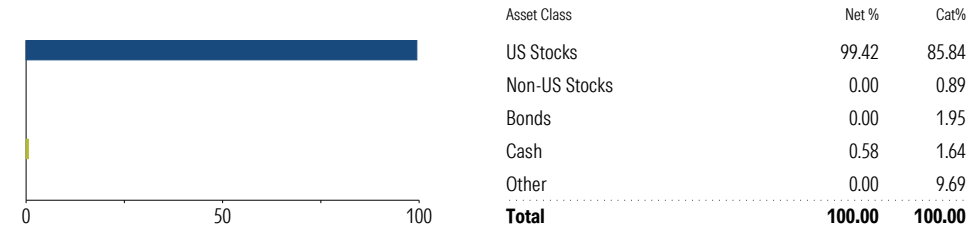

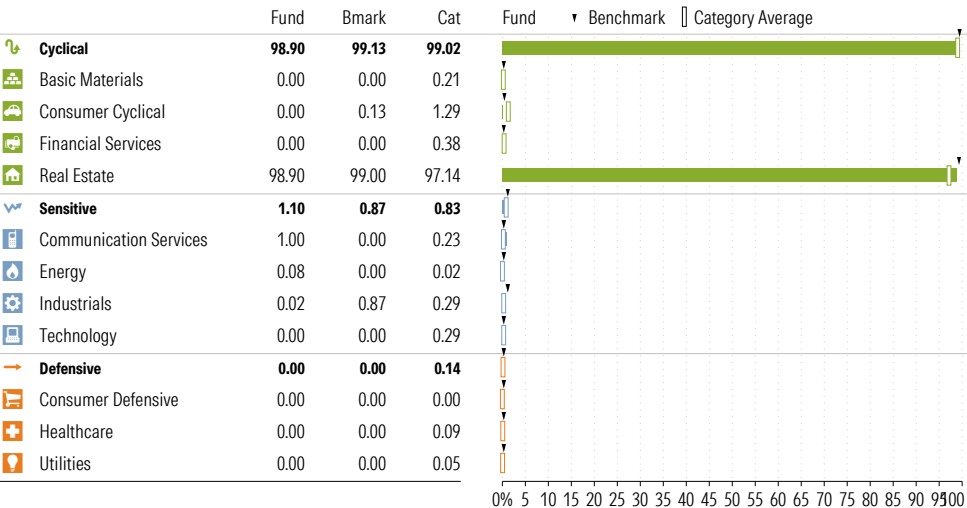
Style Breakdown
