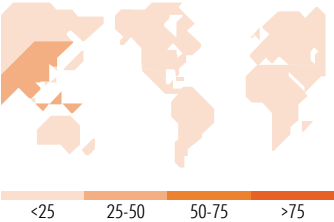

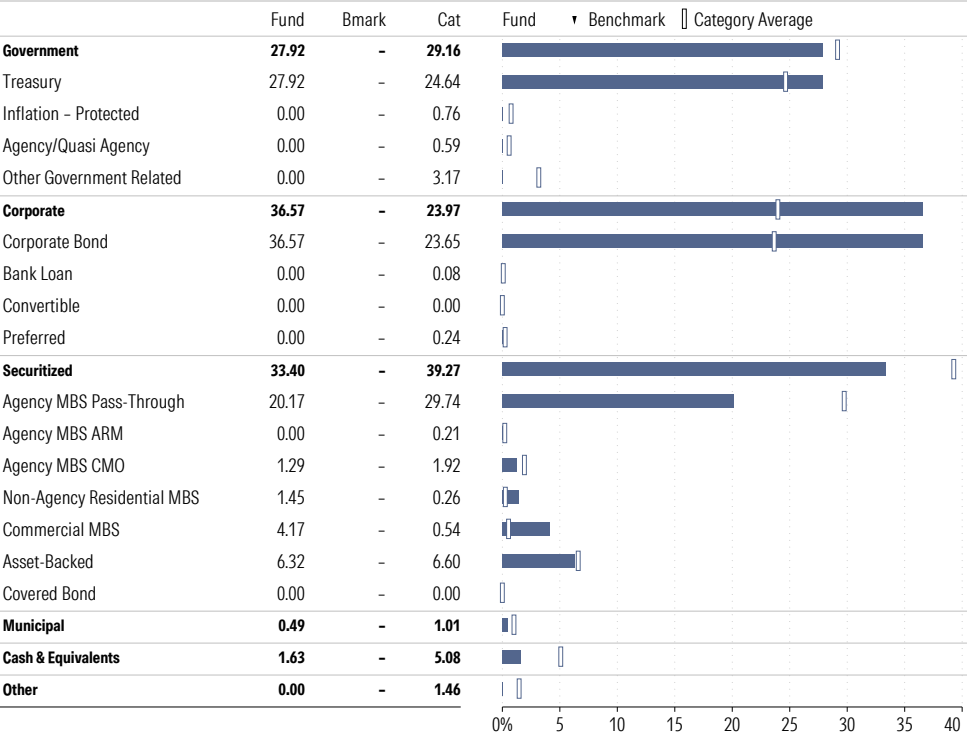

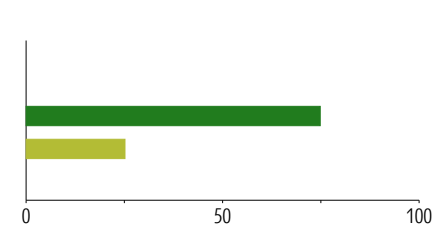

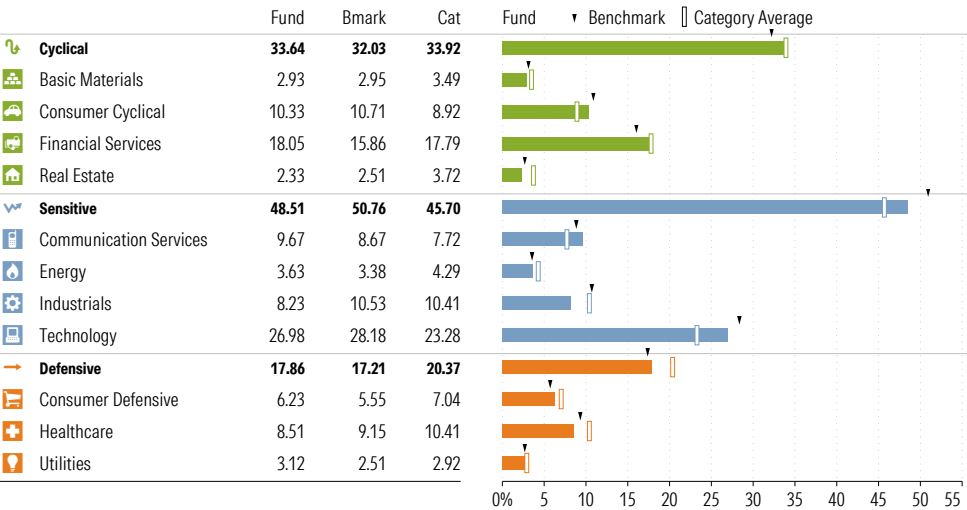

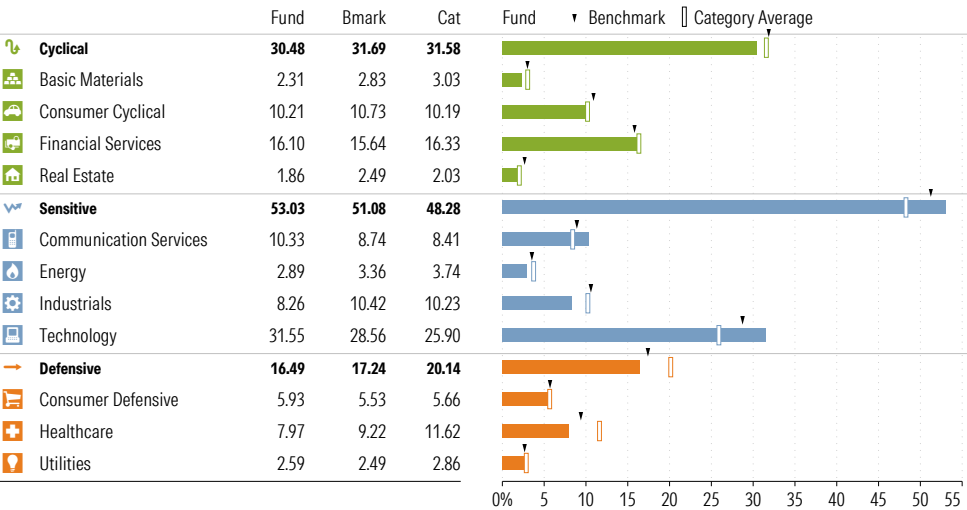
Style Breakdown

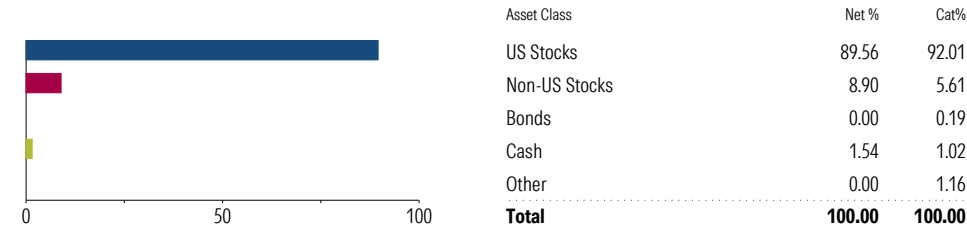

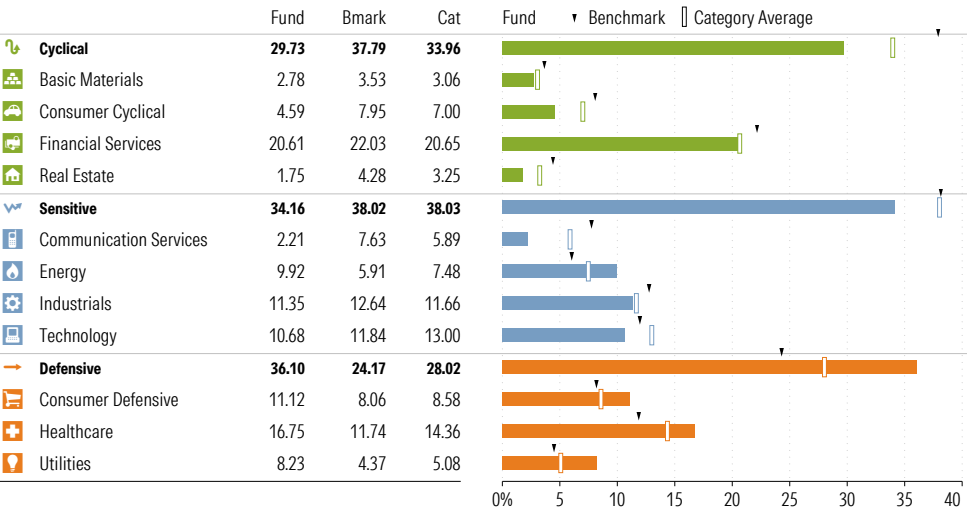

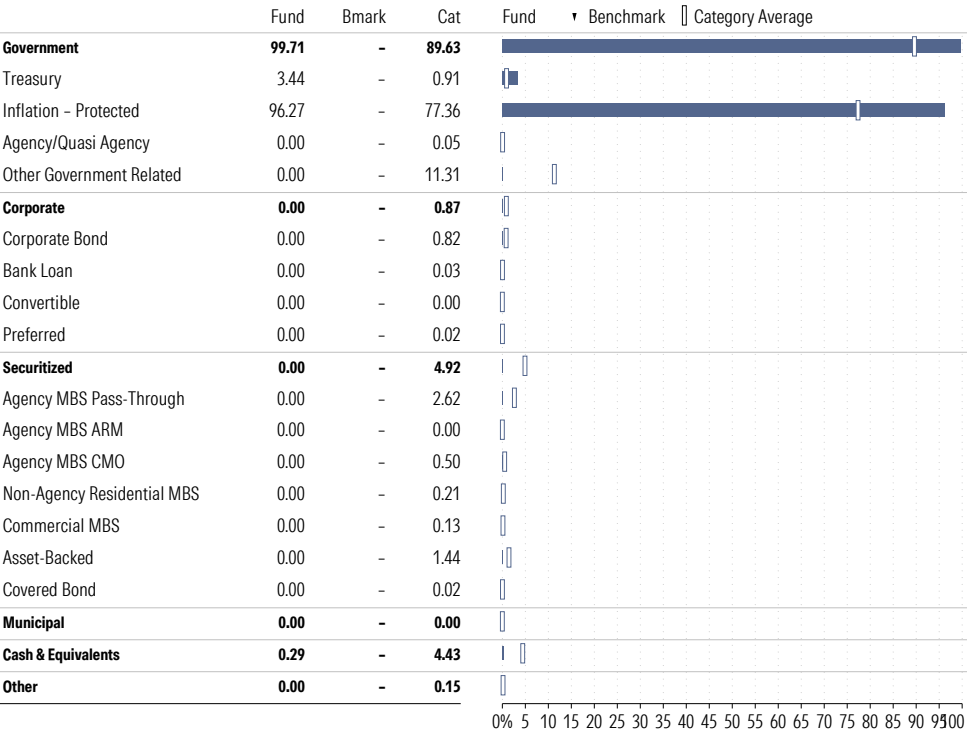

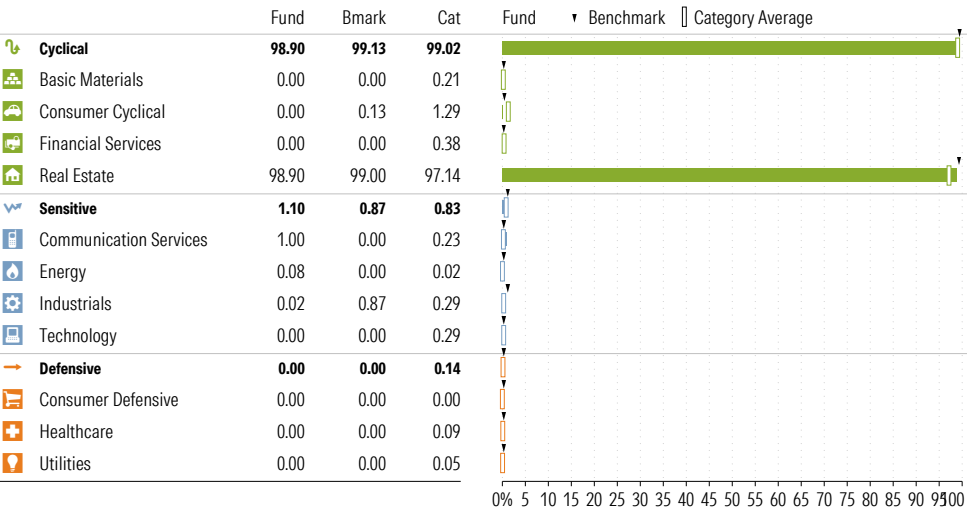
