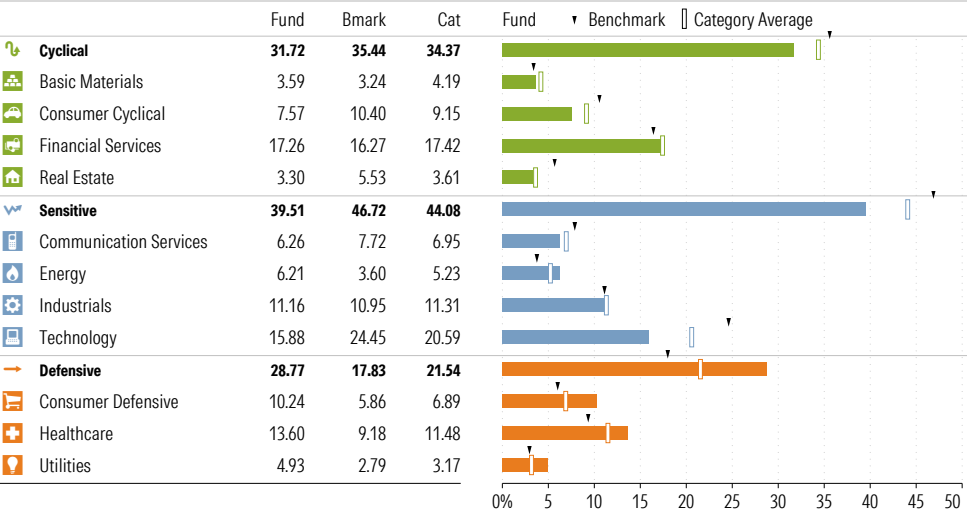

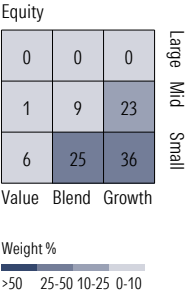

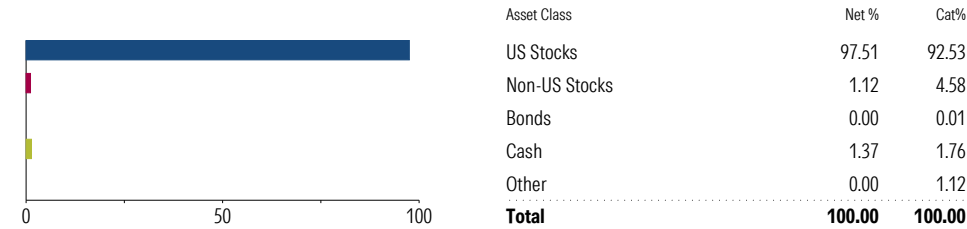

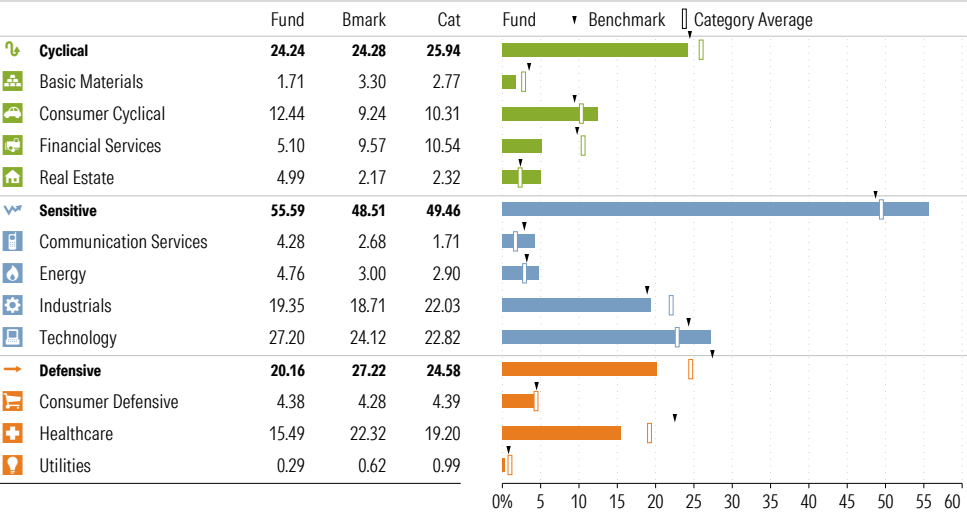
Style Breakdown

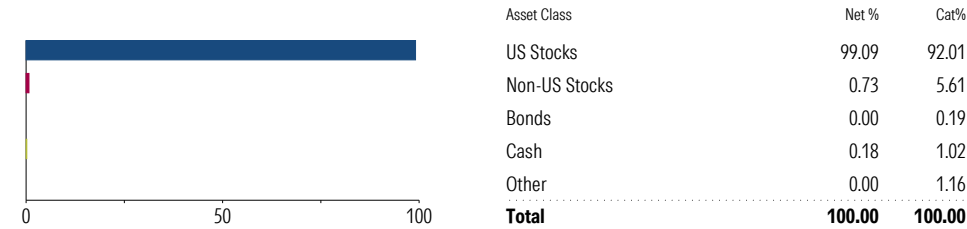

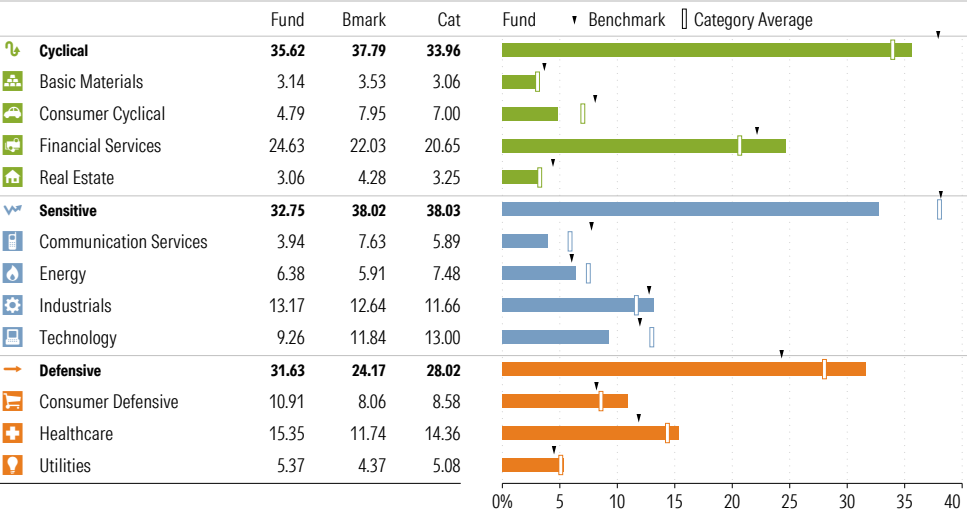
Style Breakdown
