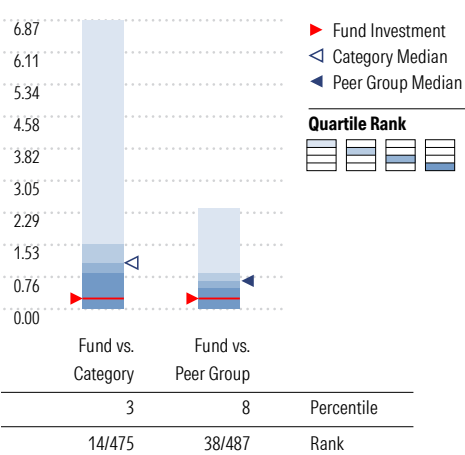

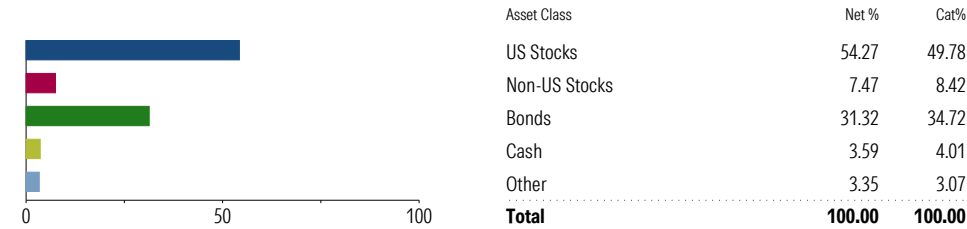

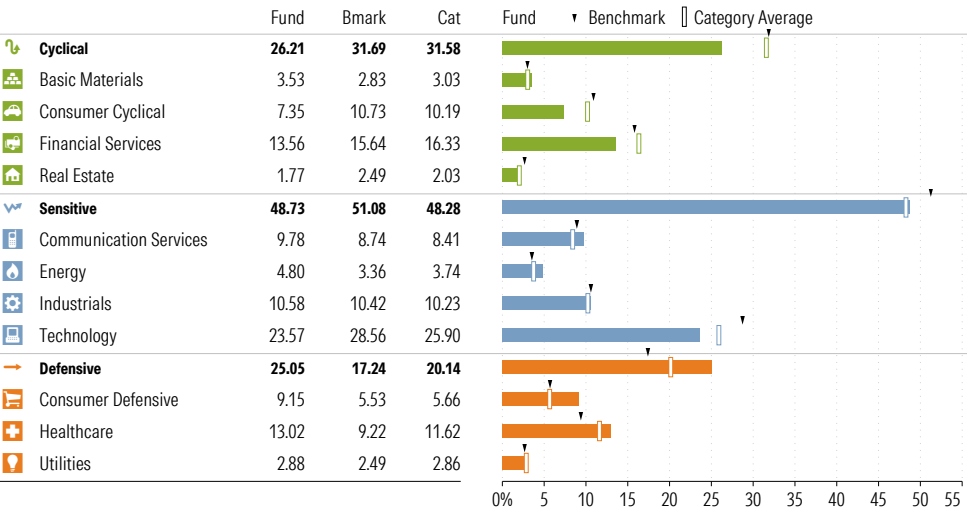

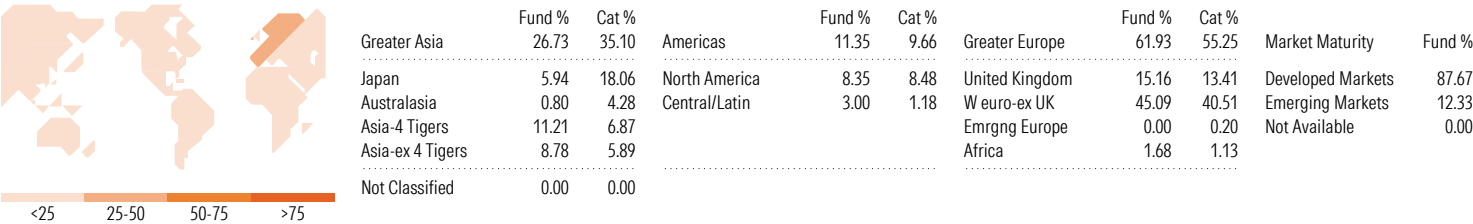
Asset Allocation as of 06-30-2025

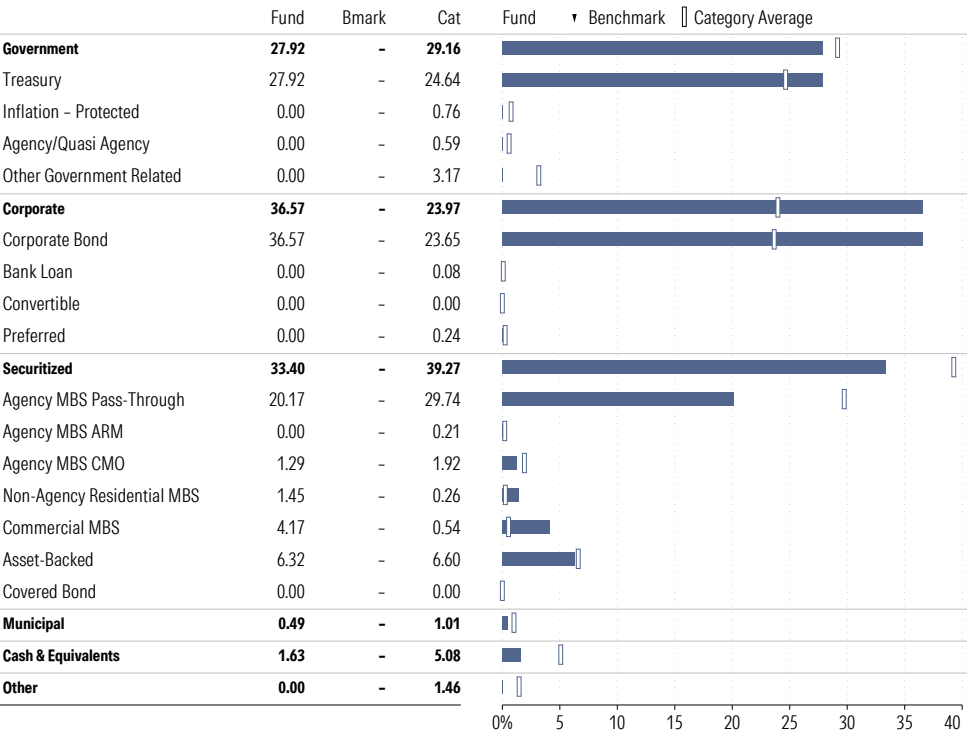

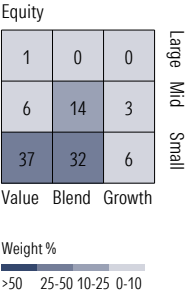

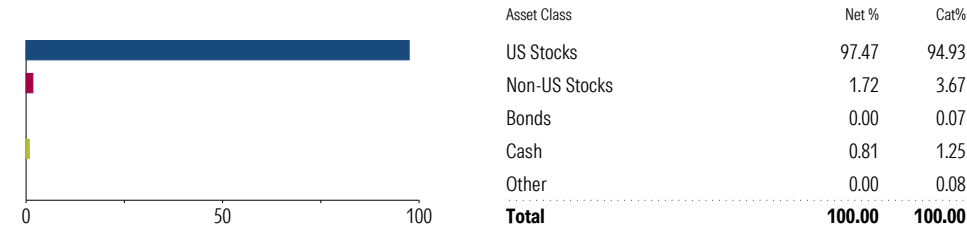

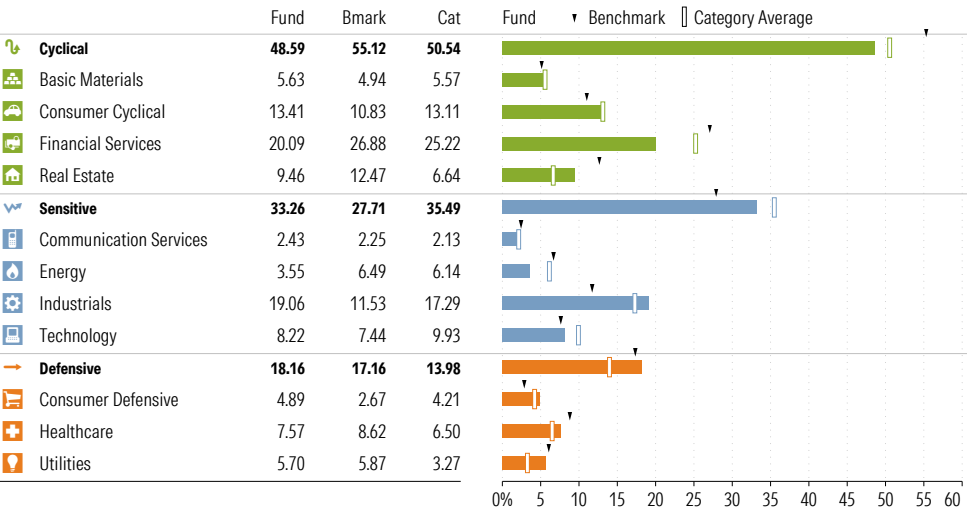

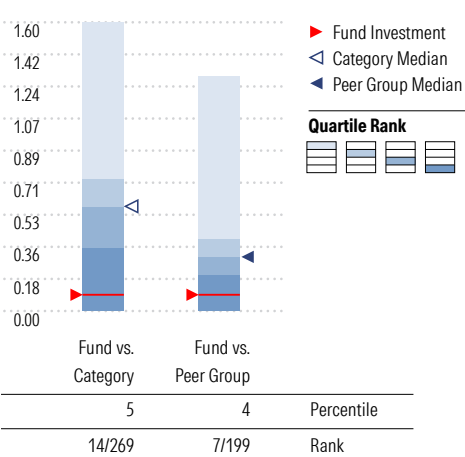

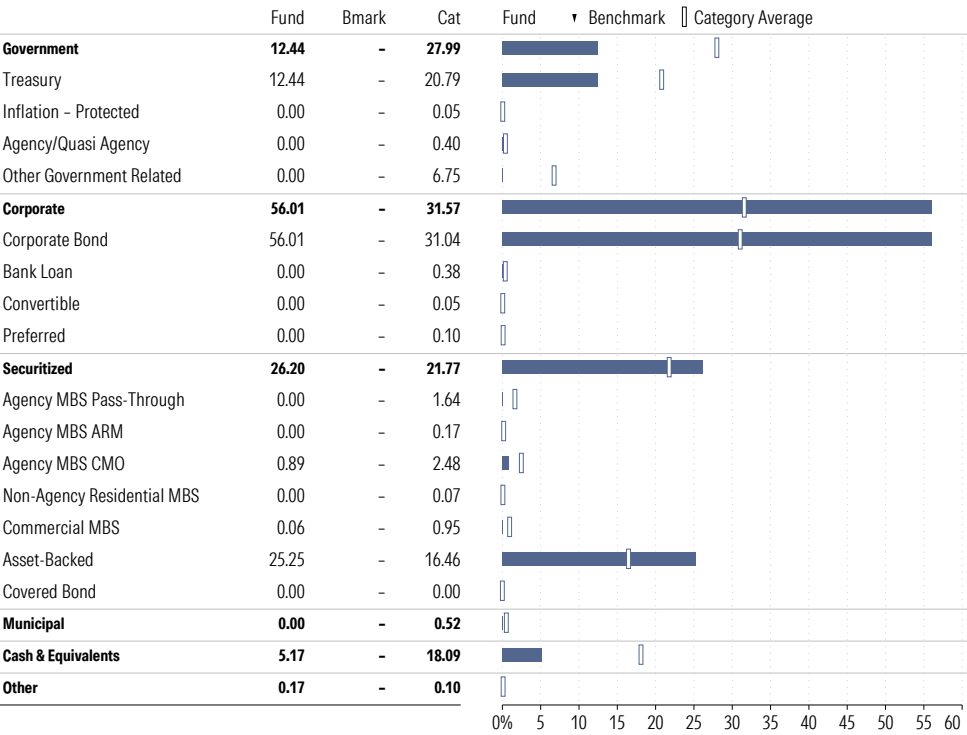

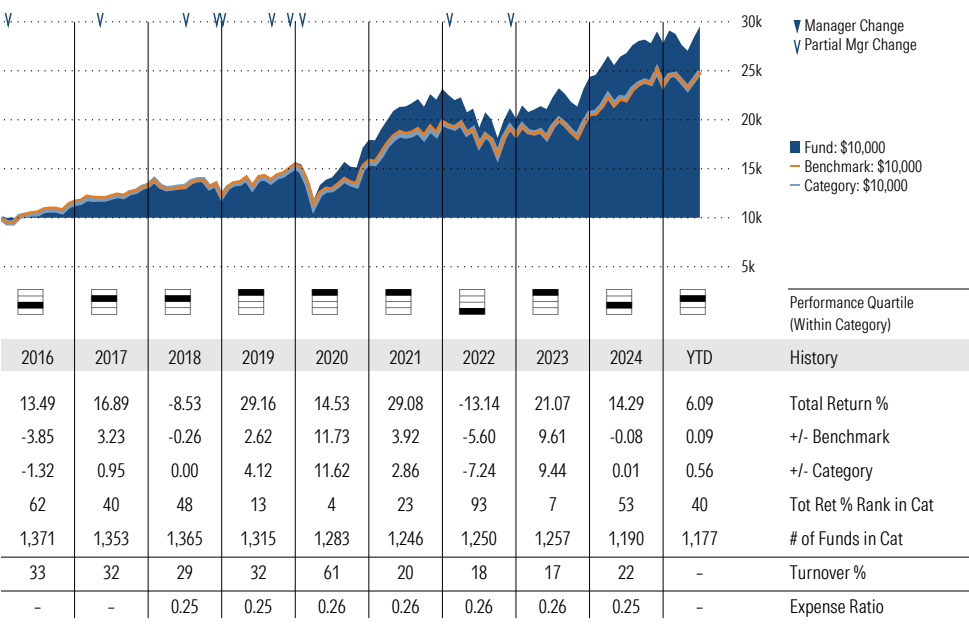
Morningstar Investment Management LLC Analysis

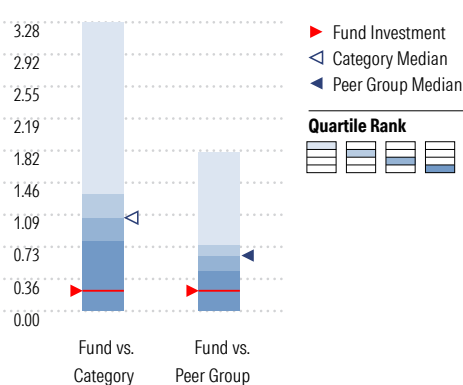

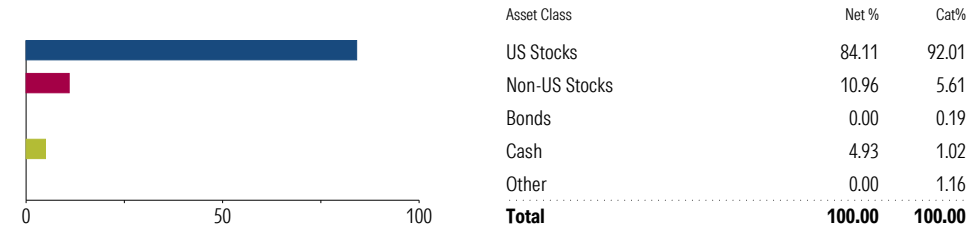

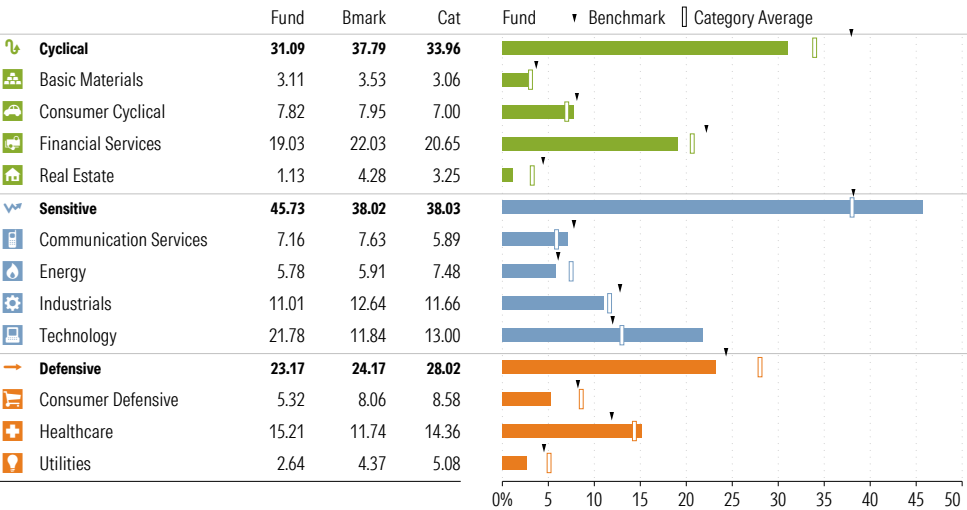
Style Breakdown
