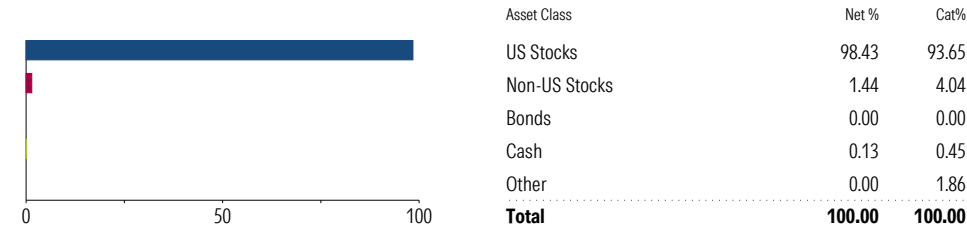

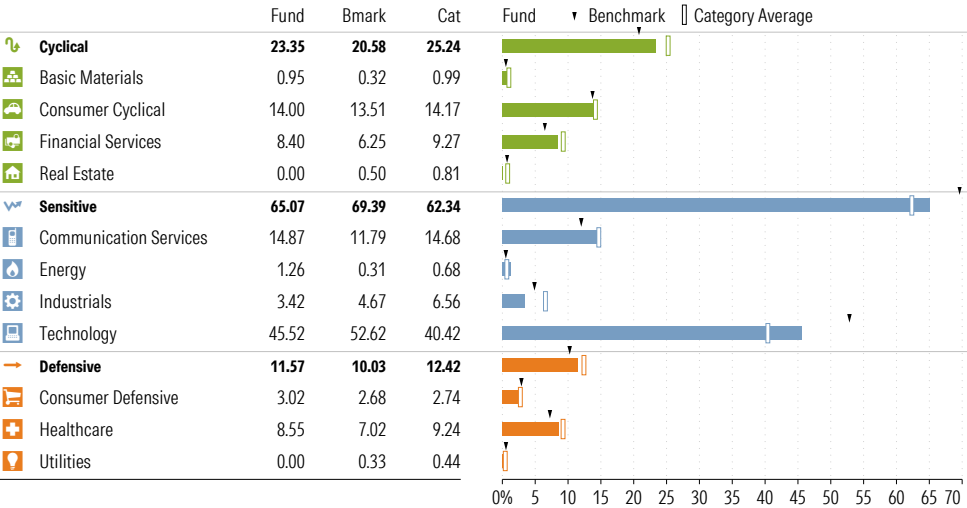
Style Breakdown

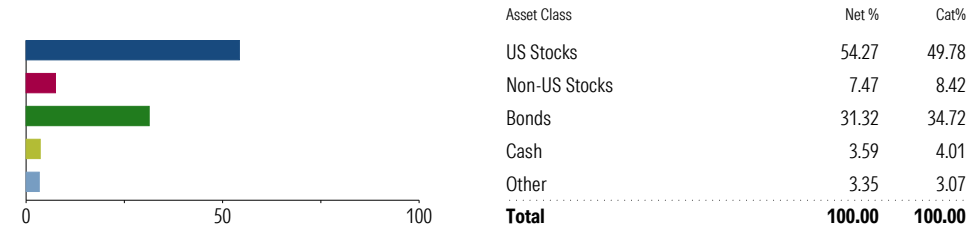

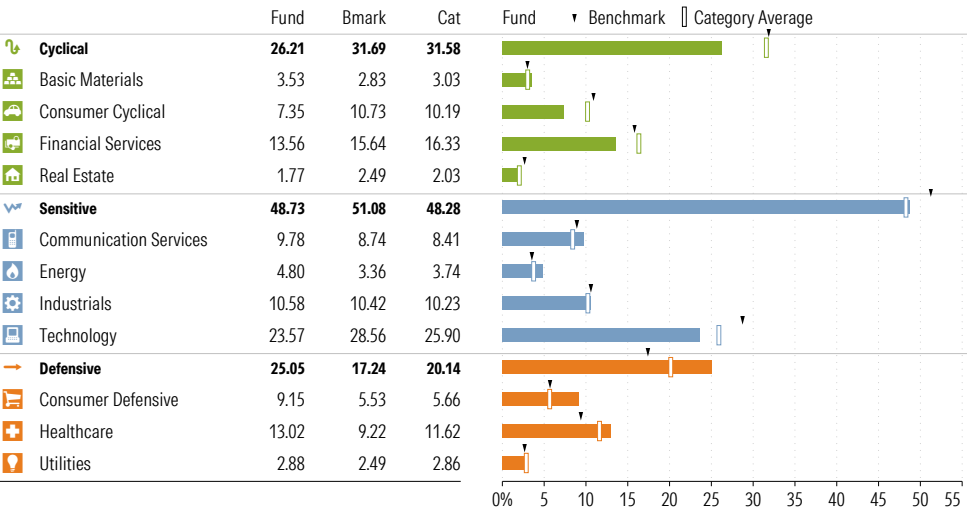

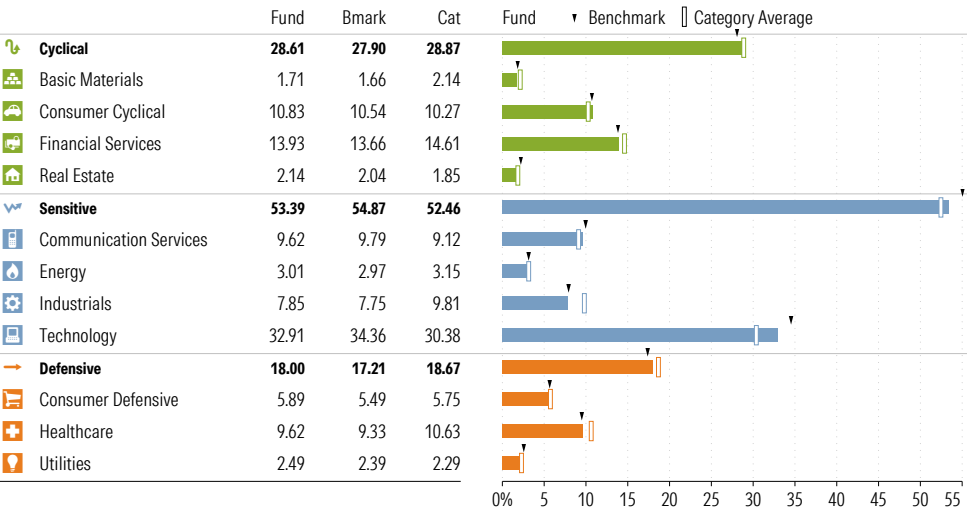

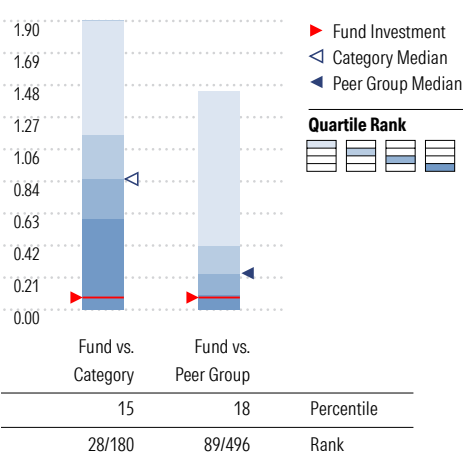

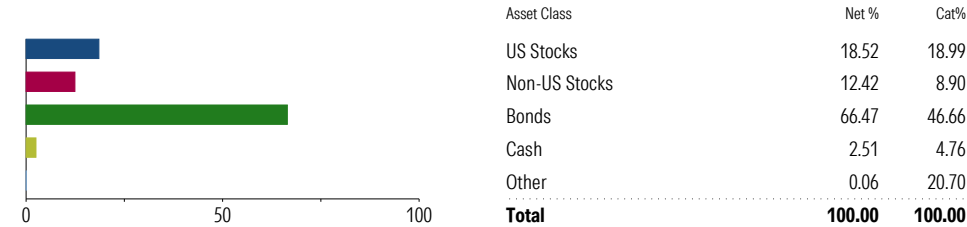

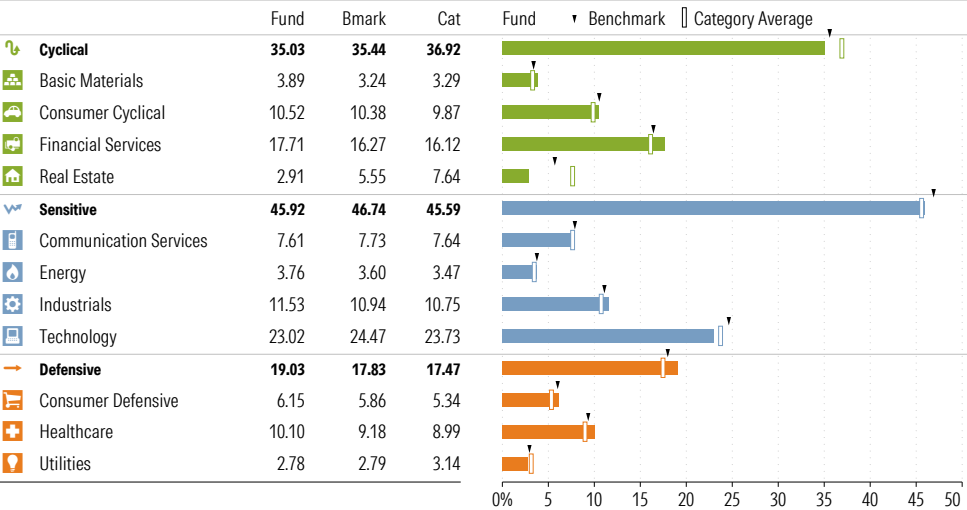
Style Breakdown

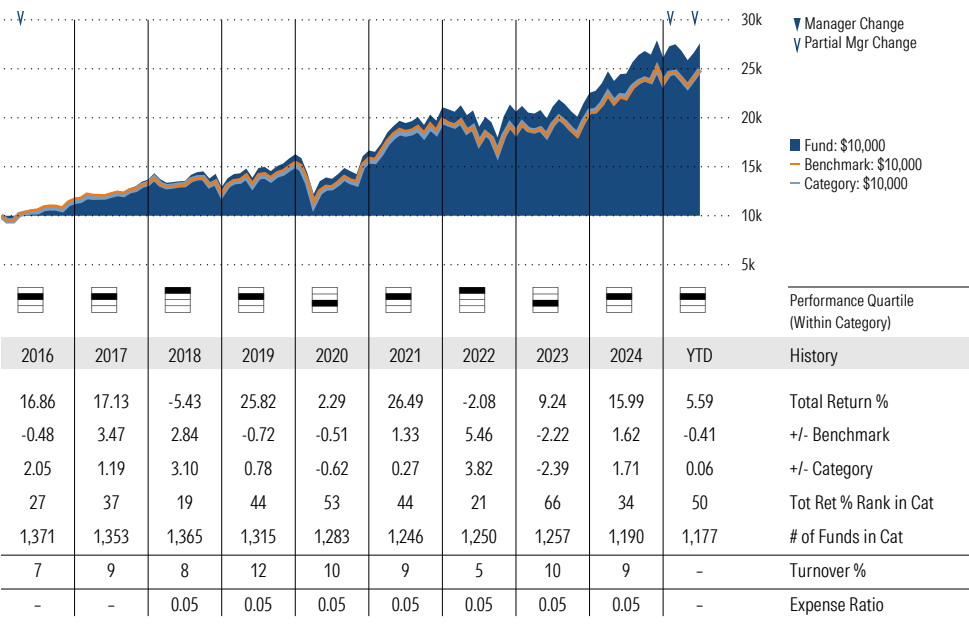

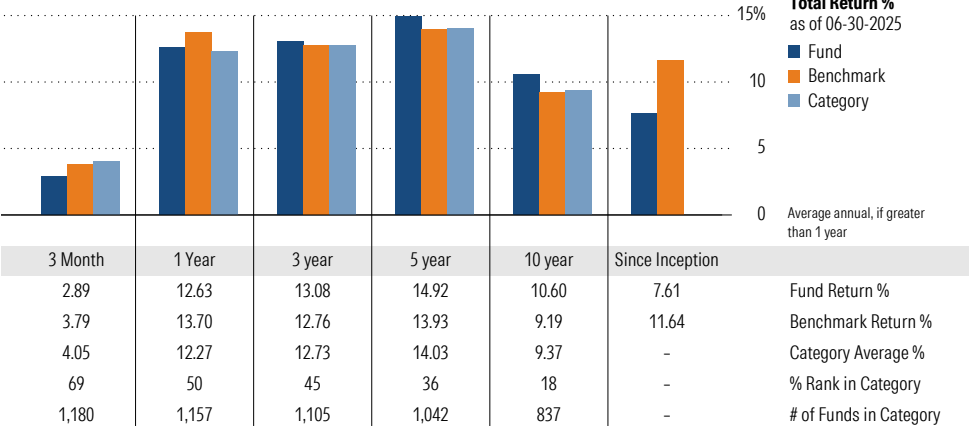

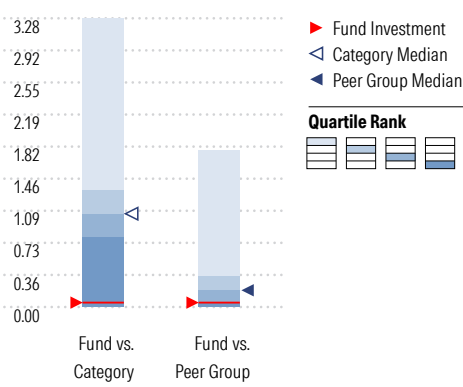
