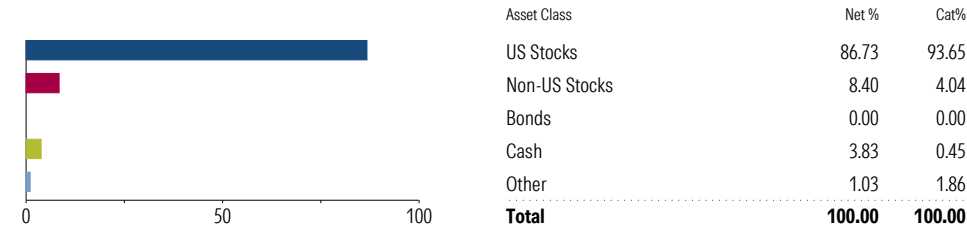

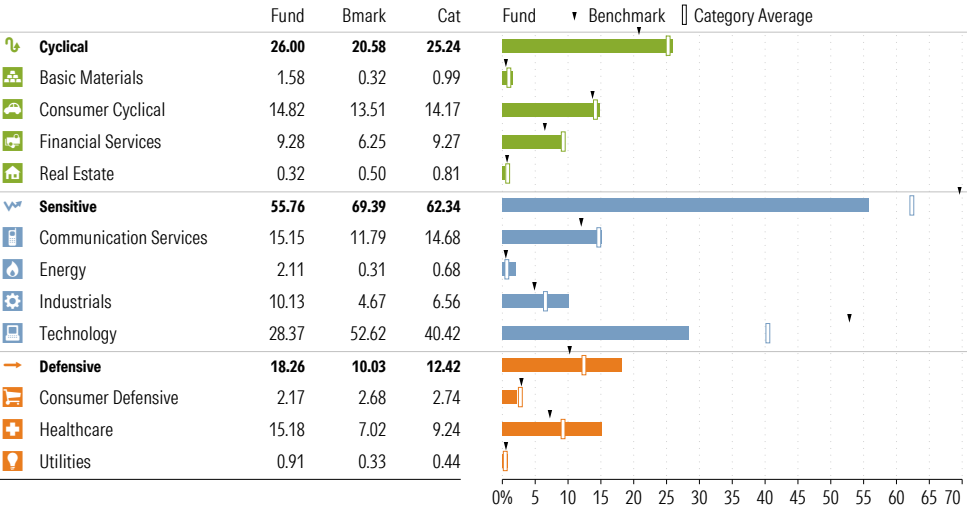

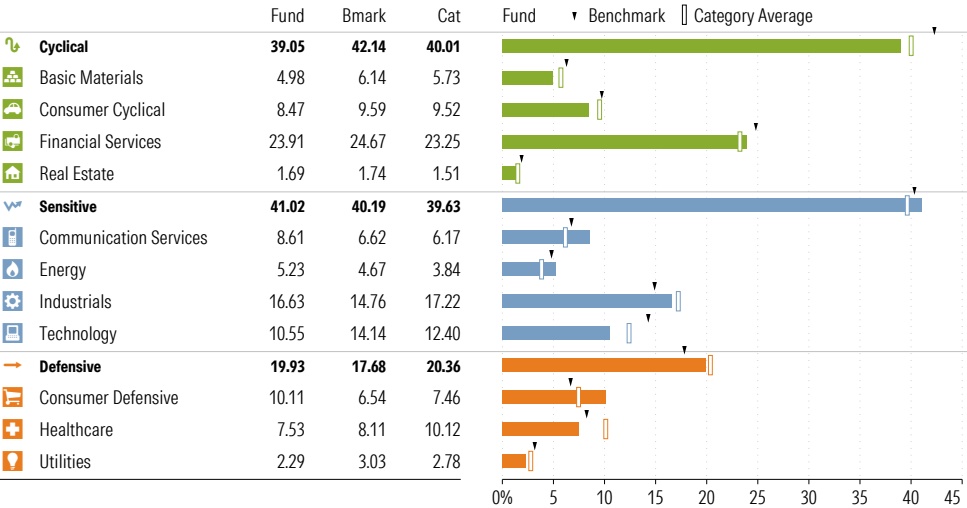

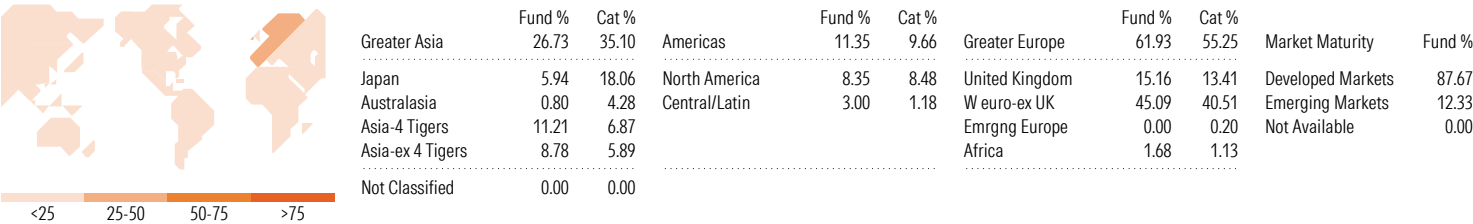

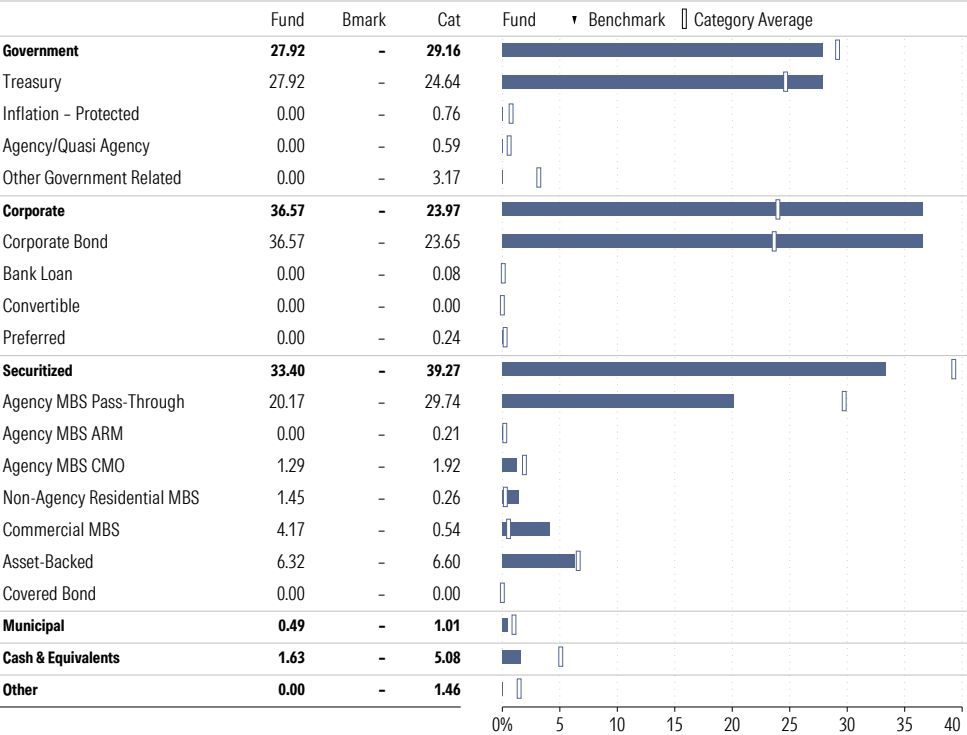

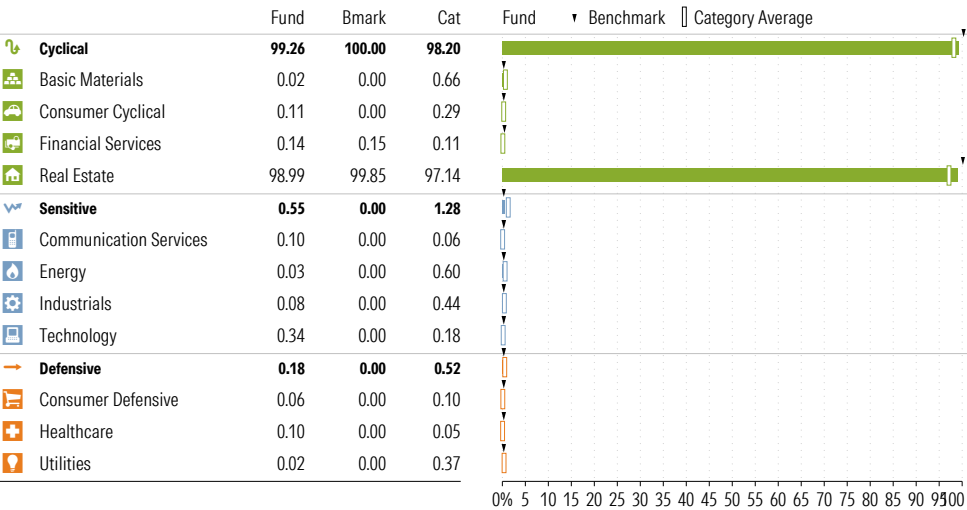
Style Breakdown

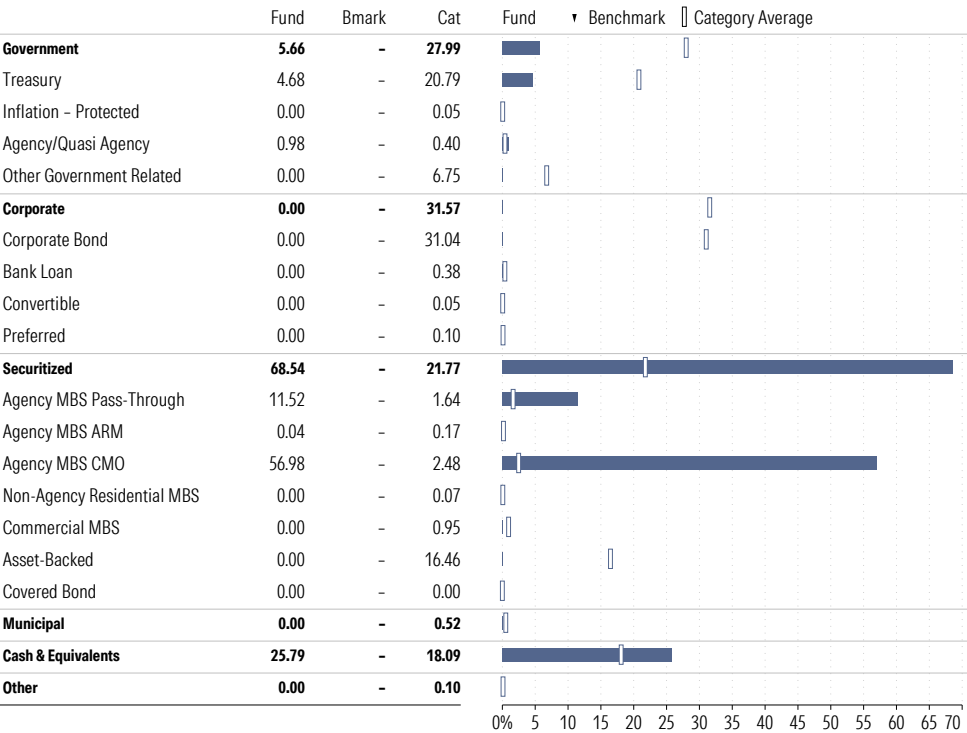

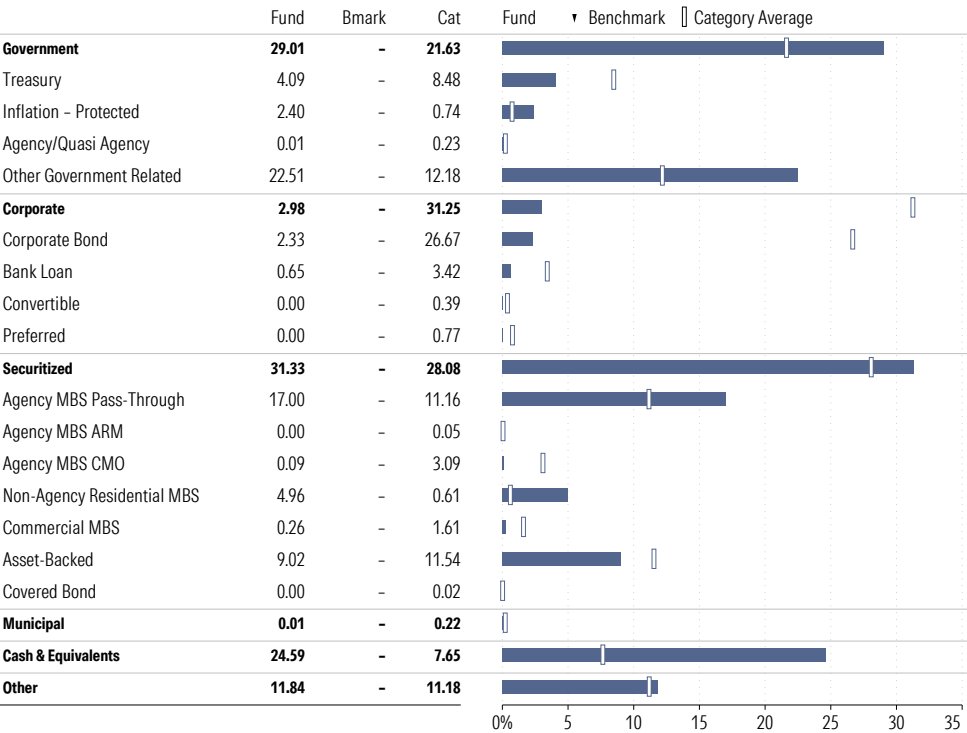

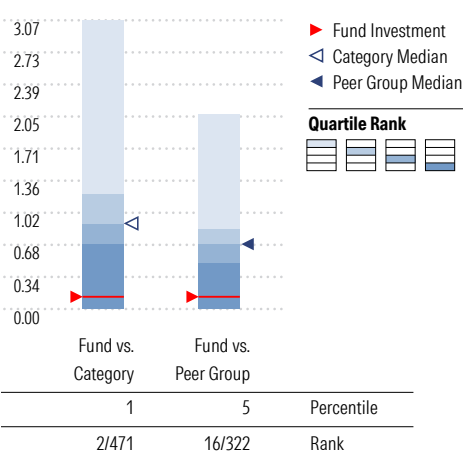

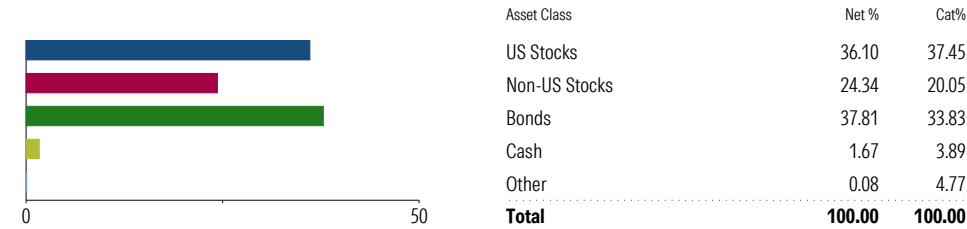

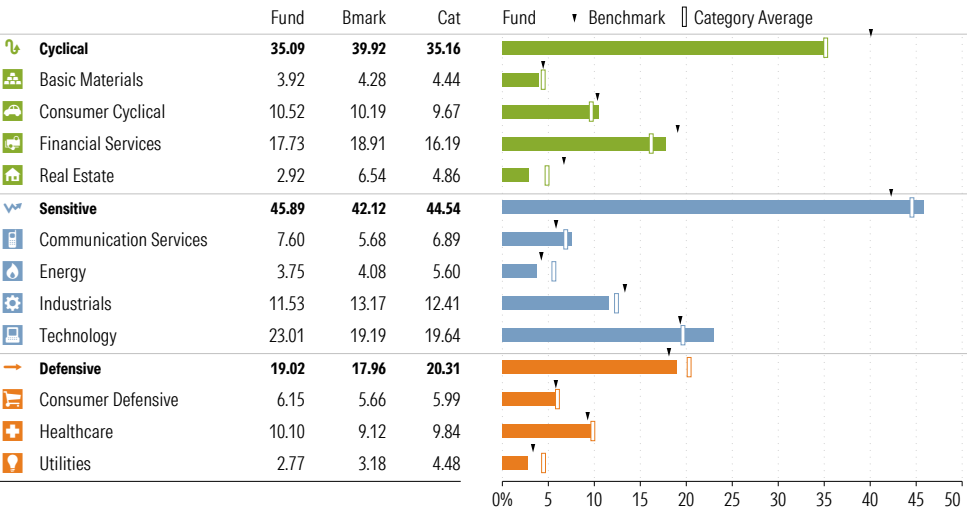

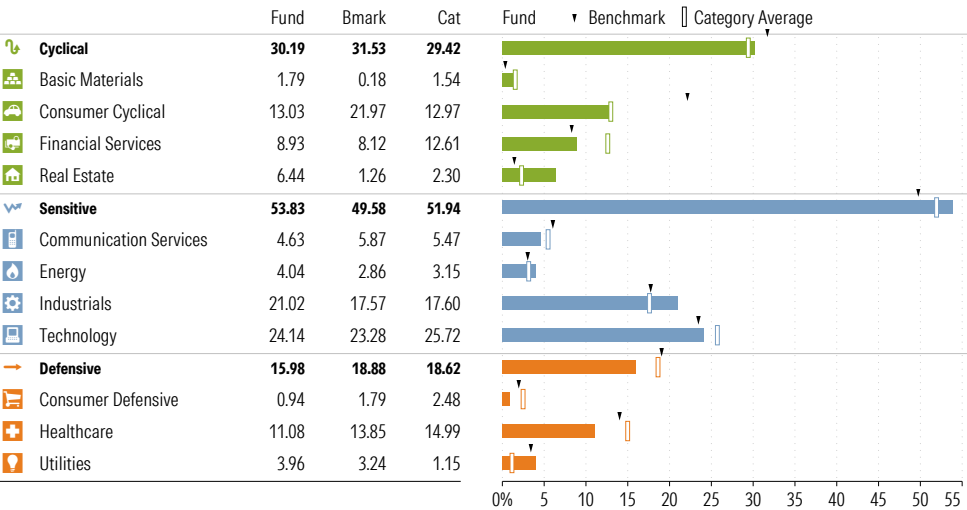

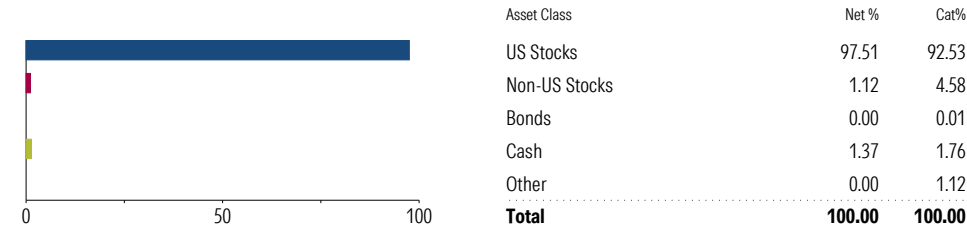

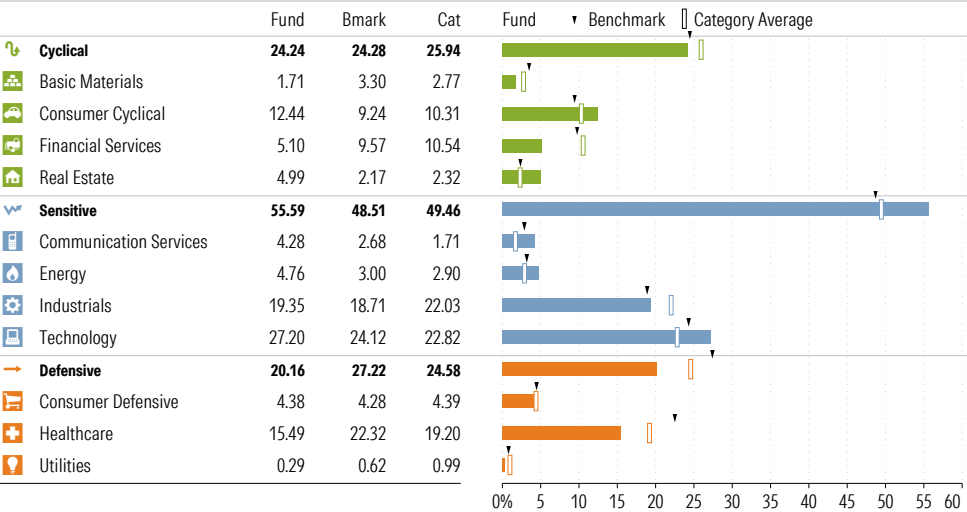

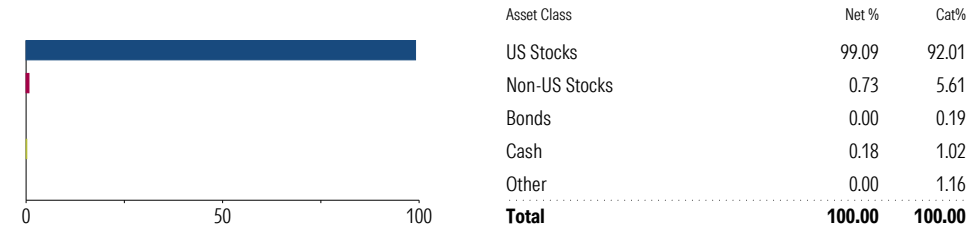

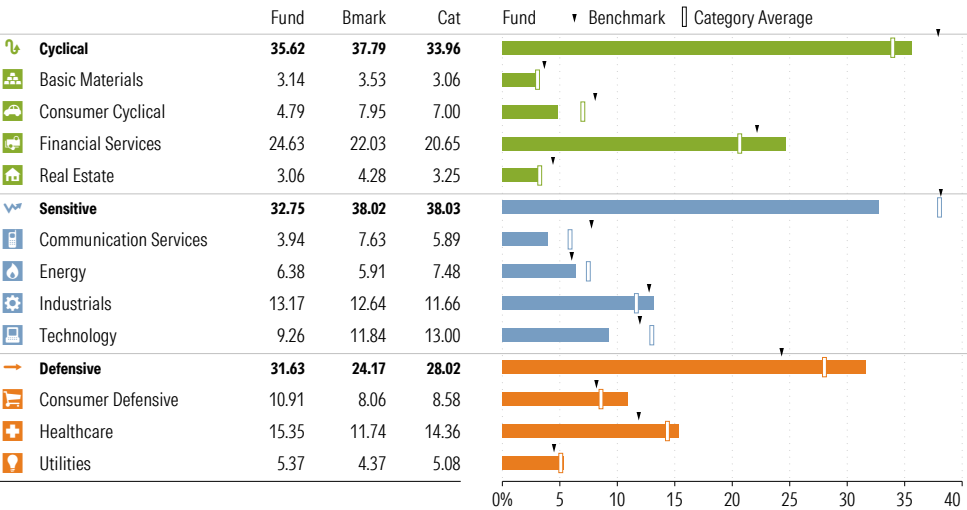
