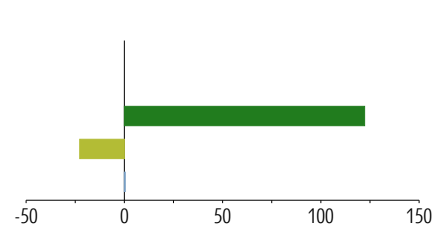

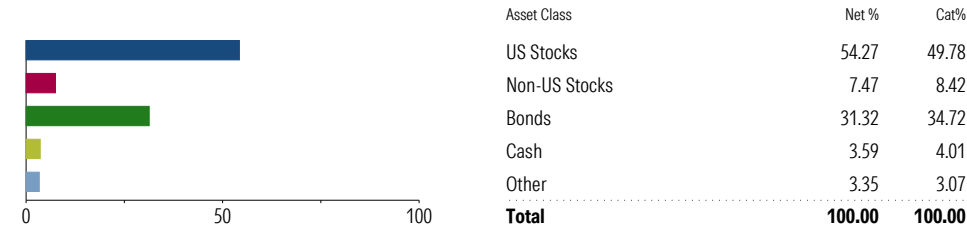

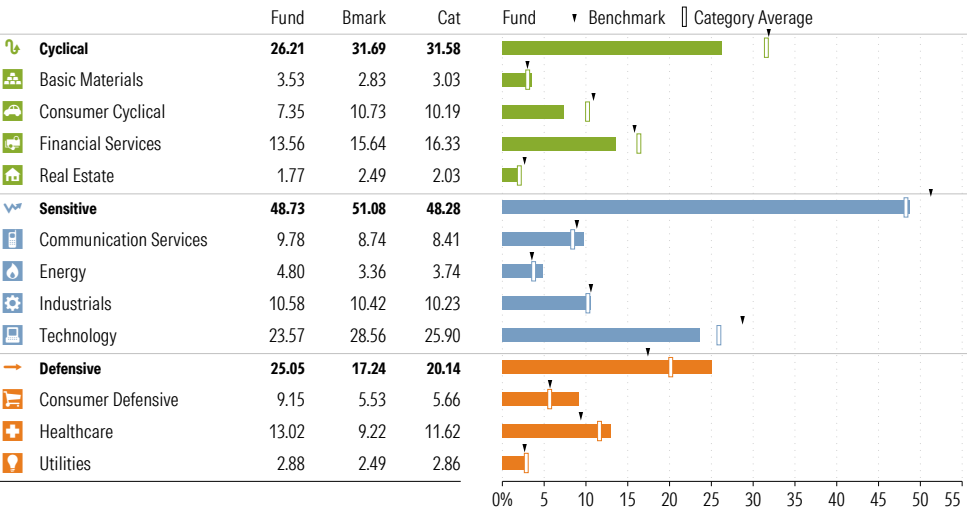

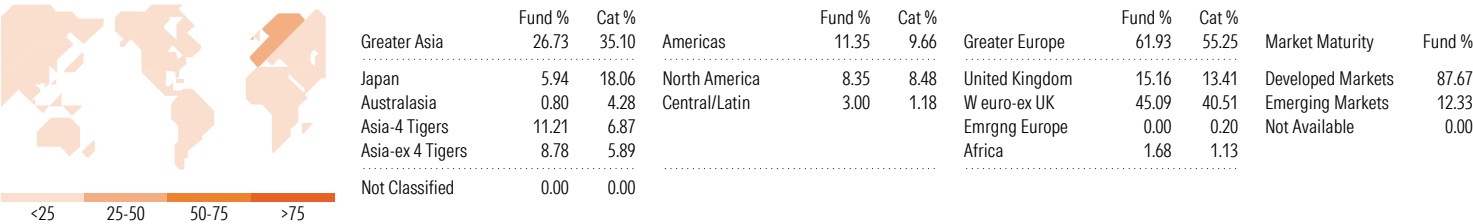

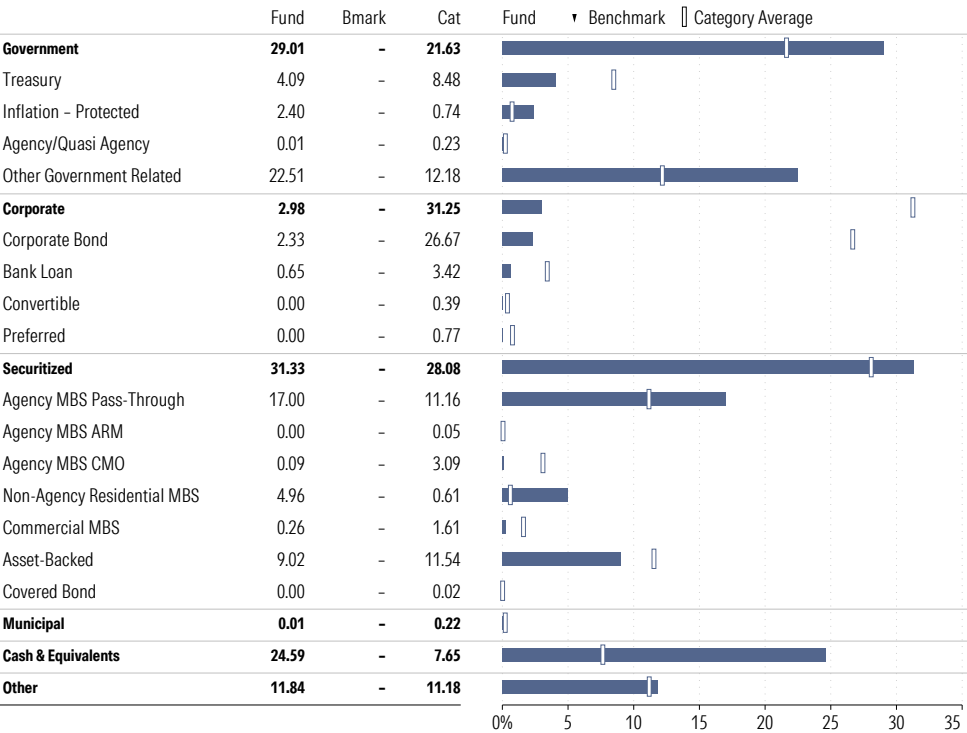

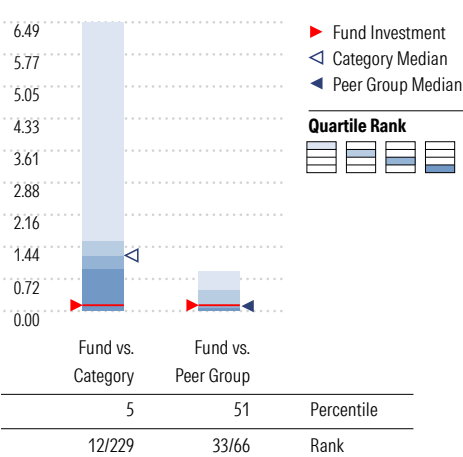

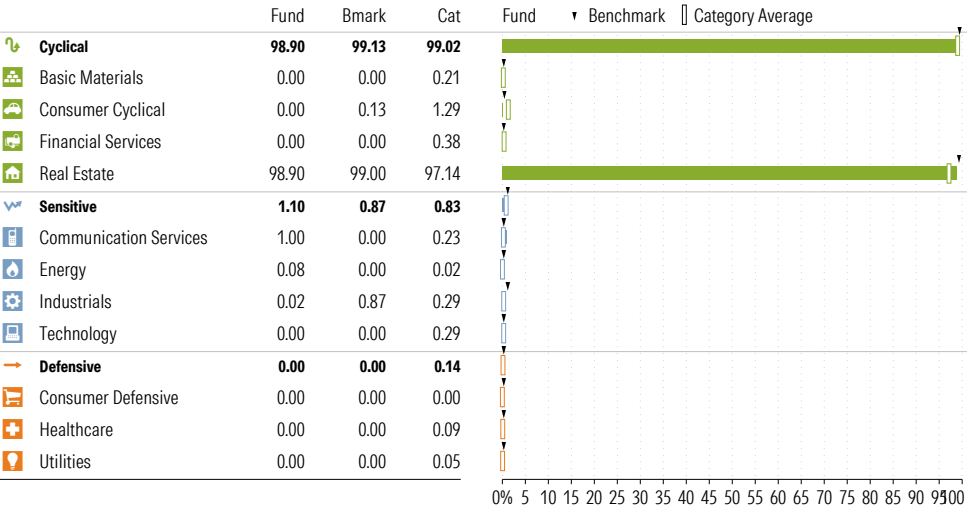

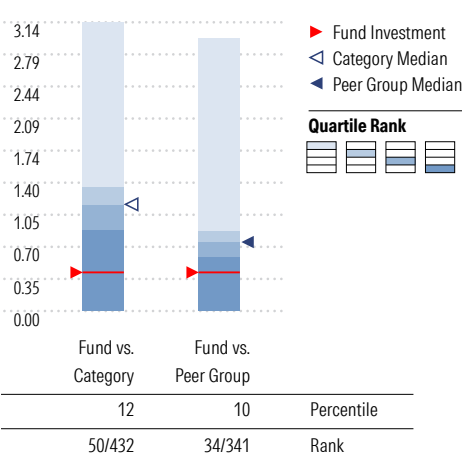

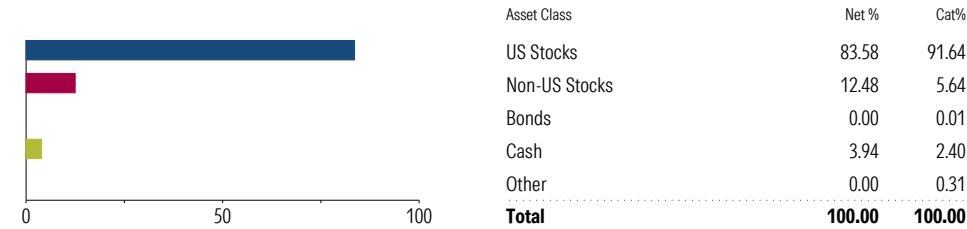

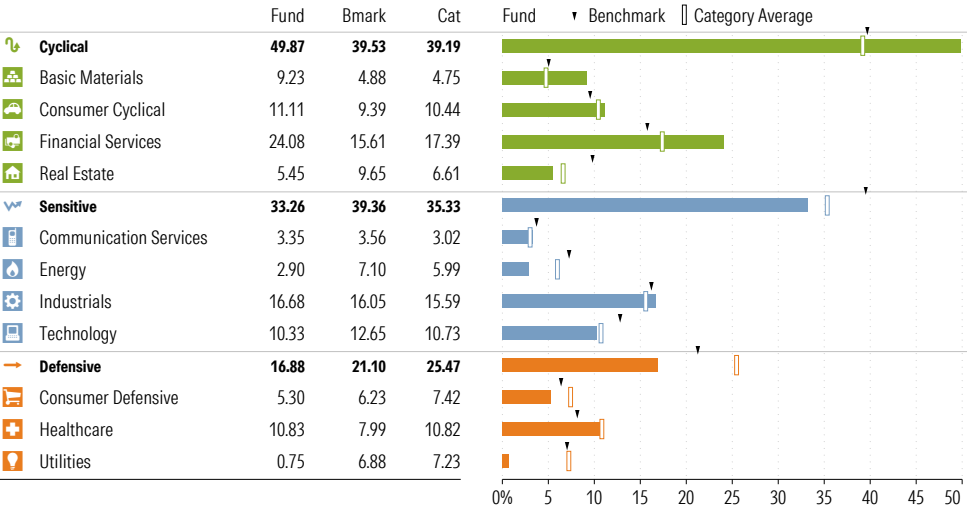
Style Breakdown

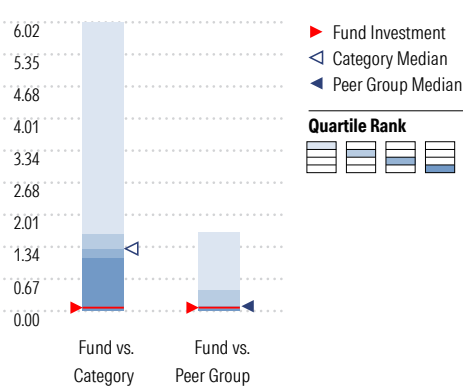

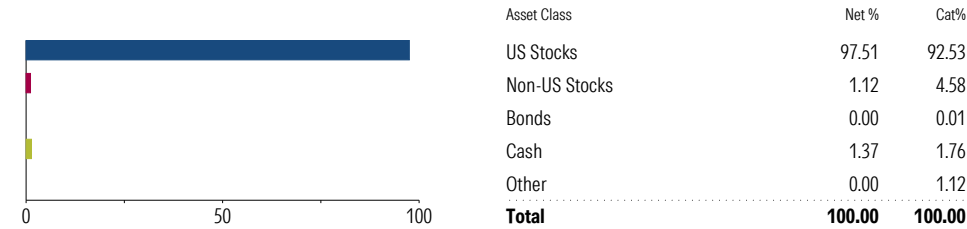

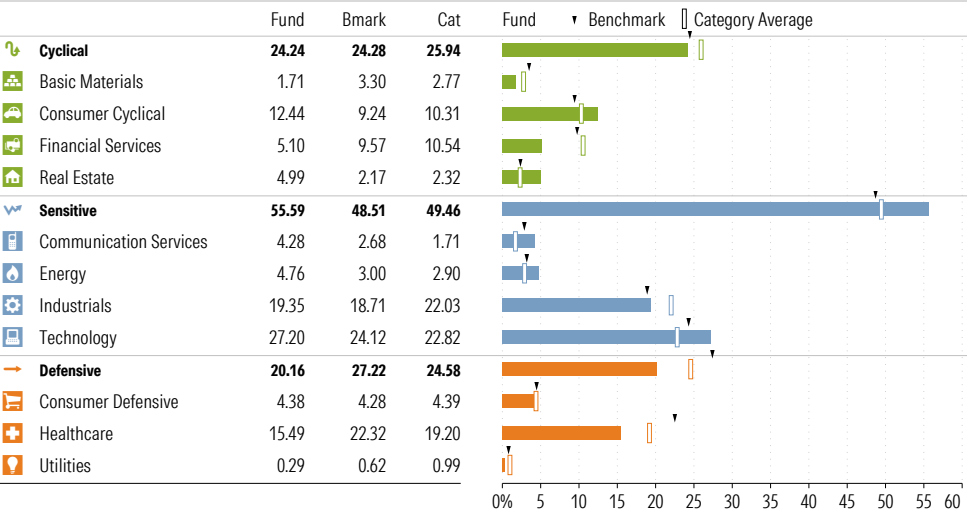
