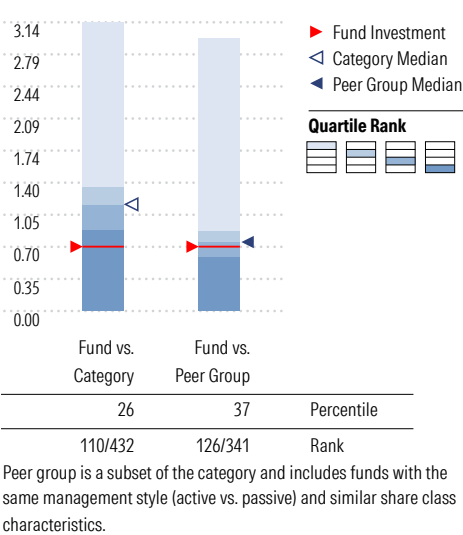

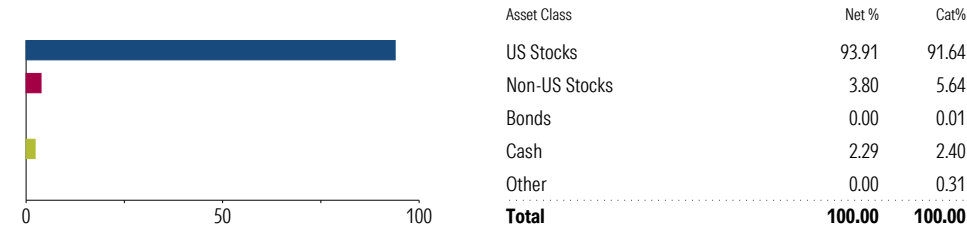

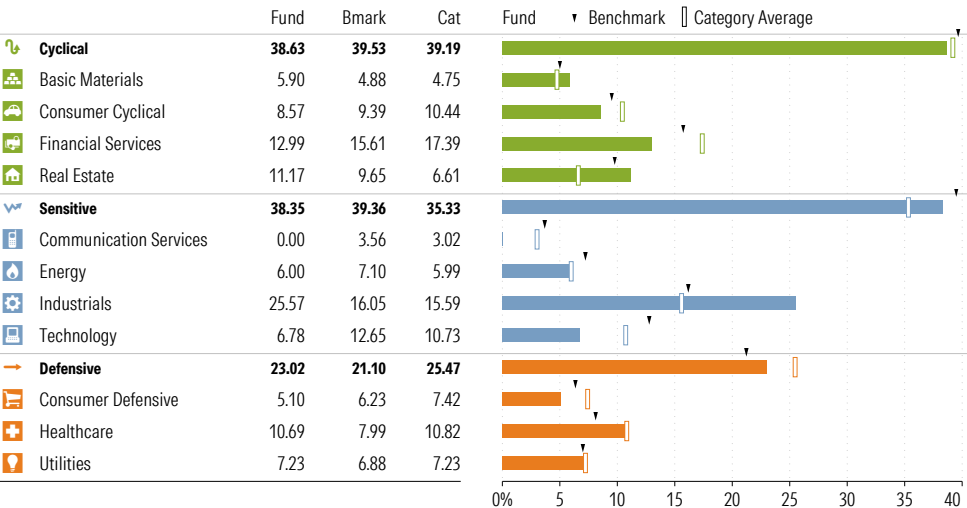

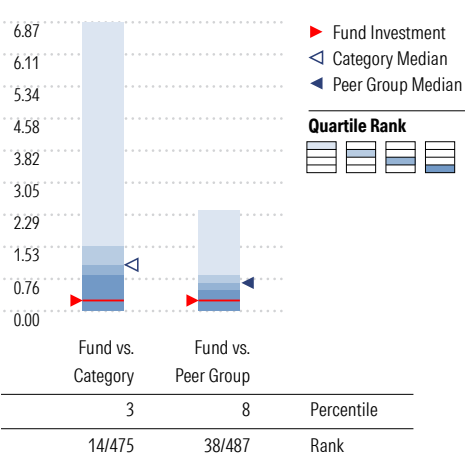

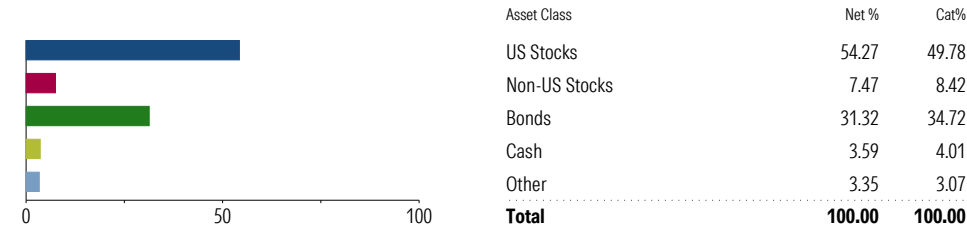

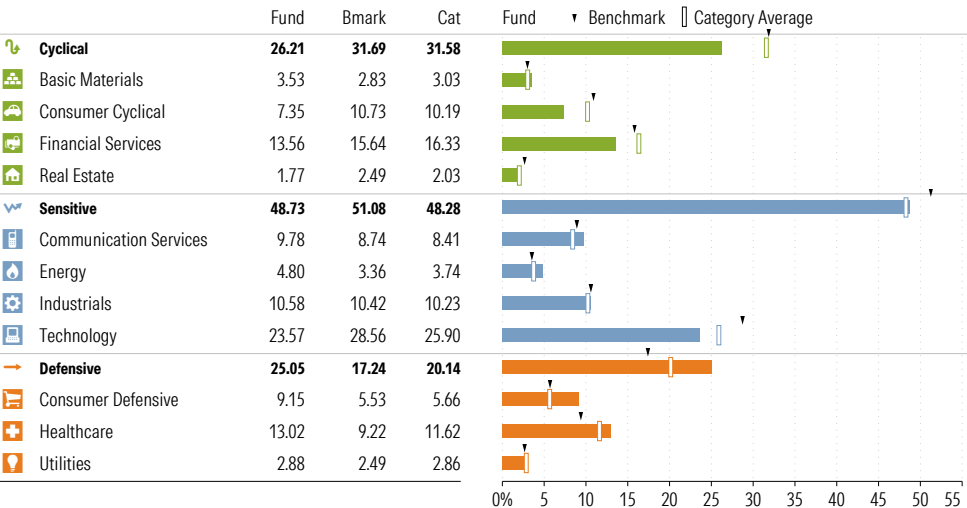

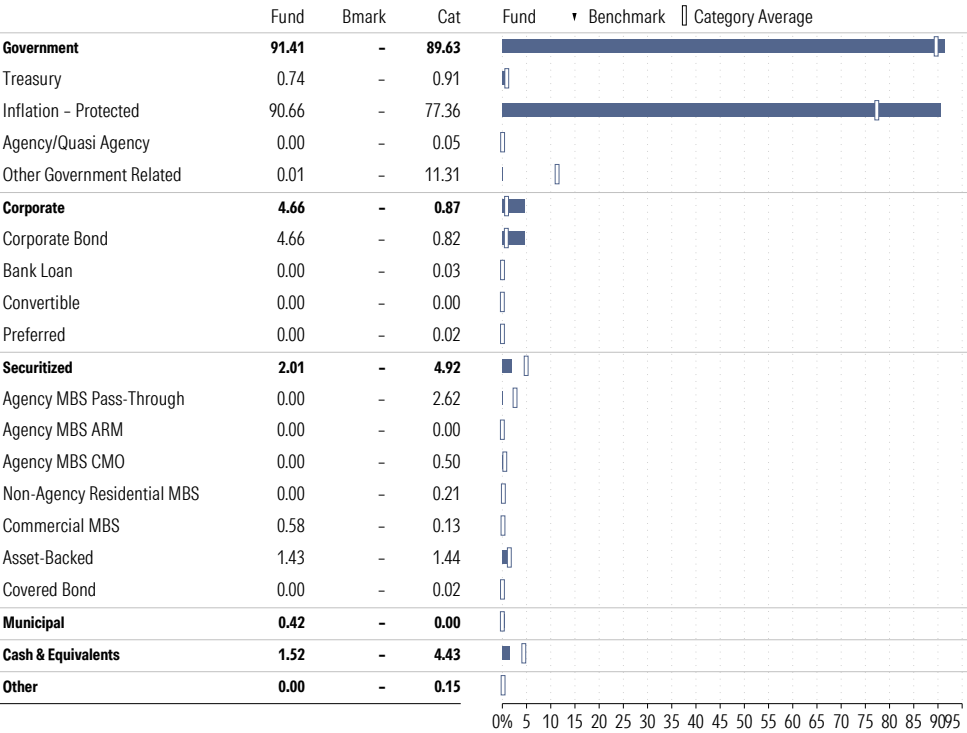

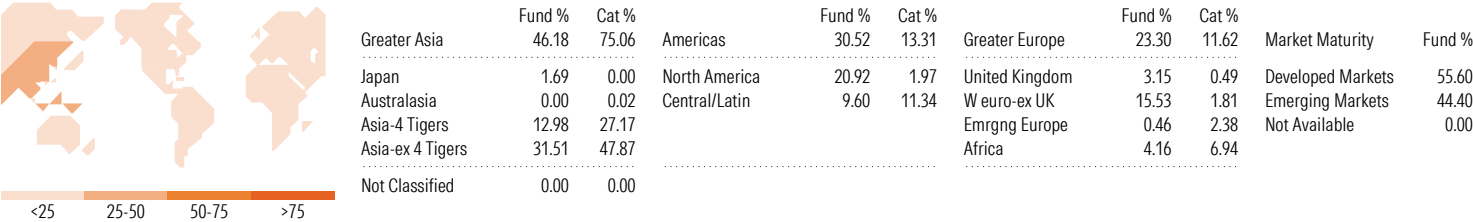

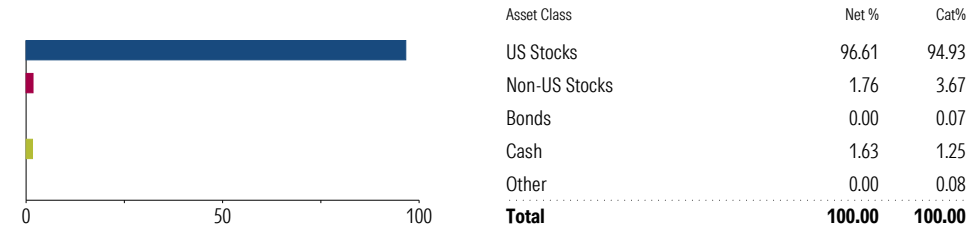

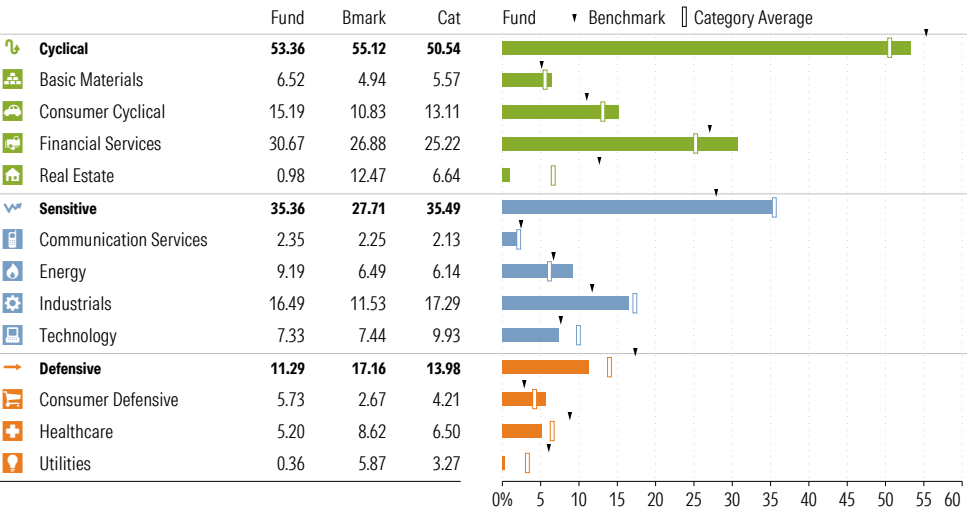

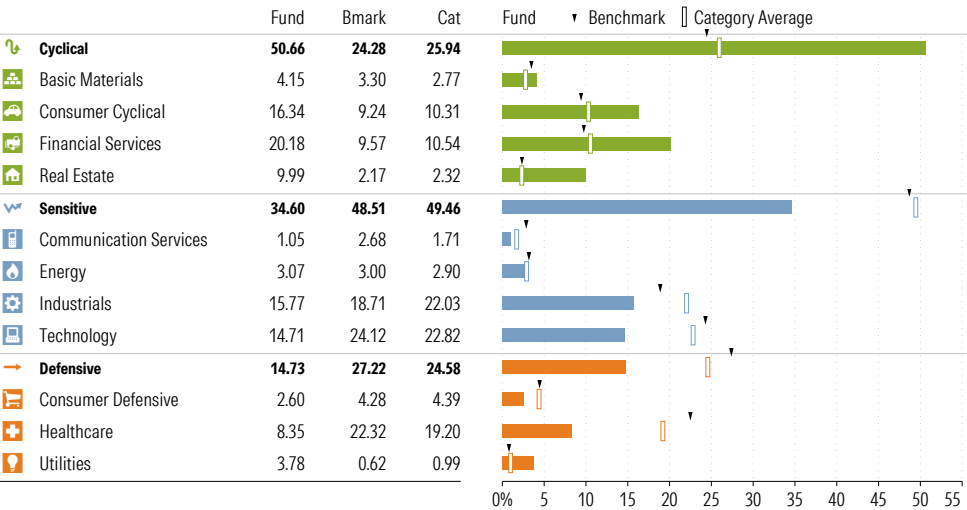

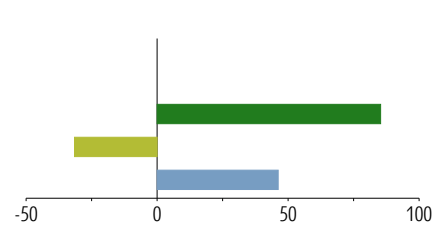

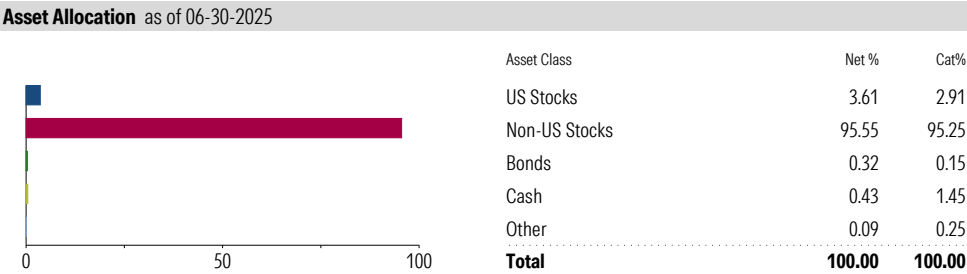

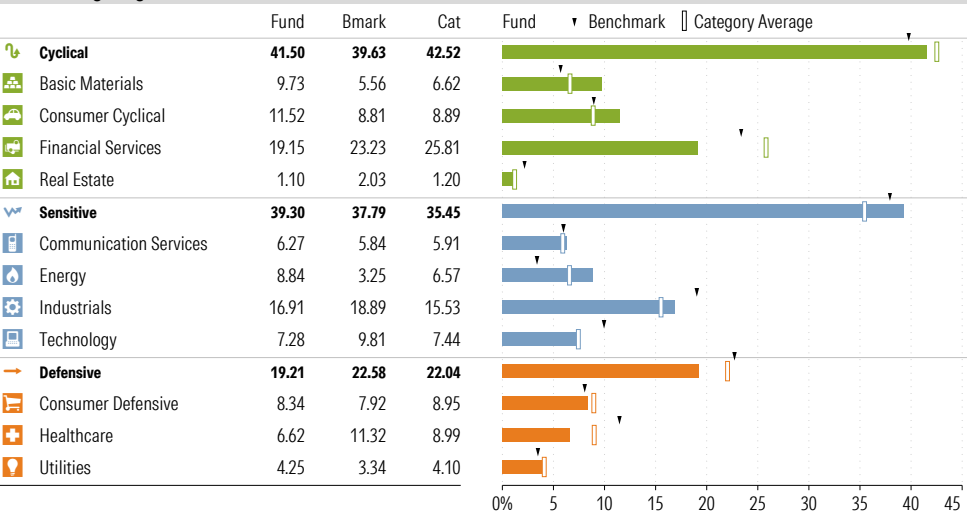

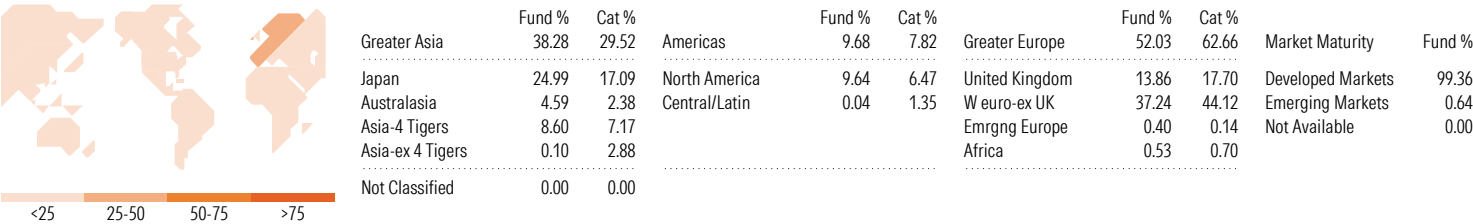

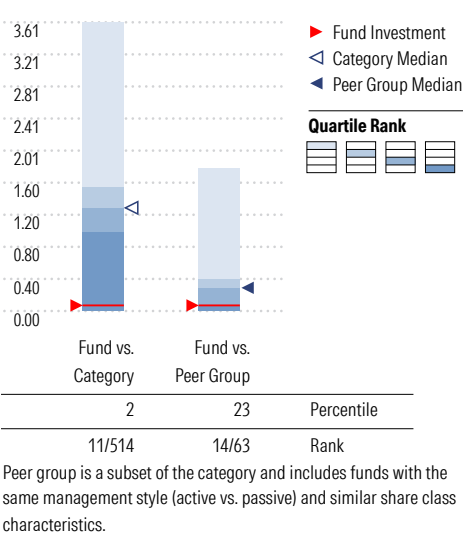

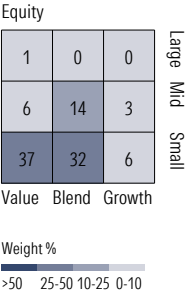

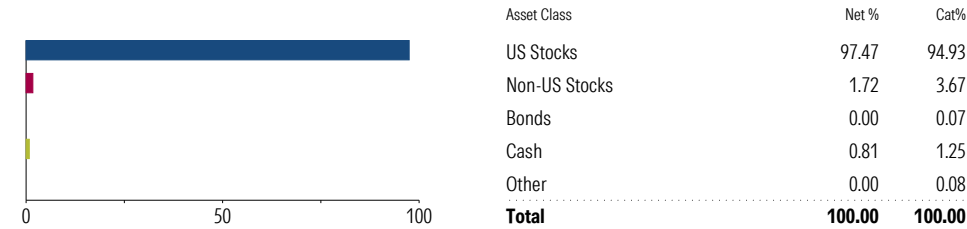

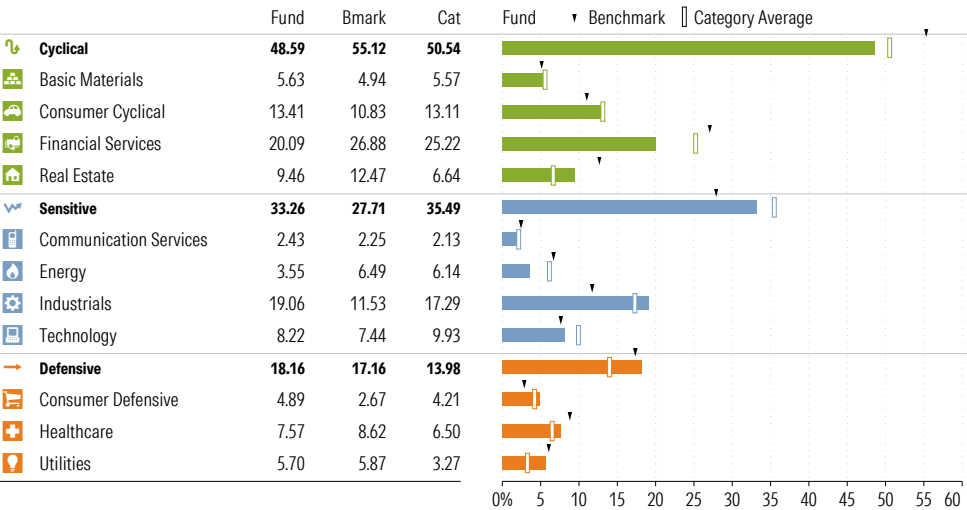
Style Breakdown
