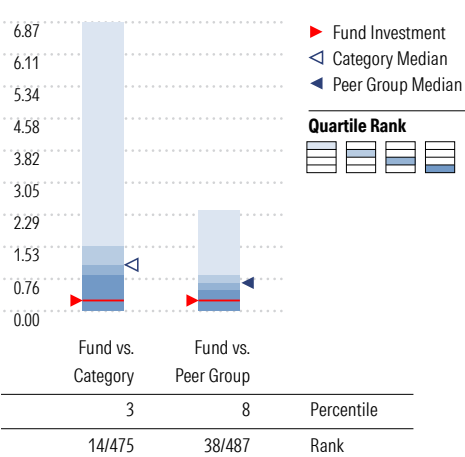

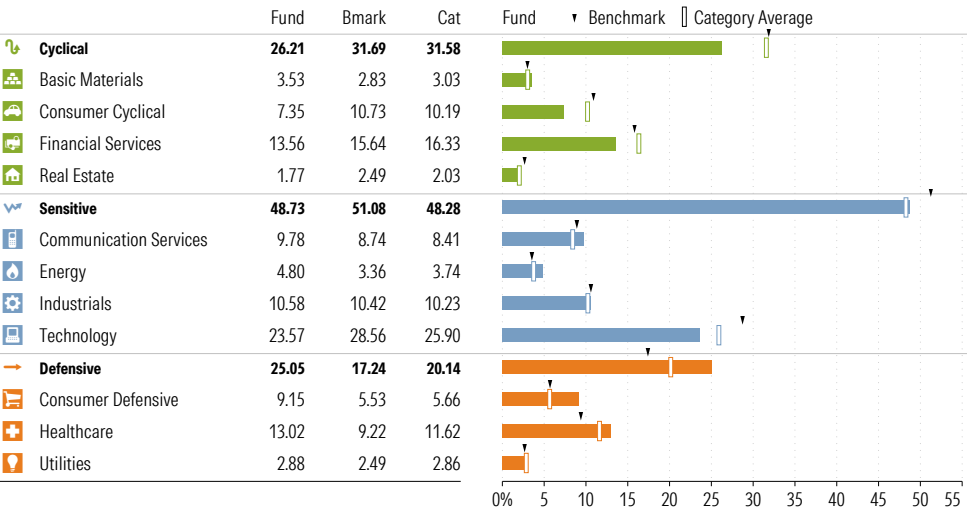

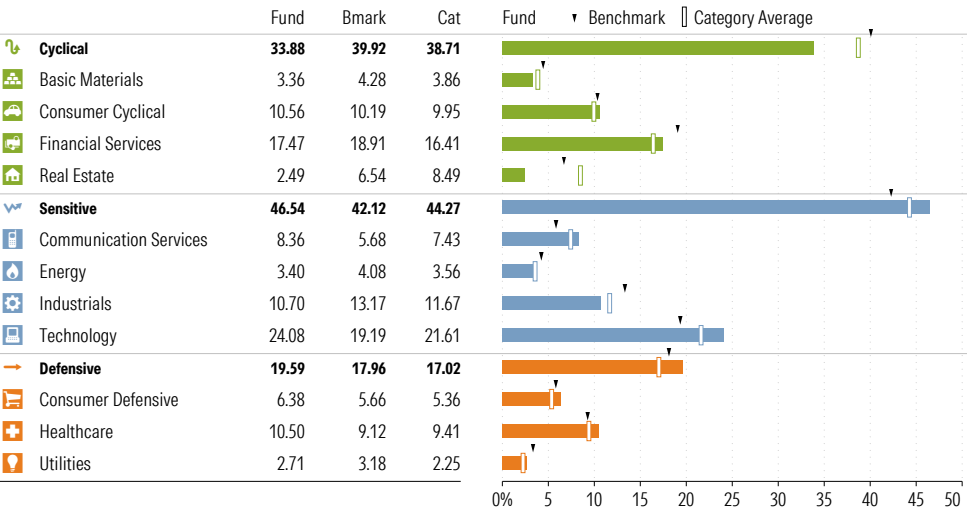

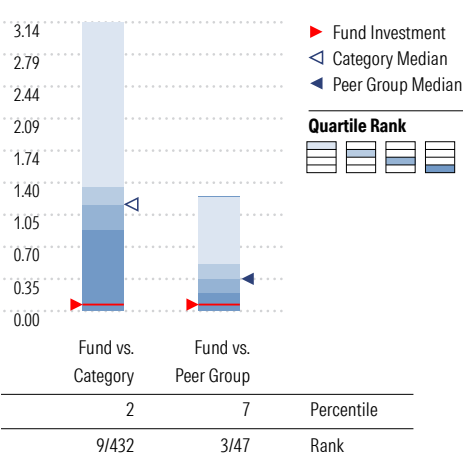

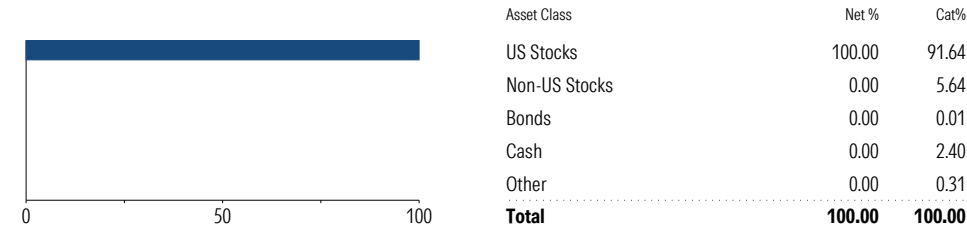

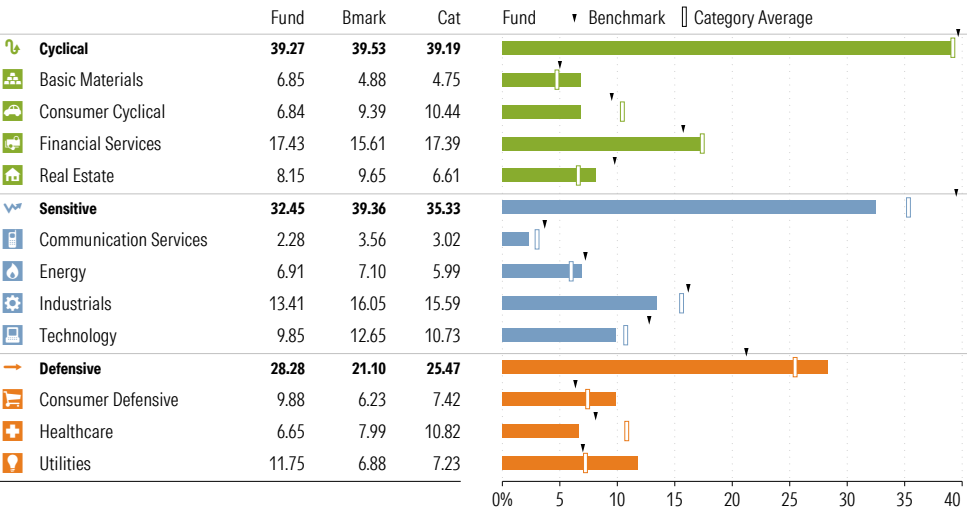

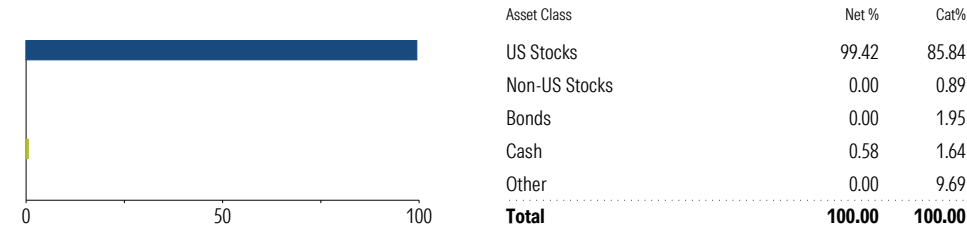

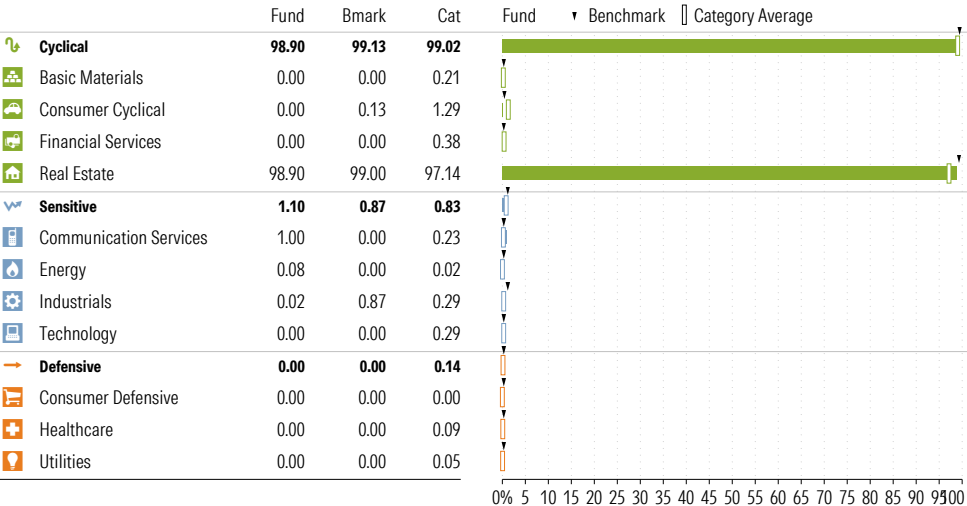
Style Breakdown

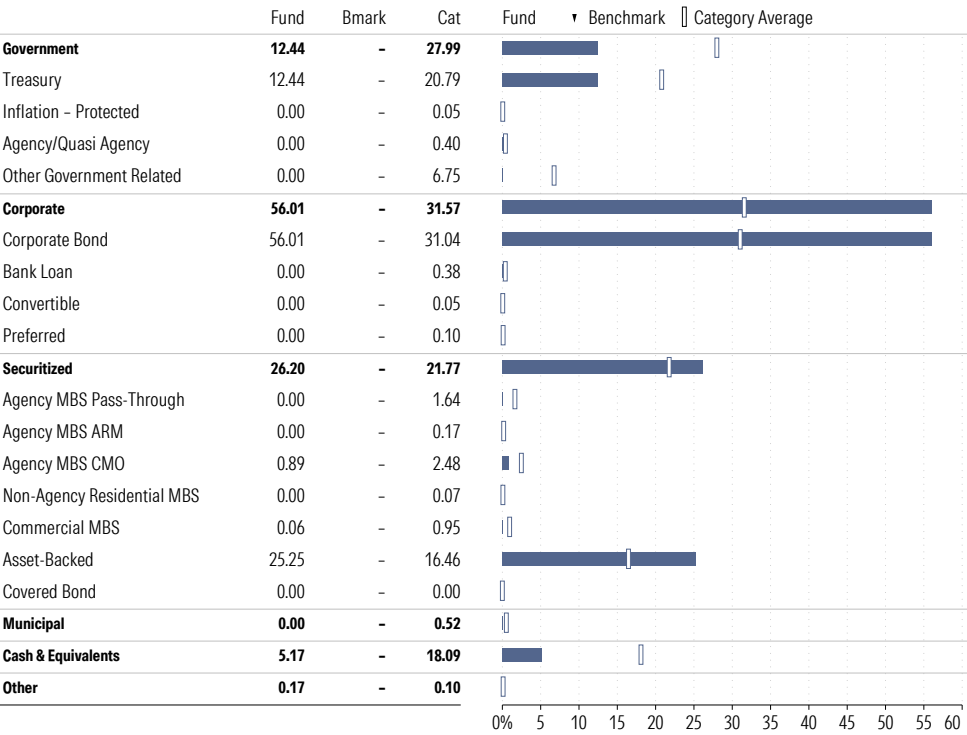
