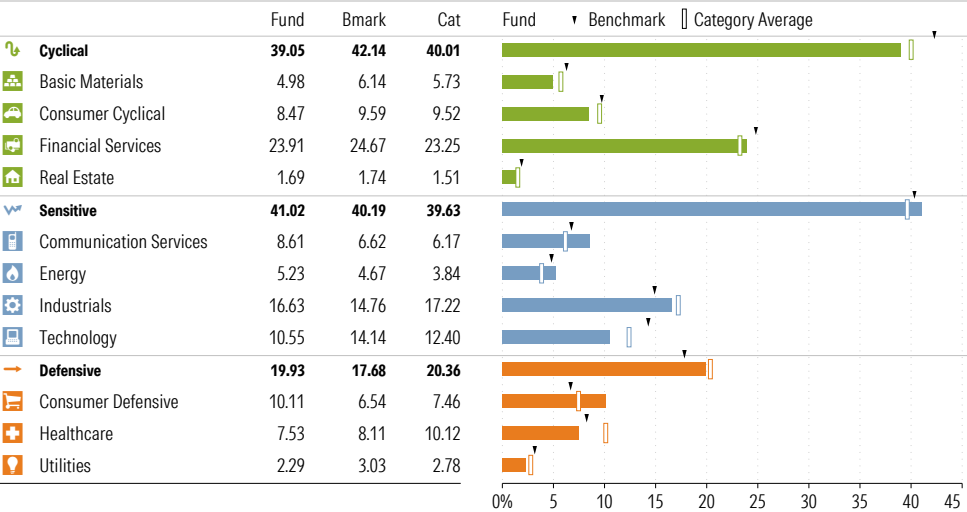

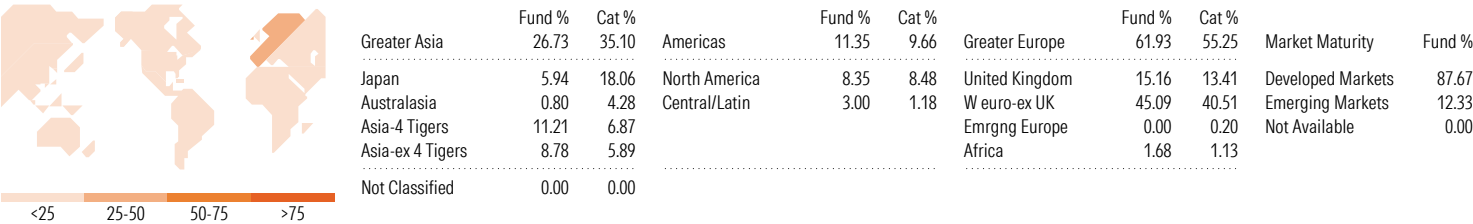

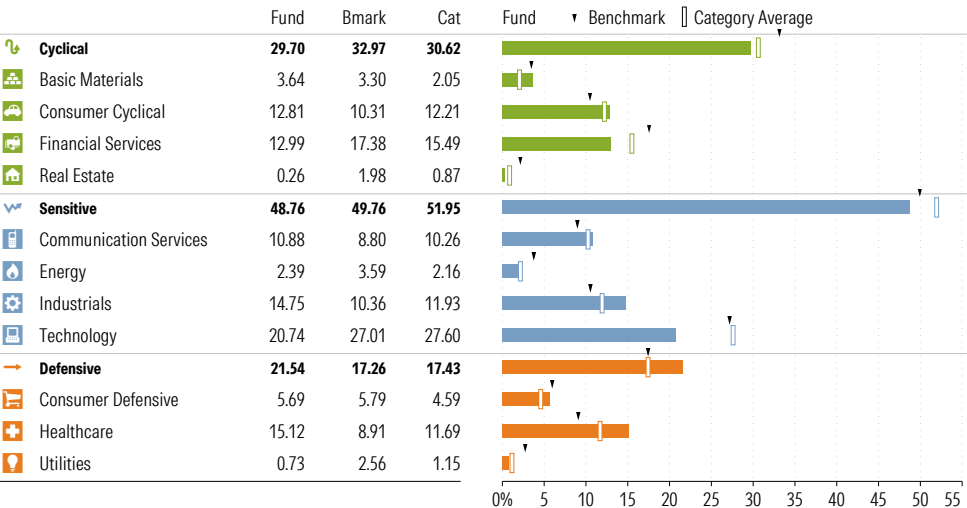

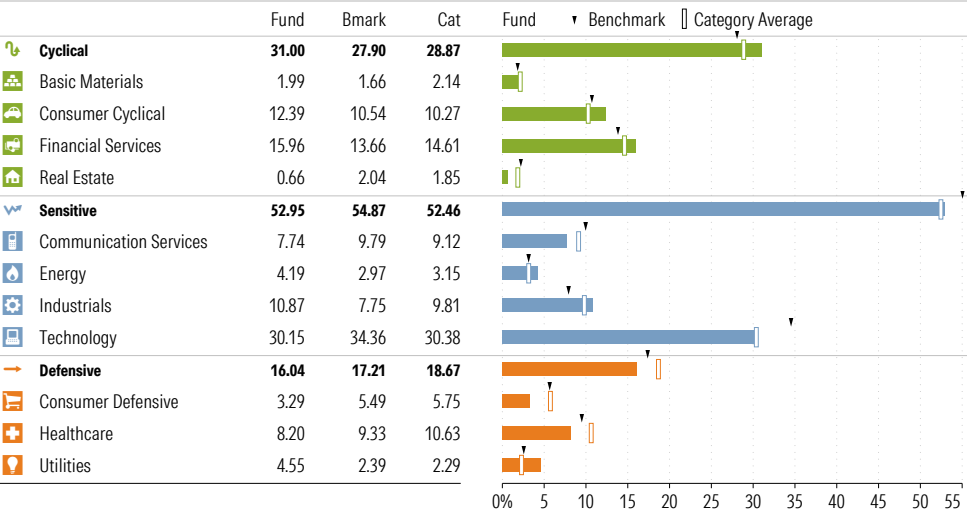

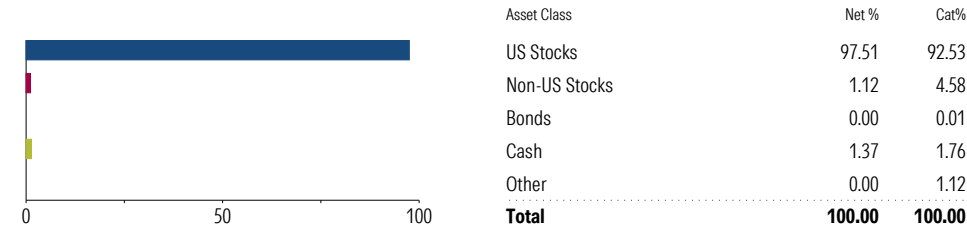

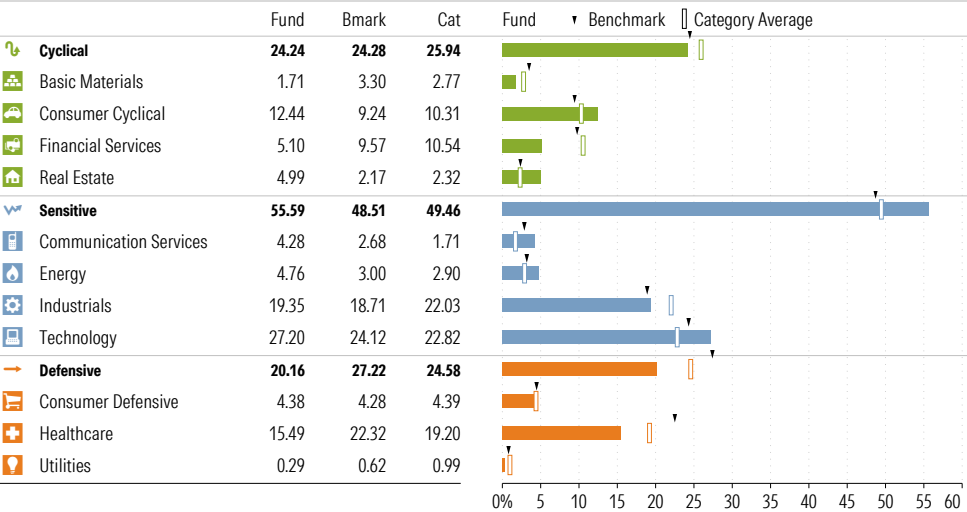

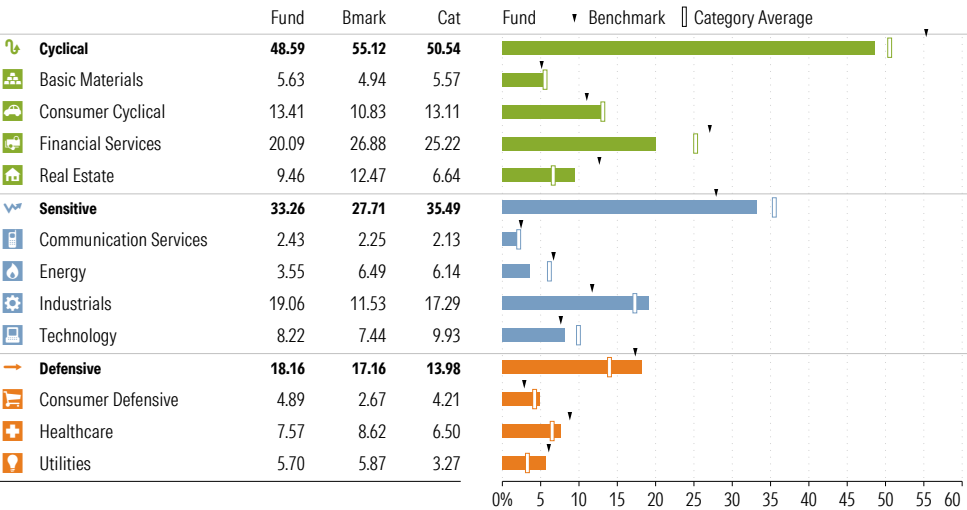

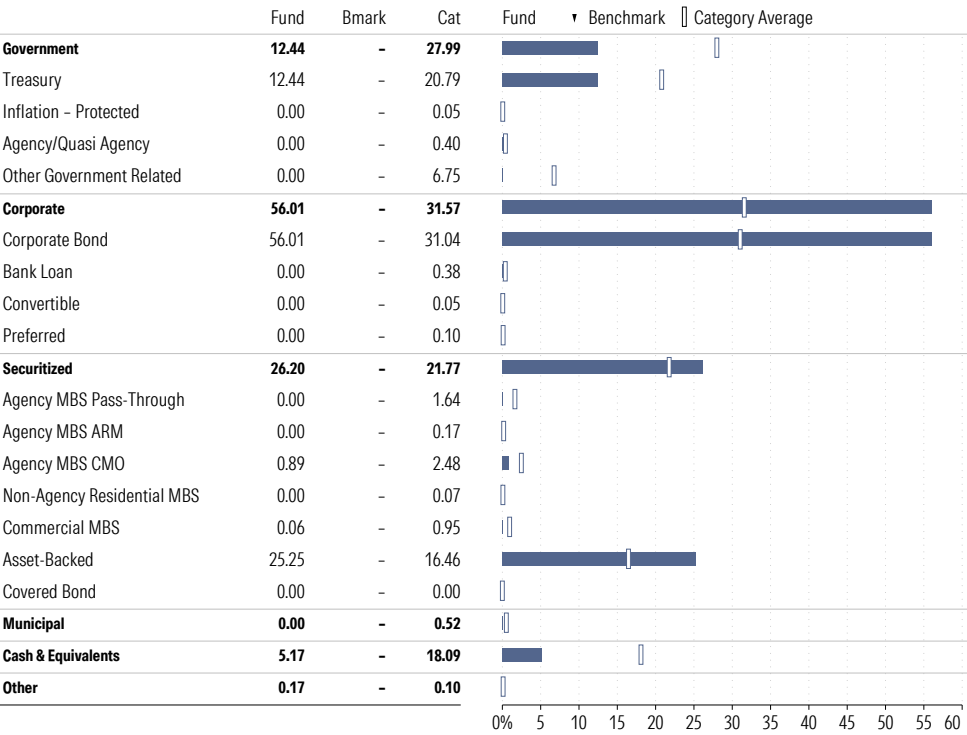

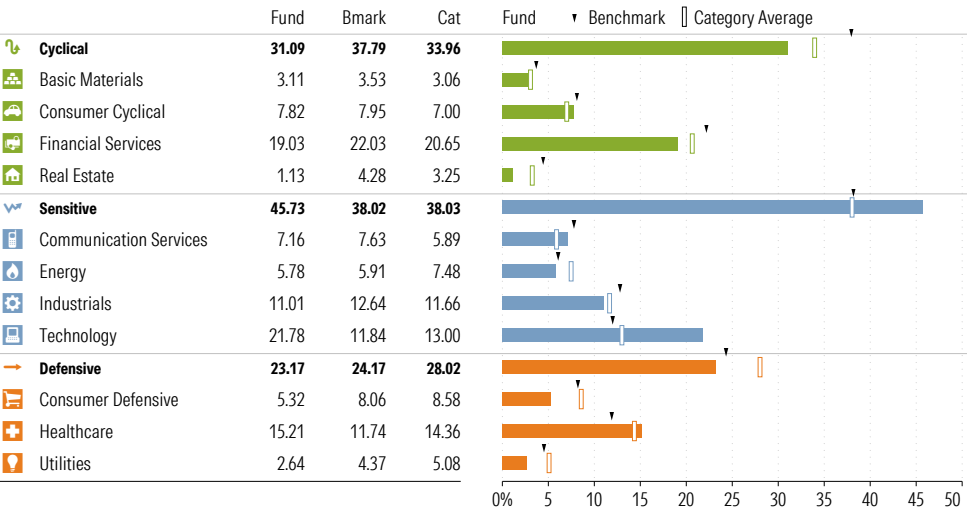
Style Breakdown
