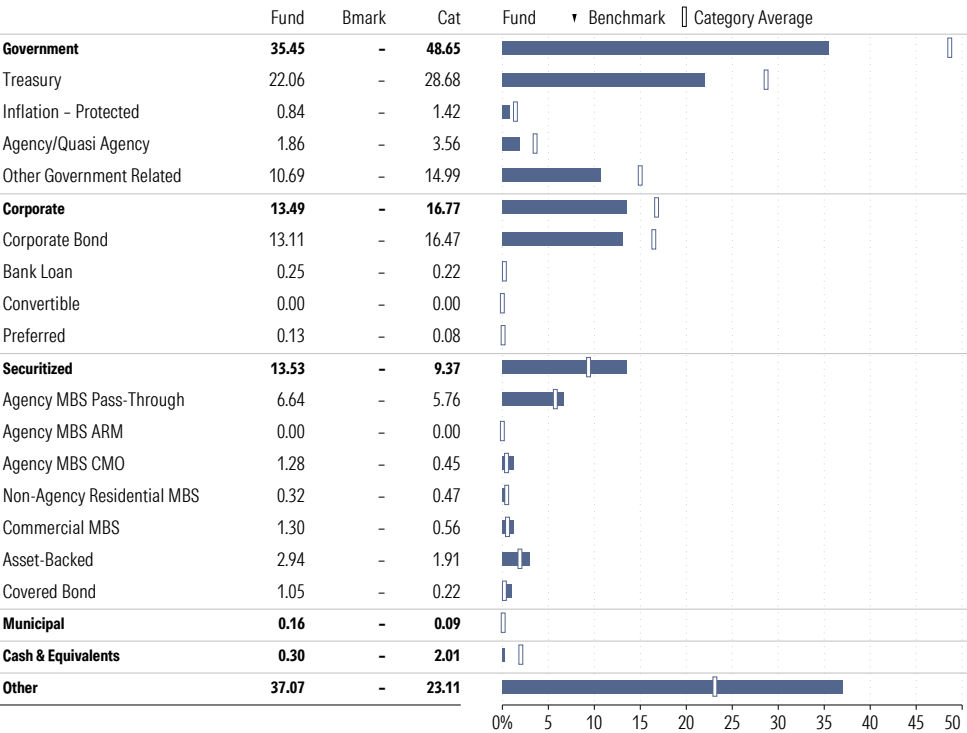

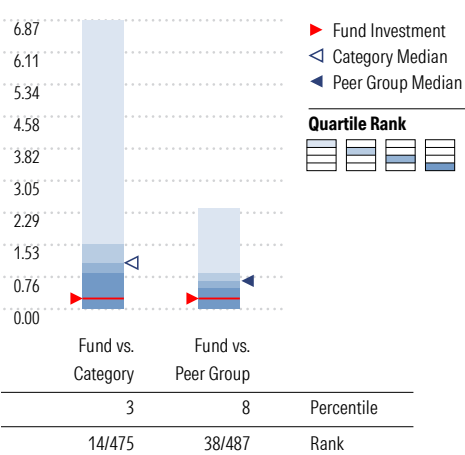

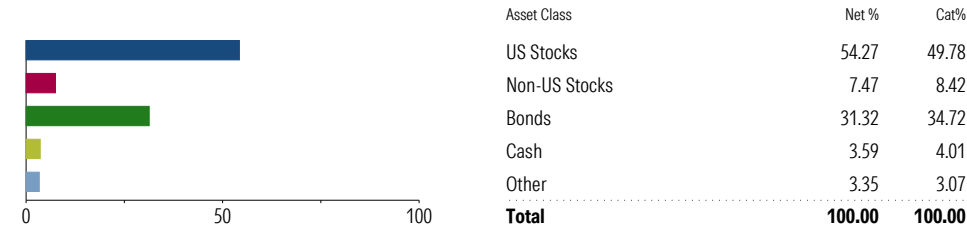

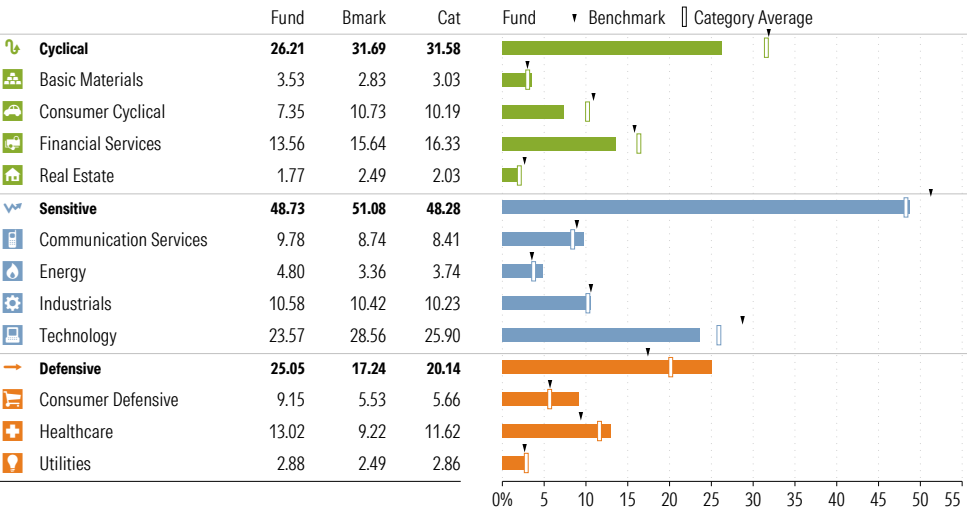

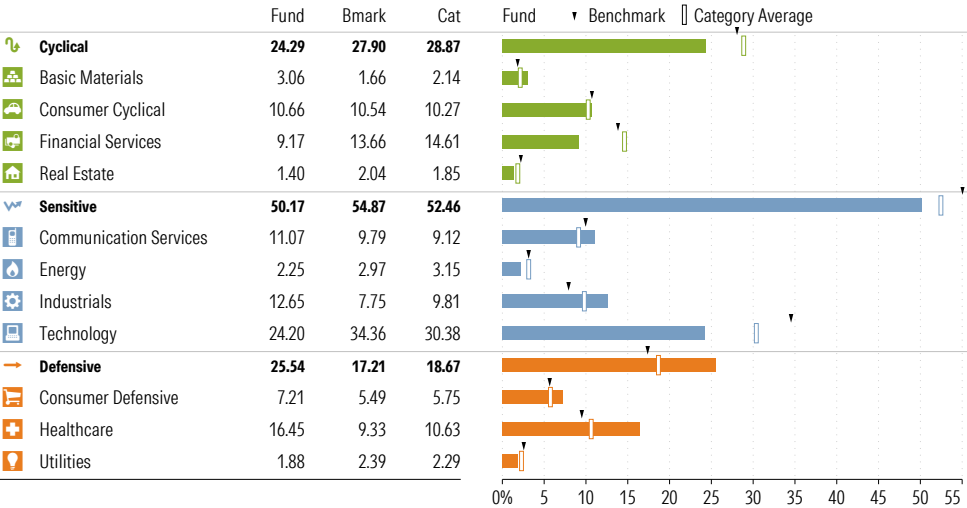

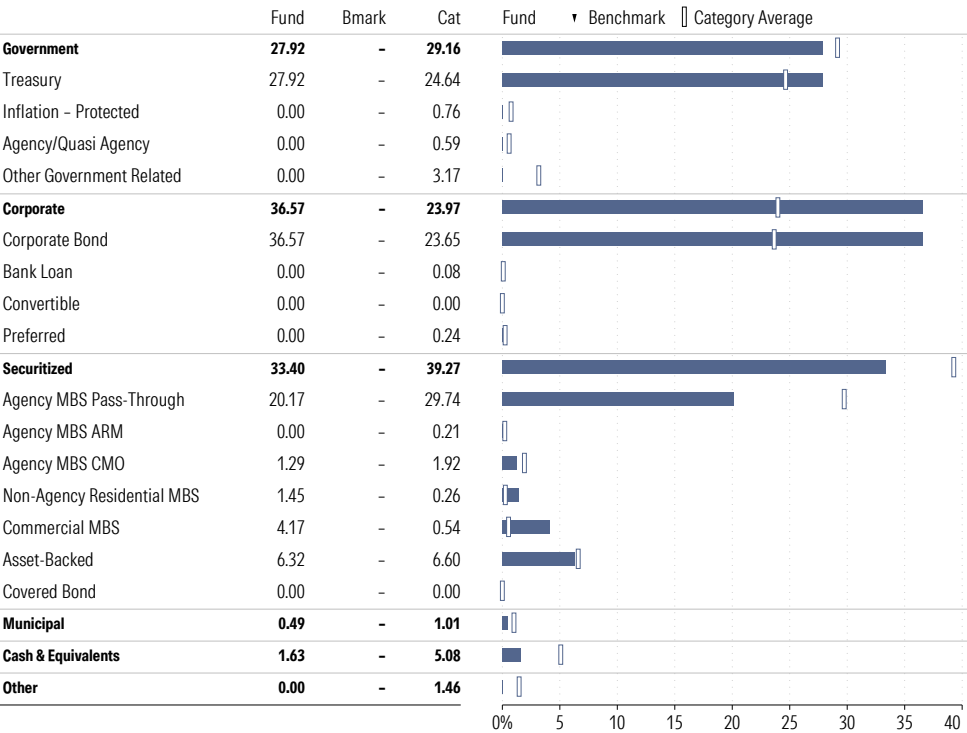

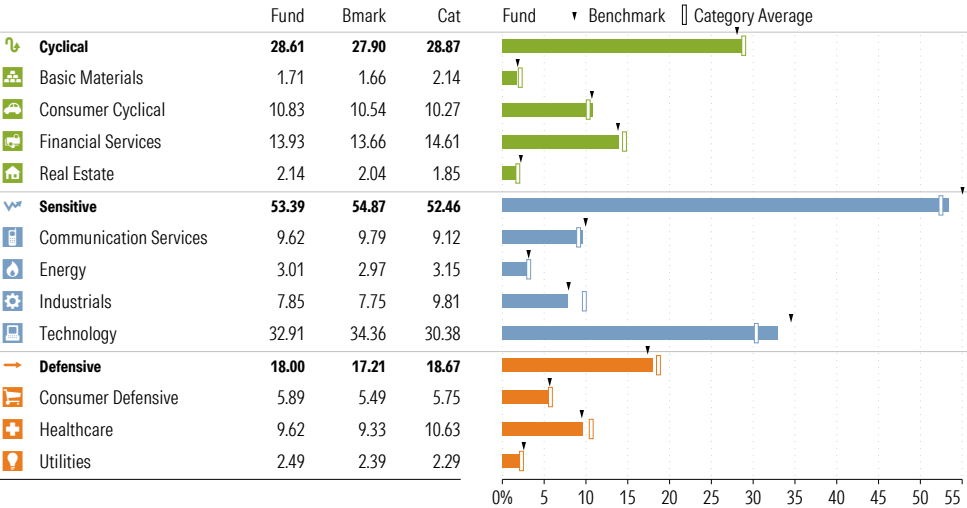
Style Breakdown

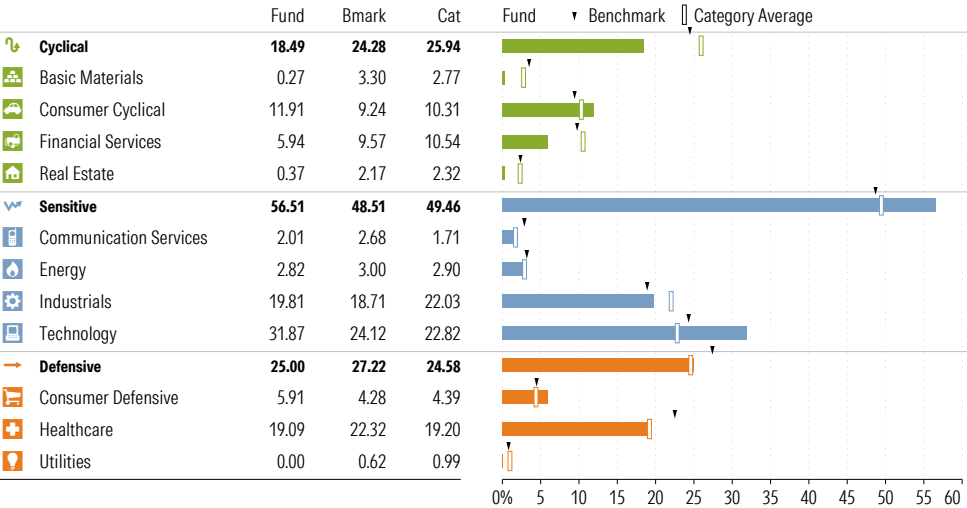

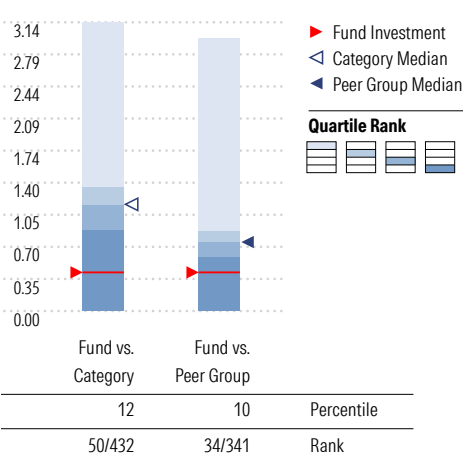

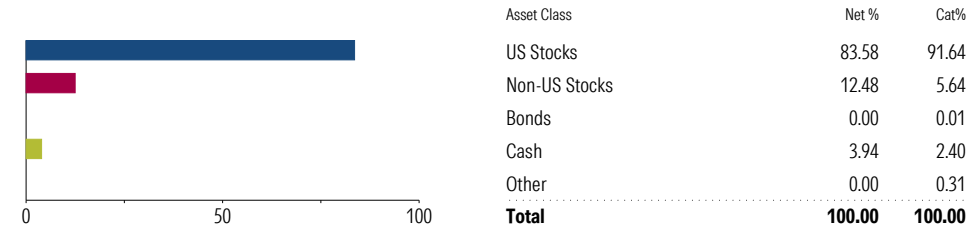

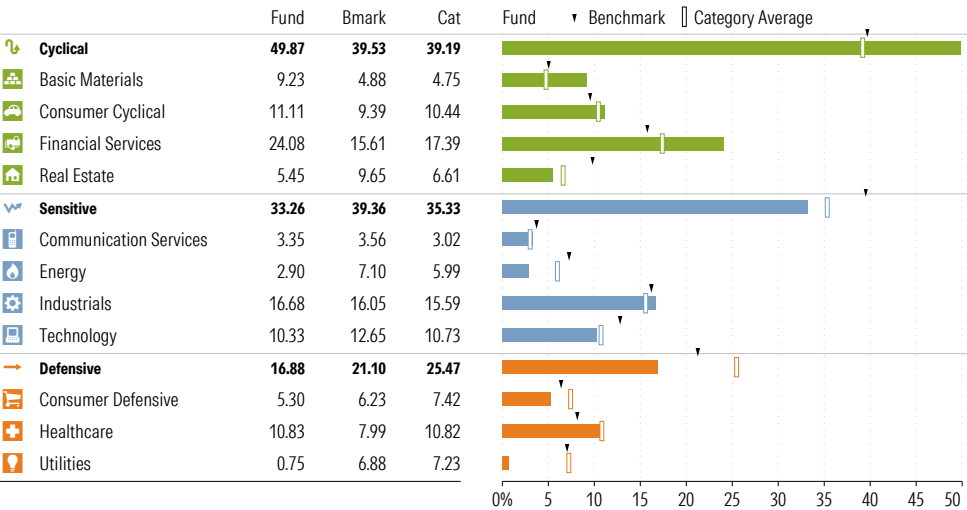
Style Breakdown

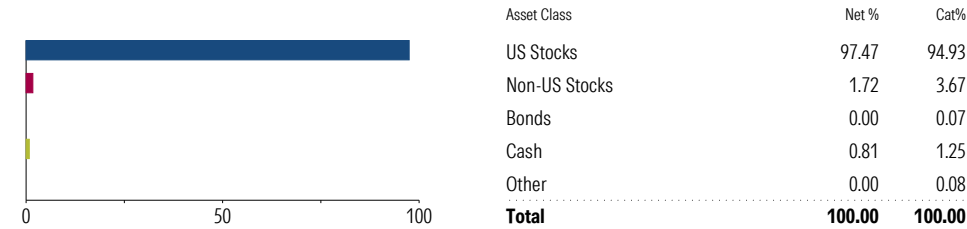

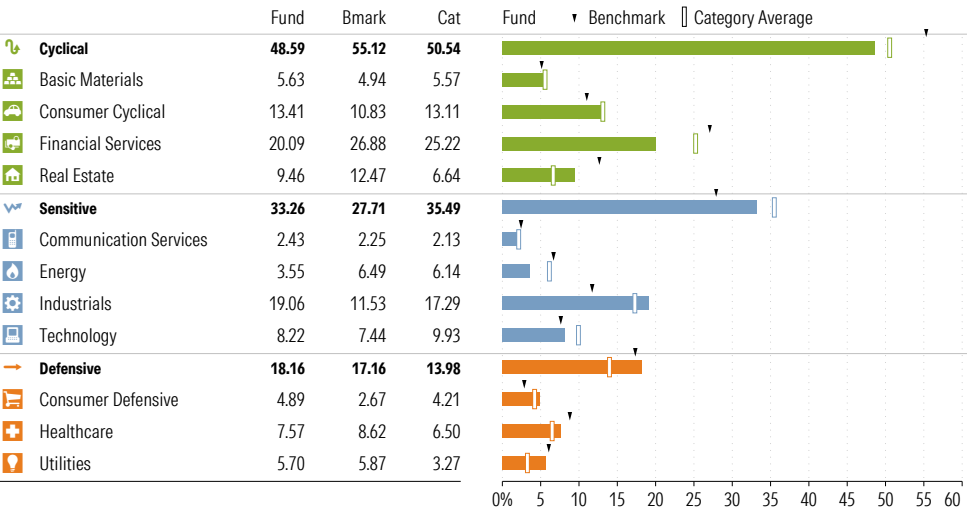

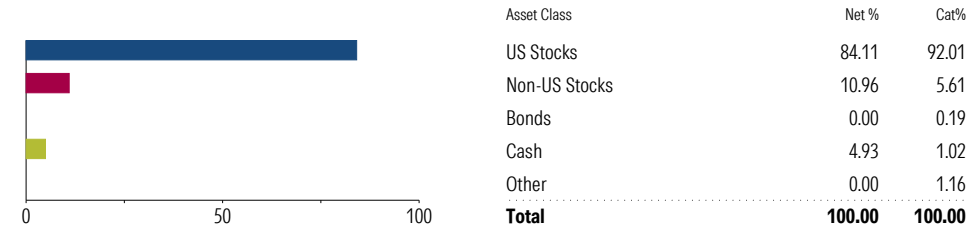

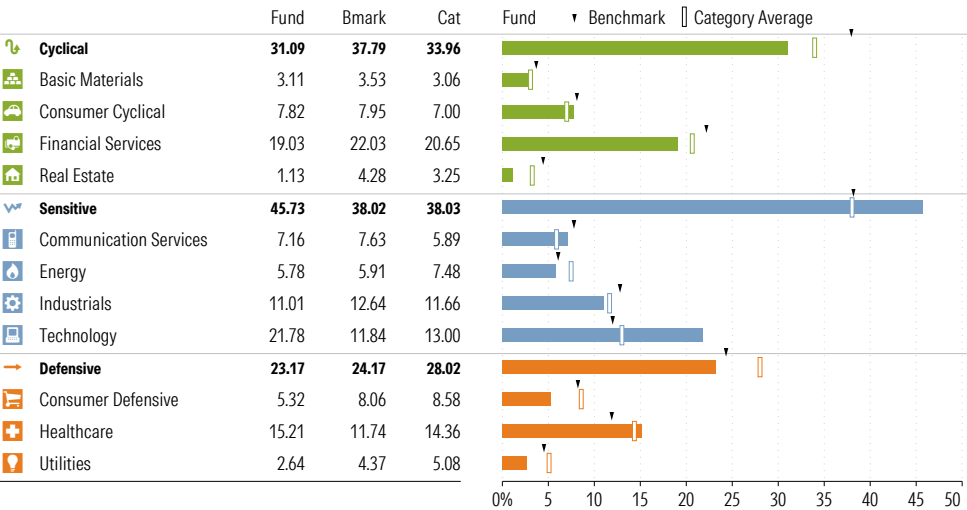
