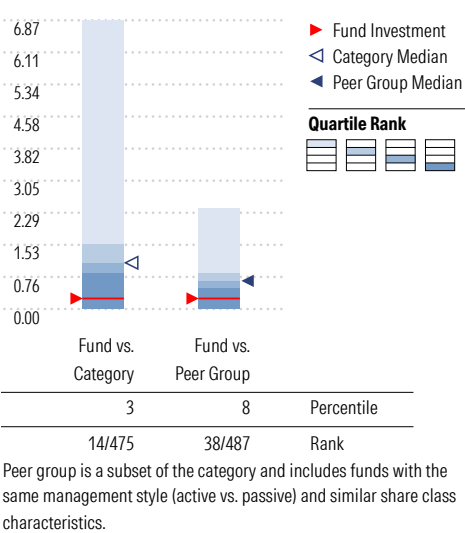

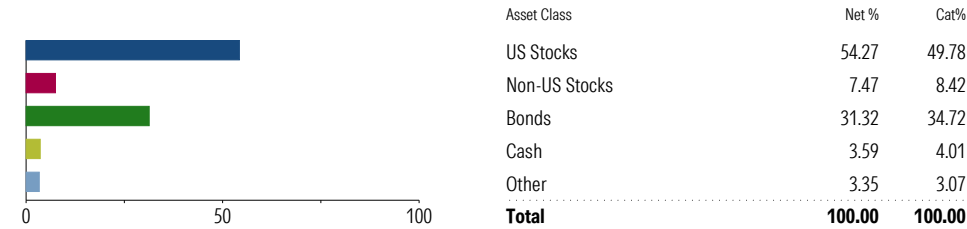

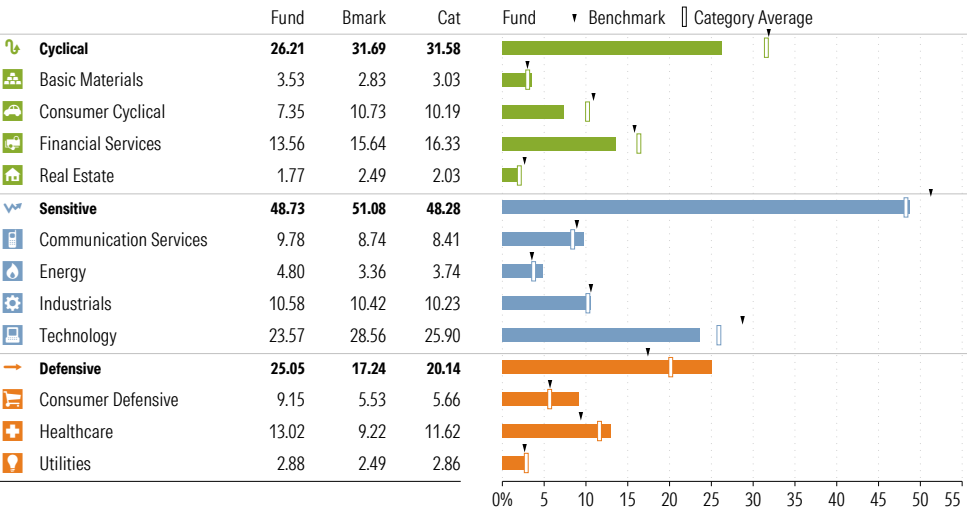

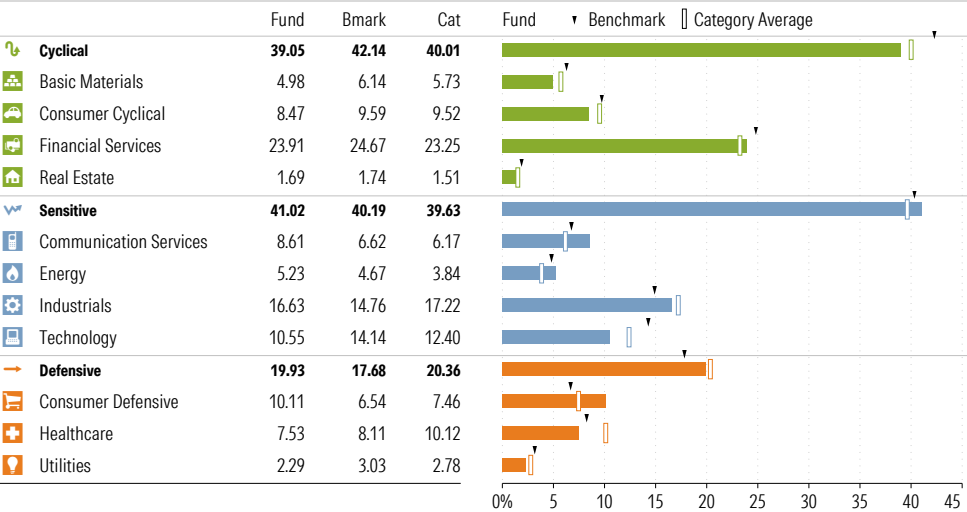

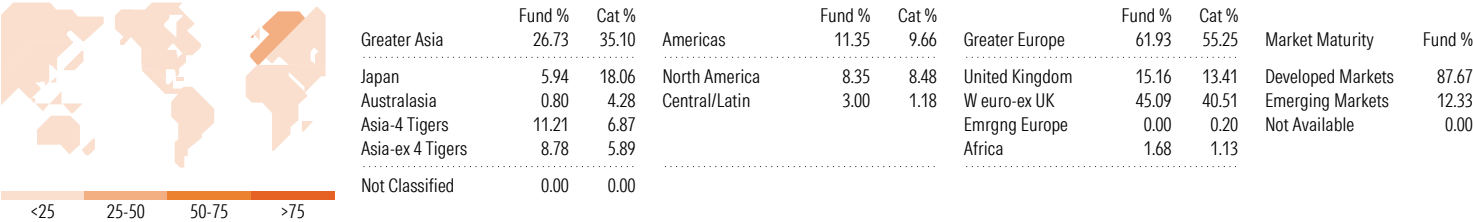
Style Breakdown

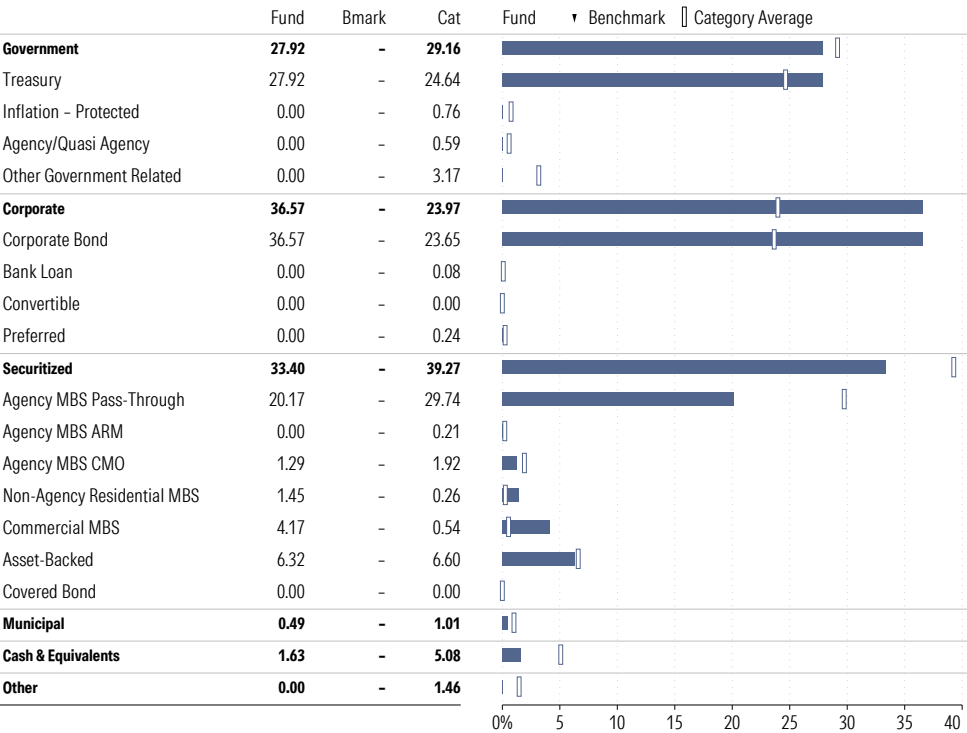
