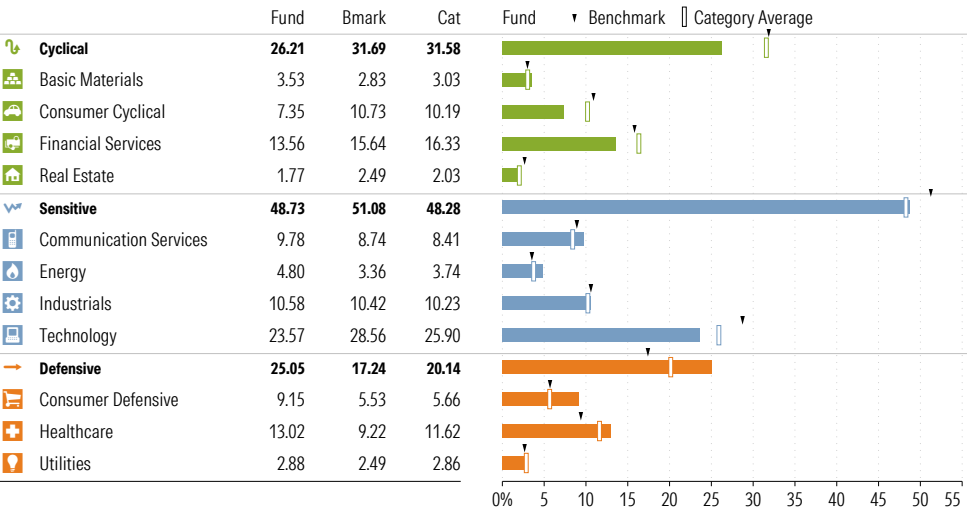

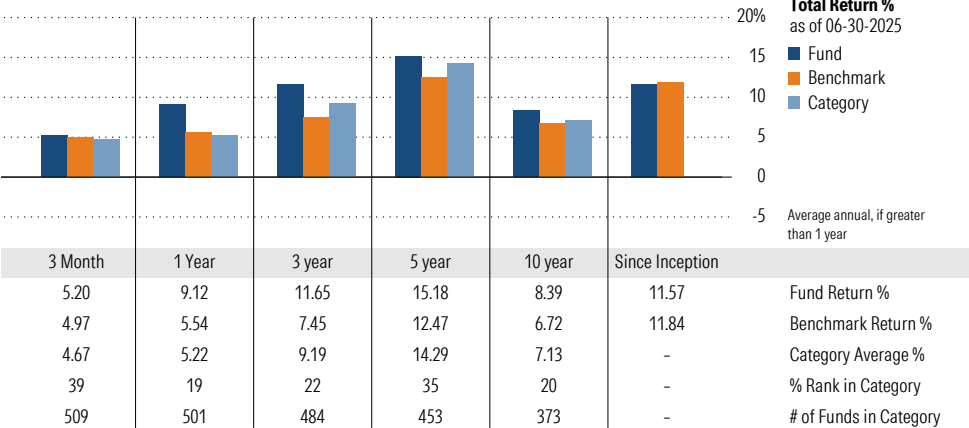

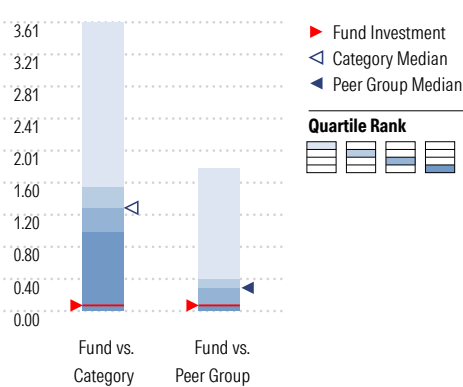

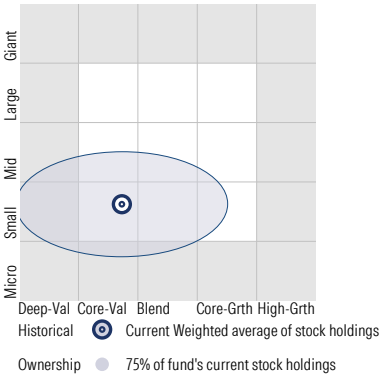

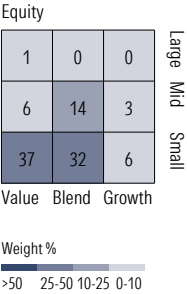

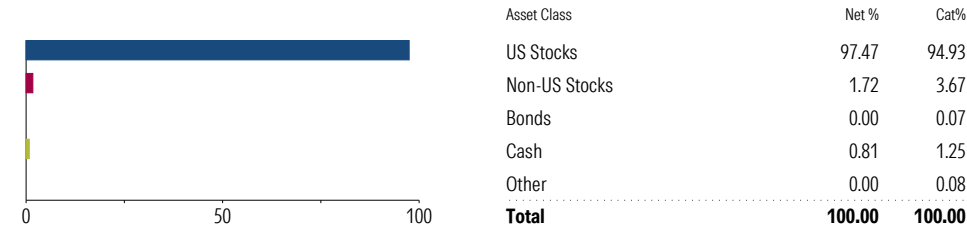

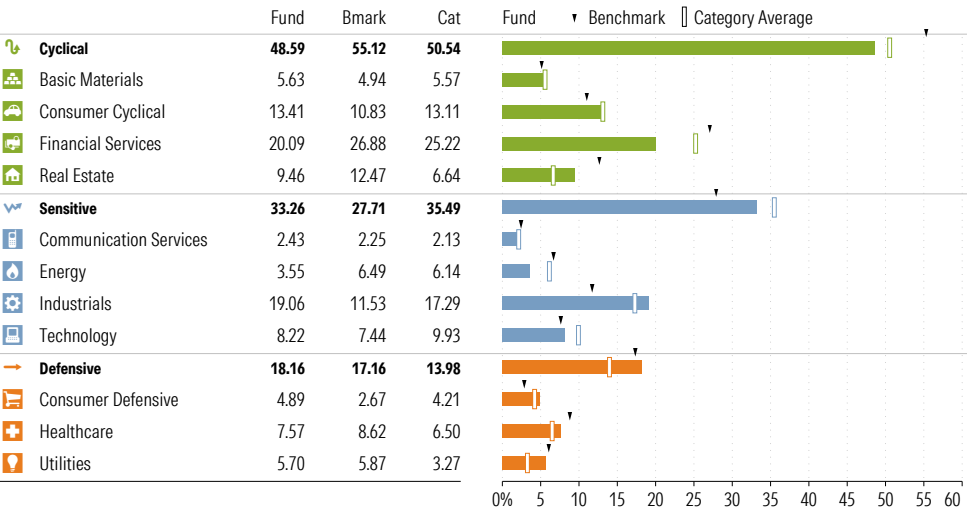
Style Breakdown

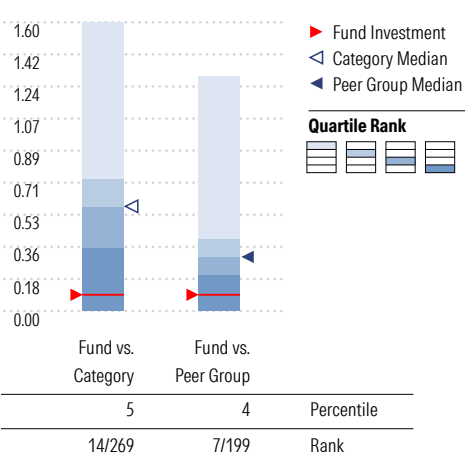

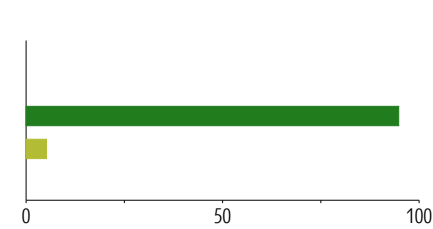

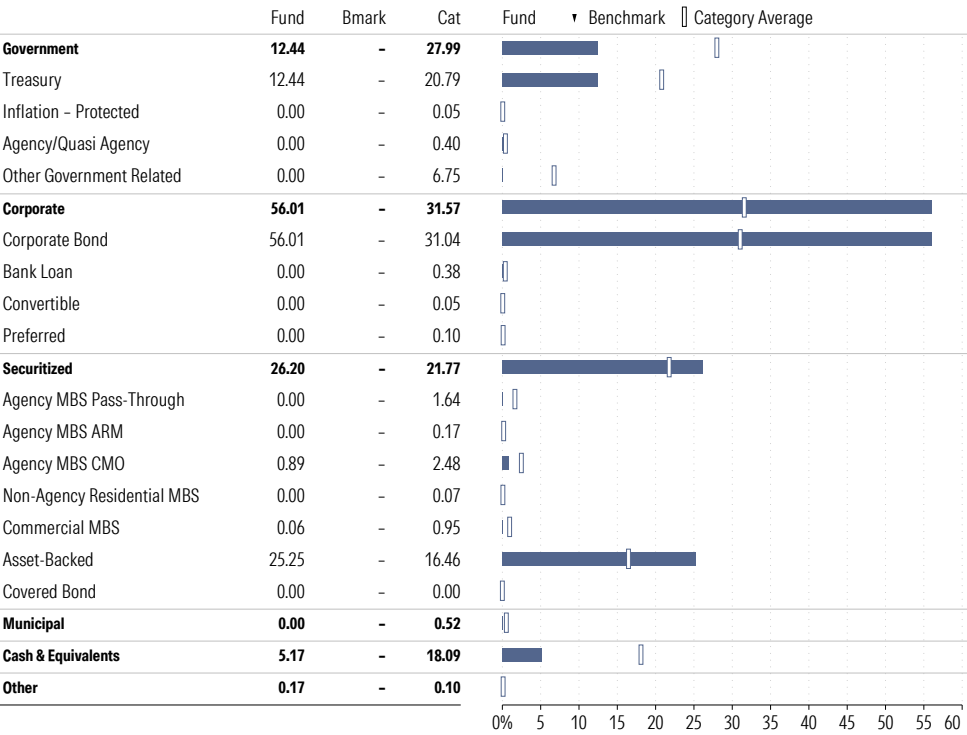
