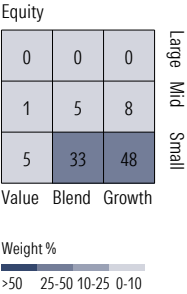

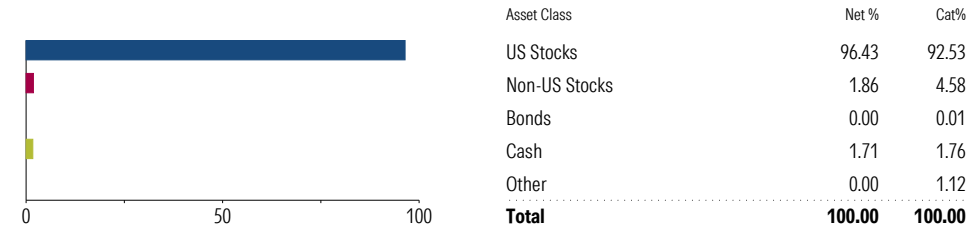

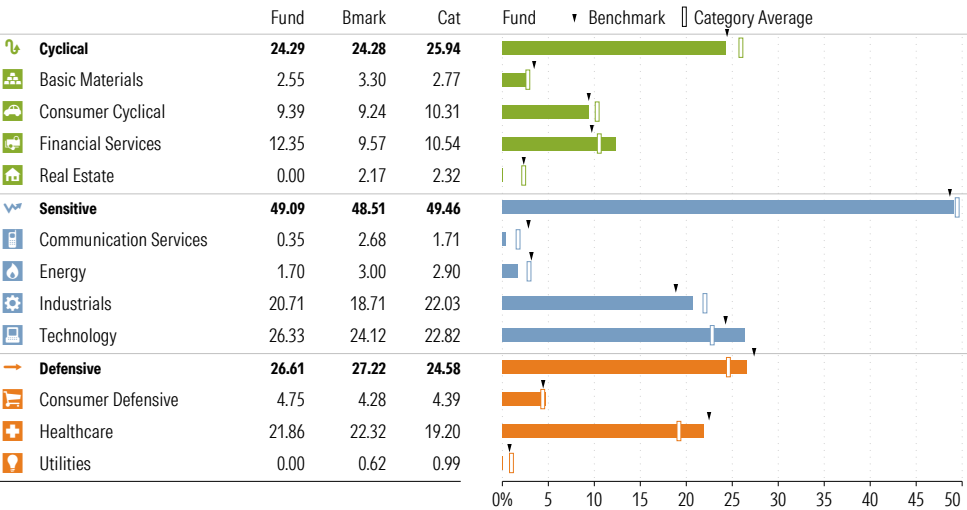

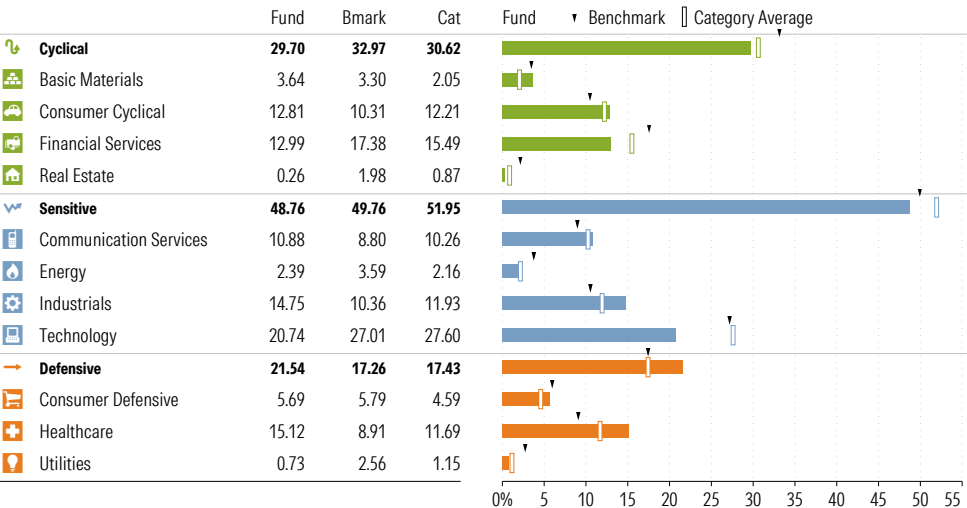

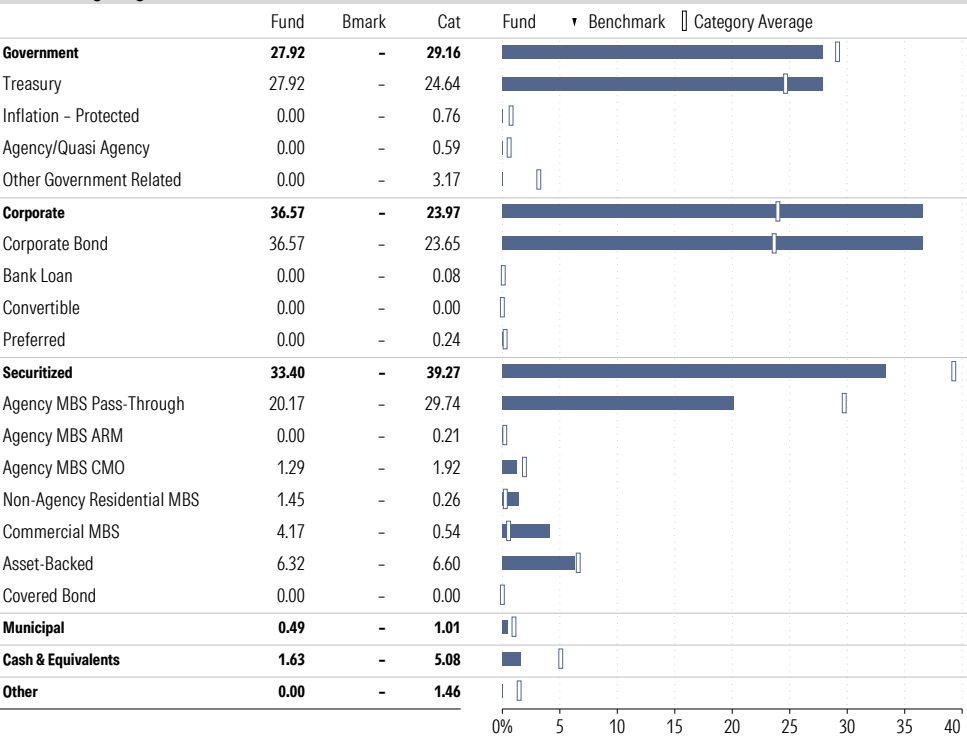

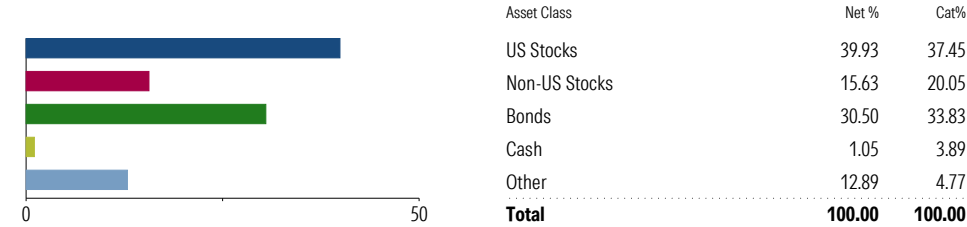

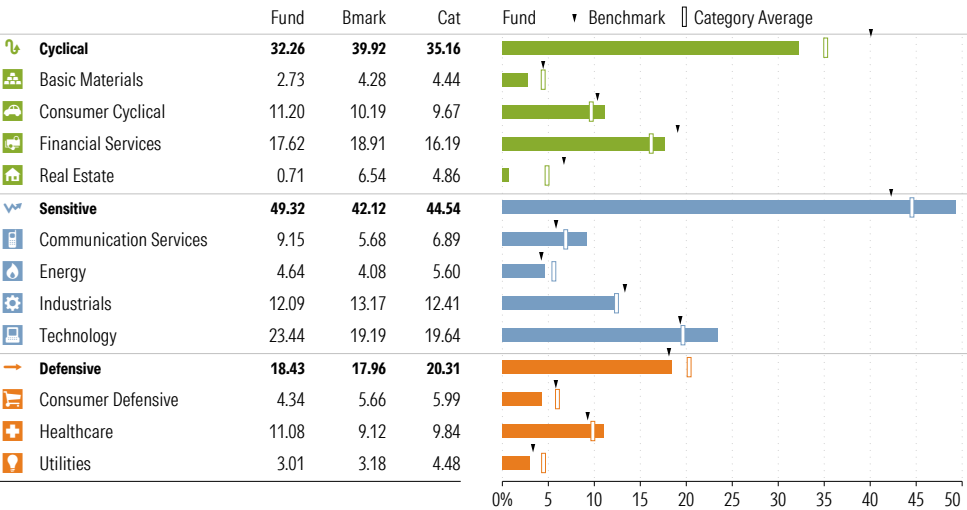

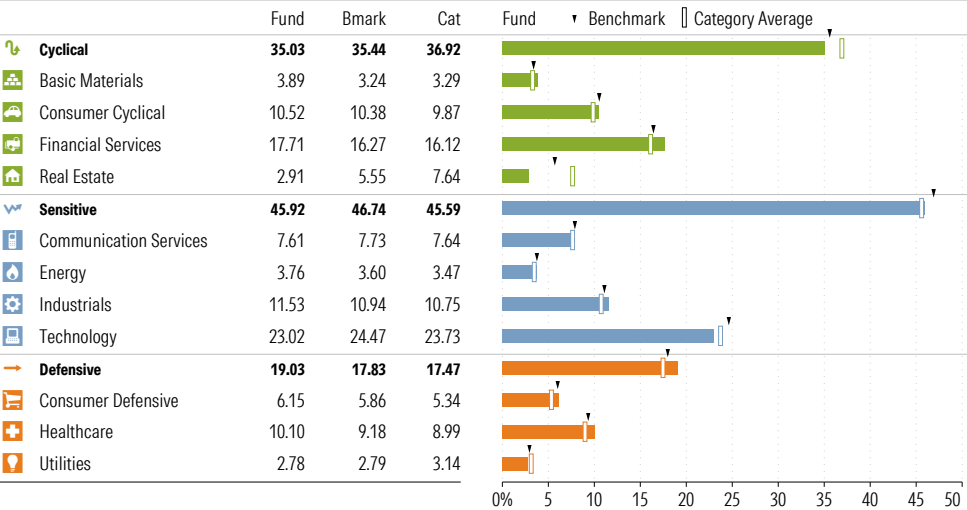
Style Breakdown
