

This is not surprising, given that part of the equity bucket is dedicated to a thematic sleeve, that can lead to different parts of the stock market depending on which themes are in play. But, as a broad, global allocation fund, we are not concerned with this screen failure.




Asset Allocation as of 06-30-2025

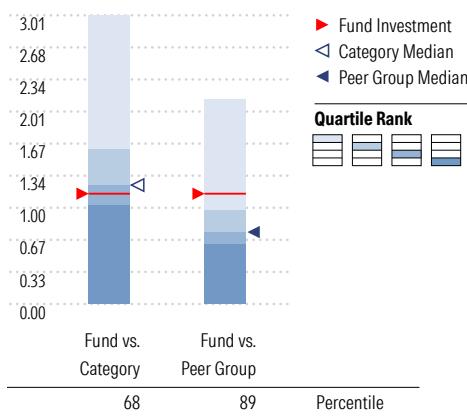

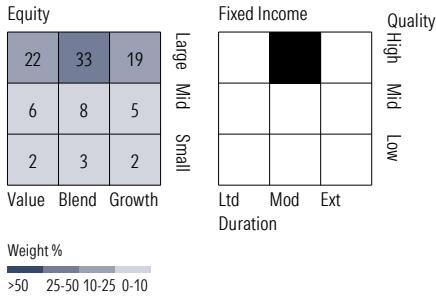
Asset Allocation as of 06-30-2025


Asset Allocation as of 06-30-2025

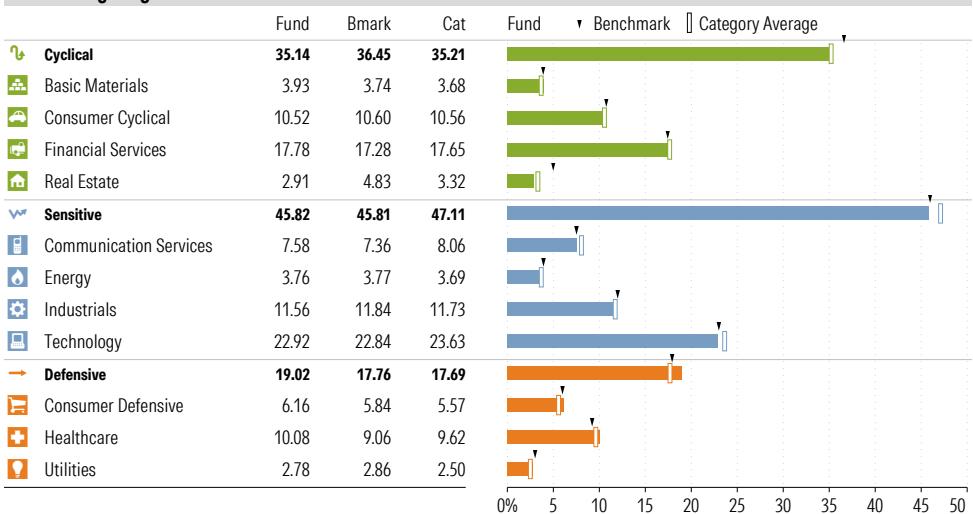


Asset Allocation as of 06-30-2025


Asset Allocation as of 06-30-2025
