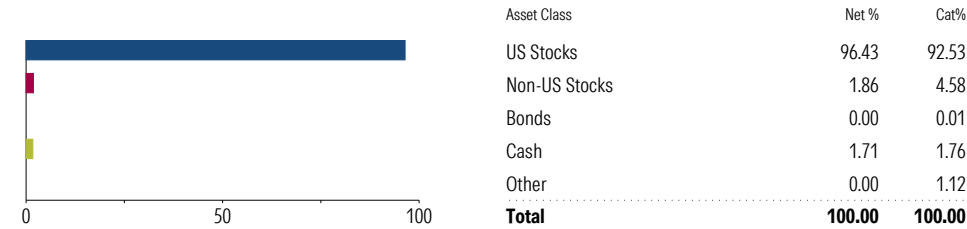

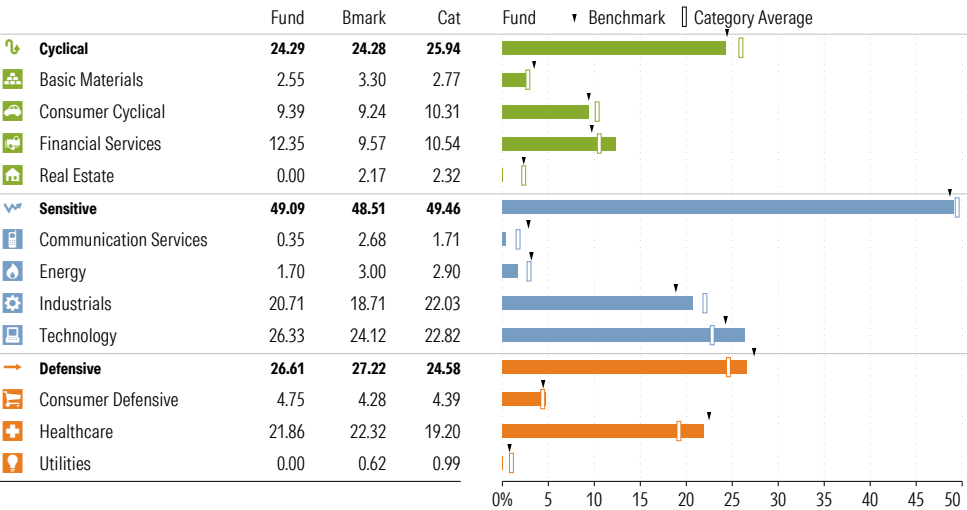

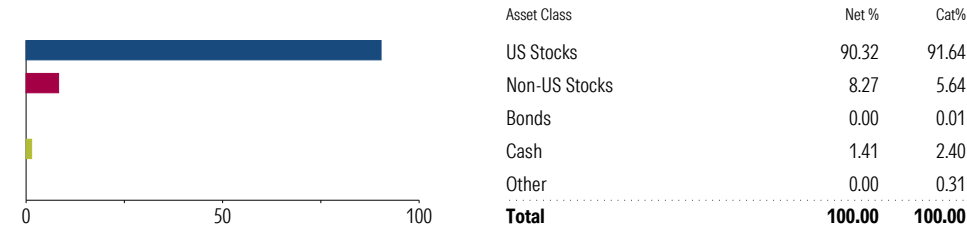

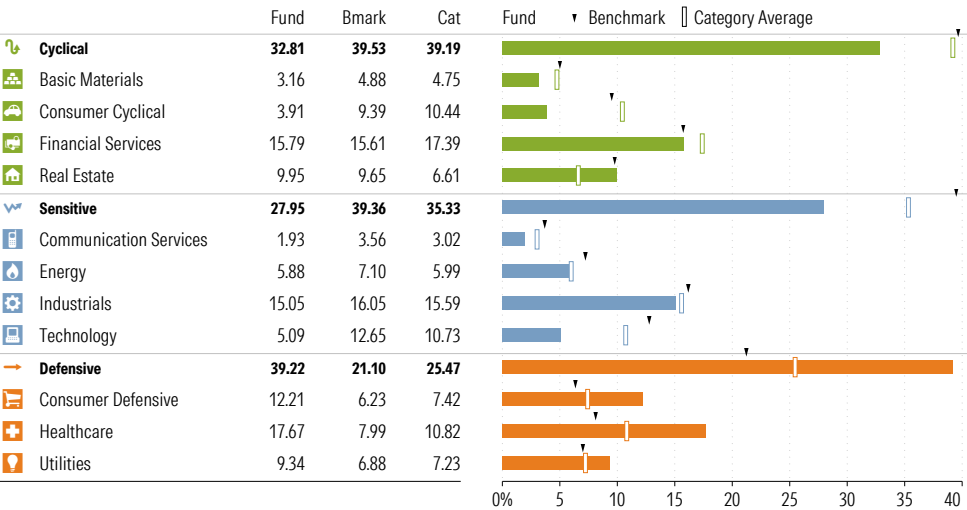

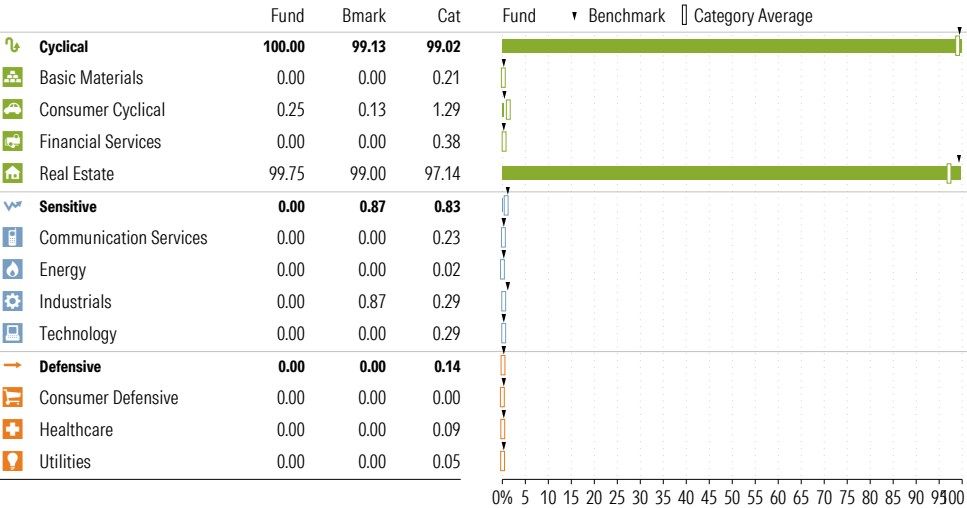

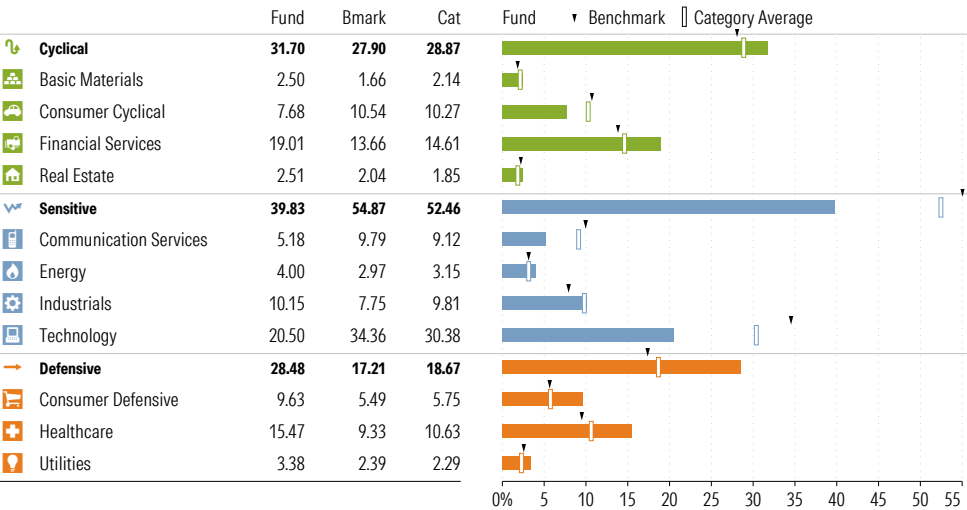

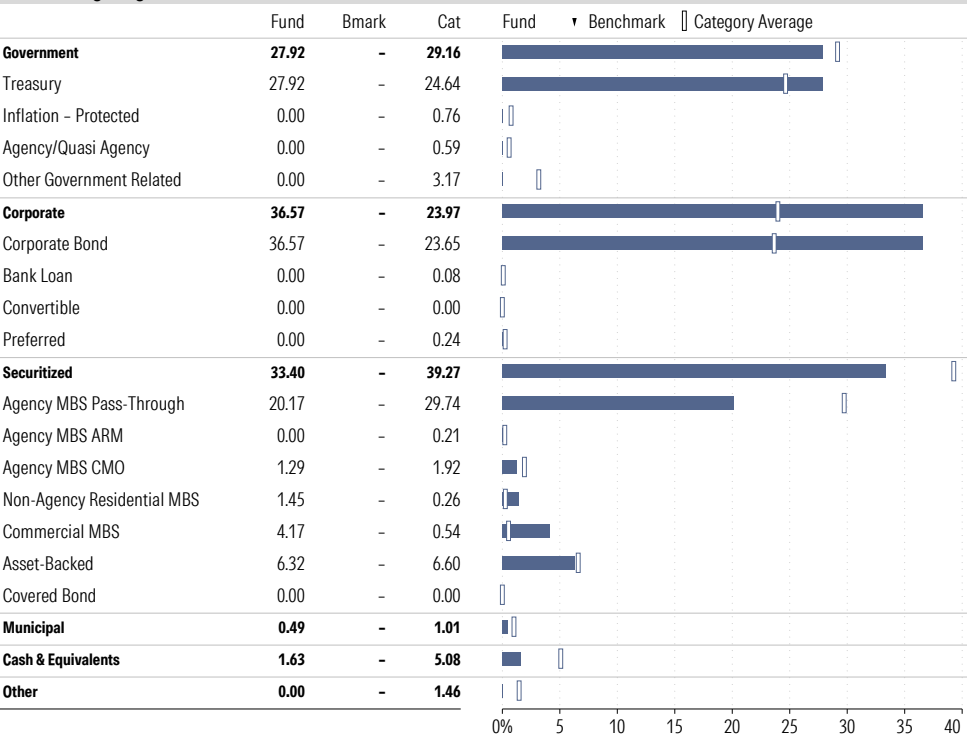

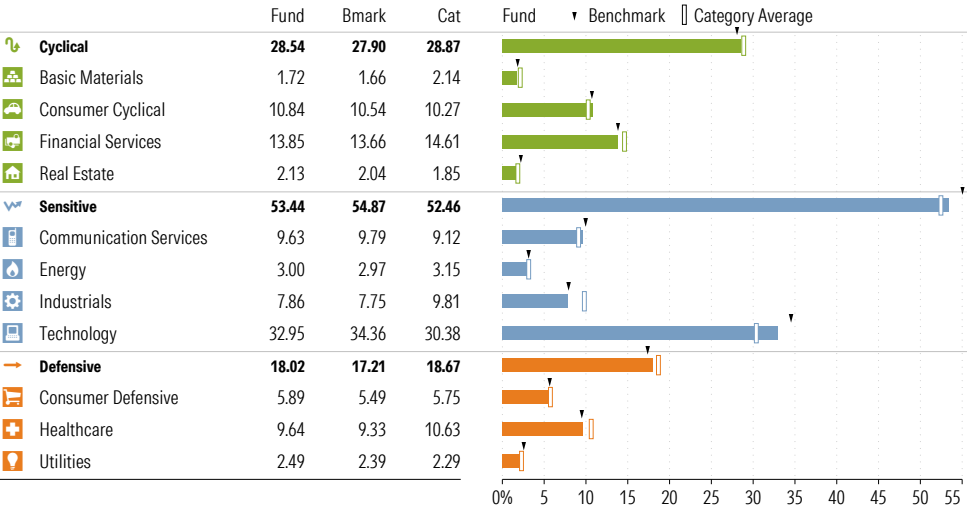

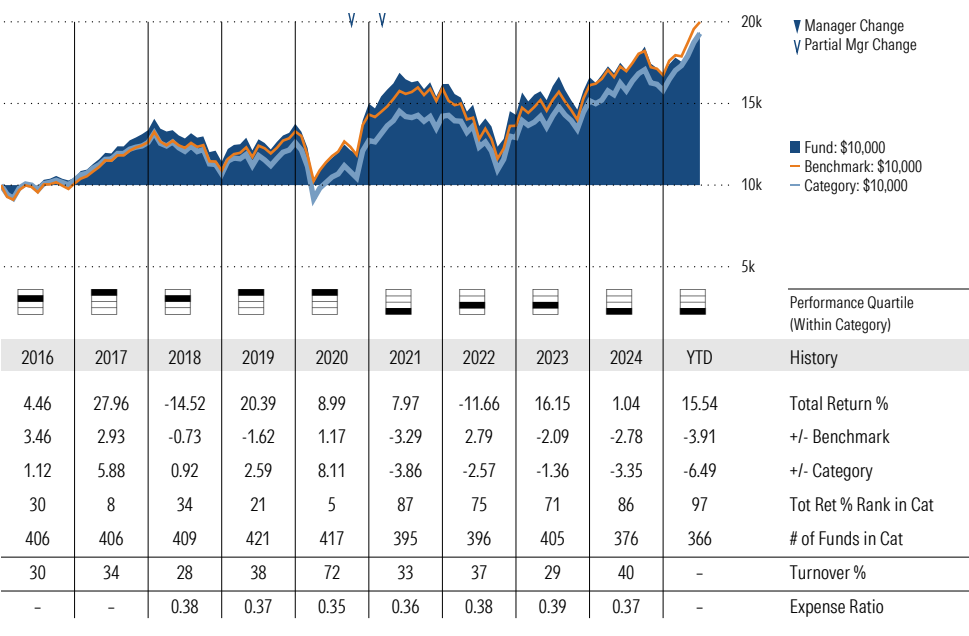
Morningstar Investment Management LLC Analysis

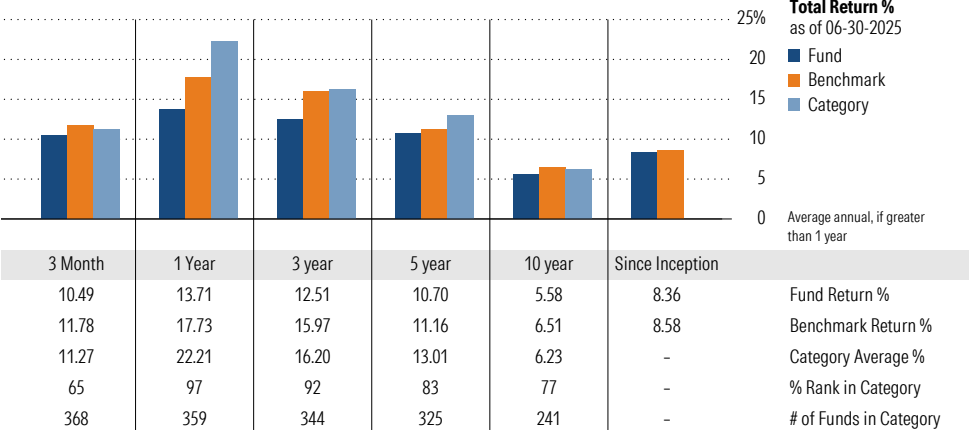

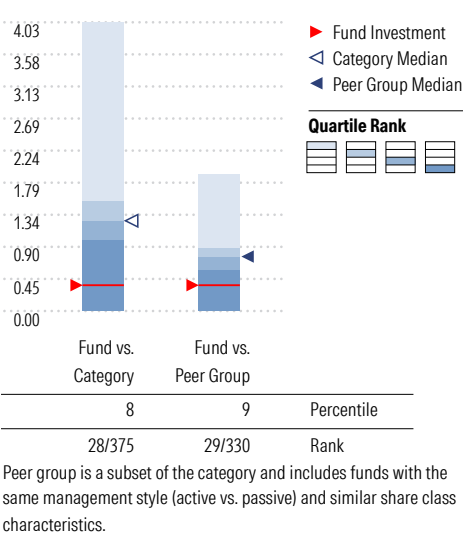
Growth of \$10,000

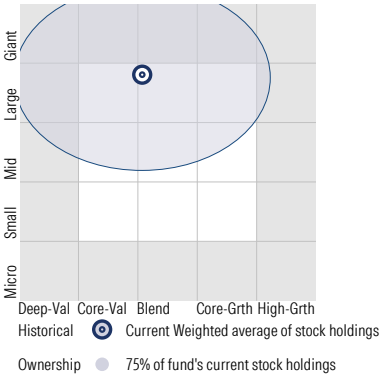

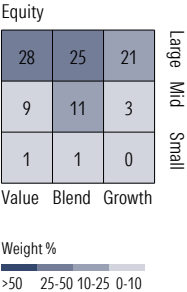

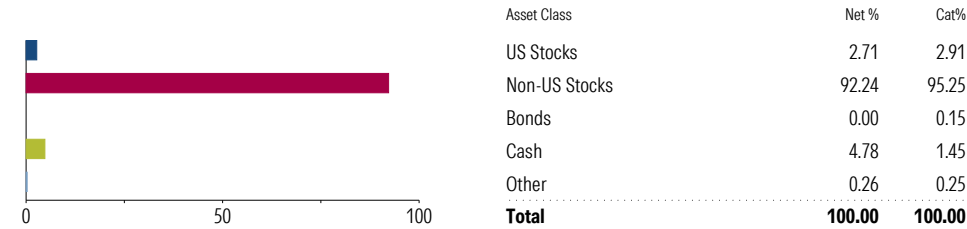

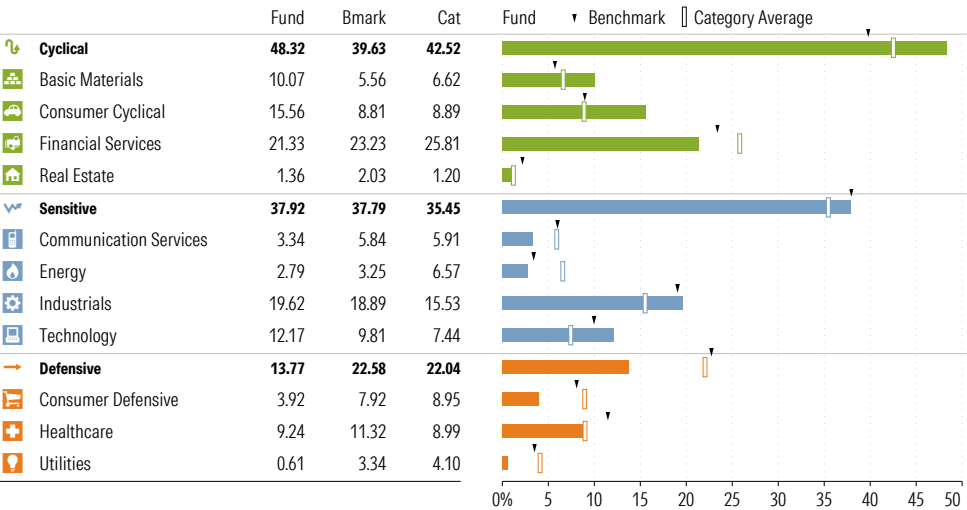
Style Breakdown



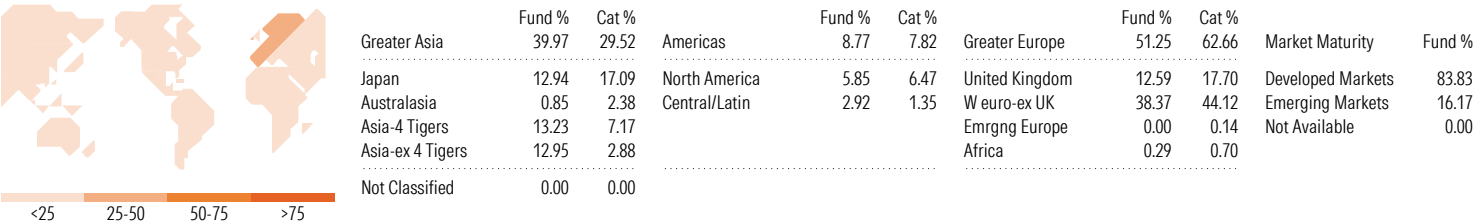
Asset Allocation as of 06-30-2025
