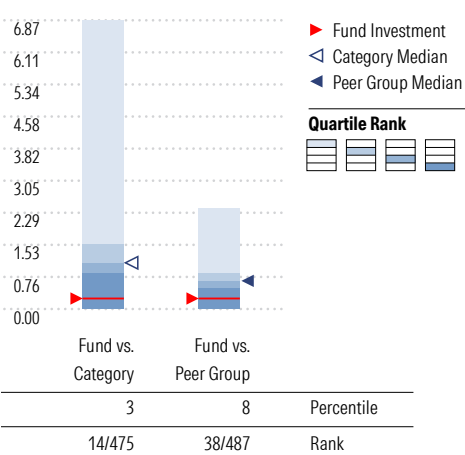

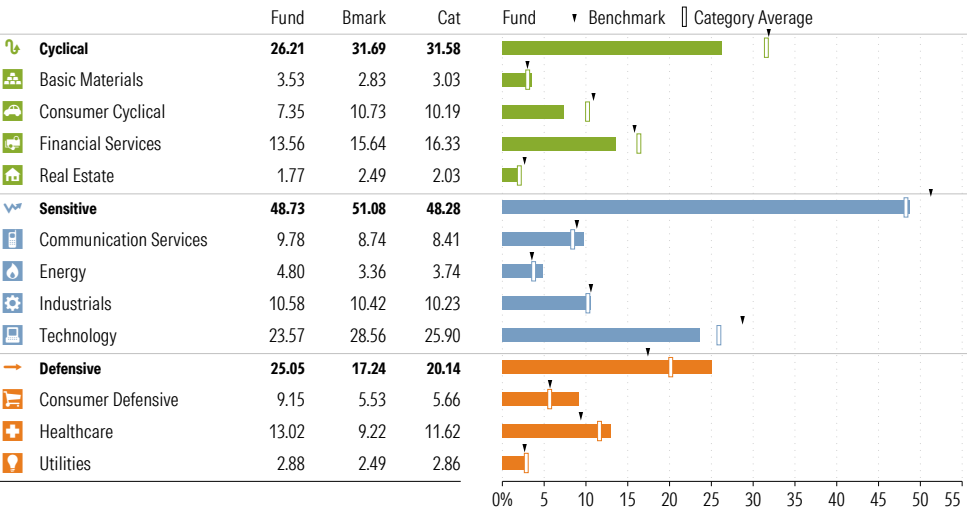

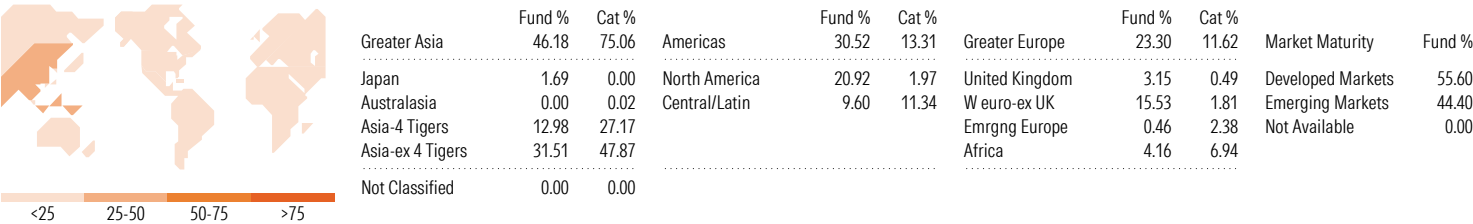

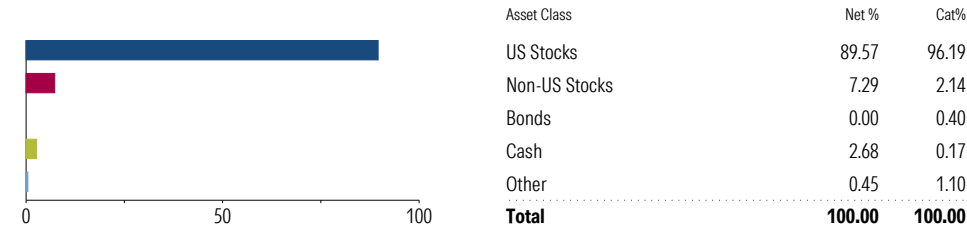

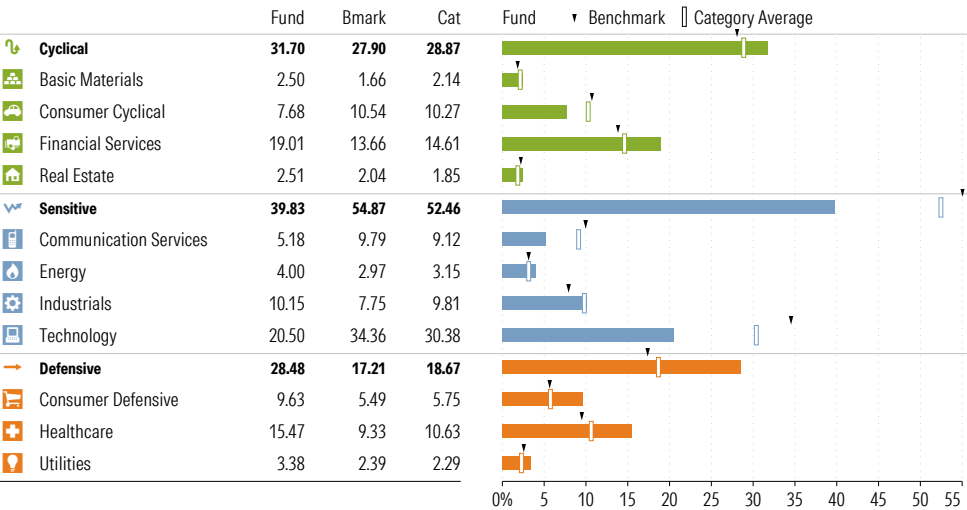
Style Breakdown

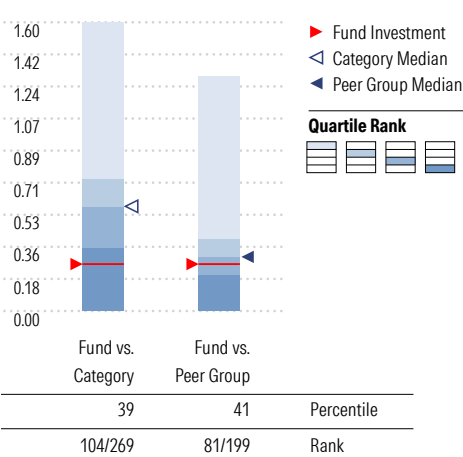

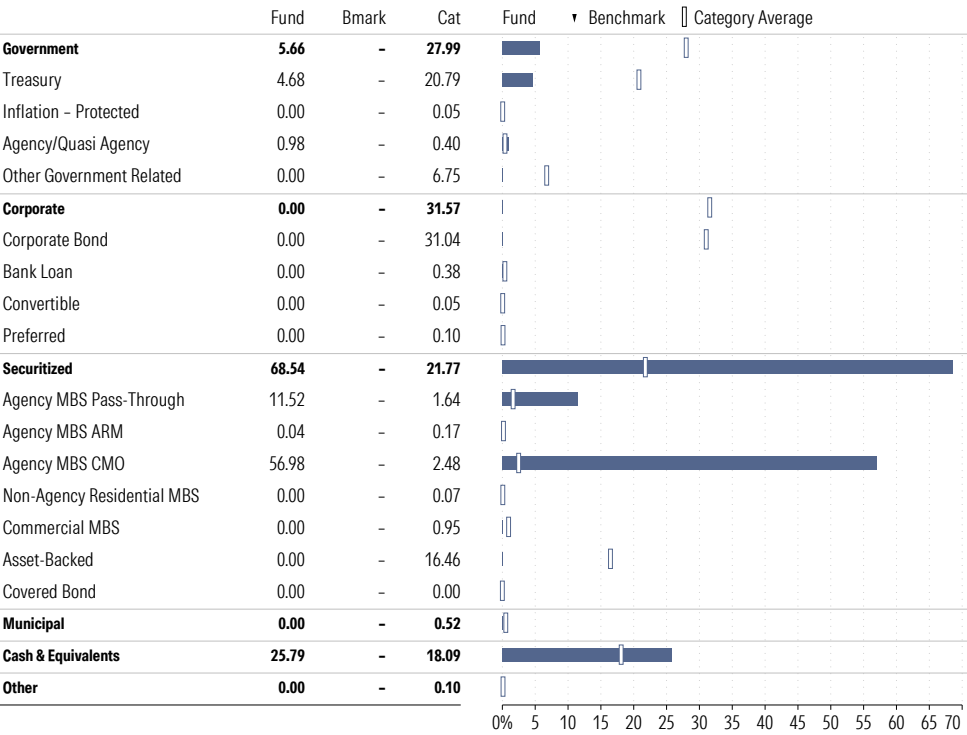

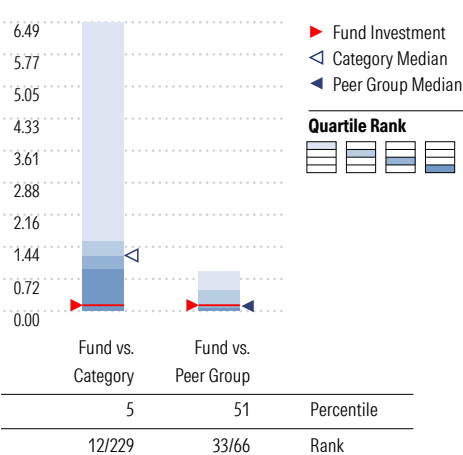

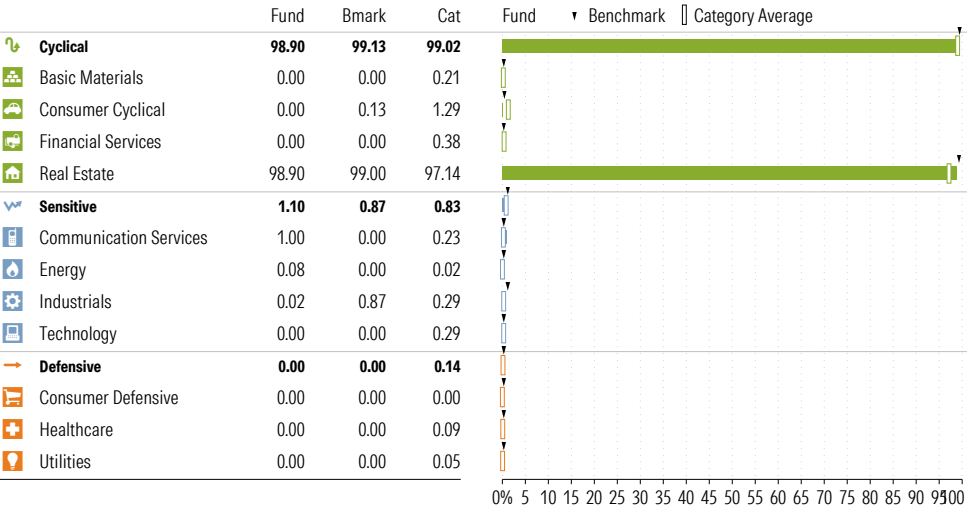

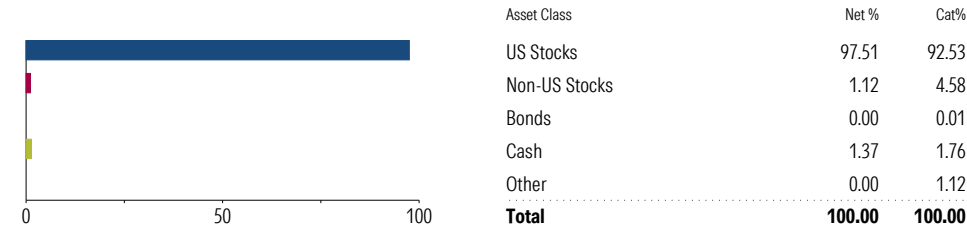

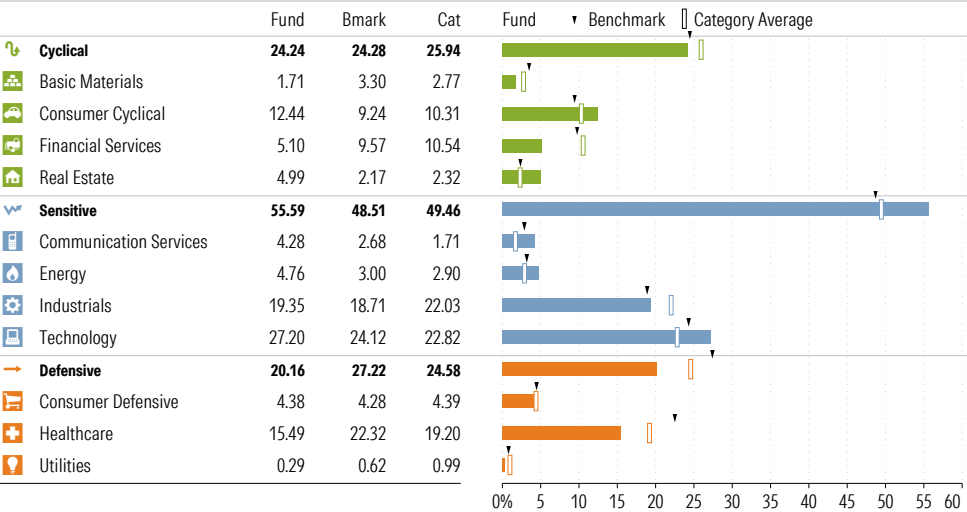

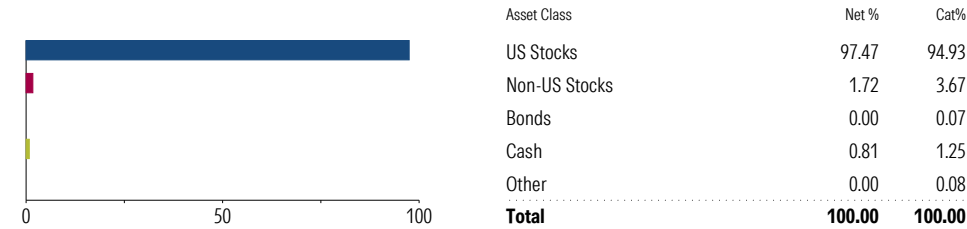

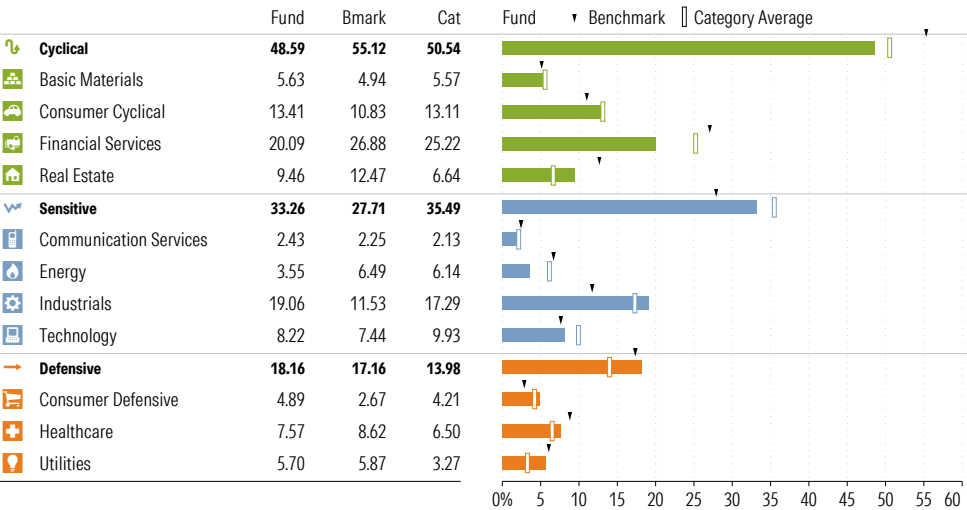
Style Breakdown
