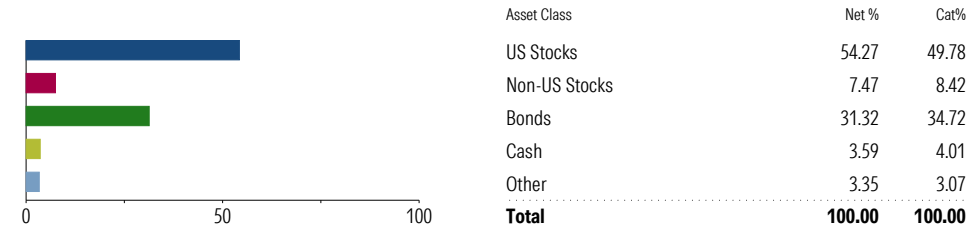

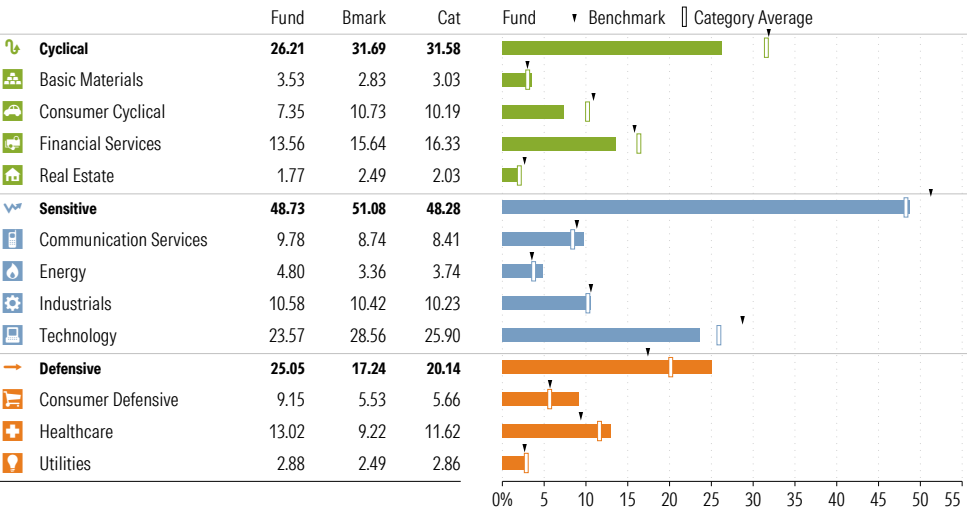

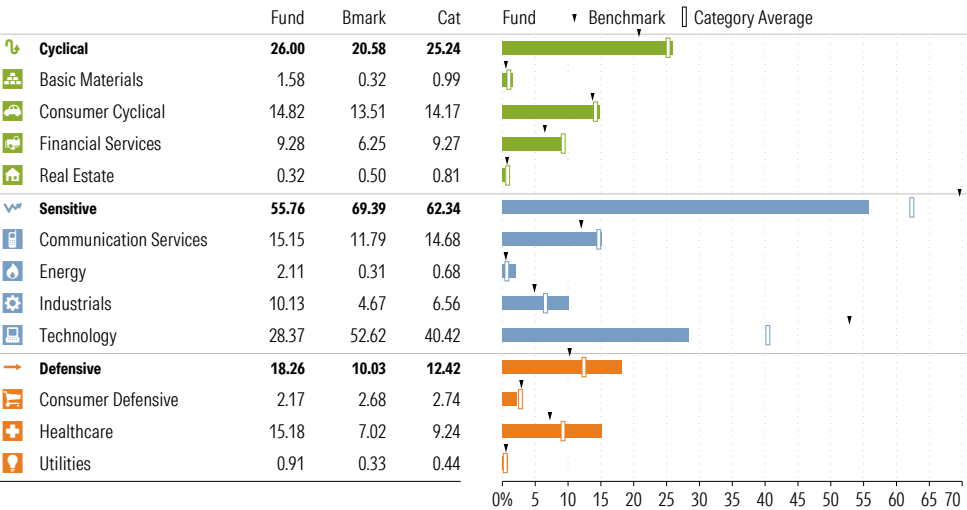

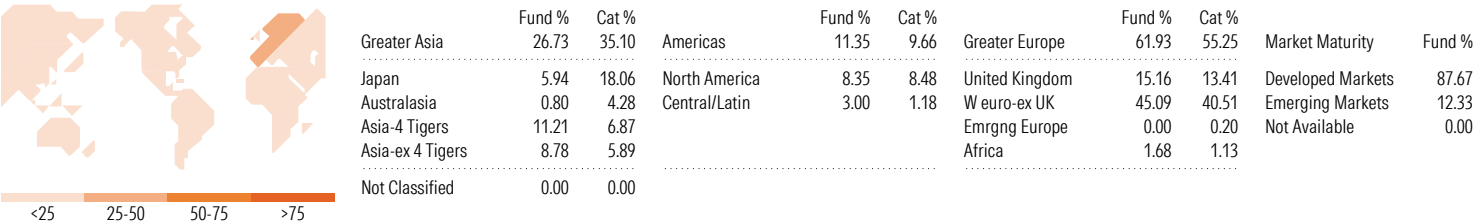
Asset Allocation as of 06-30-2025

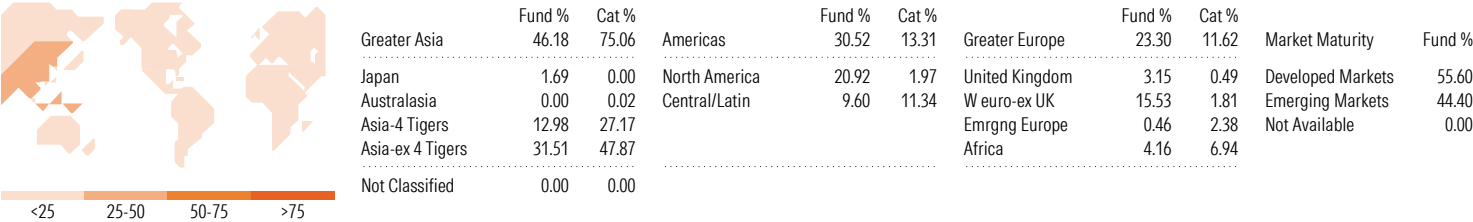

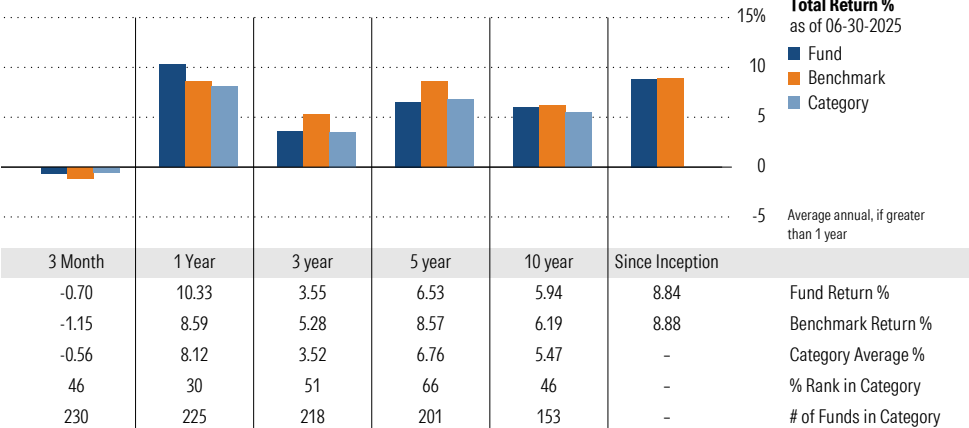

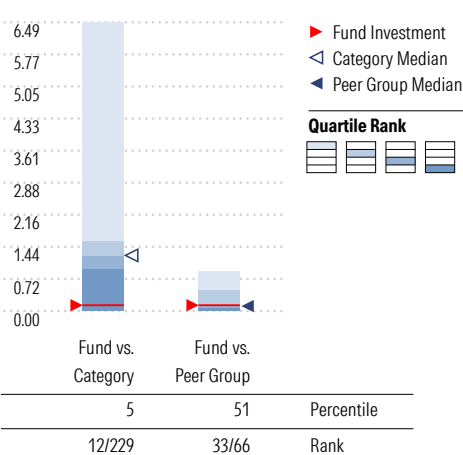

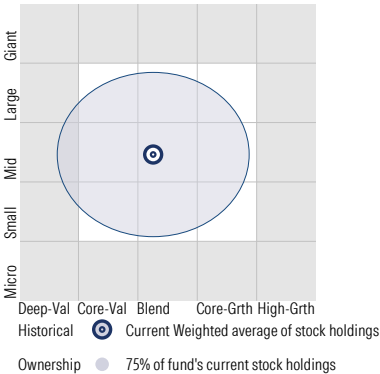

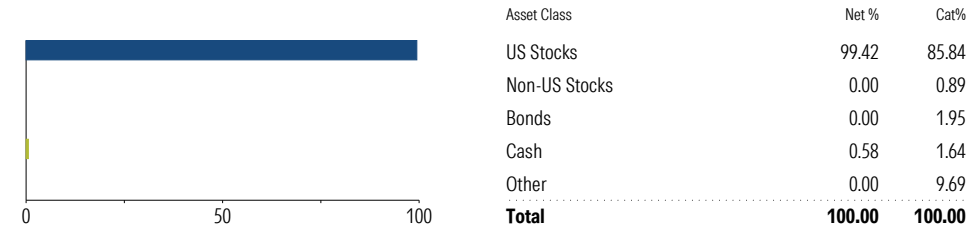

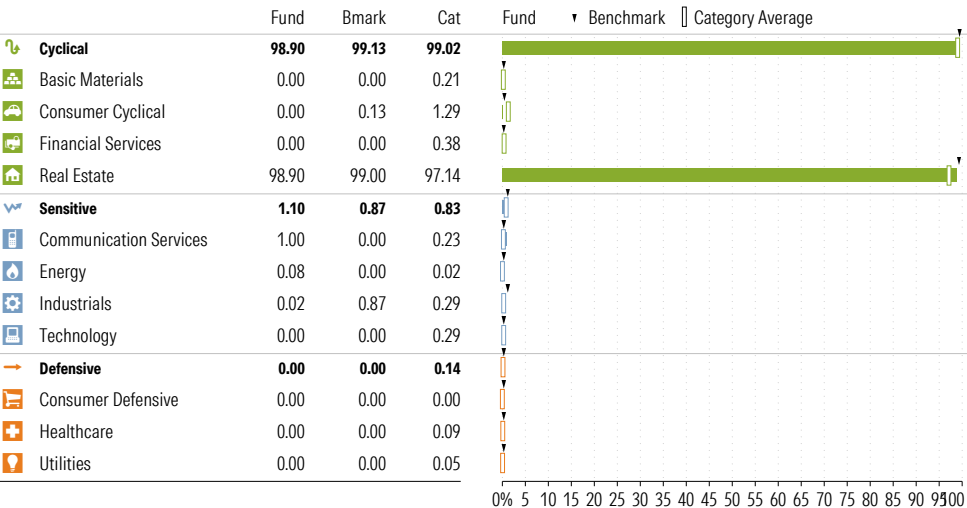
Style Breakdown

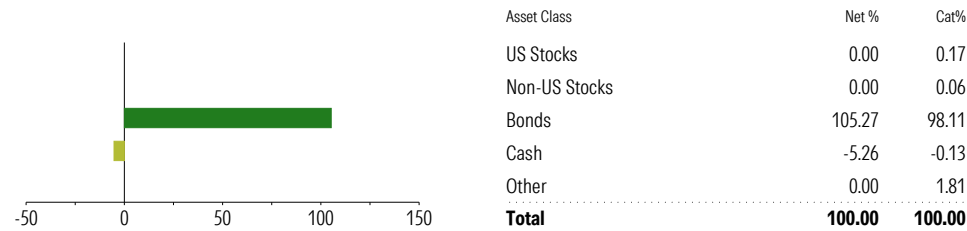

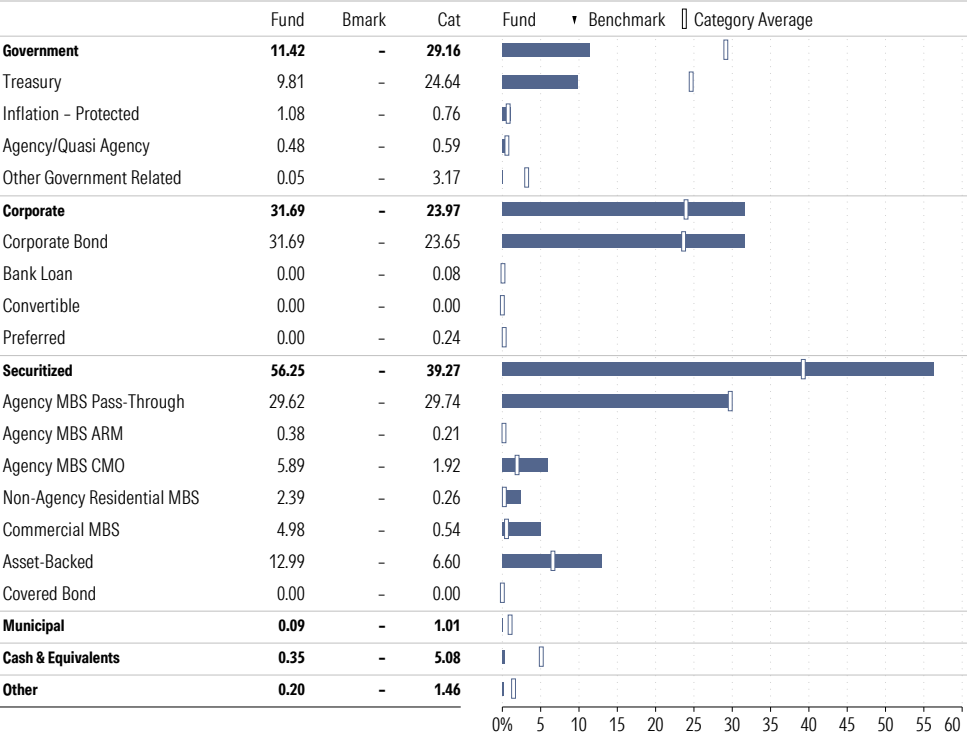
Asset Allocation as of 06-30-2025
