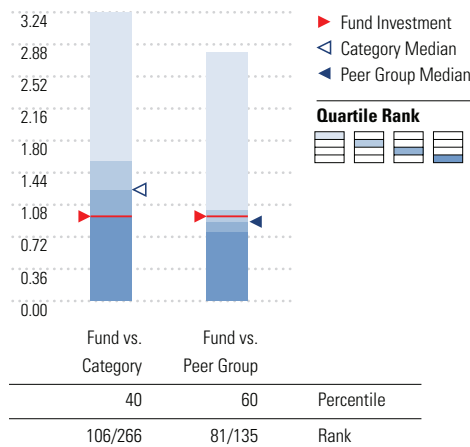

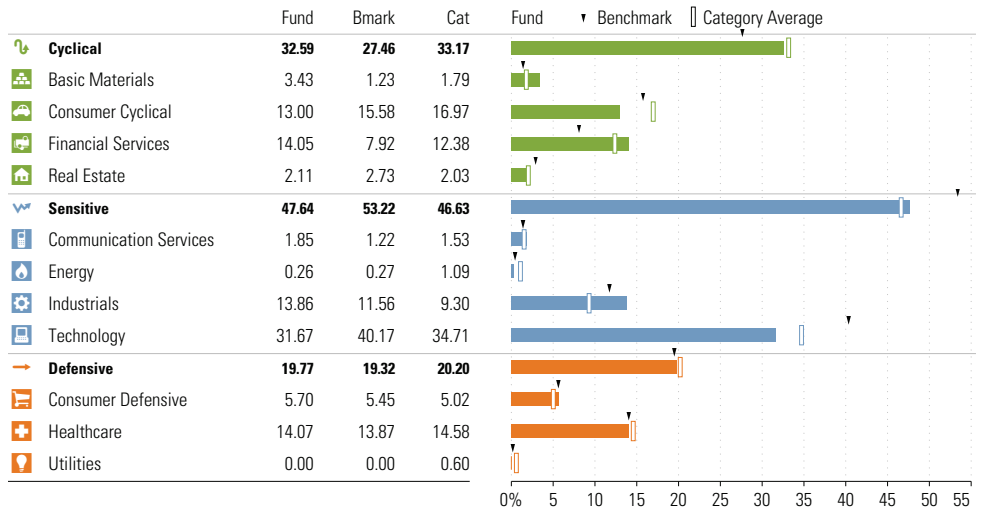

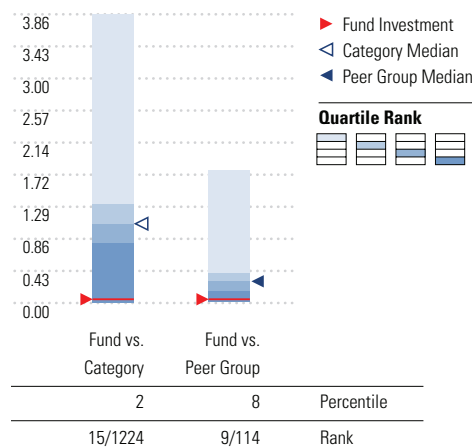

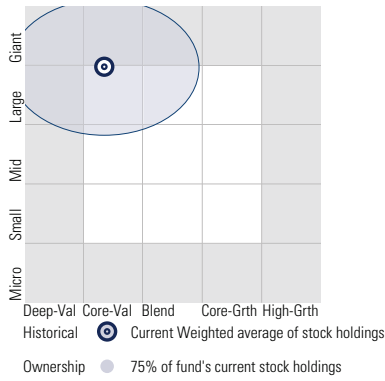

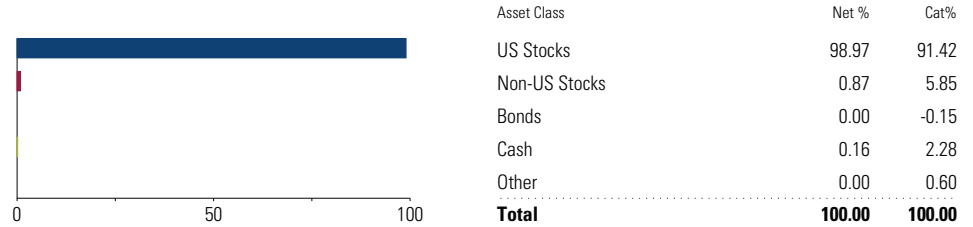

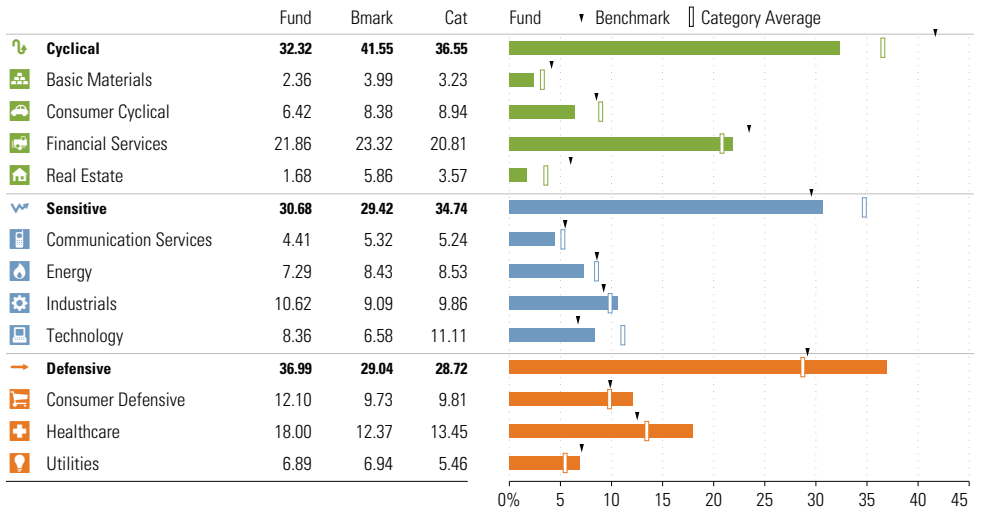
Style Breakdown

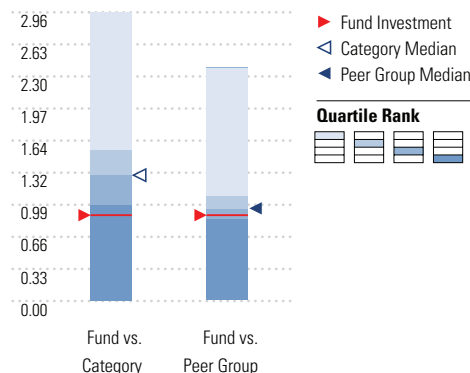

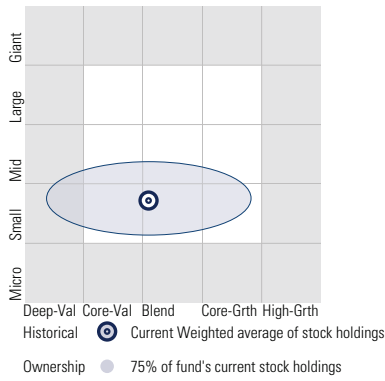

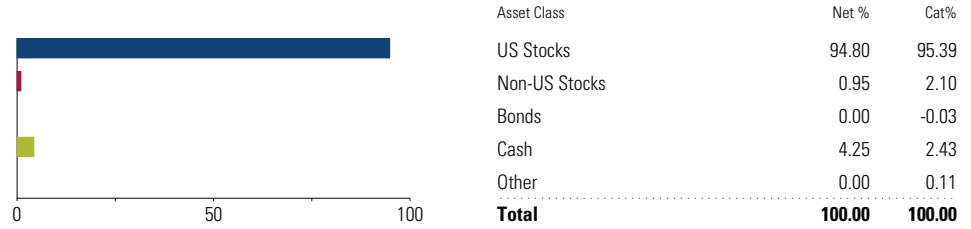

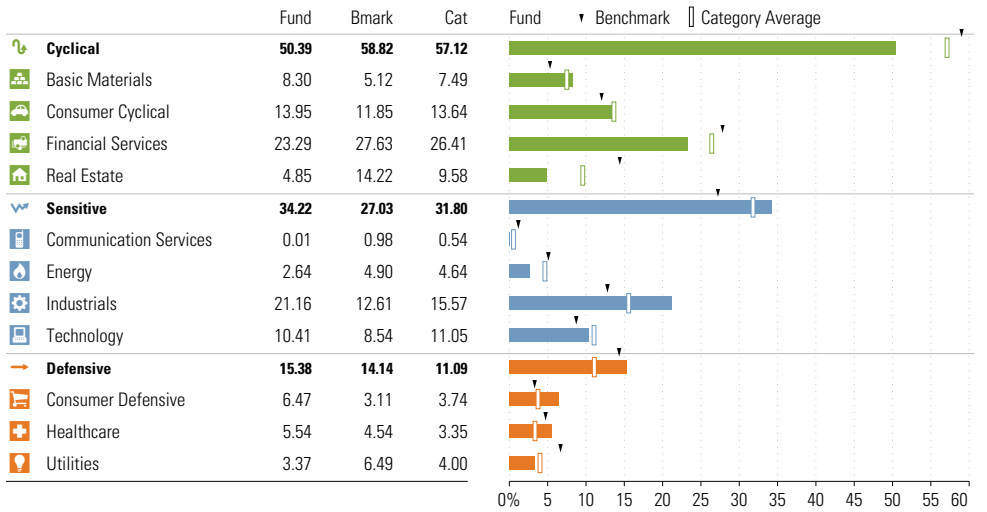
