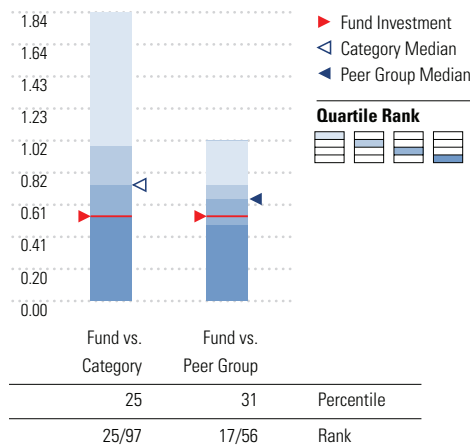

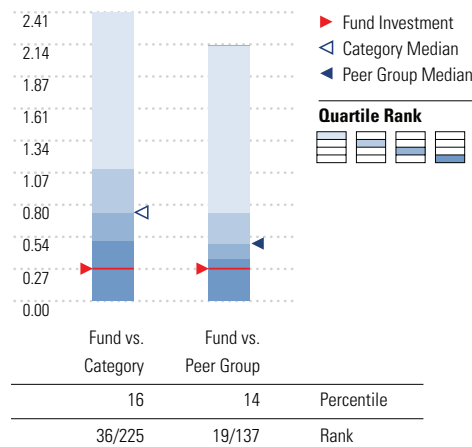

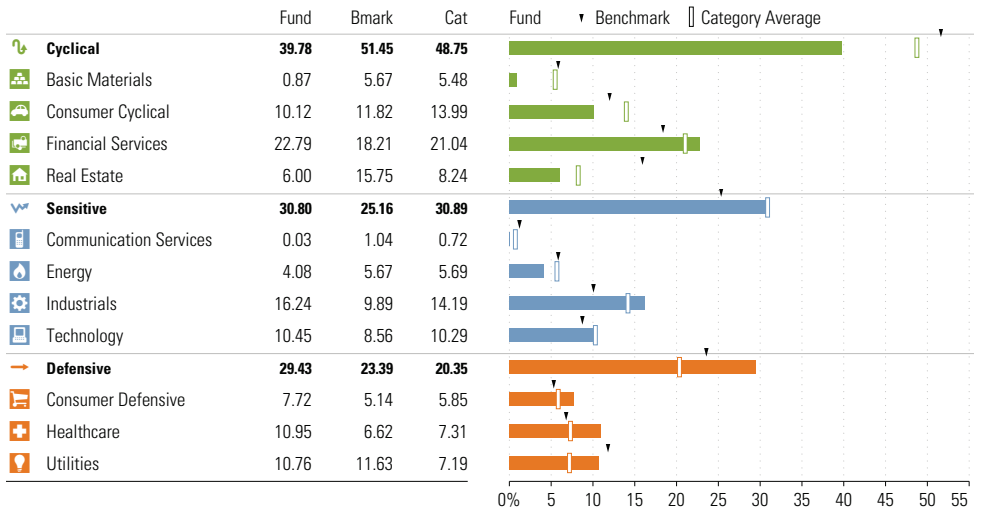

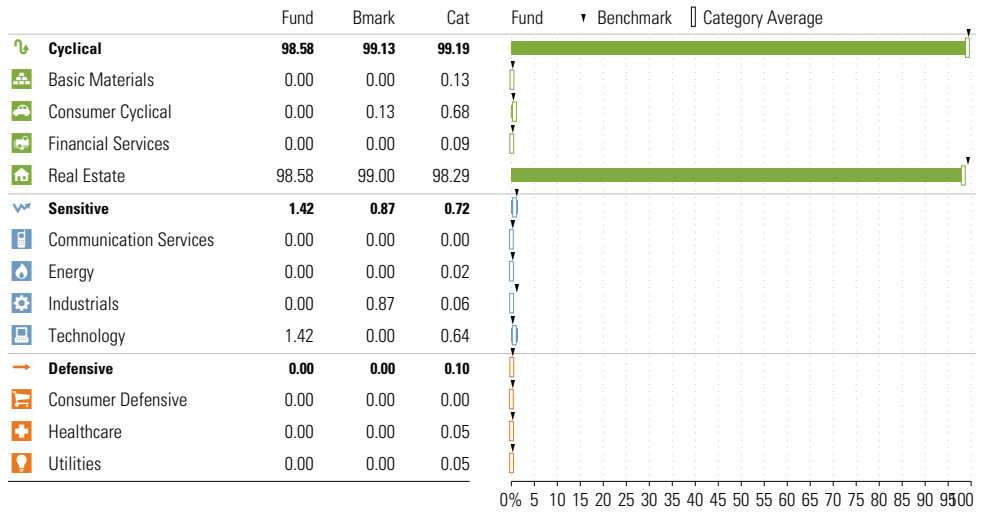

Historical Current Weighted average of stock holdings

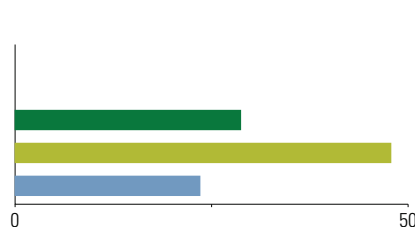

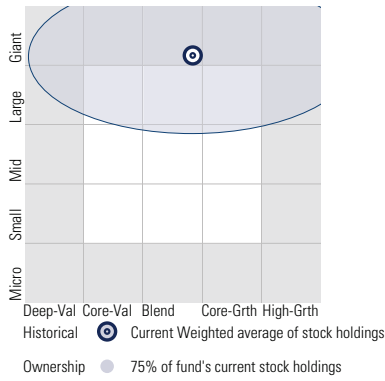

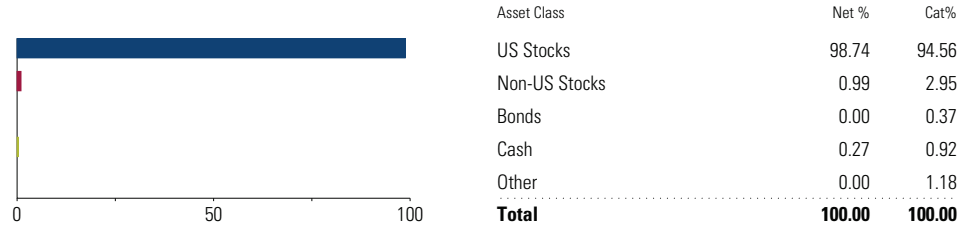

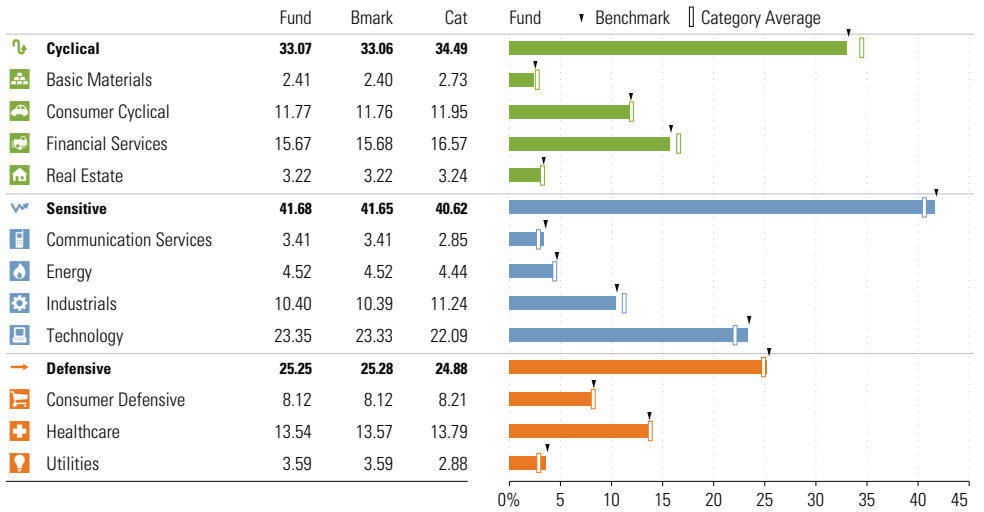

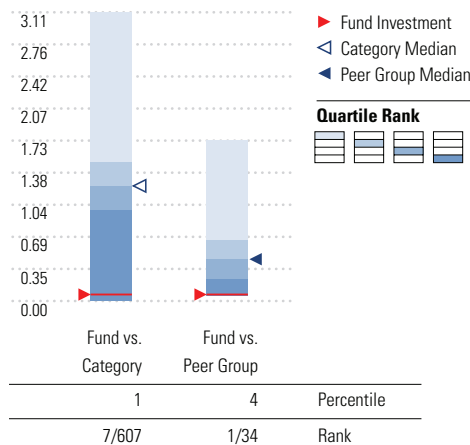

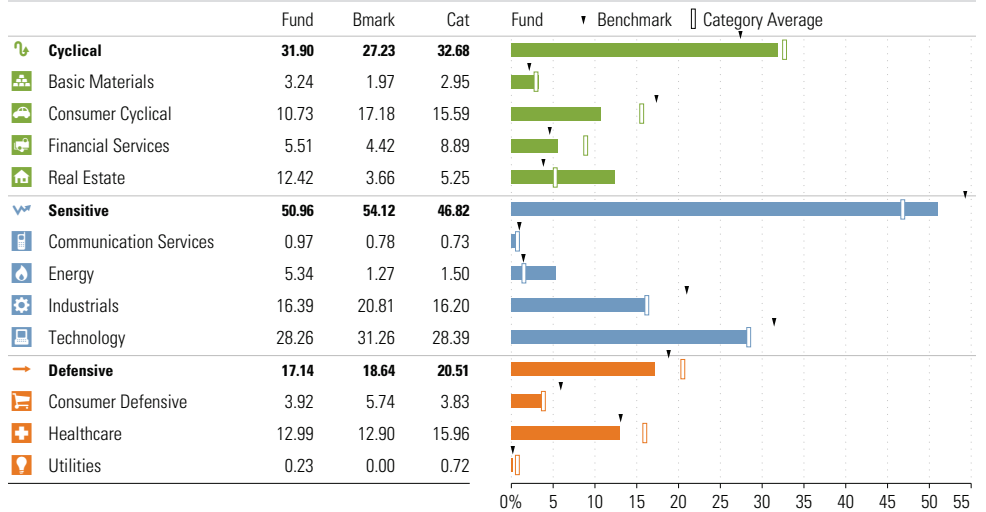
