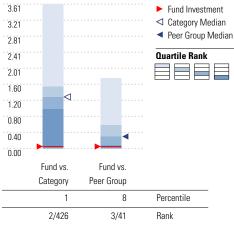


Morningstar Index Russell 2000 Value TR USD

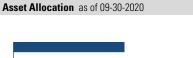
