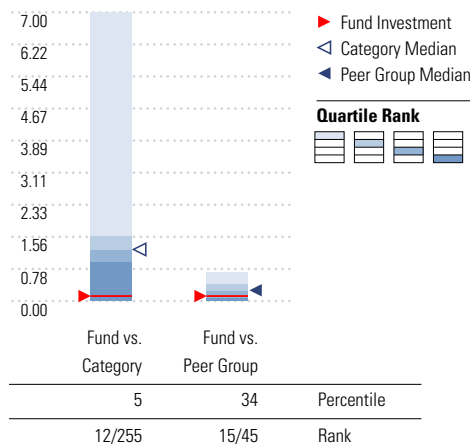
## Growth of \$10,000

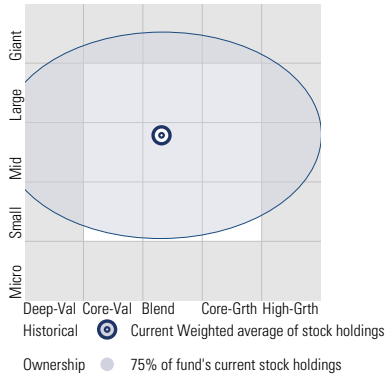

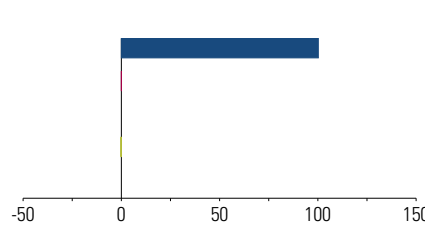

**Asset Allocation** as of 09-30-2020

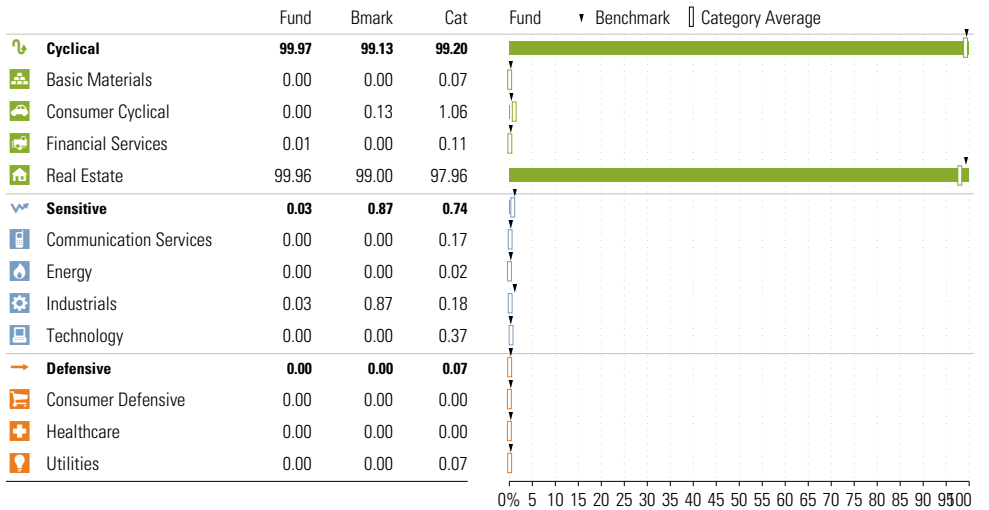
