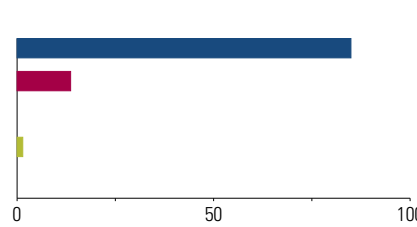

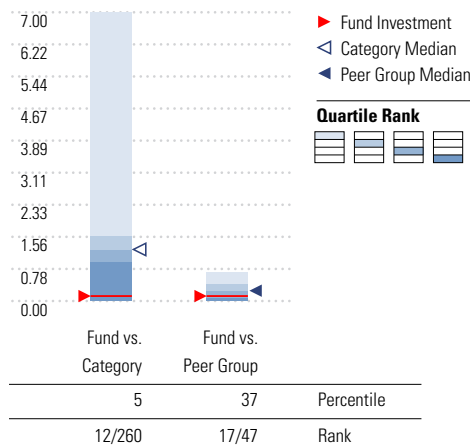

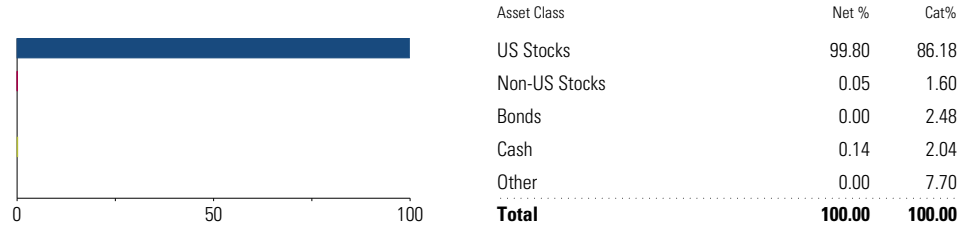

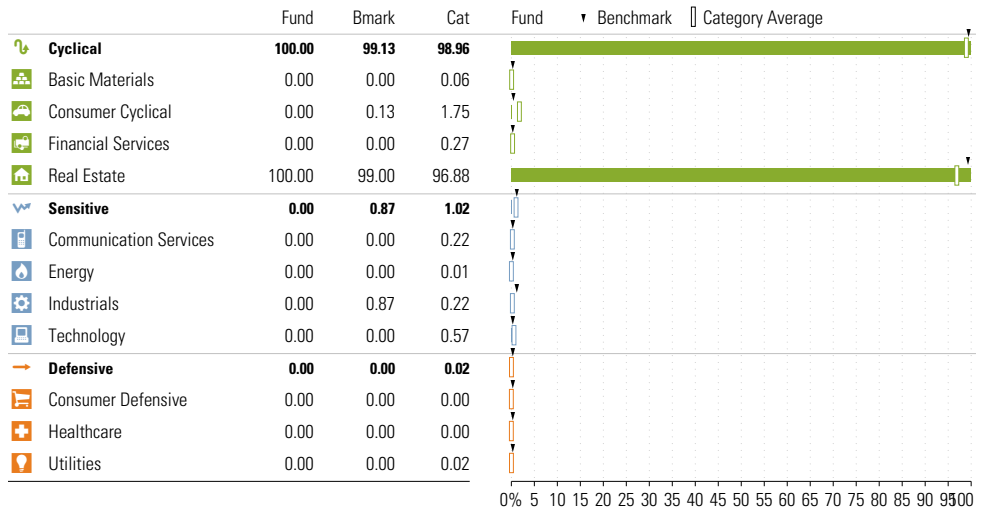
Style Breakdown
