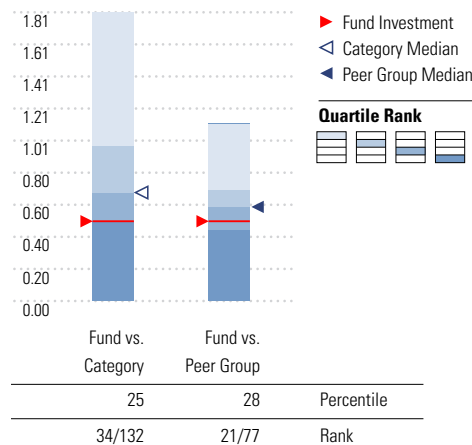

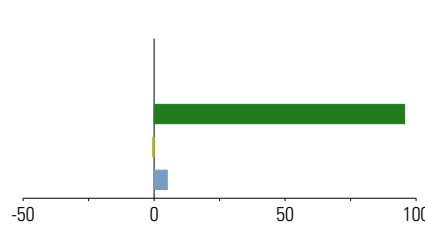

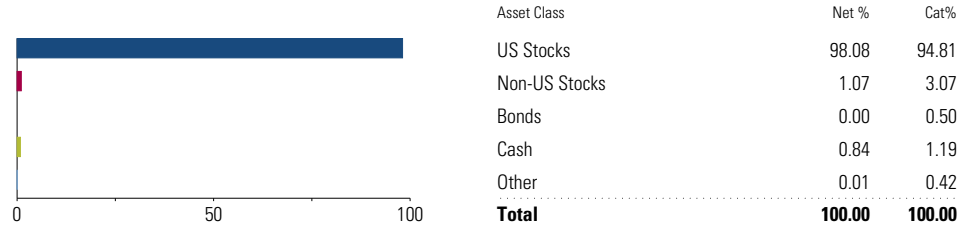

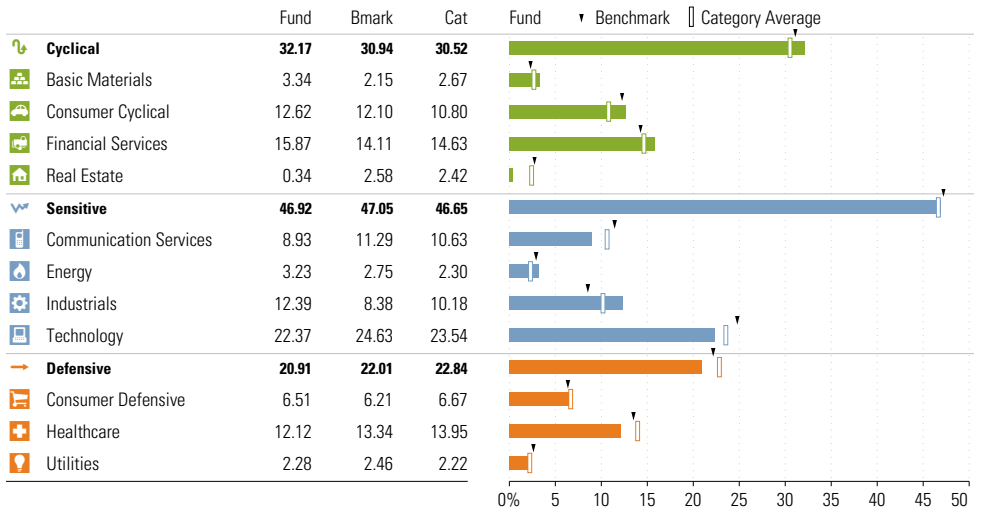

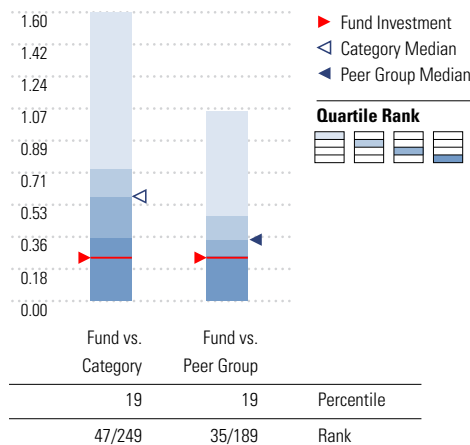

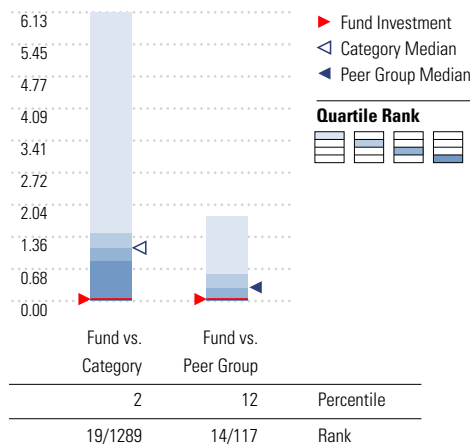

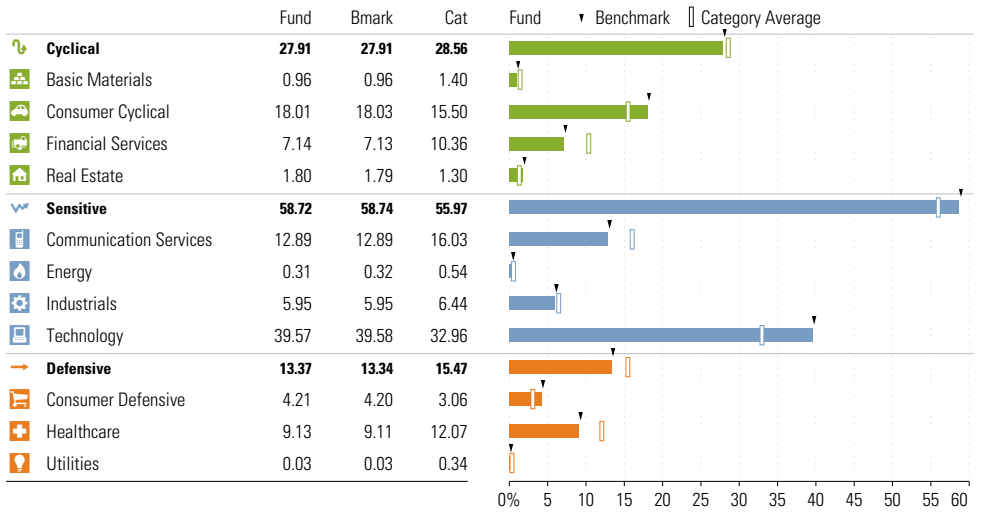

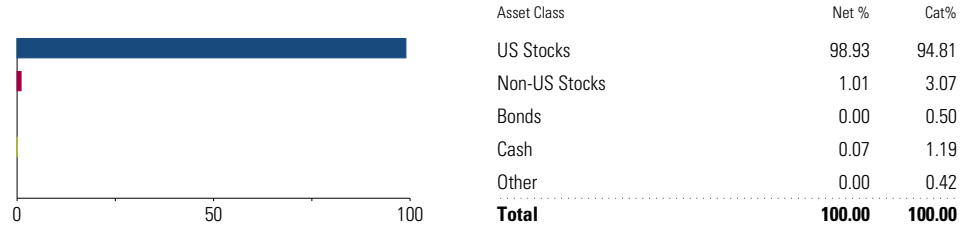

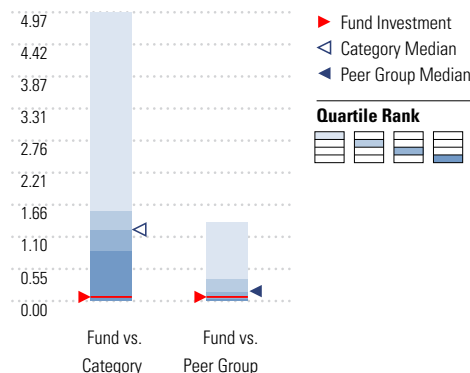

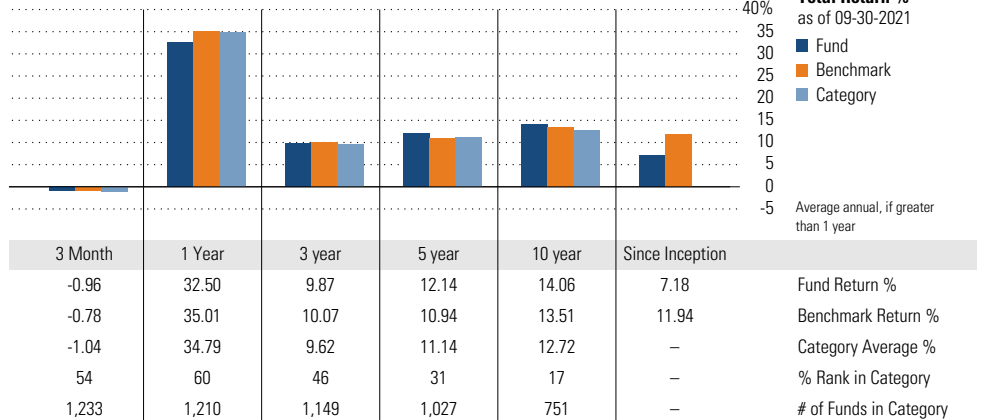

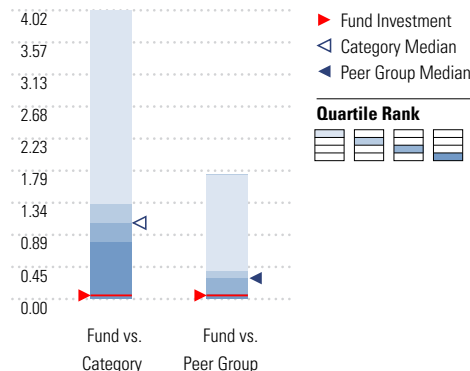

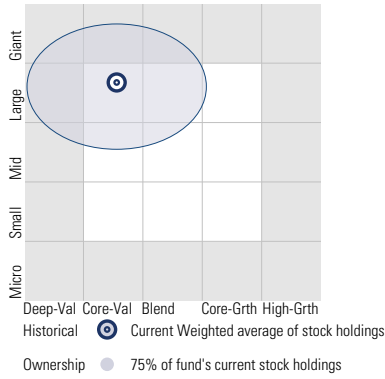

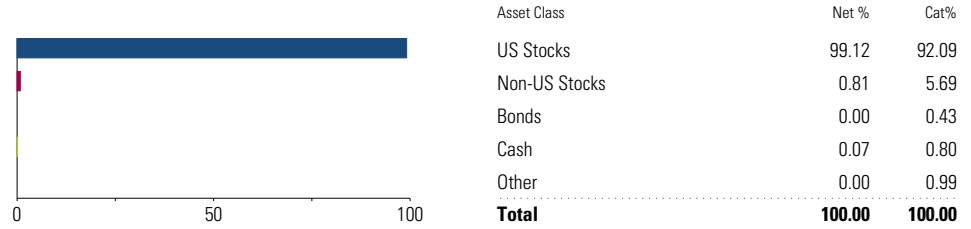

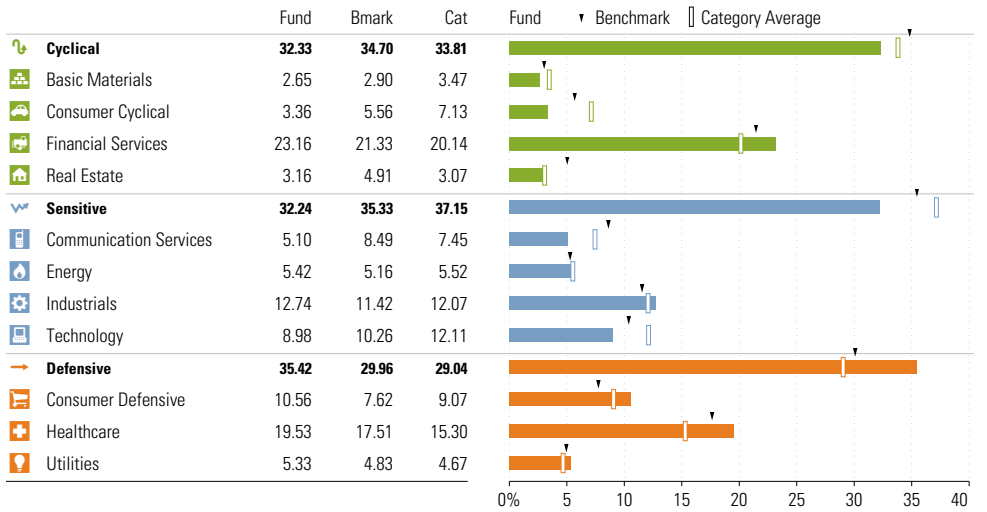
Style Breakdown
