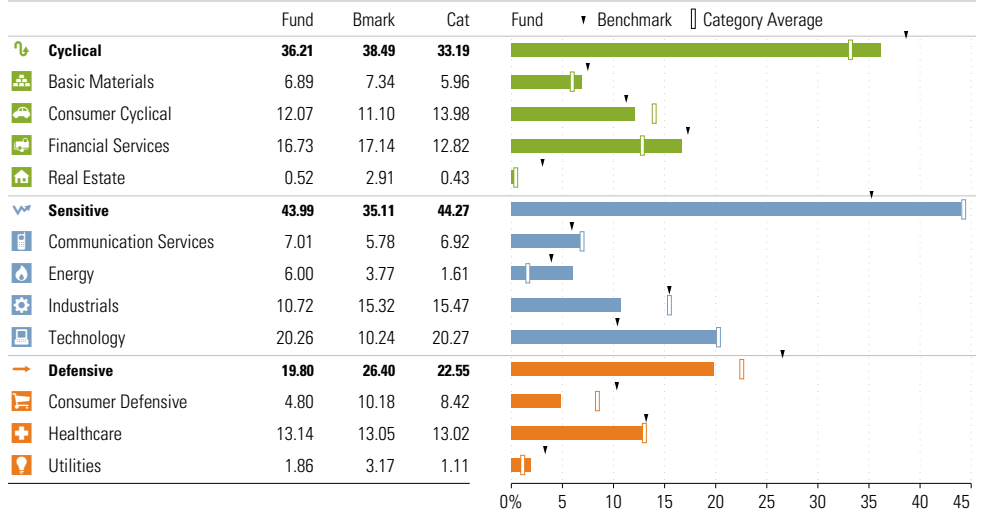

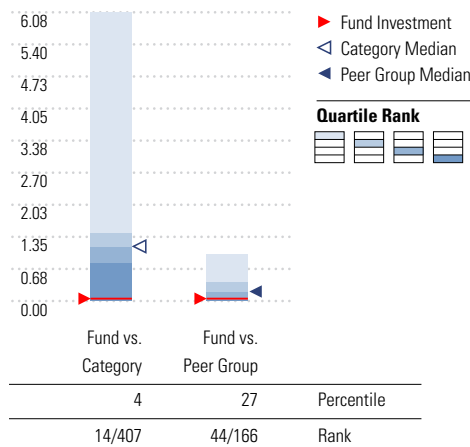

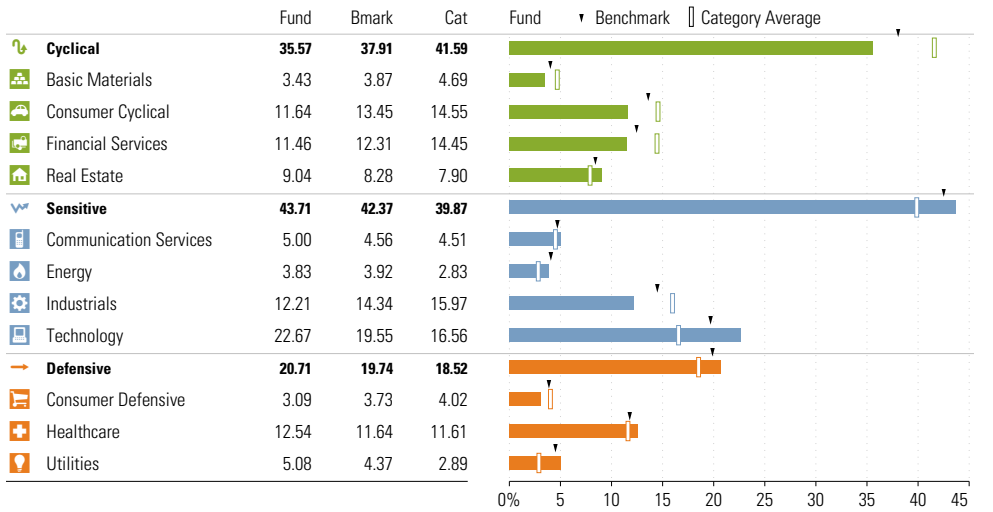

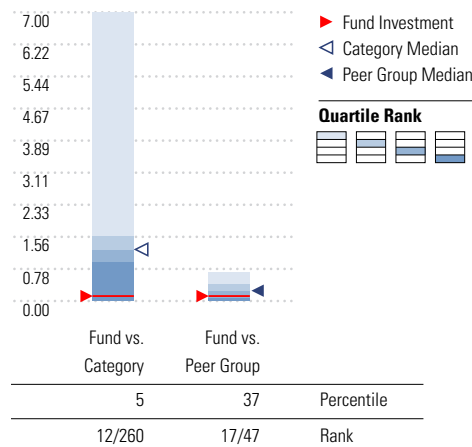

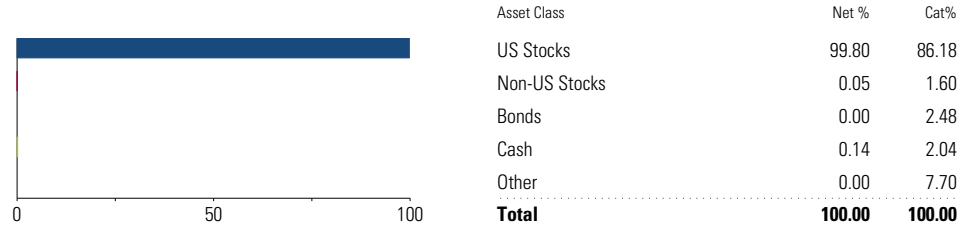

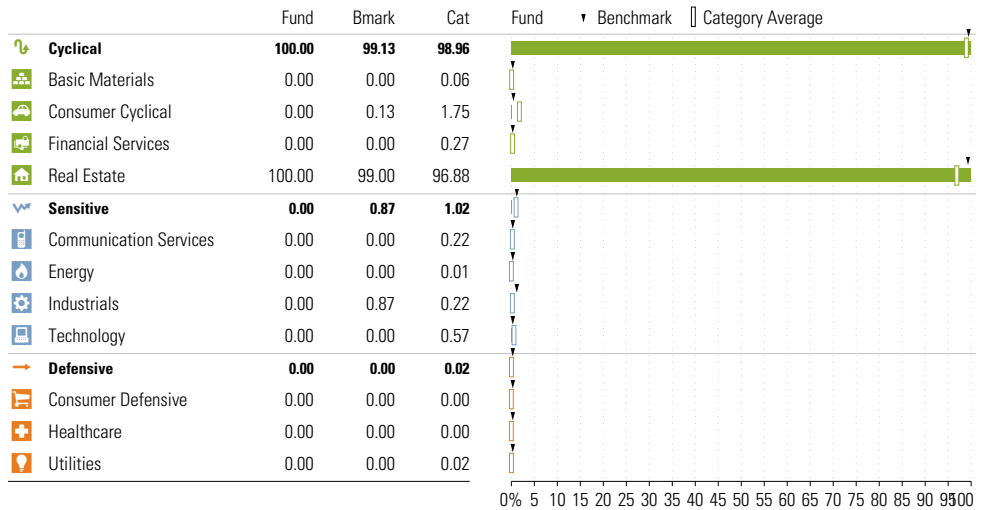
Style Breakdown
