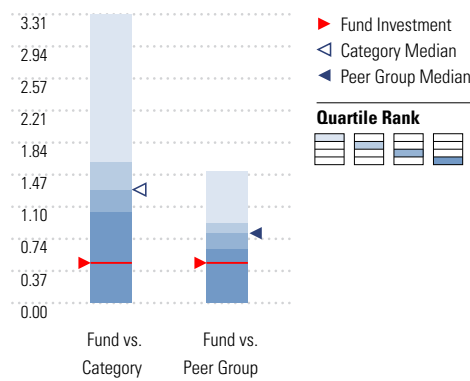

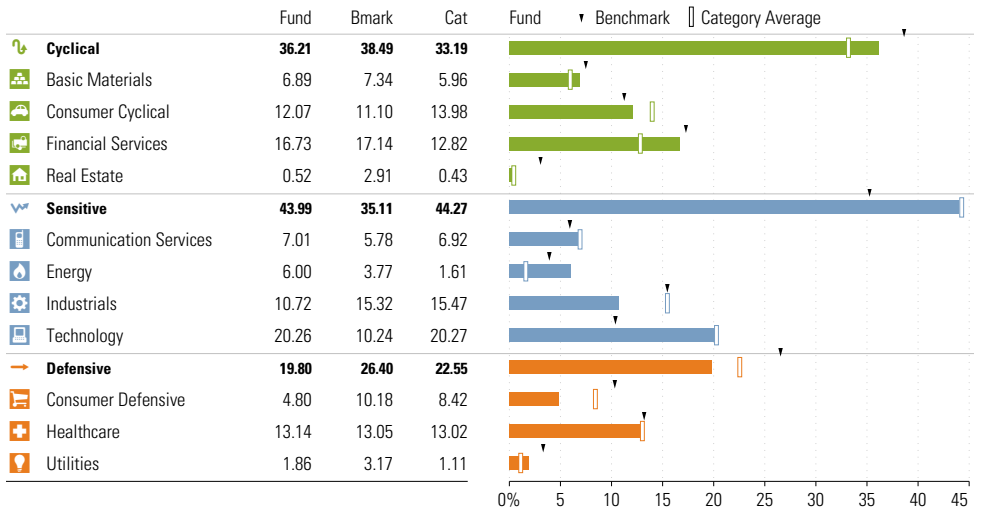

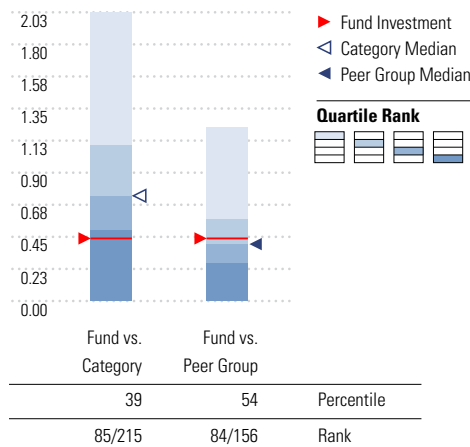

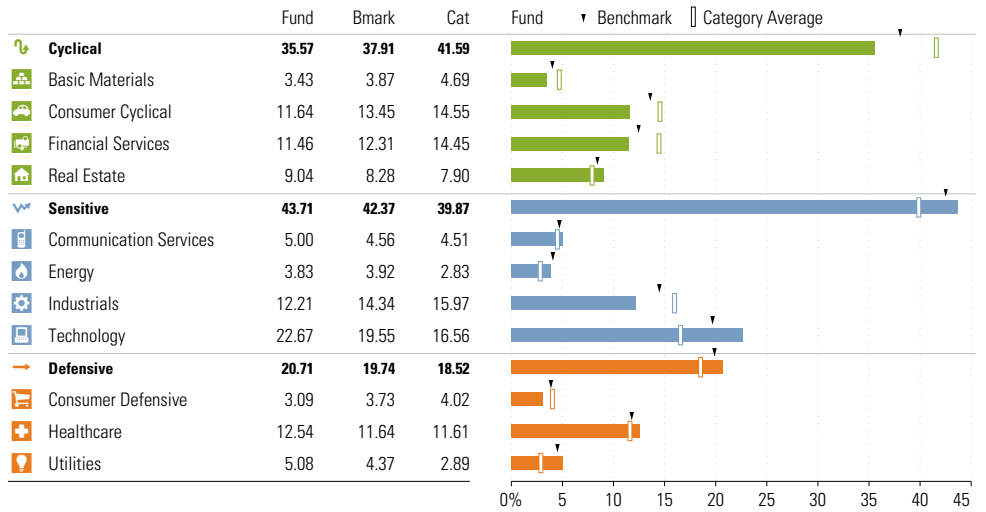

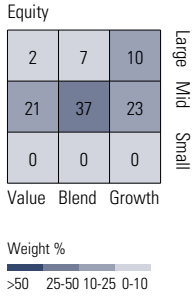

✔ **Net Expense:** The fund's expense ratio of 0.12 is 88.79% lower than the Real Estate category average.

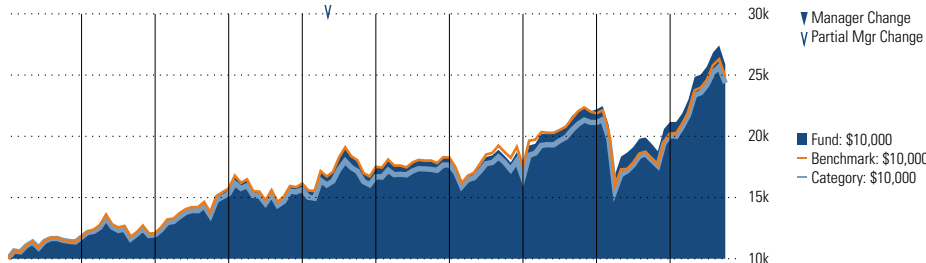

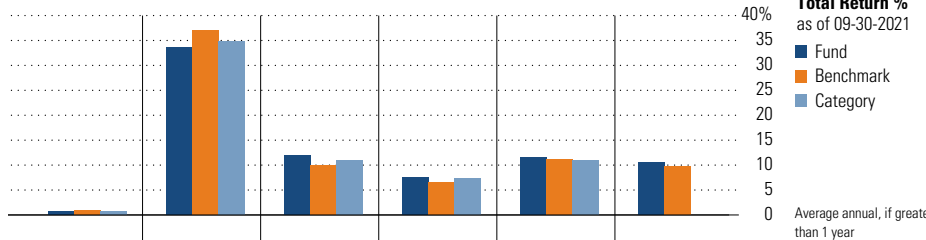

Growth of \$10,000



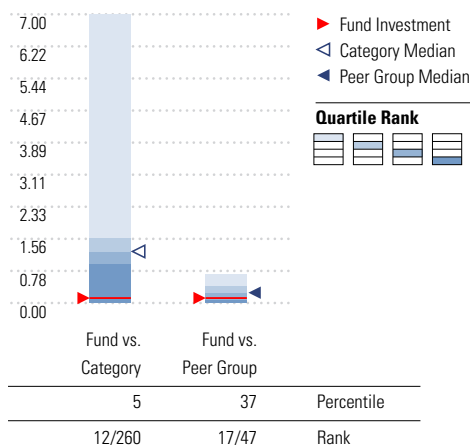

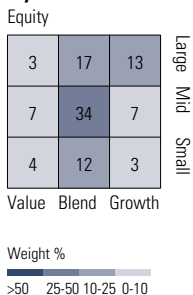

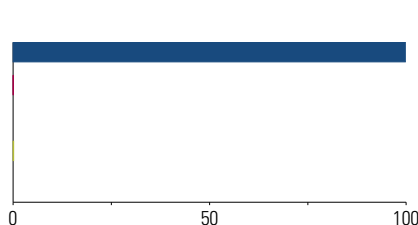

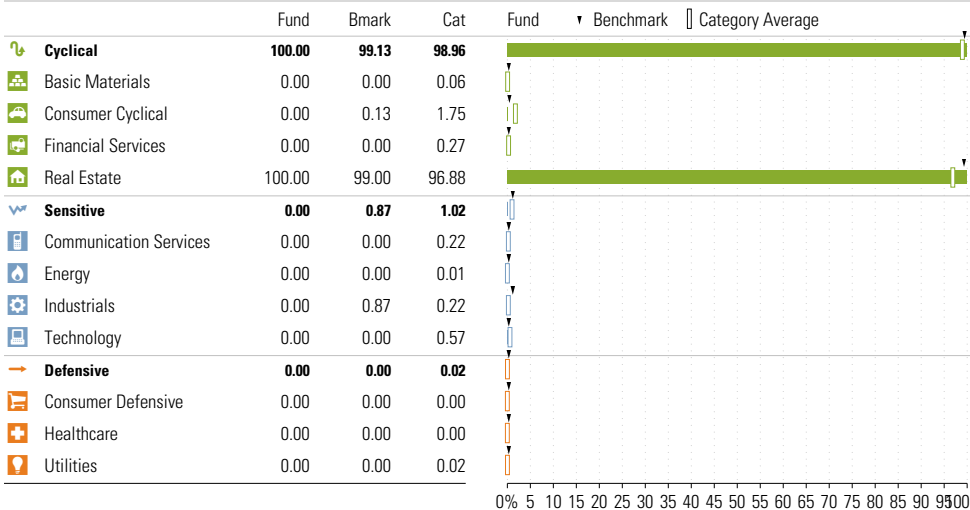
