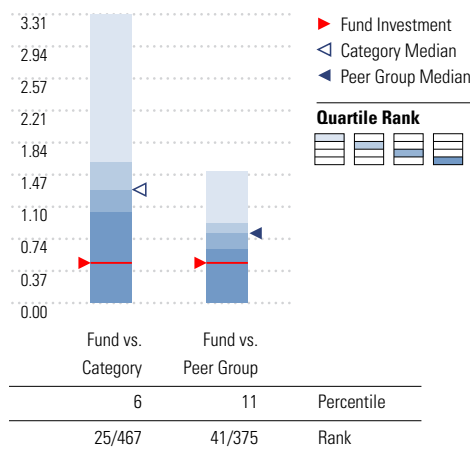

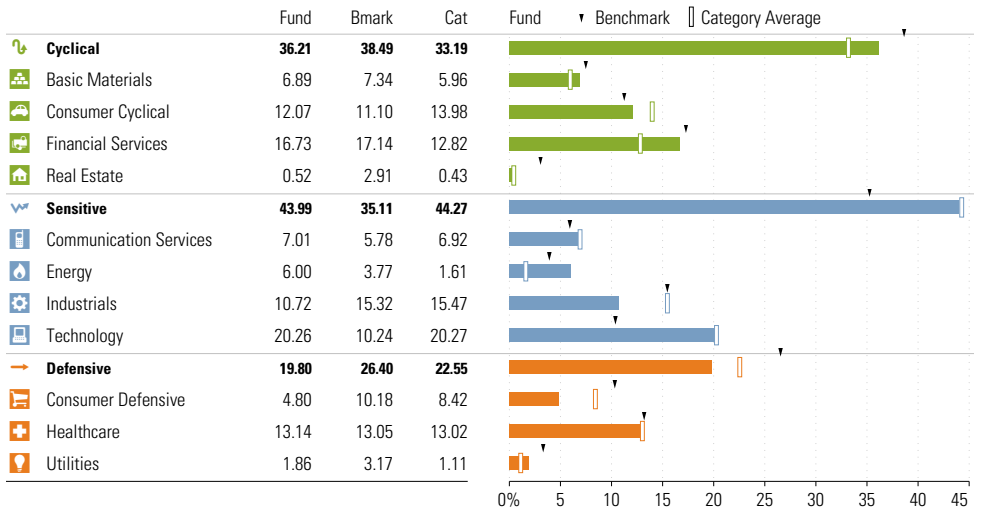

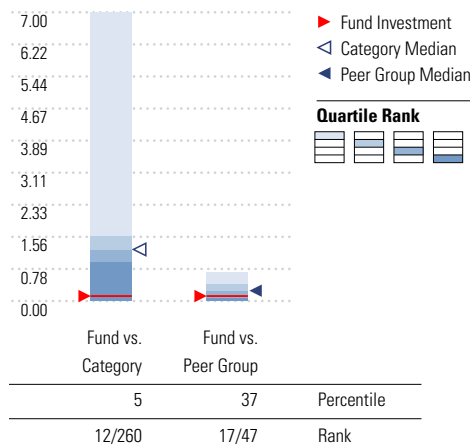

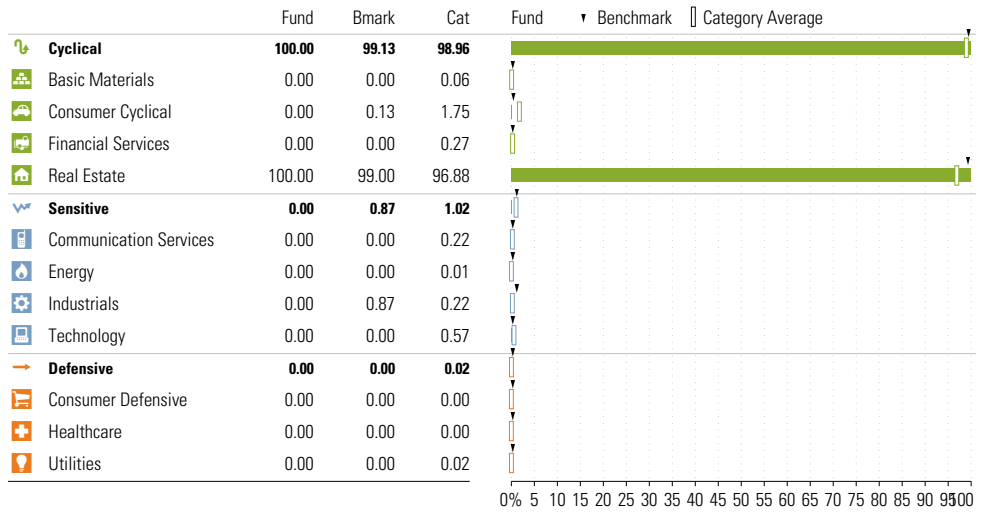

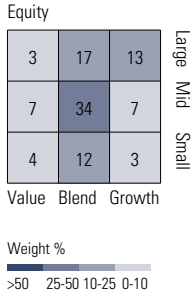
Asset Allocation as of 09-30-2021

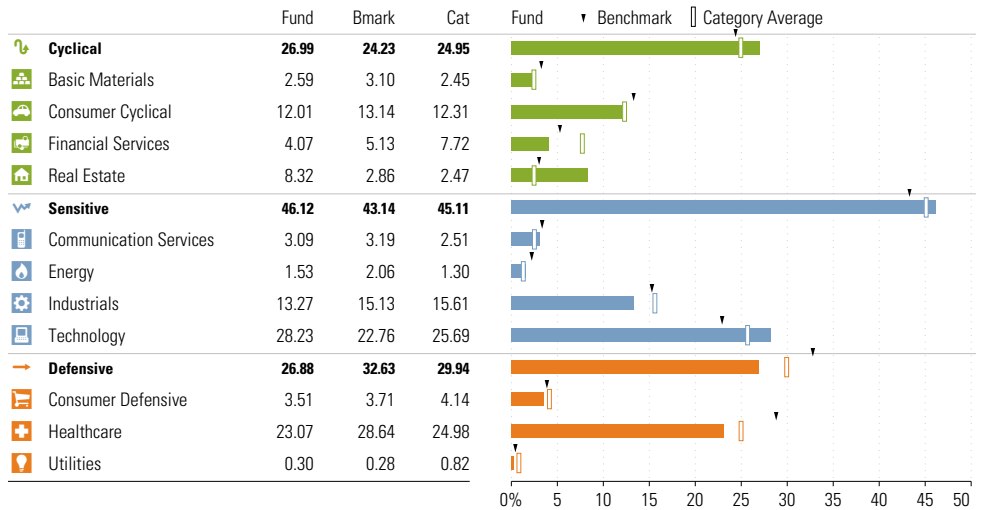
Asset Allocation as of 09-30-2021
