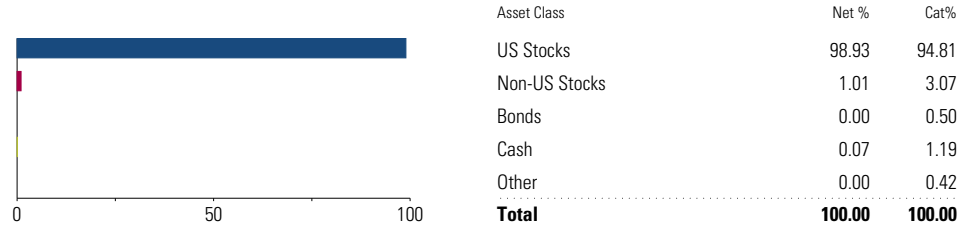

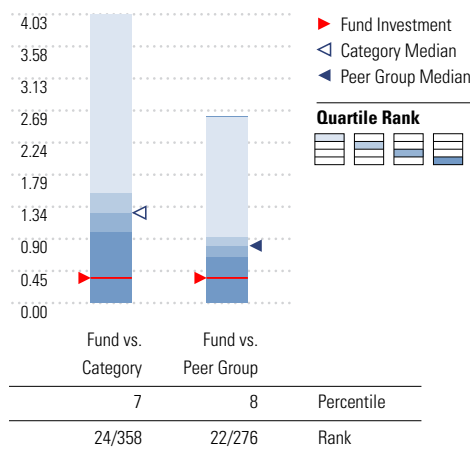

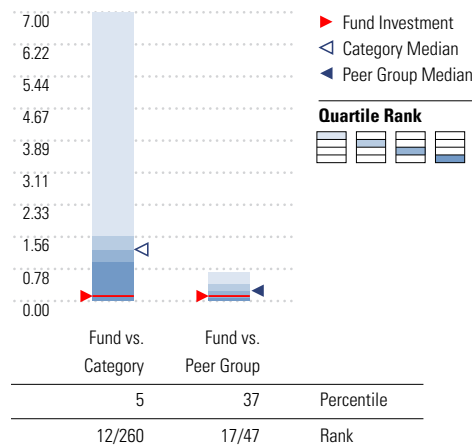

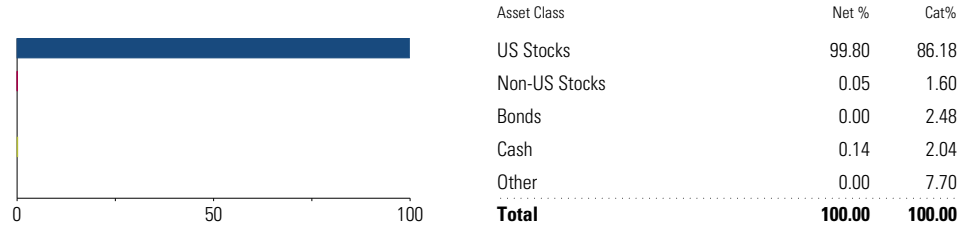

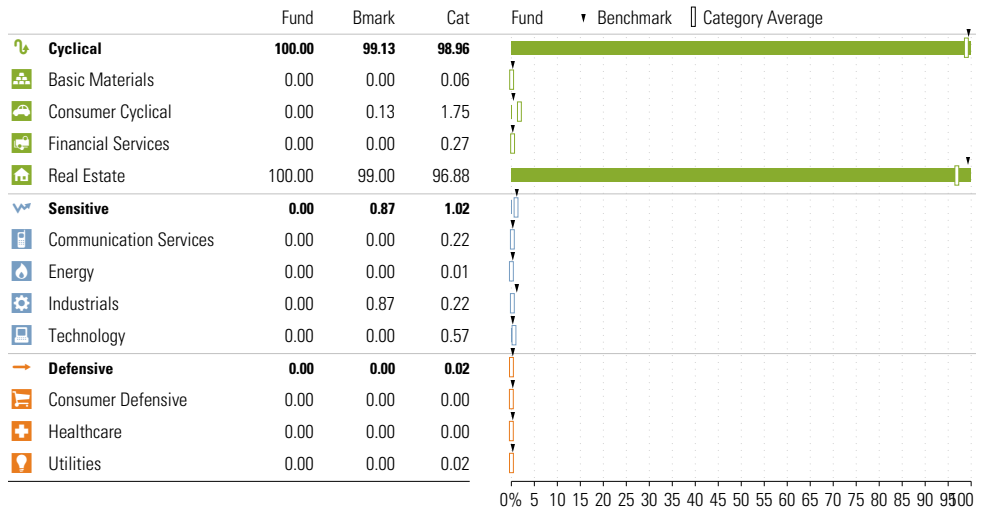
Style Breakdown
