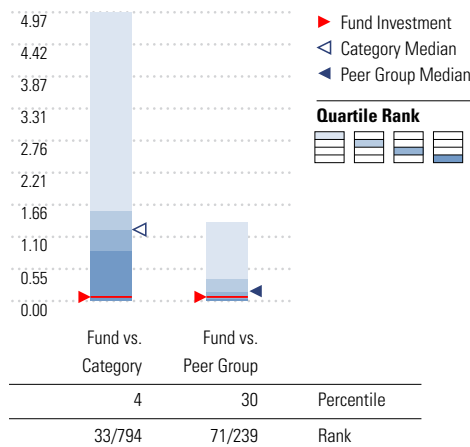

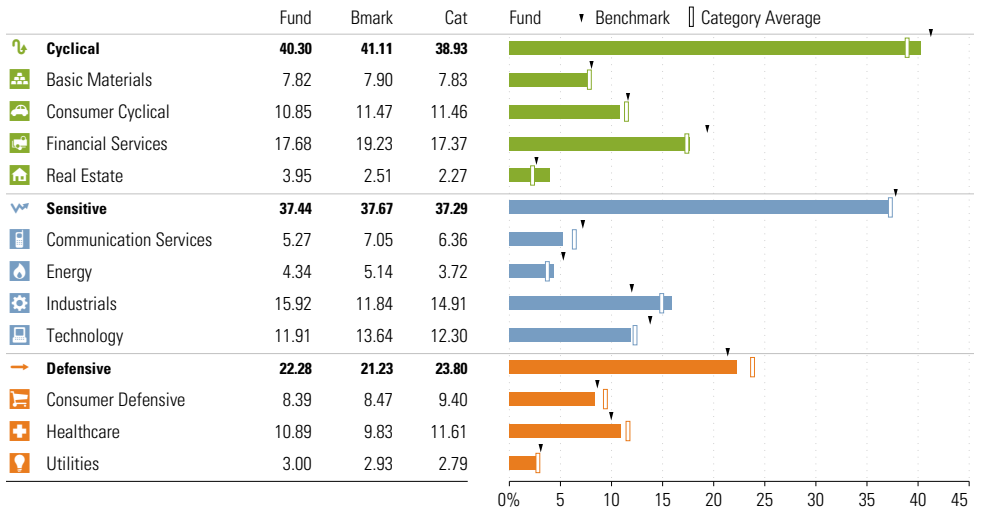

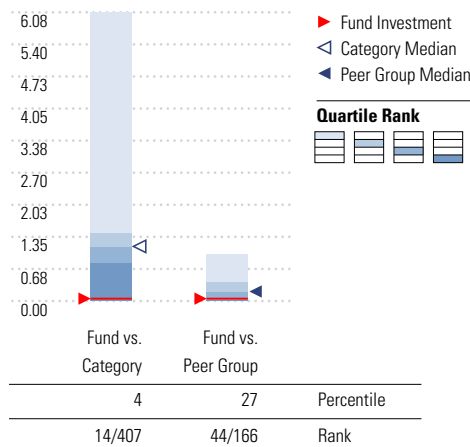

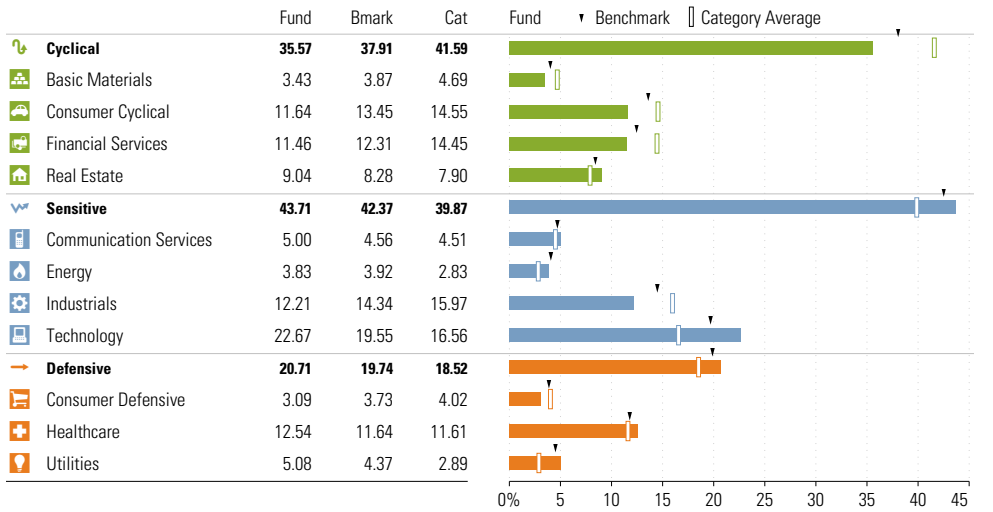

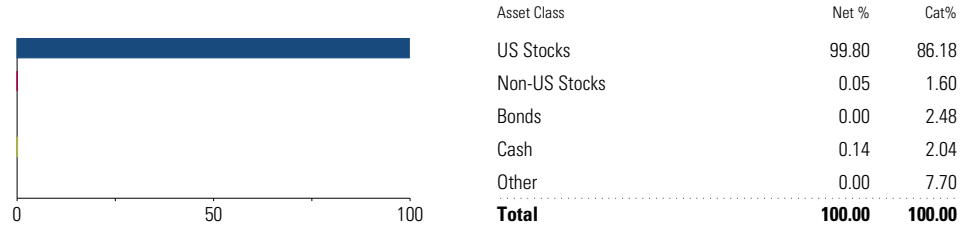

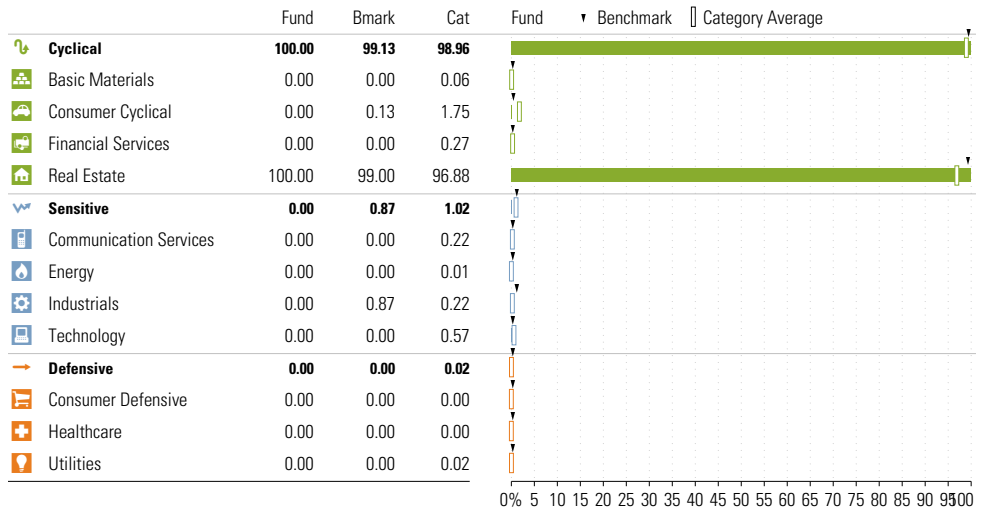
Style Breakdown
