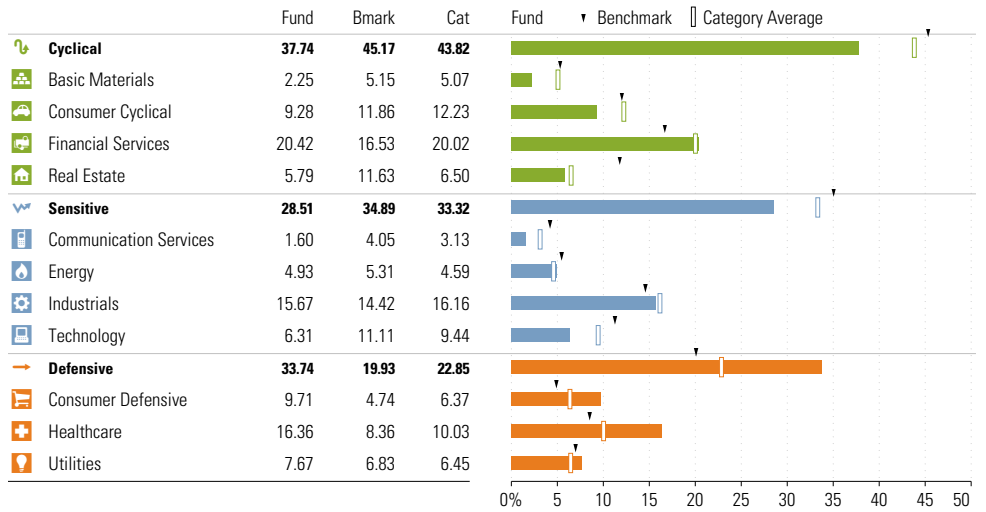

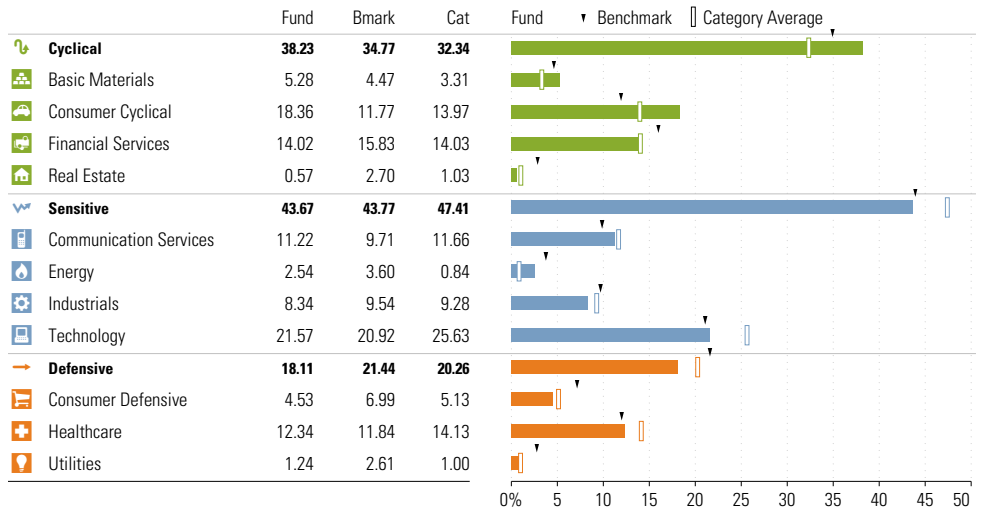

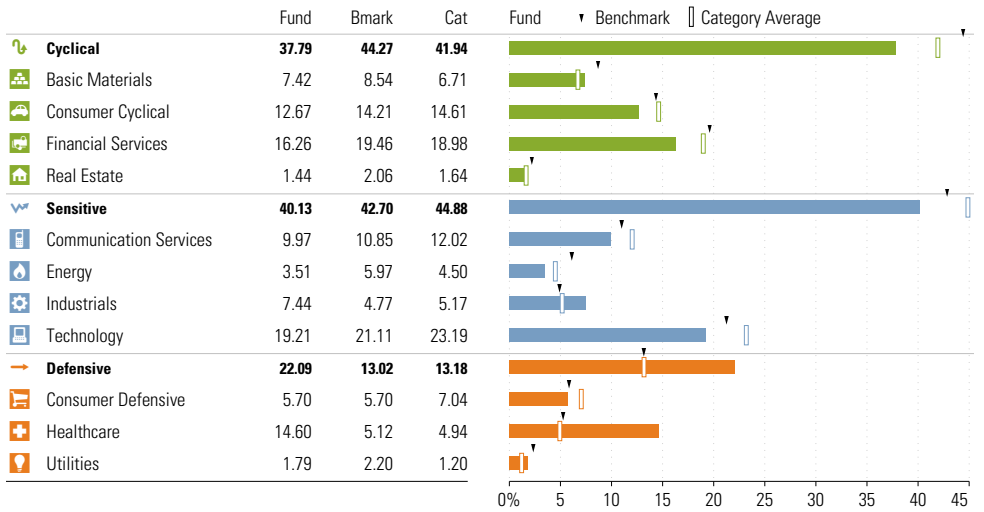

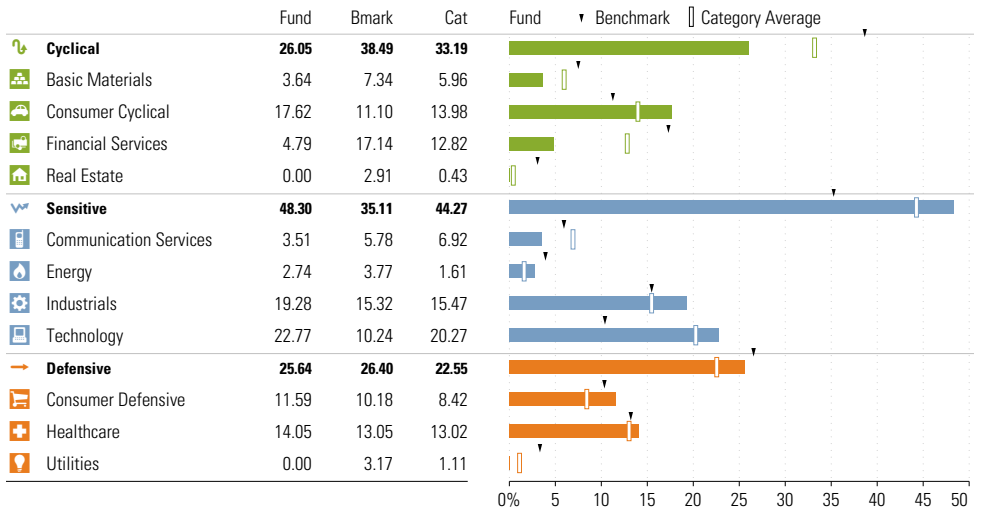

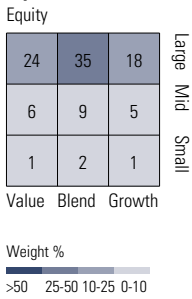

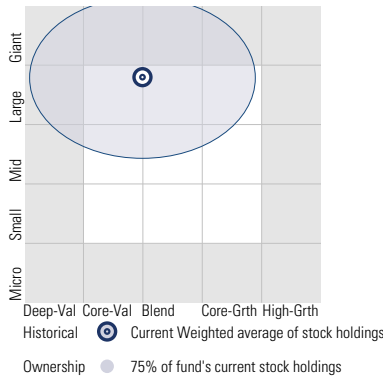

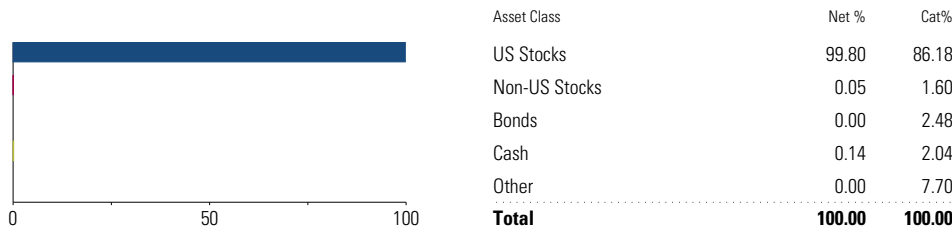

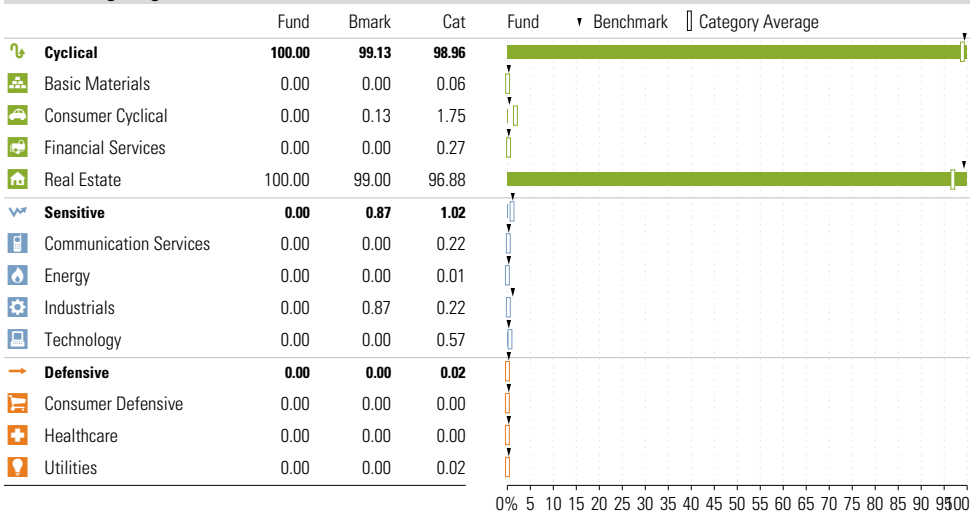
Style Breakdown
