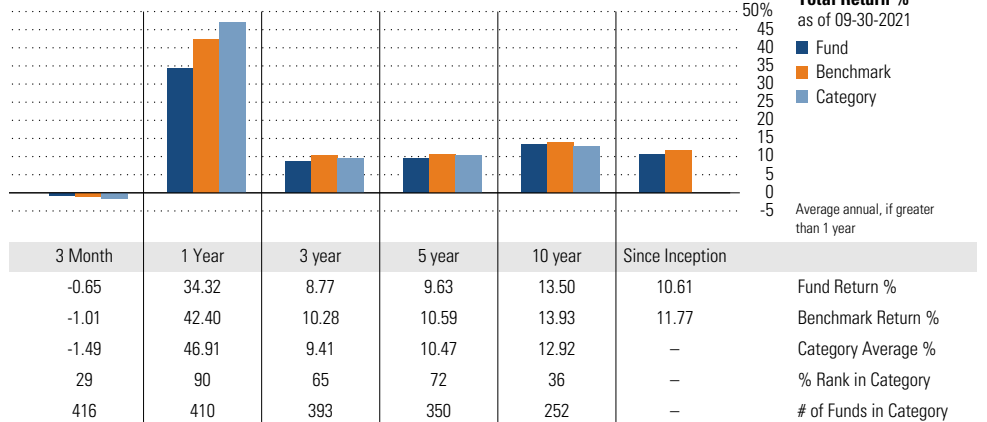

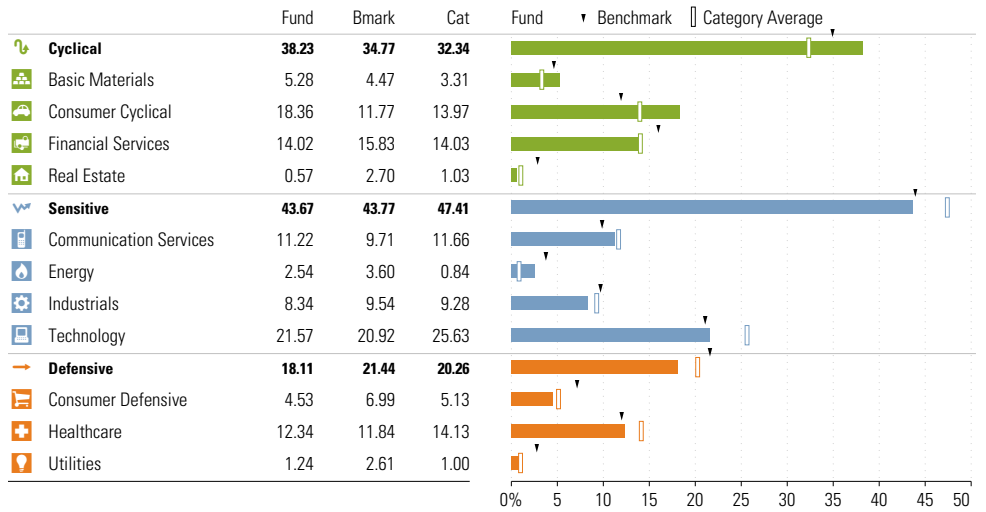

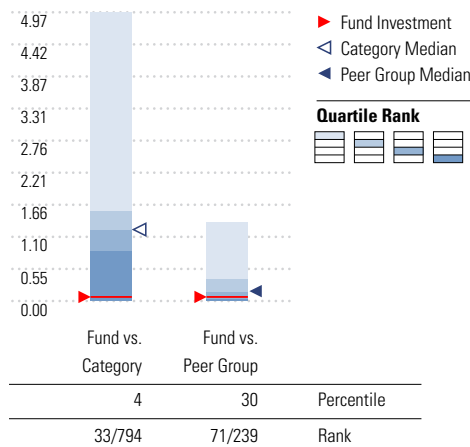

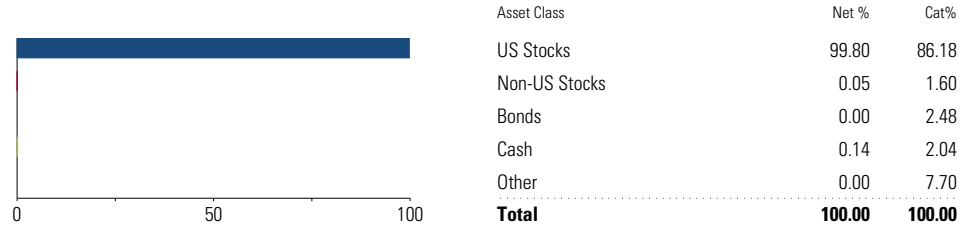

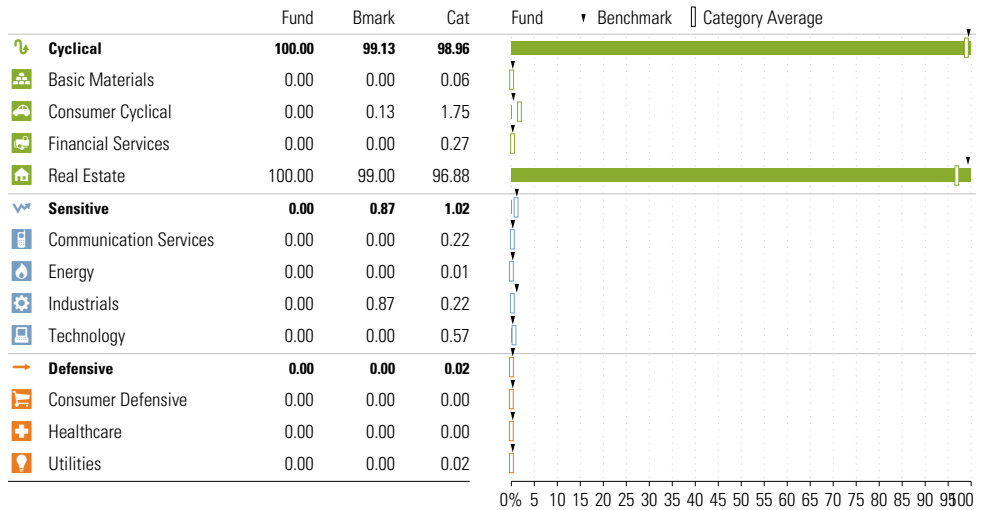
Style Breakdown
