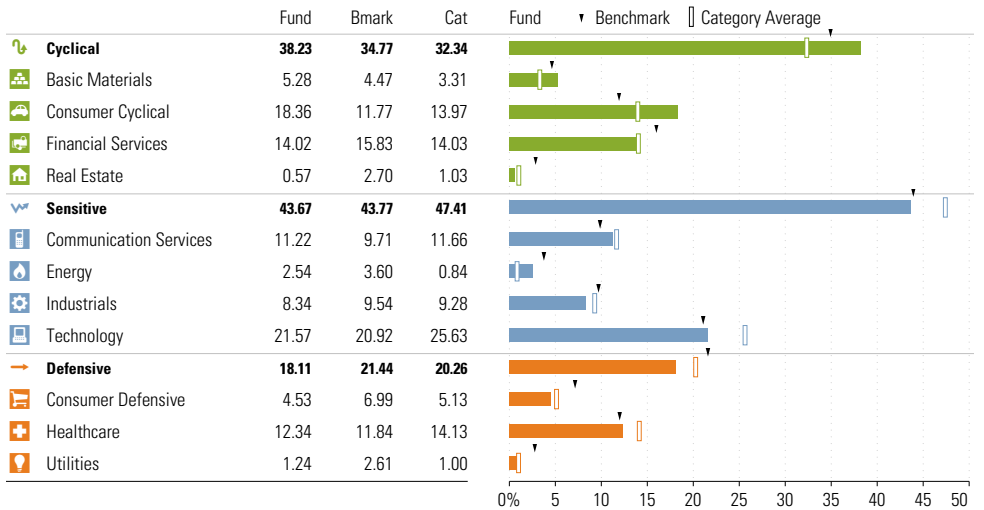

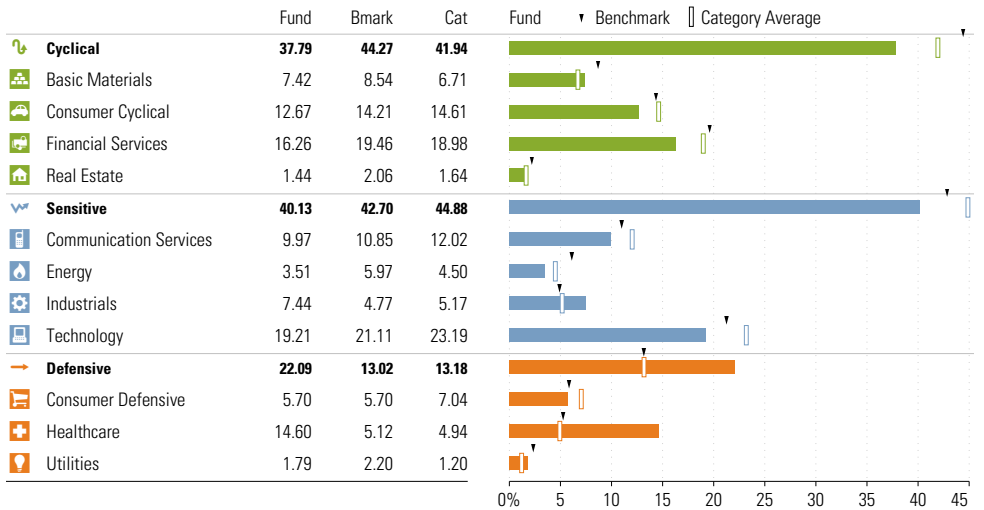

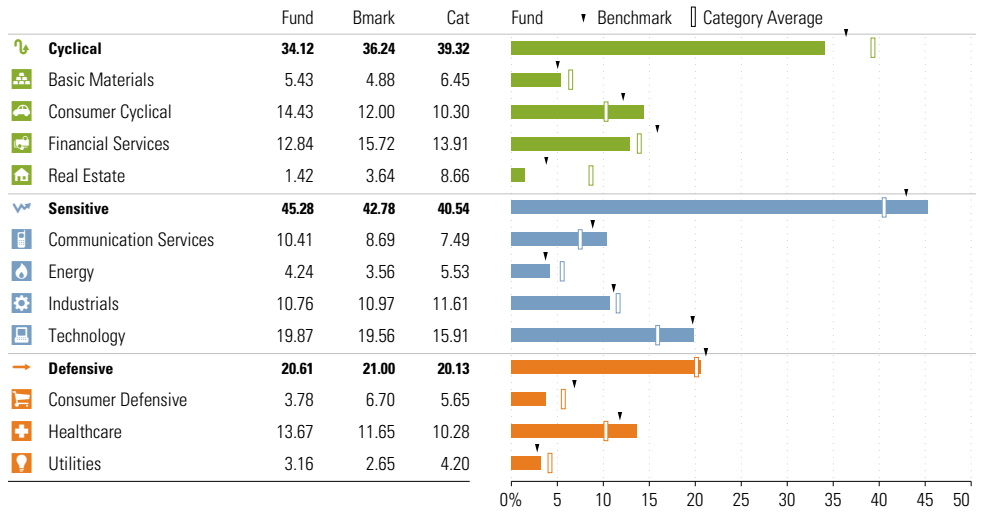


Asset Allocation as of 09-30-2021

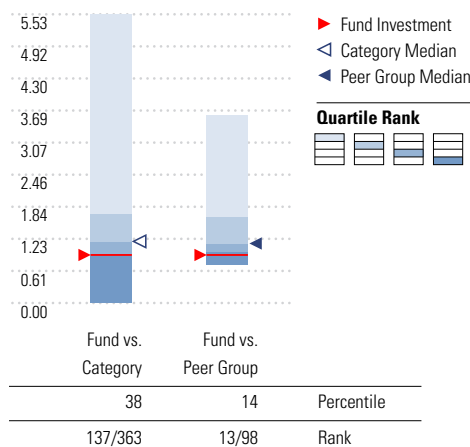
Growth of \$10,000

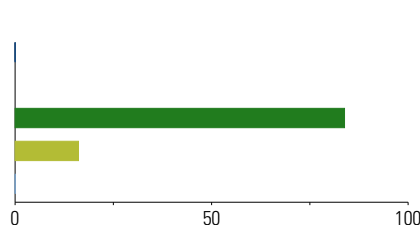

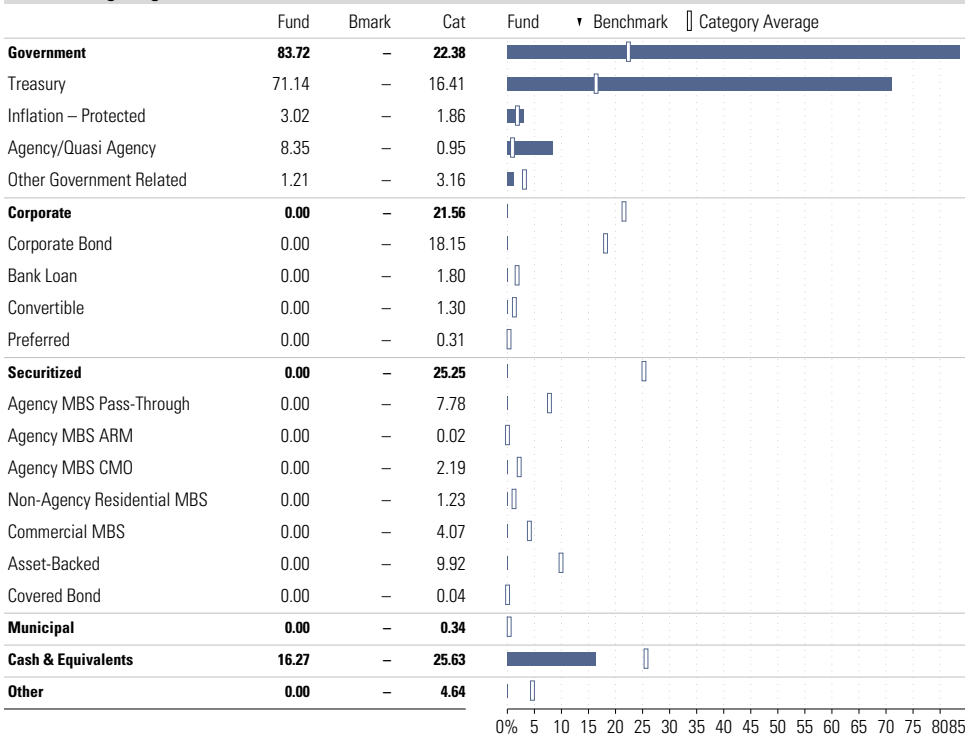

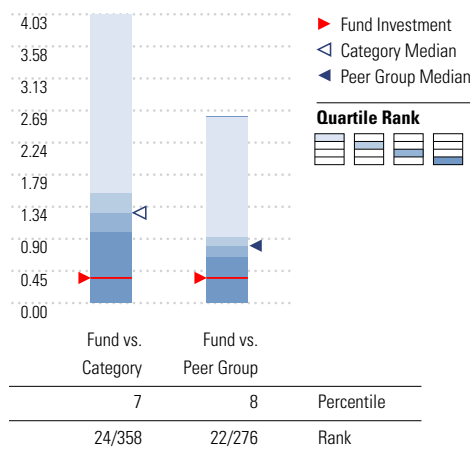

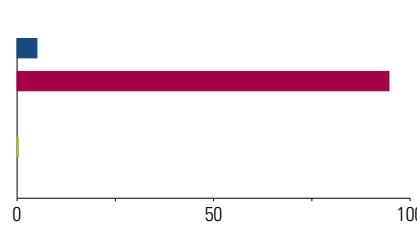

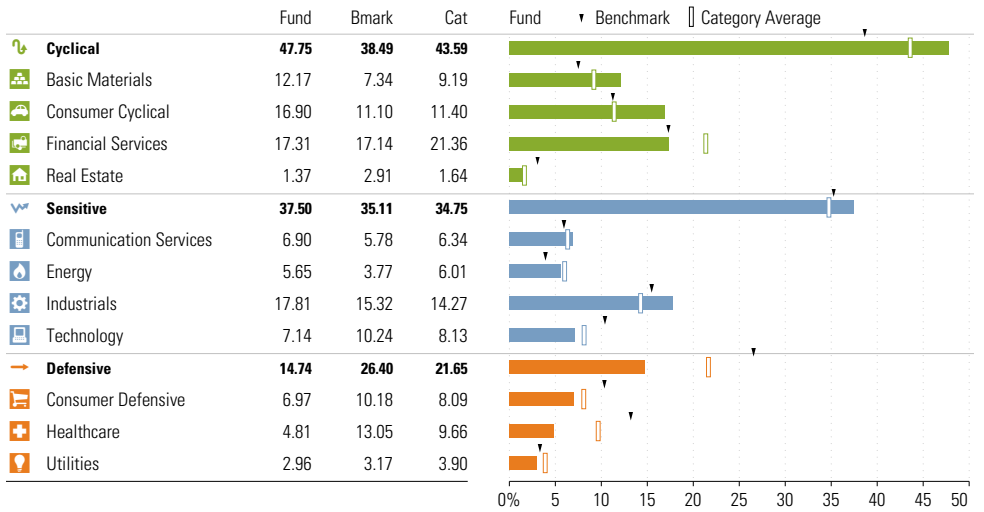
