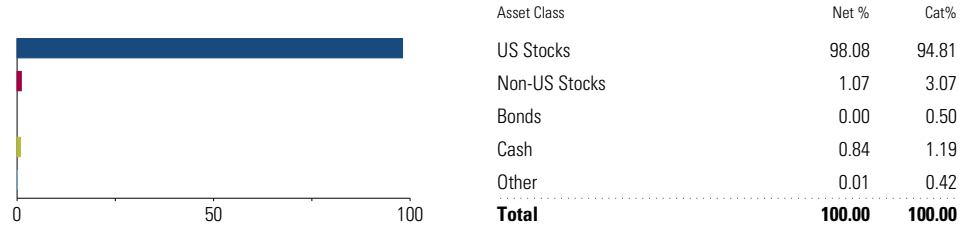

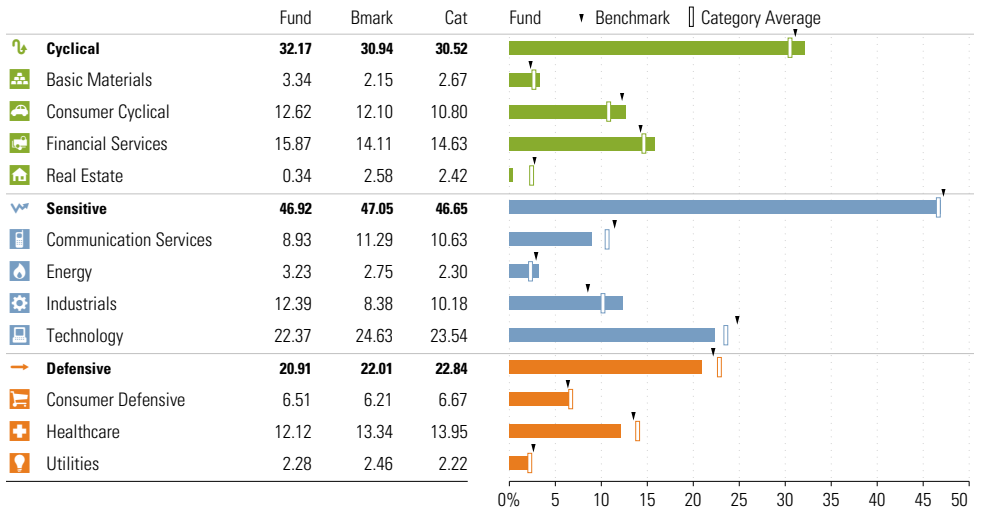

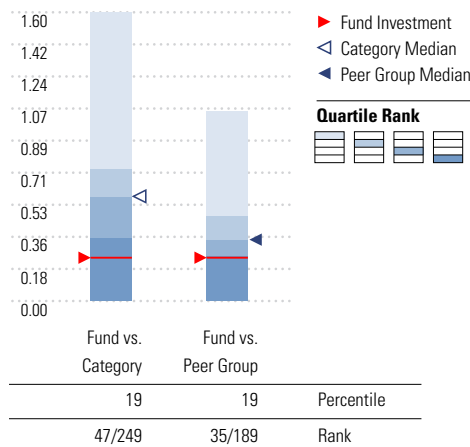

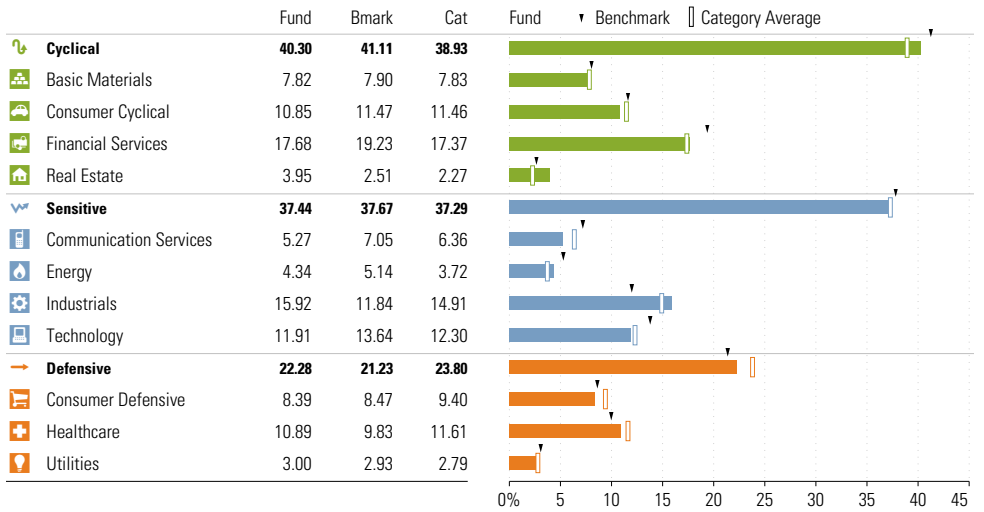

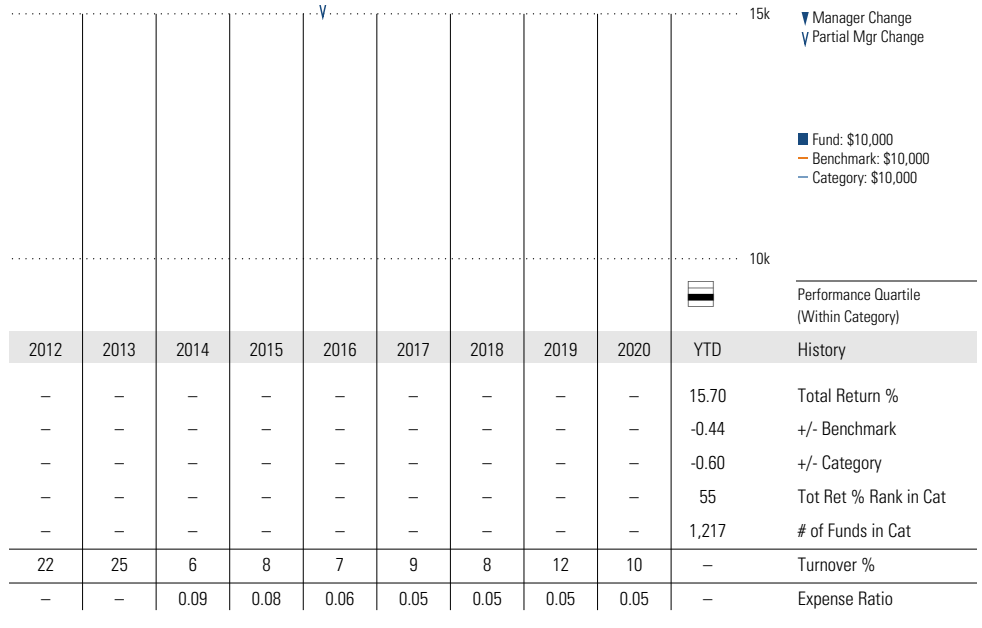

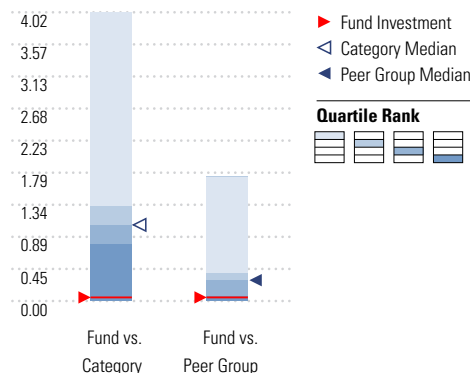

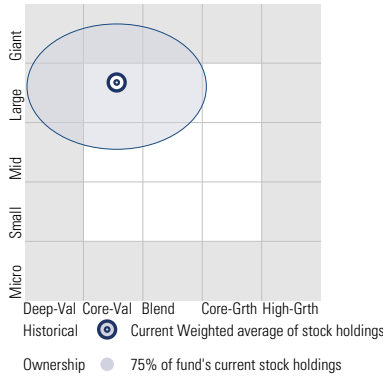

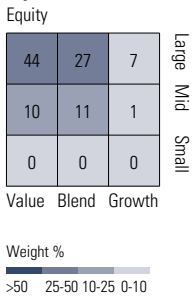

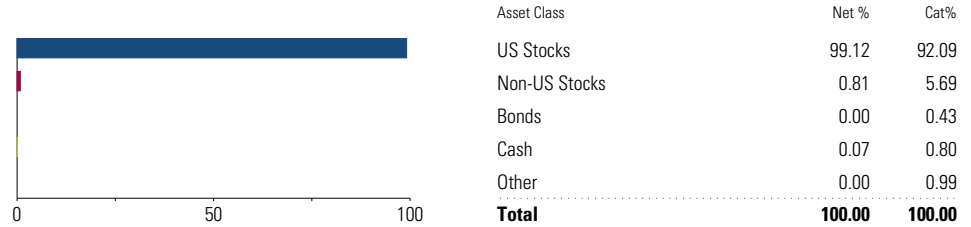

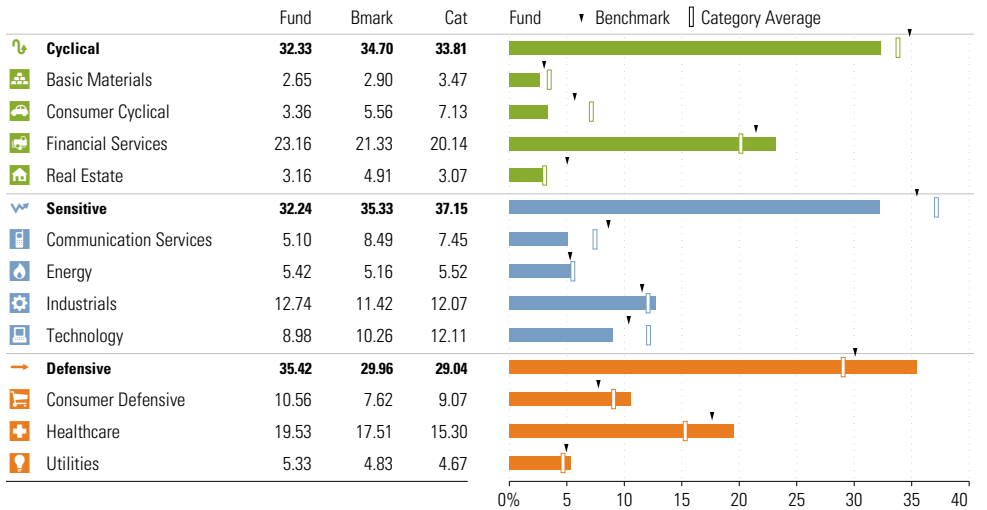
Style Breakdown
